Elf Licence

This licence (hereafter referred to as the “Elf licence”) grants the right to use licenced Content subject to the terms and conditions set forth and referenced as follows:

I. Definitions.

- a. **Product Identity** means trademarks, trade dress, and non-functional and creative expressions that are not essential to, or can be varied without altering, the ideas or methods of operation of a game, including works of visual art, music and sound design, and clearly expressed and sufficiently delineated characters, character organizations, dialogue, settings, locations, worlds, plots, or storylines, including proper nouns and the adjectives, names, and titles derived from proper nouns. The term Product Identity shall in no event include elements that are the exclusive property of one or more third parties, or that are in the public domain.
- b. **Elf Licensed Content** means (1) any material that has been expressly designated by yourself or a previous a licensor as constituting Elf Licensed Content. You must have the rights to the content to designate new content as Elf Licensed Content.
 - i. Elf Licensed Content specifically excludes Product Identity unless you specify otherwise.
- c. **Original Elf Content** means content that you have licenced under the Elf licence. This is a subset of the larger set of Elf Content, and therefore any content that is Original Elf Content is also Elf Licensed Content.
- d. **Designated Elf Content** means new or adapted content that you have designated as Elf Licensed Content to contribute to the pool of Elf Licensed Content, and which may be licenced by others as Original Elf Content. This is a subset of the larger set of Elf Licensed Content, and therefore any content that is Designated Elf Content is also Elf Licensed Content.
- e. **Copyright and Similar Rights** means copyright and/or similar rights closely related to copyright including, without limitation, performance, broadcast, sound recording, and Sui Generis Database Rights, without regard to how the rights are labeled or categorized. In no event shall Copyright and Similar Rights include trademark or patent rights.
- f. **Effective Technological Measures** means those measures that, in the absence of proper authority, may not be circumvented under laws fulfilling obligations under Article 11 of the WIPO Copyright Treaty adopted on December 20, 1996, and/or similar international agreements.
- g. **Licensed Rights** means the rights granted to You subject to the terms and conditions of this Elf License, which are limited to all Copyright and Similar Rights that apply to Your Use of the Elf Content and that the Licensor has authority to license.
- h. **Licensor** means any individual or entity granting rights under this Elf License.
- i. **Sui Generis Database Rights** means rights other than copyright resulting from Directive 96/9/EC of the European Parliament and of the Council of 11 March 1996 on the legal protection of databases, as amended and/or succeeded, as well as other essentially equivalent rights anywhere in the world.
- j. **Term** means the term of the Copyright and Similar Rights licensed herein.
- k. **Use or Used** means to use material by any means or process that requires permission under the Licensed Rights, such as production, reproduction, creation of derivative works, public display, public performance, distribution, dissemination, communication, or importation, and to make

material available to the public including in ways that members of the public may access the material from a place and at a time individually chosen by them.

1. **You** or **Your** means the individual or entity exercising rights granted under this Elf License.

II. Grants & Limitations.

- a. **Primary Grant to You.** Subject to the terms and conditions of this Elf License, for the Term Licensor hereby grants You a worldwide, royalty-free, non-exclusive, irrevocable license to exercise the Licensed Rights in the Elf Licensed Content to Use the Elf Licensed Content, in whole or in part. Licensor hereby authorizes You to exercise the Licensed Rights in all media and formats whether now known or hereafter created, and to make technical modifications necessary to do so. Licensor hereby waives and/or agrees not to assert any right or authority to forbid You from making technical modifications necessary to exercise the Licensed Rights, including technical modifications necessary to circumvent Effective Technological Measures. You are granted the right to sub-licence the Elf content on exactly the same terms as in this agreement.
- b. **Grant of Elf Content by You.** You hereby grant to any recipient of the work containing the Elf content a licence to use the original Elf Licensed Content and any Elf Licensed Content specifically designated by you under the terms and conditions of this agreement as Designated Elf Content. You may not offer or impose any additional or different terms or conditions on the Elf Licensed Content that you have licenced, or apply any Effective Technological Measures to the Original Elf Content if doing so restricts exercise of the Licenced Rights to any recipient of the Elf Licensed Content.
 - i. For clarity, it will not be a breach of this agreement to apply Effective Technological Measures to the content if the content is also provided, in the same work or the same distribution, without Effective Technological Measures.
- c. **Database Rights.** Where the Licensed Rights include Sui Generis Database Rights that apply to Your Use of the Elf Licensed Content, this Elf License grants You the right to extract, reuse, reproduce, and Use all or a substantial portion of the contents of the database, and if You include all or a substantial portion of the database contents in a database in which You have Sui Generis Database Rights, then the database in which You have Sui Generis Database Rights (but not its individual contents) shall constitute Elf Licensed Content.
- d. **Limitations.**
 - i. Nothing in this Elf License constitutes or may be construed as permission to assert or imply that You are, or that Your Use of the Elf Licensed Content is, connected with, or sponsored, endorsed, or granted official status by, the Licensor or others designated to receive attribution hereunder.
 - ii. Moral rights, such as the right of integrity, are not licensed under this Elf License, nor are publicity, privacy, and/or other similar personality rights; however, to the extent possible, the Licensor waives and/or agrees not to assert any such rights held by the Licensor to the limited extent necessary to allow You to exercise the Licensed Rights, but not otherwise.
 - iii. To the extent possible, the Licensor waives any right to collect royalties from You for the exercise of the Licensed Rights and Use of the Elf Licensed Content, whether directly or through a collecting society under any voluntary or waivable statutory or compulsory licensing scheme.

- III. **Required Notice.** The grant of this Elf License to You is expressly conditioned on You including the notice statements described in subsections (a)-(c) below in a reasonable manner based on the medium, means, and context in which You Used the Elf Content:
- a. **Elf Notice.** The following statement designating the location and the terms of this Elf License:

This product is licensed under the Elf License 1.0 located at [LOCATION TBD] and others. All warranties are disclaimed as set forth therein.
 - b. **Attribution Notice.**
 - i. A statement based on reasonable, good-faith efforts that identifies each Licensor or creator of the Elf Licensed Content You Used and any others designated to receive attribution, including all upstream licensors of Elf Content upon which work is based or derived from, in any reasonable manner. For the avoidance of doubt, both Licensor and all parties similarly credited under Licensor's attribution notice should be included in Your attribution notice unless otherwise reasonably indicated by such parties.
 - ii. A statement indicating how You wish to be reasonably credited with respect to the Adapted Elf Content licensed by You under this Elf License, including by pseudonym or anonymously if designated.
 - 1 If your preferred attribution is a graphic, image, sound, virtual reality content, video content, or any other form of content beyond pure text, you must include a pure text version of your attribution as well.
 - 2 You may attribute any Licensor with the pure text version of the attribution, or an audio or visual rendition of that text, at your discretion.
 - 3 If a Licensor fails to include a pure text version of their preferred attribution, you may attribute to them using a description of their preferred attribution.
 - 4 You may adapt any attribution as reasonably required to provide accommodation to disabled individuals.
 - iii. A statement indicating which, if any, elements of Product Identity have been licensed by you or by other licensors as Original Elf Content or Designated Elf Content. If this statement is omitted, it is considered a statement that no such elements are further licensed.
 - c. **Deattribution.** If you receive a request from a Licensor to remove the attribution to that Licensor from your work, you must reasonably comply with that request. For clarity, reasonable compliance does not require the destruction of any already printed physical copies, nor for anyone to cease distribution of any already printed physical copies.
 - d. **Reattribution.** If you receive a request from a Licensor to change the attribution to that Licensor in your work, you must reasonably comply with that request and adapt the attribution to the new name, pseudonym, or anonymous as the case may be. For clarity, reasonable compliance does not require the destruction of any already printed physical copies, nor for anyone to cease distribution of any already printed physical copies.
 - e. **Attribution Valid Notwithstanding Variation.** So long as the above elements in III(a) – III(b) are included, an attribution intended to comply with the requirements of another licence will be deemed to also comply with this licence.

This content specifically includes product identity as Designated Elf Content.

IV. **Warranty & Limitation of Liability.** Licensor licenses the Elf Content as-is and as-available, and makes no representations or warranties of any kind concerning the Elf Content, whether express, implied, statutory, or other. This includes, without limitation, warranties of title, merchantability, fitness for a particular purpose, non-infringement, absence of latent or other defects, accuracy, or the presence or absence of errors, whether or not known or discoverable. Where disclaimers of warranties are not allowed in full or in part, this disclaimer may not apply to You. To the extent possible, in no event will the Licensor be liable to You on any legal theory (including, without limitation, negligence) or otherwise for any direct, special, indirect, incidental, consequential, punitive, exemplary, or other losses, costs, expenses, or damages arising out of this Elf License or use of the Elf Content, even if the Licensor has been advised of the possibility of such losses, costs, expenses, or damages. Where a limitation of liability is not allowed in full or in part, this limitation may not apply to You. The disclaimer of warranties and limitation of liability provided above shall be interpreted in a manner that, to the extent possible, most closely approximates an absolute disclaimer and waiver of all liability.

V. **Other Terms & Conditions.**

- a. **Termination & Remedies.** Your license to Use the Elf Licensed Content will terminate automatically if You fail to comply with the terms and conditions of this Elf License. Your license will be reinstated, effective as of the date of termination, if You cure such violation on a going forward basis (without the obligation to destroy inventory on hand) within 60 days of Your discovery of the violation or if Licensor waives such violation in writing. No such termination shall affect, limit, or disrupt the rights of any Licensor or downstream licensee of

any Elf Licensed Content under any Elf License. Only the Licensor and Licensor's upstream licensors under this Elf License (which You are deemed to be in privity herewith) may bring enforcement action against You hereunder. This constitutes a limitation on Licensor remedies with respect to the license grant in the Elf Licensed Content hereunder; however, this Elf License neither limits Licensor's remedies in any way with respect to Licensor's Product Identity, nor does it limit Licensor's right to offer the Elf Licensed Content or any other content under separate terms or conditions.

- b. **Modifications.** This Elf License may not be amended, superseded, modified, updated, repealed, revoked, or deauthorized. Neither You nor Licensor may modify the terms of this Elf License; however, You may enter into a separate agreement of Your own making provided such agreement does not seek to modify the terms hereof. This Elf License does not, and shall not be interpreted to reduce, limit, restrict, or impose conditions on any use of the Elf Content that could lawfully be made without permission under this Elf License. To the extent possible, if any provision of this Elf License is deemed unenforceable, it shall be automatically reformed to the minimum extent necessary to make it enforceable. If the provision cannot be reformed, it shall be severed from this Elf License without affecting the enforceability of the remaining terms and conditions. No term or condition of this Elf License will be waived and no failure to comply consented to unless expressly agreed to by the Licensor. Nothing in this Elf License constitutes or may be interpreted as a limitation upon, or waiver of, any privileges and immunities that apply to the Licensor or You, including from the legal processes of any jurisdiction or authority.
- c. **Construction.** This licence is published simultaneously with an FAQ document. The FAQ document is intended to provide a general indication of the drafts' intentions in interpreting the Elf licence and in the event of a dispute, the FAQ is intended to be admissible to and used by any adjudicating body for any such purpose. The Elf licence may be translated into other languages. You and Licensor agree that if there is any conflict between the Elf licence, the FAQ, and any such translated version, the English language Elf licence shall control. The current version (1.0) of the Elf FAQ is only intended to be admissible to explain the current version of the Elf licence (1.0), and no subsequent FAQ shall be admissible to explain this version (1.0).
