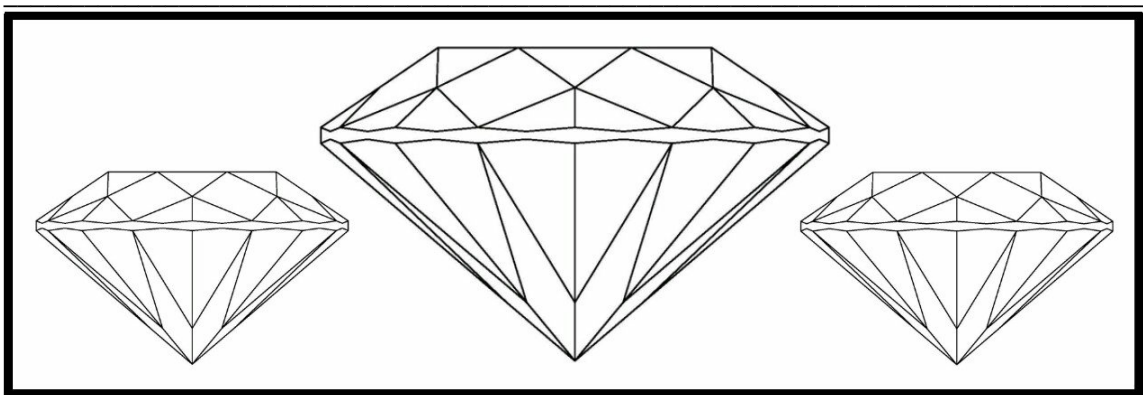

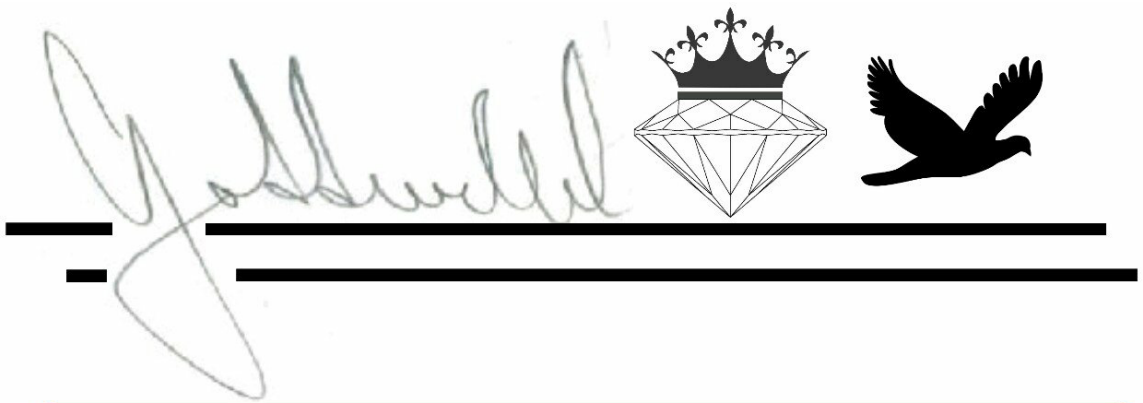

In the interest of the protest against Chinese People republic criminal ties

I warmly greet all ASEAN countries, and it is in my interests to wish You many good successes.

My name is King Gottwald Peter, ID's Diamond Oasis, ID's federal government, representative of the new government state and legal governmental entity.

My interests are to establish contact between our states, to establish partnership relations between our institutions for supranational cooperation of the states, but also to promote common security.

My present-day statement today is a request to support a protest against the Popular republic China, and I therefore support your strategy to grow your stronger position and thus security with the ability to organize global opposition to the Popular republic China at a level more significant than the Popular republic China multilateral agreement on terrorist security threat.

Please the ASEAN States to organize a legal protest against the leadership of the People's Republic of China due to ongoing activities to support the development of markets with the representatives of the European Terrorist States and thus to promote a better capacity for stability of the terrorist regime and the function of crimes at International level.

The crimes of the European states cause violations of more than 90% of international law and legitimate principles. The European states commit intentionally systematic genocide against over 350,000,000 people worldwide over a period of more than 18 years. The value of crimes at the level of the first-priority duty to the UNSC to achieve the complete destruction of a terrorist entity in the first case, in any case.

The People's Republic of China refuses to ensure legitimate performance under the legal responsibility of internationally legitimate law. The Republic of China has shown that China's interests are global terrorism, violations of international rights and abuse of UNSC membership for its own Chinese interests with the significance of terrorism against other states, and thus re-proving China's inability to sit at the UNSC.

That is why I invite Your ASEAN countries, for the purpose of joint international organization for the purpose of increasing the protest of the

governments of the countries against the People's Republic of China, and thus ensuring the justice of legal interest and the security of the real freedom of our states and of the governments of the countries at international level and of neocolonization.

In the same interest, I support the ASEAN states in the right of this protest in order to create a cooperative claim for the purpose of protest in order to weaken the Popular republic China in disputes over the islands of the South China Sea, which today have no settled controversial situation and can not establish and assert the rights of China as legitimate.

In my interest, the CPR membership of the UNSC, each member must be impartial and with the foundation of a peaceful democracy without dictatorship. The People's Republic of China is founded on dictatorial interests of blocking other parliamentary parties and violating freedom of nations by right that only leads to isolation of the state in order to maintain its influence against the interests of the state and their rights of democracy.

At the same time, the People's Republic of China has often violated sanctions against the Republic of Korea, and thus the People's Republic of China has often reinforced the egoistic growth of the North Korea of nuclear power without the risk of a USA strike seeking to secure the security of its state and American soil, and the importance of International policy principles.

In the case of the Popular republic China, the trade support for the North Korea also creates a threat to the states seeking a legal and fair solution to the conflict of the disputed island territories, thus creating a threat to the China Republic's military reinforcement in friendship with the North Korea where both states of the same ideology jointly strive to increase the terrorist interest and causing a new regional war, and hence the threats of the intercontinental wars of the nations against China.

In relation to the activities of the People's Republic of China, there is a growing threat of wars that need to be stopped. If the Popular republic China will not be willing to stop the growth of lawsuits at the level of the South China Sea law dispute resolution and if the Popular republic China continues to stop supporting north Korean and European Terrorist alliances, I would also ask for an act of protest against the Popular republic China, Stop the legitimacy rights of the Popular republic China.

In the event of the cessation of the legitimacy of the Popular republic China, it is possible to use the Thai Wan government as an entity based on its illegitimacy in the 1960's due to the overthrow of the government in the form of the occupation and the takeover of power by the People's Republic of China which has fully exploited its power to issue a resolution on the prohibition of legitimacy rights and Government of Thai Wan.

The Thai Wan Government is still active and without any criminal and terrorist interest, a body which is executed in the interest of respect for international law, for peace purposes, open state democracy and the real function of parliament with the right of parliamentary democracy, constant support for development, The rights of citizens and enforcement with the justice function of the courts and the police, the regime with its own commercial network at the

advanced and prestigious level and its own army, today it is real that in the view of Thai Wan practices the government is genuinely advantageous for the government's recognition as legitimate sovereignty for continental China, To assume the responsibility of UNSC membership. In the same case, it is legally permissible to achieve the progress of today's consideration of the legitimacy of the UNSC resolution to ban the legitimacy of the Thai Wan government and thus because the Thai Wan government is based on recognition by its own population, and thus the Thai Wan government is actually active as a real state Which therefore has full rights to use international rights and freedoms.

Thai Wan is today and has always been a legitimate state because Thai Wan is peaceful and have an own state capacity, and the UNSC resolution damaging the rights of Thai Wan is therefore inconsistent with the UN Charter, articles 1 and 2, as basic articles establishing international law and UNSC resolutions for modifying of resolutions. The UNSC must not violate UN Charter 1 and 2 articles, but the resolution against the Thai Wan Government is indeed evidence of a fundamental violation of the rights of states and the admission to bureaucratic neo-colonialism.

The Thai Wan Government is a fully stable state format with all claims that can not be illegally blocked from the Chinese Continent regime. In the case of the recognition of the UNSC Resolution against the legitimacy of the Thai Wan Government, then it is necessary to look at the legitimacy of the resolution in terms of the true meaning of the current rights of the international standards, which again prove that Thai Wan is a legitimate government and state without the possibility of resisting and blocking be the UNSC resolutions. The resolution against the Thai Wan government was formed in about 1960, according to the principles of the ideology of international law of this date. Today is year 2017, for decades international law has been transformed to the benefit of the Thai Wan government, which has retained the function of its regime, recognition by foreign governments, as well as all the legal principles of a legitimate state, and today there is the year 2000, a new millennium Already due to a better development of international rights, is based on a much better form of peaceful and just forms of justifiable rights which, therefore, today confirm that the Thai Wan Government has full rights to pursue its own legitimacy and free state rights at international and national level.

The Popular republic China today reaffirms that in the view of the Popular republic China current regime interest and activity, it is not possible to respect the resolution against the Thai Wan government and recognize as Legal in the PRC responsibility, because of the recurring situation when I am fully entitled to international law and the obligation to create a new government of the country in the territories of European terrorist states The same foundations as the origins of the People's Republic of China, but in my case as a consequence of the legal process of international law, and not only in the history of the Chinese armed movement to overthrow the legitimate government and establish its sovereignty in the dictatorial liquidation of all the opposition citizens, whis is really difference between me and today China. China is criminal Camps, holocausts and displacement. I'am Legal governmental institution, prison for criminal and terrorist groups, liquid of terrorist regime, I have a much strengthen rights than PR China in their history of origine.

This means that I have a much greater right of sovereignty in the European Territorial zones and a much greater value of the right of recognition than the regime of the People's Republic of China with regard to the establishment of the Chinese regime. Therefore, if the People's Republic of China is today in favor of cooperating with terrorist countries in Europe, then the People's Republic of China now confirms that the regime is only terrorist and criminal with the result of open violations of international rights and peace standards and duties of the UNSC activity. The performance of the Popular republic China is a confirmation that in the form of the actual creation of the regime and in order to support the blockade against the interests of my party in Legal interest supported by the name of the World Order, the present regime of the Popular republic China can not even be legitimate, and meanly if the origin base of similarities is in time of PRC beginning.

The People republic China is legally based and created on the Political Rights, whis is today fully disrespected and blocked in International use, be the activity of the PRC regime.

The PRC self-declaration is, The People republic China can not be a legitimate political subject, and the intelligence about the Popular republic China, in view of the outcome of monitoring the government's activities and regime regimes internally and internationally, is confirmation that in the final conclusion, the Popular republic China government decides on its own inability to legitimize its own regime or, The Popular republic China's regime interest at the level of attempted criminal infiltration into international political structures for abuse for its own interests of terrorism and violation of the rights and integrity of other states.

The same evidence of the Popular republic China's inability to legitimize is once again based on the fact that the Popular republic China has never established the right of the state to democratically recognize elections, and thus the regime has established its own dictatorship, accompanied by concentration camps, dictatorship, Holocaust, displacement of its own population, and enslavement of the nation by the power of the regime. The Communist Party of the united power has since the full beginning of its inception, without the opening of democratic law, demanding the use of the other parliamentary political parties in abusing the regime's power to block growth, recognition of other political parties and their ability to use legal means to increase their state influence. The situation in the Popular republic China has been completely identical to democracy and freedom in the Third German Empire under the leadership of Adolf Hitler for the period of the Second World War, 1939-1945 for over fifty years.

Evidence that the Popular republic China is merely a totalitarian and terrorist regime without any function of state democracy and only for dictatorial and fascist discrimination of state law as acts of crimes where such a regime can not be recognized is thus demonstrated in the view of the Popular republic China also having an obligation to support Thai Wan Cooperation in the Chinese Parliament with full equivalence and for the purpose of open democracy and joint control of the single state.

The origin of Thai Wan and the Popular republic China, two regimes

originating from one Parliament, two regimes that originate only as political parties, but which together extend the jurisdiction of the state and the legal principle of democracy. So everything was working under all the principles of statehood, but then came the Popular republic China movement that started the occupation of China and created its own domination for the sovereignty of the new regime, based only on dictatorship and crime against the Chinese state, and without any recognition of the rights of democracy, the facts of criminal activities Which openly suggests that the Popular republic China can not be a legitimate government.

If the government of the Popular republic China fulfilled the conditions of its own legitimacy, that would only be the case if the Popular republic China opens the parliamentary democracy and the right of the state of free choice without any influence on the vote. This at the same time means that the government of the Popular republic China must allow access to all Thai Wan political parties to serve as a single entity government democracy. Only the Popular republic China is here as a political subject that fully blocks political principles and creates dictatorial crimes against the legitimacy of international law, and thus the Popular republic China publicly confirms that it does not own the right to recognize a political subject.

The People's Republic of China has a similar foundation as ISIS or Adolf Hitler in the territory of the occupied states during the Second World War.

Today's Popular republic China is therefore an open motivation only for the growth of radicalization abroad and the discrimination of the obligation of the peaceful course of democracy, each political party is aware of the openness of the possibility of overthrowing the legal function of the government and of establishing its own regime.

That is why I support, in the interests of protest, the steps to promote and recognize legitimacy for the Thai Wan government and ensure recognition of the full independence of the state. Today, the Popular republic China has blocked the UNGA's freedom to vote, so rights to the same principles of independent voting can be used, as is the case with the Uniting for Consensus club, and the possibility of creating an independent international vote for the purpose of exempting the Thai Wan government and also for the purpose of overthrowing the rights of the Popular republic China For membership in the UNSC, today supports more than 100 countries.

I understand that the Popular republic China's strategy of defending terrorist interests is the way to achieve economic domination at international level, but also the principles at the level where the Popular republic China, in response, raises the capabilities of its armies as a threat of a real war, but that's why I also confirm that I am My own values of the economy that can create and organize the independence of the Popular republic China economy, and establish the strength of our armies, based on a drastically more powerful force than the Popular republic China armies and allied states that provide security stabilization for the Popular republic China under Chinese treaties.

That is why I certainly Thank You for your interest in stabilizing a free

world without crimes, and so I really Thank everyone who is willing and active to support the protest against the People's Republic of China and the pursuit of terrorism.

The United Nations Organization has set up organized co-operation of state opposition against terrorist organizations for this purpose, and it is therefore necessary to activate such obligations.

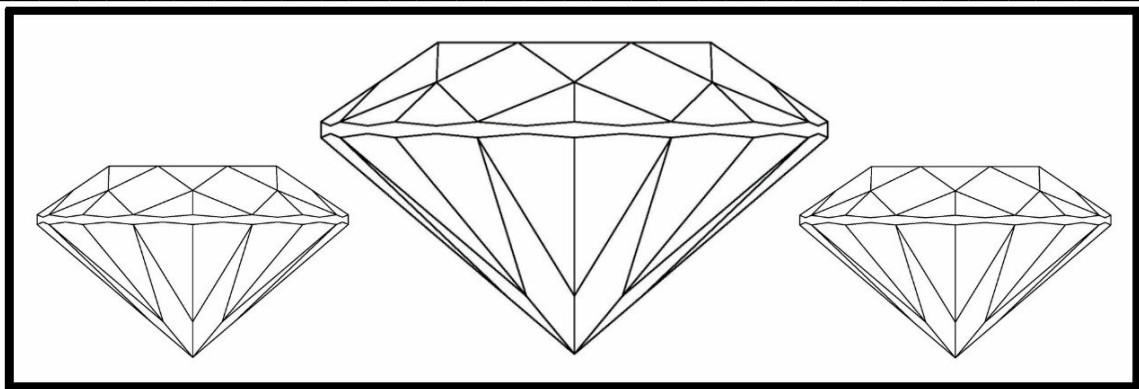

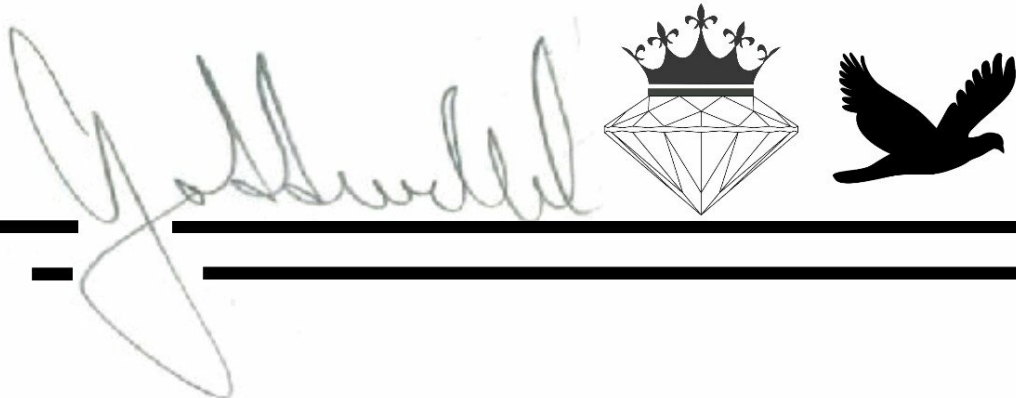
