

Transcription of meeting at home of Linda Mti between Mti, Gavin Watson and Angelo Agrizzi

8 May 2015

Legend: GW = Gavin Watson

LM = Linda Mti

AA = Angelo Agrizzi

GW: Jiba tried to close down twice but Dramat didn't want to give the docket over to close it down. Then Jiba took off De Kock off this case, but then De Kock came back on, smug back on this case. And the person that is controlling the whole process is...Breytenbach. And I want to implicate Willie. Because Breytenbach and Willie still talk as well Mr President . It's a fact. I want to say that. Willie is sitting on the fence Mr President, I know he has done things for you, but he is sitting on the fence, wherever he goes.

LM: Mmm

GW: I can talk to him like this. I want a whole document, I said to Angelo, then I want to sit down..but our facts have got to be right. I've got people, Ntlemeza, working on their side, so I can get that right. I wanna say, this is Breytenbach's thing. All she wants to do is discredit us in the paper. So that when this thing comes up, our agreements with the banks come up, overdraft facilities and that come up they throw this thing in the press. Always calling it up in the press. They want to get something to stick so they can discredit us in the press. Now Mr President we need to get this thing closed down. We need the right people in the right place. Ntlemeza is the right guy at that place, doing what he can. Now we need to get the right person at NPA. Either we get Chauke in, or Jiba or the woman down in Natal. One of them got to...look at what's happened to Jiba. Jiba is bugged up in the press, he told me that.

LM: Mmm

GW: He said Jiba is his person, okay.

[inaudible] just ask the questions, we get on with Jiba. I didn't say you working with her I said just we get on, Okay?

Now Jiba's been bugged up, Mrwebi has also been bugged up, okay in the press. So how do we protect them Mr President? By putting the right person in there. I don't know who is advising Mr President but you need to make the right decisions now, you haven't got much time to go. That's how I talk to him.

GW: Now we need to get our facts right.

LM: But you have them well...

GW: No...I don't know...hang on...you don't know whether it's De Kock and who else on that side. Because there is an Indian woman there too I hear.

LM: Mmm

GW: So who is there, who is in that unit? We got the opportunity now, you understand what I mean? Has Jiba got a letter of appointment, that she will be acting? Or not?

LM: She had that when that was signed. He asked...suspended [inaudible]

GW: But you see I want to say when this thing happens Mr President happens, suspend him immediately and put our person in.

LM: She had accepted. She got it late last year or early this year when the President first spoke about. I don't know...legal advice...[inaudible]

AA: Have you explained to him what you have cautioned...how to move those investigators, Gavin?

GW: No she said they were moved. They've been moved.

AA: Okay.

GW: They've been moved. Smit. Smit's actually been...what they did Rich is they called in the whole case. But they don't make it only a Bosasa thing, they call everything in, you know what I mean? All the cases they called them in, he's investigating them but Bosasa's one of them. They didn't want to make it a Bosasa thing. They are going to suspend him, Smit. GW: By SARS! By some unit, ICC or something..what is it?

AA: I don't know Gavin!

LM: This disbanded unit that is under-

GW: Ja! Pillay and them. [inaudible, talking over each other]

AA: We've got to be careful. If that is the truth, then he would be out in the cold anyway. Because that unit has been disbanded. He can't feature if he is part of that unit. If he was part of that unit, you see this is why it doesn't make sense to me. They're disbanded, so he's got no portfolio anyway.

GW: He's been...no I am just telling you this is what they telling..

LM: No no..he could be-

GW: Hang on, hang on..

LM: He could be. Agree I think the unit is in the process of being disbanded.

AA: Yes

LM: So it doesn't mean he could not have been part of it if that...So it's possible.

GW: So ja we need to get the right facts

AA: That's why I am saying, we don't know that

GW: Hang on. We know that this is what they're saying..hang on, Angelo...our guys just talk, but they don't get down to the facts. This is why we need to have a document written and it needs to be factual. This is why I am saying to you now, and explain to him so on both sides..

AA: If we make an accusation or...I mean it doesn't matter we can make that accusation that there's a linkage between this guy and that rogue unit... but what happens if there's no linkage. But we are going on what people tell us, but there is no factual...they've got to give us the substance of it so that we know...because if we put the document forward and its wrong and these guys aren't part of the rogue unit, he's got the names already of the rogue unit, then they can say ooh if this is wrong, how much more is wrong

GW: I had a meeting with the guys yesterday again. [Masondo] verified things..I got-

AA: We have to

GW: That's why I am speaking to him now. He can verify it on his side.

LM: Its not a big deal Angie –

AA: No no Rich we've got to be careful. We can't make – its like me saying Breytenbach sniffs cocaine, but I can't prove it

GW: Hang on we can prove it, okay. They said to me, Sesinia's guy said the same thing to the guy I met yesterday again...said the same thing.

AA: Ja?

GW: But as I said we need facts...

AA: Absolutely beyond reproach

GW: That's right. When sit with the President and I go through the document, it's gotta be factual. So I am just saying what he needs to do on his side is get hold of Jackie, they will know who they're interacting with on the other side. They can ask that question. Then now we're getting...I am meeting a guy again on...the senior counsel again on Monday to go through that again. We want to know facts. Once its on paper, we're buggered.

GW: Okay. But then on the Smit case, that unit we need to make sure that unit is a SARS unit

AA: Exactly that's my question

GW: Okay, because Ntlemeza says it's not part of his unit.

LM: Mmmh

AA: You see

GW: It's not. Now Jackie and Jiba will know exactly what it is because they are lawyers. They've got a legal process you understand and find out for us...because the President wants me to do a presentation to him when he gets back from Russia.

LM: No, no Gav me I was saying to management at theres nothing that stops us to make the conditions-

LM: Where we do not know, it means we verify

GW: Ja

LM: So we can put, we can put the names but whether they are SARS or SAPS...for us, we know them to be SAPS. But we can then...-

AA: Assume?

GW: No, no, no, no...but he can

LM: I am saying

GW: Ja I agree with what your saying

LM: The starting of sketching up the linkages is not a problem. But we don't quote on the linkages of these fellows to SARS until we find information. Because we know that they have been in the case, and they have been on the case on behalf of SAPS...

AA: So on the document we just put there...

LM: Here, once we have verification about them, then we...

GW: But you could do it over the weekend

LM: Yes galuke I am saying whether they are part of SARS or SAPS does not stop...

AA: We can presume...

GW: Just get hold of Sesinia there just find out from him what is that unit, so we can verify with him...ICC or something Rich...
