Bunker Hill Post Scholarship Applications Available

The Killilea Scholarship Fund Committee of the Bunker Hill Post 26, American Legion, has recently voted to reopen their scholarship assistance program for the 1984-85 academic year. Scholarship awards totaling \$2,000 will be granted.

Charlestown residents between the ages of 16 and 23 or any son or daughter or grandson or granddaughter of any member of Bunker Hill Post 26, The American Legion, in good standing or was in good standing at the time of death, are eligible to apply for a scholarship.

There will be two general scholarships, one for \$1,000 and the other for \$500 for Freshman only of any accredited four year college or university.

Two other scholarships, each in the amount of \$250,

will be awarded towards the tuition at the Bunker Hill Community College in Charlestown. One of these scholarships will be named the H. Vincent Strout Memorial Scholarship, in honor of the late Past Commander of Post 26, American Legion.

Applications and information on the scholarships to be awarded by the Killilea Scholarship Fund of Bunker Hill Post, American Legion, are available at the Kennedy Center, the Charlestown Patriot, the Bunker Hill Museum, the Charlestown Branch Library, and the Charlestown Boys and Girls Club.

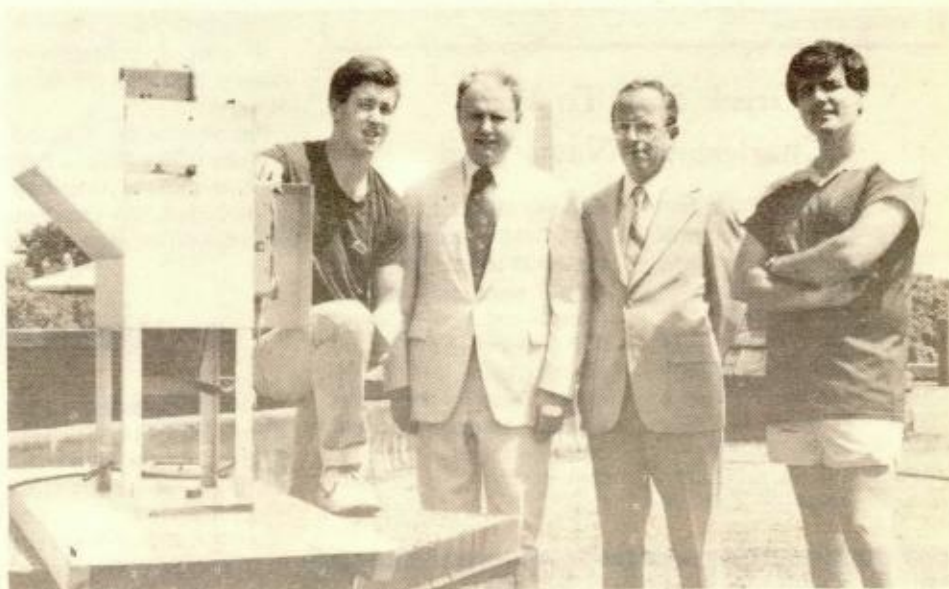

Representative Richard A. Voke, after securing a commitment from the state's air quality agency to perform air quality studies in Charlestown, recently assisted in the installation of a particulate monitor atop the Life Focus Center/Charlestown District Court House located in City Square. The Acting Commissioner of the Department of Environmental Quality Engineering (D.E.Q.E.), Thomas McLaughlin, was on hand in Charlestown to supervise the installation, while technicians from the air quality division secured the machine, making sure it functioned properly. The apparatus was set-up carefully and readied to have readings and samples taken every six days.

Representative Voke reported that the D.E.Q.E. apparatus would be serviced initially by Life Focus Center staff. Analysis of data will take place in Tewksbury, the location of the D.E.Q.E. laboratories. Subsequent to the preliminary findings, D.E.Q.E. technicians will maintain the detection device.

Voke was encouraged with the cooperation afforded Charlestown by the state agency. The Commissioner of the D.E.Q.E. made assurances regarding their commitment to the community, and to the objectives of the Charlestown legislator, those objectives being a comprehensive study of Charlestown's en-

vironmental condition. Representative Voke made the following comment regarding the installation proceedings, "Through reasonable negotiations with the

D.E.Q.E. Commissioner I was able to secure their commitment. After helping set-up the machinery, and discussing the operating procedures, with the experts, I am confident

the results will be of the highest quality. My staff and I will stay in close contact with both the Department of Public Health and the D.E.Q.E. to make sure that the flow of data between the two state agencies is obstacle free and their goals mutual."

Representative Voke has remained committed to obtaining monitoring for Charlestown since the news of Boston Edison's plans to convert their Mystic plant to coal became known. The Edison Company subsequently halted their plans to reconstruct in Charlestown, while continuing in South Boston.

The local Representative has made a point of scrutinizing closely all potential violators of Charlestown's air quality and environmental health. "We will continue to do so, and will continue to keep the state agencies accountable to the concerns of Charlestown residents," concluded Voke.

Greek Ship To Visit Charlestown Navy Yard

The National Park Service and the U.S. Navy will host the Greek training ship ARIS A 74 at Boston National Historical Park's Charlestown Navy Yard from July 27 through August 2. While here on a good will visit, the ship will be open to visitors from 4 p.m. to 6:30 p.m. the evenings of July 28

through August 1. At 3100 tons and 100 meters in length, this is the largest naval ship built in Greece and carries about 200 midshipmen, 80 enlisted men, and 14 officers. This ship resembles a small passenger ship and could serve as a hospital ship or transport in war-time.

obstruct a sidewalk curb ramp designated for use by disabled persons. Penalties for violating these regulations are stiff. A vehicle may be immediately towed or receive a \$100 fine.

Commissioner of Handicapped Affairs, Susan M. Scully, explains that the fines are with good reason. "Non-disabled drivers who park in HP/V reserve spaces, or cars that block sidewalk curb cuts do more than just commit a parking rule violation - they deny a disabled person's right to equal access and handicap that person's mobility."

The Commission is coordinating this Handicapped Parking Awareness Week with City Councillor Maura Hennigan, the Traffic and Parking Department and the Police Department in response to continuing complaints from disabled residents across the City about their inability to travel freely in their communities because of cars

blocking curb cuts or taking HP spaces.

As part of this awareness campaign, residents will pass out flyers on car windshields and put up posters which explain handicap parking regulations and fines. Boston Police and Traffic and Parking Enforcement Officers are

being instructed to step up enforcement of HP/V spaces and curb cuts with ticketing and towing.

Bunker Hill School Update

The future of the Old Bunker Hill School is still up in the air, according to Ms. Jan Noonan of the Department of Public Facilities, City of Boston.

Presently there are four proposals before the department for renovating the 118 year old structure which is located at the corners of Baldwin and Bunker Hill Streets.

The developers include the Bunker Hill Preservation Society; Dudley Godfrey, Jr. and Ernest Lonano; the Crowninshield Corporation; and the New England Housing Corporation.

All but the New England Housing Corporation have submitted plans for a condominium conversion. The Housing Corporation is involved in researching and developing housing

alternatives for low and moderate income families. Their plan calls for a cooperative management arrangement where the occupants partially own and operate the facility. The plan also calls for a democratic governing body with an elected board of directors.

However, according to Noonan, "most of the people from the immediate neighborhood that we have heard from are in favor of the condominiums."

The department was "entertaining the idea of a resident task force" says Noonan, "but, that's not definite."

As for another community meeting, Noonan stated that she did not know if it would be "fruitful."

Noonan stated the department will "hopefully make a decision within the month", but presently "everything is in limbo."

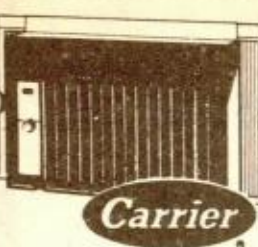

Kennedy Center Receives Nutrition Mini-Grant

In an effort to eliminate what state officials have called a "shocking increase in malnutrition in the Commonwealth," the Department of Public Welfare has announced that JFK Family Service Center, Inc. will receive a \$4,185 mini-grant to provide nutrition outreach to low income families in the Charlestown area.

A 1983 Massachusetts Nutrition Survey was released last fall which showed that as many as 17,500 children in this state are suffering from chronic malnutrition. The study found that 32% of the children surveyed live in households which are eligible for food stamps, but are not receiving them.

Less than one month after the survey was released, the Legislature approved a supplemental nutrition budget totalling three million dollars for this year. Approximately \$54,000 has been distributed through the Department of Public Welfare in the form of mini-grants aimed at increasing the number of participants in the food

"These mini-grants will help us attack the problem of malnutrition from the local community level," said Public Welfare Commissioner Charles M. Atkins. "Local organizations know their communities and they know what the barriers are to food stamp participation."

"Each community has specific needs - and unique reasons as to why people are not receiving food stamps. One area may have a sudden unemployment problem because of a plant closing. Another community may have a large elderly or non-English speaking population. All these people may be eligible for food stamps and not know it. With the mini-grants, local organizations can reach out to these people and help them to apply," Commissioner Atkins said.

JFK Family Service Center will use its nutrition mini-grant to produce and distribute bi-lingual flyers to low income families and train volunteers to screen people for food stamp eligibility. The organization will focus its outreach efforts on newly unemployed and low income families with children, recently divorced women with children, non-English speaking families, refugees, the homeless, the elderly and families in rural areas.

JFK Family Service Center applied for the nutrition mini-grant through a competitive application process through the Department of Public Welfare. According to Public Welfare Commissioner Charles M. Atkins, JFK Family Service Center is one of 12 organizations to receive a mini-grant. The grants range from \$3,500 to \$5,000.

Receives Historical Commission Preservation Award

Secretary of State, Michael Joseph Connolly, Chairman of the Massachusetts Historical Commission presented ten 1984 Historic Preservation Awards to groups and individuals from throughout the Commonwealth at the sixth annual MHC Preservation Awards ceremony held recently in New Bedford.

Included among the ten winners was Joseph Delmastro, a skilled craftsman. Employed by the L.V. Mawn Construction Company and working under the supervision of Ann Beha Associates, Architects, Joseph Delmastro's work was

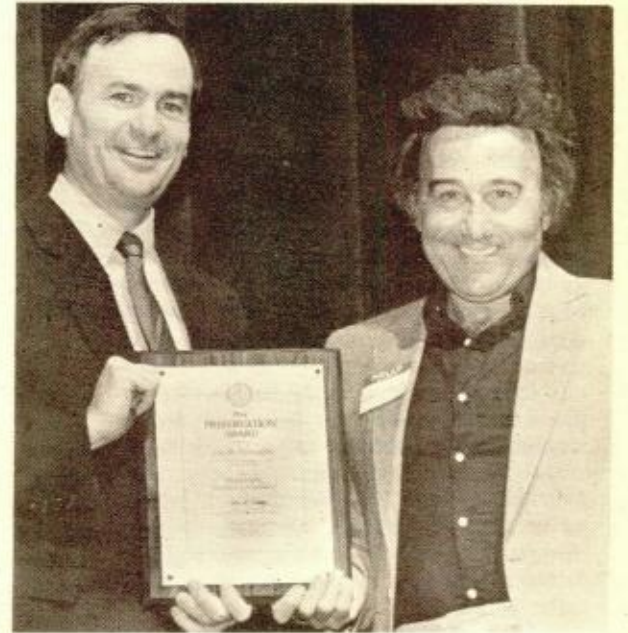
decisive in restoring the historic Austin Block in Charlestown to its early 19th century appearance some 80 years after the original stonework has been removed to make a modern storefront.

Since research on the building suggested that splitstone from Outer Brewster Island in Boston Harbor had been used originally, Mr. Delmastro traveled to the island and gathered the matching stone. While other craftsmen were unable to work with the stone in a style that approximated the early 19th century craftsmanship, Mr. Delmastro committed the

necessary time and patience to make his work take on style of his fellow craftsmen of 160 years ago.

While the Austin Block project received financial support initially from the Charlestown Preservation

Society, Historic Boston Inc., and the Massachusetts Historical Commission, it was the skill and patience of Mr. Delmastro which allowed the restoration goal to be realized.

Facts About Drugs - F.A.D.

It is important to know about withdrawal symptoms from various drugs so that you may recognize them among your friends and, perhaps, even your family. Withdrawal symptoms are a group of reactions or behavior which happen when a drug is withdrawn, upon which the body has physical dependence. If a person goes to a detoxification center, another drug may be given to counteract the abused drug, helping the person to tolerate the withdrawal. Not all drugs to which physical dependence develops have these opposite drug substances; and withdrawal can only be controlled by carefully spacing and decreasing the drug.

In drug dependence on morphine or heroin or any other opiate-type, it appears within a few hours of the last dose and reaches peak intensity in twenty-four to forty-eight hours. Symptoms include: anxiety, restlessness, insomnia, running nose, perspiration, gooseflesh, abdominal and/or muscle cramps, hot flashes, nausea, bowel problems and diarrhea.

In drug dependence of the barbiturate type, it appears within twenty-four hours of the last dose, reaches peak intensity in two or three days, and subsides slowly. Symptoms: anxiety, involuntary twitching of muscles, hand tremors, weakness, dizziness, nausea, vomiting, insomnia, epileptic type of seizure and service convulsions (possible death), delirium tremens, paranoid reactions, delusion and hallucinations.

In drug dependence the alcoholic type, withdrawal appears with the following of symptoms: tremors, sweating, nausea, rapid heartbeat, rise in temperature, jerky reflexes and in severe cases, convulsions, delirium tremens (confusion delusions, hallucinations.) These symptoms can be modified by the careful administering of barbiturates by a doctor.

Even though cocaine is not physically addicting, the withdrawal from the drug produces a deep depression which is the opposite of the user's previous state of euphoria.

If a friend of yours seems to be showing signs of withdrawal, and you are not sure what drug he/she is on, it is best to take him to an emergency unit of a hospital.

Receives High School Diploma

Ms. Irene Leighton, a resident of Charlestown and an employee of Blue Cross / Blue Shield, was selected last year by the company to participate in a unique program to earn her high school diploma. On June 27th, Ms. Leighton was one of 31 people to receive a high school diploma from the Christopher Columbus High School at a ceremony held at Longfellow Hall at Harvard University.

The Adult Diploma Program, in which Ms. Leighton was a student, allows a person the opportunity to earn high school credit for learning

acquired through life experience. The program was developed by the Continuing Education Institute, an educational and training center located in Medford. Classes are taught by staff from the Continuing Education Institute in space provided by companies such as the Bank of Boston, Blue Cross / Blue Shield, Massachusetts General Hospital and Millipore Corporation, which have employees enrolled in the program.

In order to earn the high school diploma, a person must prove high school level ability in reading,

science, writing, math and United States History. Sixteen credits are needed to graduate. Eight of these credits can be earned for learning gained through life experience. For example, credit was given to Ms. Leighton for the acquisition and utilization of skills that have been used in her position at Blue Cross / Blue Shield.

The idea behind the program is that learning occurs in every setting, not just the classroom. If a person can demonstrate the knowledge and skills which have been acquired from working, raising a family, managing a home or being part of a community, then credit can be given for those skills.

Hancock Square Condominiums To Occupy Site Of DaPrato Statuary

The old DaPrato Statuary Building on Main Street is in the process of becoming the new Hancock Square Condominiums.

Presently, the scaffolding-covered facility has left many residents curious as to what is to become of the nearly 100 year old Main Street landmark.

According to Jim Langley, owner, the building is being restored to the original size and the bricks are being secured in order for safe reconstruction of the interior.

As plans stand, the four

floor story structure will become home to 19 units of condominiums, 17 of which will be two bedrooms and two will be single bedroom.

Langley stated he was advised to build 25 units, but decided on 19 because "but less people is better because they'll have more room."

While no two units will be alike, Langley stated most will be dual level with spiral staircases and fireplaces, and all units will be air conditioned.

In addition to building a floor a top the present structure (which according to Langley was originally

part of the building but destroyed some 30 years ago by fire), the remaining four stories which are 12 feet and 18 feet high will become dual level.

The exterior is being repointed; a process in which the old grout between the bricks is replaced. Once this is completed and the brick restored, the building will be treated with a water-base chemical for protection.

According to Langley, the repointing will "take some time." Since the building was built sometime near 1886, fallen bricks have been "repatched". By repointing the brick, Langley states the walls which have deteriorated as a result of poor roof drainage will be secured.

"This process will take awhile," stated Langley, "but it will look like a new building."

Since the beginning of the project, Langley stated there has been the constant problem of youths loitering on the premises. "The older kids break in and drink in there, and then the younger kids go in," stated Langley. While there has been no evidence of vandalism, Langley fears someone may be hurt.

Langley also stated there has been a problem of people hanging on the scaffolding. In order to prevent both the loitering problem and climbing the scaffolding, contractor Bill Perry has hired a guard.

Despite the long process of repointing, Perry stated the completion date for the overall project is set for December.

"My outside goal will be sometime in October."

stated Perry. "And we hope a two bedroom model unit will be ready after August."

Both Langley and Perry stressed a desire to hire local labor for the project.

"I am a firm believer in local help," stated Langley. "You've got to give something back to the community."

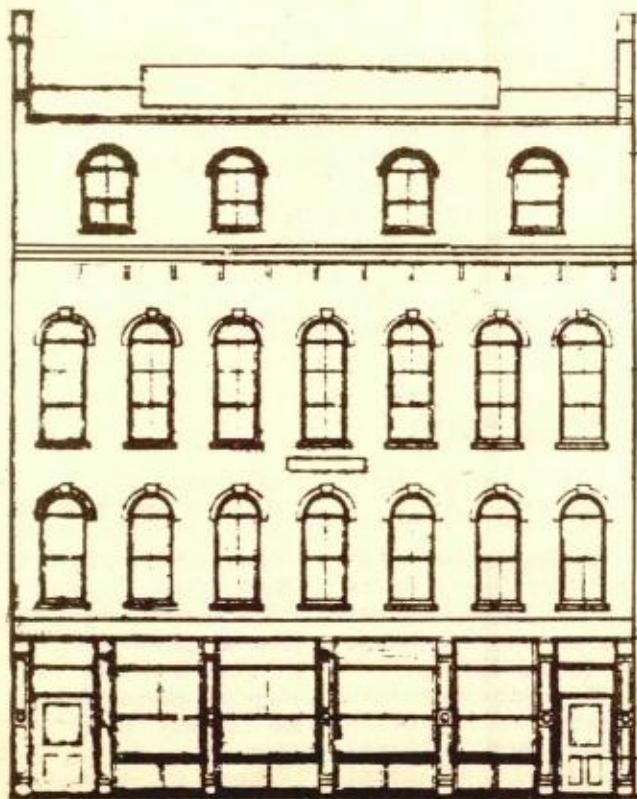
Perry stated despite announcements in the daily construction report, *The Dodge Bulletin*, there has been no local replies as of yet.

"Anyone who wants to bid is more than welcome, especially if they are competitive," stated Perry.

Perry said that among the needed subcontract work are electricians,

plumbers, heat and air conditioner specialists, and framers.

If anyone is interested, Perry stated, he welcomes all bids.

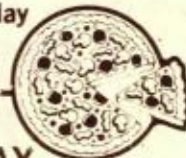

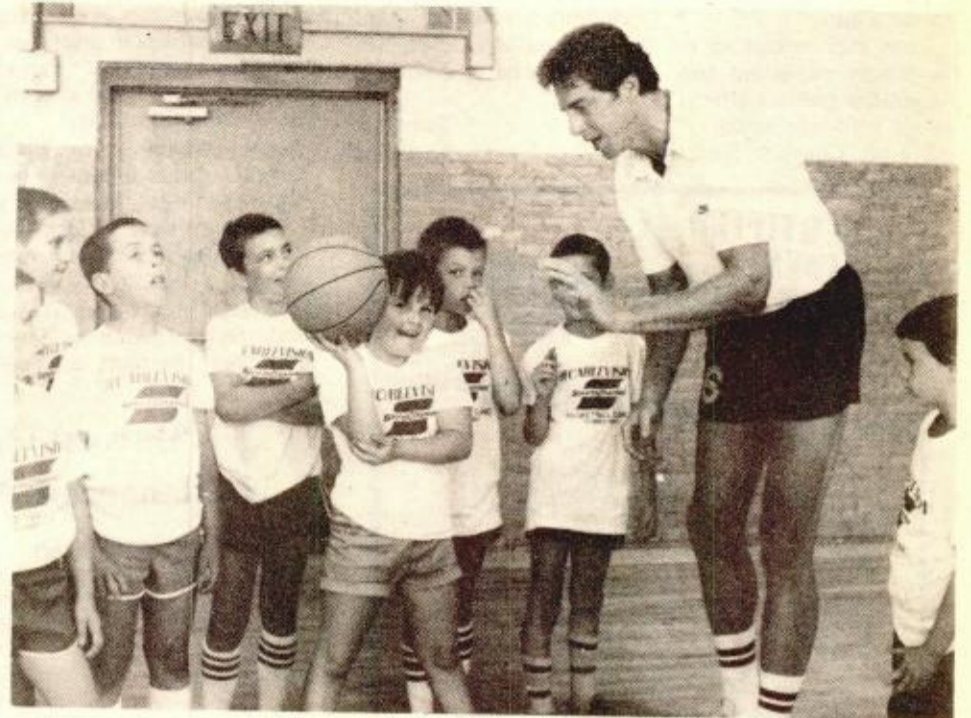

Burned Out Building Endangering Neighborhood

Dear Mr. Reed:

On April 20, 1984 there was a fire at 85 Russell Street, Charlestown. The damage which it did to the interior of the house forced the occupants to move out. The house is now vacant. It is one of about ten row houses on that stretch of the block and butts up against my own.

The Fire Department did an excellent job of putting out the fire on April 20 so as to minimize damage. However, after nearly three months, the house at 85 Russell Street remains unrepaired, open to the elements and accessible to trespassers. There is profound concern in our neighborhood that we will not be so lucky the next time a fire breaks out, which seems likely if something is not done soon.

As I have indicated, and I am sure you know, this stretch of Russell Street is densely populated. Most buildings are constructed of wood and many share common walls with their neighbors on either side. A fire in any building is a direct threat to the lives and property of everyone

in the immediate area, since the firewalls separating the houses are at best capable only of retarding the lateral movement of a fire for a short time. The fire of April 20 has demonstrated this.

The owner is unwilling or unable to repair, inhabit or properly secure the property. Telephone calls to your department from me and my neighbors have resulted in no visible action at 85 Russell Street although much sympathy and many good intentions have been expressed by members of your department. I also realize that your department is scandalously understaffed on account of forces beyond your control. Nevertheless, I write you today to ask that you personally direct swift action under the ample authority of the General Laws of the Commonwealth, as well as the ordinances of the City of Boston, to remedy this grave situation.

This building in its present condition, and by virtue of its location, simply constitutes a major disaster waiting to occur. A little action now will save all of us a lot of grief later. Accordingly, I ask that you board this building up forthwith. I will be glad to assist you in any way I can.

Please advise me of your activities and progress with respect to this situation.

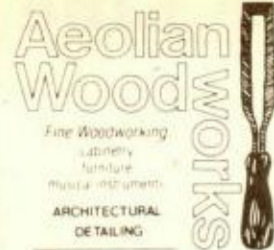
