

Terms & Conditions

Introduction

These Terms of Use govern access to and the use of the website **The Edge Funder** at www.theedgefunder.com and its associated services (collectively, the “Platform” or “Services”), operated by The Edge Funder, LLC (referred to as “The Edge Funder,” “we,” “us,” or “our”).
