

## Wall Street Site Of Six Alarm Fire — Seven Homes Destroyed

 Once again a multiple alarm fire strikes a Charlestown neighborhood, forcing seven more families to leave

their burnt out homes. Seven single family wooden homes on Wall Street were destroyed by a suspicious six alarm fire, which reportedly started

on the front steps of Number 10.

Charlestown resident, Jim Lynch, spotted the fire at approximately 5:15 a.m. Lynch, who was on his way to his parent's home to borrow his father's car, noticed what looked like "exhaust from a dryer" at Number 10, but when he opened the door, he saw the flames in the doorway. He yelled "Fire", went next door to his parents to get them and his sister out of their home, and called the fire department.

Rita Boyden, who lives at Number 10 Wall Street, was sleeping on her first floor when she heard Lynch's yells. Boyden's son, Bobby, heard her cries and woke the (continued on page 8)

### Three Residents Hospitalized Following Chlorine Gas Leak At Clougherty Pool

A chlorine gas leak at the Paul Clougherty Pool was Charlestown residents to the Massachusetts General Hospital on Sunday morning, July 14, 1985.

The three teenagers, who are all 15 years old and employed at the pool, were overwhelmed by the gas when they opened the shed door where the chlorine gas tanks were stored. According to pool supervisor, Helen

Myers, the youths noticed a drop in the water level of the pool and "were opening the storage room to operate the controls of the pool to raise the water" when the accident occurred.

## Next Central Artery Community Meeting Announced For July 30

Two meetings concerning the North Area/Central Artery Project will be held in the upcoming weeks. On July 30, 1985, a North Area Community Meeting will take place at 7:00 p.m. at the Knights of Columbus Hall, 75 West School Street. This meeting is open to everyone, and members of the consultant team and representatives from the state will be present to discuss issues of urban

design and streetscape.

Six different areas for new development, totalling 25½ acres next to City Square, will be available as a result of this highway construction project. The preliminary plans submitted in 1982 show offices, residences, retail shops, recreation, a hotel, and parking. The height of the buildings in this area could be as high as 60 feet. The buildings projected in

1982 totalled over 560,000 square feet.

In addition, the total number of jobs created by development on the parcels was projected to be over 1,500. At recent community meetings, the Task Force has spoken out clearly for these jobs to be available to Charlestown residents. At the July 30th meeting, new options for development on the parcels will be presented for discussion by the community.

On Thursday, August 1, at 4:30 p.m., an interagency workshop is scheduled. Project engineers, architects, administrators, and representatives from city and state agencies will attend, along with representatives from the community and the North Area Task Force to continue work on issues of urban design.

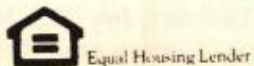

His name was Francis Xavier Power. Maybe the only people who were aware of that fact were his wife, Eunice, and their children. To every other knowledgeable basketball fan in Boston, he's simply known as "coach." Frank Power, however, was much more than a coach. He was a teacher, an innovator and a gentleman. Once you played for Frank's team, you were indelibly one of his kids. Whether you were Representative Fitzgerald, or Clerk of Court Jerry McClain or just a person who has fallen on rough times, Frank would do anything to help. I've never met a man quite like Frank Power, and I'm quite sure I never will.

You see, Frank Power died as a result of a heart attack while in Ireland, the land he loved. Frank was born in Ireland and proud to show it. That he died in the land of the green while teaching basketball was just, and I'm sure Frank would agree.

It will be sadly odd this year to see the B.C. Basketball Team huddle without Frank Power right in the middle dispensing his knowledge. This knowledge was garnered on floors and playgrounds from Southie to Roxbury from Charlestown to Chestnut Hill and from Chestnut Hill to Mission Hill. To say

he'll be missed is an understatement of major proportion.

Last week over 1,000 people from all walks of life attended a memorial service for Frank at Mission Church. Mayor Flynn, who Frank helped get into Providence College, attended. Frank's good friend, Bob Cousy, spoke at the service. B.C. Basketball Coach, Gary Williams, who probably appreciates more than anyone the true brilliance of Frank's basketball mind as well as his recruiting skills was present.

Usually after a church service, the congregation would all flee to their own life and careers. This sunny day in front of Mission was different. The people did not want to leave. One by one they told their favorite Frank Power anecdote. Each was funnier than the one preceding. My personal favorite was told by Bill Monahan, who is now a Belmont Selectman. At the time of his story, he was a 12 year old kid travelling to Lowell to play in a basketball tournament. When the Mission Hill players got dressed, they went upstairs to play. The tournament director immediately came over and informed Frank that his team could not take the floor because they wore t-shirts and cut-off jeans. Frank dismissed himself and returned 15 minutes later with full uniforms and told the Director "Now try to beat us" — and you know nobody could.

My first emotion is that I lost someone dear in my life. My second and stronger emotion is that I had a chance to know Frank Power. Frank, we love you and we miss you.

Can you just imagine 920 high salaried jobs at the School Committee building!

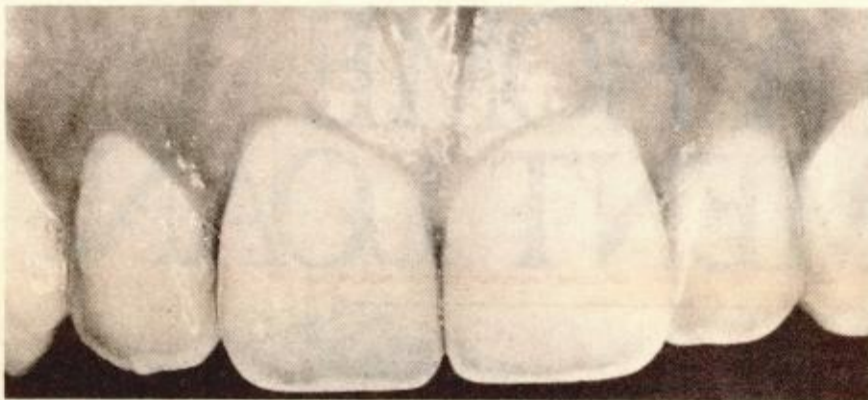

## Mayor Holds Meeting To Discuss Public Safety

In response to concerns over the delivery of public safety services, Mayor Raymond L. Flynn called together a meeting Monday, July 15th, between representatives of various city departments and Charlestown residents.

Attending the meeting with Mayor Flynn were Joseph Barnes of Charlestown, Assistant Commissioner of Parks and Recreation; Lucy Ferullo of the Mayor's Office of Neighborhood Services; Captain William McHugh and Chief Paul Cook of the Boston Fire Department; Assistant Director Ron Catena and Engineering Director John Sullivan, Jr. of the Boston Water and Sewer Commission; Dick Loring of the Traffic and Parking Department; and Charlestown residents Peter Golden of Monument Square, Bernard Evers of St. Martin Street, Martin Flynn of Lexington Street and Donna O'Brien of Monument Avenue.

Some of the concern on the part of Charlestown residents stemmed from problems the Boston Fire Department had with a faulty fire hydrant in the early morning hours of July 4th, when they responded to a nine alarm fire at Numbers 4-12 Sheafe Street that left 34 people homeless.

Mayor Flynn told those attending the meeting that he had spoken with Fire Commissioner Leo Stapleton about the hydrant on the day of the fire, and Fire Department and Water and Sewer Commission representatives confirmed that the hydrant was replaced the next day. The residents were told that there were no problems with water pressure, that the Water and Sewer Commission monitors the system continuously, and that Charlestown is in excellent shape as far as pressure and distribution is concerned.

At the meeting, the testing system for fire hydrants was explained. Every fall, each of the city's approximately 13,000 hydrants are check-

ed. Defective hydrants are noted on a bulletin board at Fire Headquarters and reported the next day in writing to the Water and Sewer Commission. The list of broken hydrants remains on the Fire Headquarter's bulletin board until the Commission repairs them, usually within two weeks. Priority is given to areas where more than one hydrant is reported broken. Additionally, when the Fire Department encounters broken hydrants at the site of fires, they are reported, repaired or replaced immediately by one of three crews of the Water and Sewer Commission.

The Fire Department announced that a pilot program was being conducted in South Boston, where markers were being placed on defective hydrants so that the Fire Department personnel would not waste time trying them in the event of a fire, and so that residents can notify the Water and Sewer Commission if they are not repaired quickly.

Another concern of residents dealt with how Fire Department vehicles could negotiate rush hour traffic, especially on the North Washington Street bridge, if an emergency occurred during these hours.

Fire Department officials first of all urged residents and other motorists to act responsibly and make way for emergency vehicles. They also pointed out that Boston belongs to the Metrofire Mutual Aid system with 27 other cities and towns, and that fire units can be dispatched over the Gilmore Bridge and from Somerville and Chelsea.

The traffic and the parking situation was brought up again, both in regard to safety and convenience. Residents were told of the progress being made to establish two resident parking programs in Charlestown, one large one in the City Square, Thompson Square and Monument areas, and another smaller one in the Little Neck neighborhood.

It was admitted that, due to the density of population in Charlestown, dealing with the number of the cars in the community was a difficult problem. Stricter enforcement of ticketing, especially at hydrants and near intersections, was promised, and residents were urged to make their feelings known to the Zoning Commission when new construction or major rehabilitation work was being done that might lead to increased numbers of cars in the neighborhood.

The Charlestown residents were assured that procedures were in place to deal with any emergency situation. The unfortunate incident of last Sunday morning was referred to, in which three Charlestown youths were accidentally exposed to chlorine fumes from a leaking tank at the Clougherty Pool on Bunker Hill Street. The youths were treated for minor respiratory problems at Massachusetts General Hospital, and serious injury was averted, due to the quick response of Fire Department personnel.

Mayor Flynn and the other members of the administration, said that they were glad for the opportunity to explain city policy to these Charlestown residents, thanked them for attending, and expressed the hope that such communication would continue.

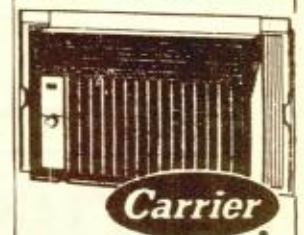

# Wall Street Site Of Six Alarm Fire — Seven Homes Destroyed

four others sleeping upstairs, while Boyden woke her sister who was sleeping downstairs.

"Jimmy Lynch is a complete hero," stated Boyden. "Without him we would never have gotten out. We would have all been dead."

Boyden said that her family escaped via the back entrance. "Thank God, we have a back way," stated Boyden. Her family ran along the alley way behind her home yelling, "Get out,

get out."

Lynch reported the fire department was at the scene within five minutes of his call. William Murphy, Acting Public Information Officer for the Boston Fire Department, stated this was a "quick" six alarm fire, with the first alarm pulled at 5:26 a.m. and the last at 6:04 a.m. The only problem experienced by the fire department, stated Murphy, was getting to the fire. Wall Street is a narrow side street off of Sullivan Street. The

corner of Wall and Sullivan is located on a steep down grade, not far from the Sullivan Street and Bunker Hill Street intersection.

The turn from Sullivan onto Wall Street is a difficult one at best for an average car, let alone fire apparatus. A telephone pole on the left hand side of Wall Street was knocked over by the fire apparatus.

"Consider it fortunate that no one was hurt," stated Murphy who commended the community, especially Lynch. "Charlestown is such a close knit community," stated Murphy, adding, "They are a fantastic group of people, an elite crew, and I'm glad to see people are watching out for each other."

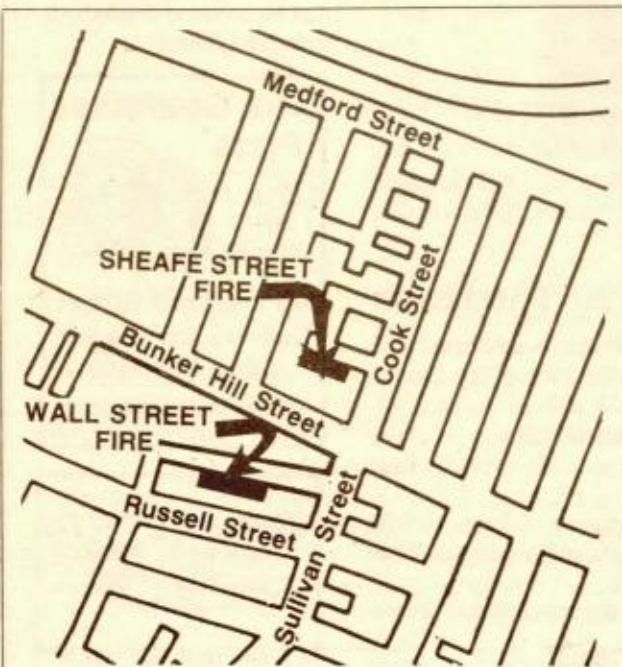
Lynch states he was on his way to work when he noticed the smoke. He continued, "My boss just changed my hours at work." Usually Lynch started work at 7:00 a.m., but his hours were just changed to start at 6:00 a.m. "It was a freak of nature," stated Lynch, "that I was even there."

While the cause of the fire is still under investigation by the Fire Department Arson Squad, many believe the fire was set. Lynch believes the blaze began shortly before

his arrival at the scene. Lynch stated if the fire had been a result of an act of arson, it was "senseless" and "pretty ignorant" since the buildings were "real homes with real people and with everything they owned in them."

Lynch left the scene shortly after the fire department arrived, stating he thought the fire had been contained to the Boyden's house.

While at work, Lynch tried to call his parents and when no one answered, he left work and arrived at Wall Street around nine o'clock. Lynch states he was shocked at what he discovered on returning to his parents' home. "When I ever turned the corner and saw the seven houses ..."

The only items salvaged by the Lynch family were three photo albums and a table, which Lynch says may be usable after it is cleaned and refinished.

The Boyden family lost

two dogs in the fire. Rita Boyden says that she will rebuild her home. "It was my mother's house. It's the only place we've ever really known," stated Boyden. Most of the victims have lived most, if not all, of their lives on Wall Street, according to Boyden. "Adding it all up, there's over one hundred years invested here."

Wall Street is located only two blocks away from Sheafe Street where 14 families lost their homes in a nine alarm blaze on July 4th.

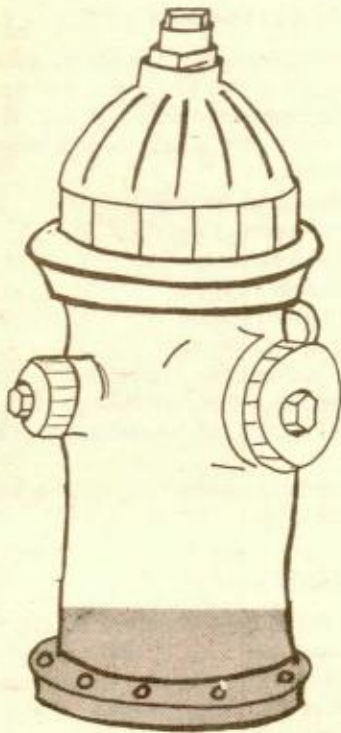

# What Can I Do To Help?

What can I do to help?

This question has been posed by many, many Charlestown residents since the nine alarm fire struck five homes on Sheafe Street on July 4th, followed by the six alarm fire on July 13th that destroyed seven homes on Wall Street.

In order to coordinate support services from the community to the victims of these two fires, a Charlestown Fire Fund Steering Committee has been established and this committee is meeting frequently to develop priorities and assess the immediate and long-term needs of the fire victims.

There are several areas in which residents, businesses and organizations may be of assistance.

### HOUSING

The most immediate need for the fire victims is housing. Many families are separated, with family members staying with various relatives and friends. Some are in temporary quarters and must find apartments. For homeowners, the housing would be on a temporary basis while their homes are being repaired. For tenants, housing might be permanent.

Every effort is being made to secure housing, whether it be through the Boston Housing Authority or through private individuals.

The committee is making a plea to local realtors, developers, and private homeowners to come forward with apartment units that may be available for rental to the fire victims who wish to stay in this community.

## "Operation Edith" — Exit Drill In The Home

The early morning fire on Sheafe Street, July 4, 1985 was a tragic event, but fortunately no human lives were lost. William Murphy of the Boston Fire Department stated these families were relatively lucky, but too many times, lives are lost when a fire occurs because individuals fear for the safety of others and endanger themselves.

The Fire Department has implemented "Operation Edith", which stands for "Exit Drill In The Home". Murphy states too many times people either re-enter a burning home or do not leave because they are looking for someone believed to be still within the home when, in fact, that person may be safe outside but in another location.

Murphy states families should have a plan which is in place, such as, "If this home is on fire, let's make a plan to get out of the house and meet at some specific spot like across the street, on Mrs. Jones' porch, etc."

"Operation Edith" can provide a family peace of mind in an otherwise stressful and chaotic time.

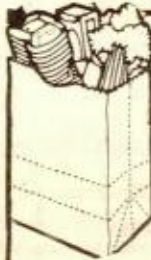

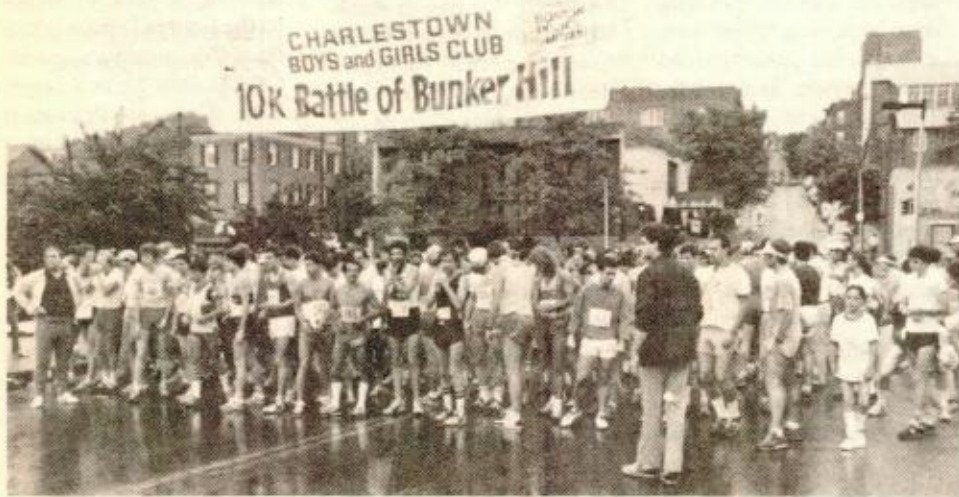

are reported to be "okay". Myers states none were seriously injured and were "checked out" at the hospital "just in case."

The Clougherty Pool, which was constructed in 1947, is in need of complete renovations stated Myers. Presently, the pool, which attracts roughly 300 residents daily, is chlorinated by means of an automated chlorine feed from chlorine tanks stored in the storage shed. This system has been outlawed by the state effective January 1986. Most pool systems are chlorinated by hand. Myers stated the automated system will no longer be utilized at the Charlestown pool and the pool will be chlorinated manually.

While Sunday's accident is the first of this nature at the pool, Myers stated, "I'm sure there were other accidents at other pools for the system to be outlawed."

According to Myers and Nancy Murphy, from the Charlestown Development Corporation who oversees the operations at the pool for the City of Boston, the system was "obsolete" and they felt uneasy utilizing the system.

E. & F. King & Co. of Norwood had delivered two tanks of chlorine two weeks ago. Murphy stated, "Last week we had decided that these were the last two tanks."

There were also three used chlorine tanks from last

summer remaining in the shed, but since the safety caps were missing from the tanks, the company is prohibited by law to remove or transport them.

The Boston Fire Department Arson Squad is investigating the accident, but Myers states, "No one is looking to place blame" since no one was seriously injured.

According to Myers, the accident could have been "disastrous" had the workers not opened the door to relieve the building gas pressure. The fumes would have otherwise been sent through the underground tunnel system and drains. The accident occurred at only one half hour before the pool was to be open to the public and, with predicted humidity and temperature in the high 80s, the normally popular pool would have been overrun with children and adults.

Myers stated the pool is "so old" that it truly is in need of a total facelift and

Myers has been fighting City Hall for the adequate funds. Up to now, Myers states repairs to the pool have been as effective as "placing a bandaid on a hemorrhage".

The relationship between Myers and the Parks and Recreation Department has not always been an easy one, as money became tight and the need for renovations became evident, but after a somewhat heated battle, Myers' efforts seem to have paid off and the relationship with City Hall has taken a reversal. "I'd like to thank Joe Barnes, Assistant to the Commissioner of Parks and Recreation, for all the time and energy he's given on our behalf," stated Myers during an interview one week prior to the accident, adding, "There's been wonderful cooperation from the city. They truly stood on their heels."

A proposal is presently before the George Robert White Fund Committee requesting approximately \$1

million for the needed repairs to the pool. Last year, a petition for the renovation was sent to City Councillor Robert Travaglini who researched available funding. The proposal, which was drafted by Nancy Murphy, calls for total renovation to the pool, diving tank, physical plant, locker rooms and plumbing network.

Mayor Raymond Flynn, who was at the pool the morning of the accident, told Myers he would pledge his support in the fight to renovate the pool. Flynn sits on the George Robert White Fund Committee along with City Auditor Leon Stamps, City Council President Joseph Tierney, President of the Greater Boston Chamber of Commerce James Sullivan and President of the Boston Bar Association William Looney, Jr.

The pool, which was closed Sunday and Monday, has reopened and will be open from 10:00 a.m. to dusk, seven days a week.

# Board Of Appeal Approves Variance Requests On Three Charlestown Properties

Three Charlestown development proposals received favorable approval from the City of Boston Board of Appeal (BOA) on Tuesday, July 16, 1985. None of the developments drew opposition from residents present.

The first appeal was made by the Sullivan Realty Trust in reference to 64 Sullivan Street, to change the legal occupancy from a three family dwelling into a four family. Despite a recommendation from the Boston Redevelopment Authority (BRA) Board that the BOA deny the proposal, the BOA voted favorably, since the change in occupancy did not require a structural change. The three level building will have one unit on the first floor and another on the second. The third unit will be built on the third floor and attic. The fourth unit will be tri-level in nature in the rear of the building with a separate entrance on Bartlett Street.

Allen Jarasitis, Attorney for the development team, which is comprised of Dan Silva and Quinton Mullin, stated he did not know the specifics behind the BRA Board vote for denial of the proposal, which was made on June 27, 1985. "I do know the BRA staff approved this," added Jarasitis, who also suggested the BRA Board may have felt this proposal would adversely impact the density of the immediate neighborhood. The attorney added that the building, which was a three family dwelling, housed a number of children including "four or five kids" in the owner occupied unit.

According to Jarasitis, the proposed change would not impact the density since three of the units would be

two bedroom apartments and the fourth will have one bedroom.

Another added attraction in this proposal, according to Jarasitis, is that the units would be priced reasonably as to encourage residents who may not be able to afford an apartment in Charlestown to remain in the town.

City Councillor Albert O'Neil stated he had no opposition to the proposal. The Board voted to allow the variance change.

The second appeal discussed at the hearing was that of Jack and Maryanne Taylor, in reference to a change in occupancy of 37 High Street from a one family into a two family dwelling. The building, which is four stories high and contains a basement is "too large for a one family," stated Attorney Jarasitis, who also represented the Taylors before the BOA. The building has been assessed by the City for tax purposes as a two family since there are two kitchens, but when the Taylors purchased the home in 1979 there was no legal occupancy.

Councillor O'Neil spoke in favor of the proposal, since he was familiar with the building having been a friend of the previous owner "for some 50 years or so."

The Board voted to grant the variance, allowing the change from a one to two family dwelling.

The final Charlestown appeal addressed at the hearing was a continuation of the June 25th appeal of proposal by Graham Gund Associates to convert the former Charlestown High School on Monument Square into 44 apartments with 40 parking spaces; 23 spaces under-

ground and 17 spaces of ancillary parking. At the last meeting before the Board, the Graham Gund Associates did not have answers to two questions posed by Board members. The BOA, at the June 25th hearing, was asked to settle a community debate over the placement of the underground parking egress. After weighing the pros and cons between a Monument Square entrance or a Bartlett Street entrance, the Board voted in favor of the Bartlett Street egress. This vote did not, however, affect the application of the variances requested.

The Graham Gund Associates may, in the future, seek a parking to unit ratio variance, since the location of the egress may require the taking of one space. Peter Matson from the development team stated that as a result of several community meetings, the development team agreed to close one of the two entrances proposed for the ancillary parking lot on the site of the former Spencer Annex, which will also reduce the number of spaces by one. Matson stated the need for these variances is not definite, since the development team is trying to redesign the parking spaces.

At Tuesday's meeting, the Graham Gund Associates addressed the two questions asked by the BOA at the June 25th meeting. The first question dealt with the asbestos removal procedure, which had in the past been twice stopped - once for failing to give adequate notification and, then again because state authorities believed the work was not being done properly. Since the last stop order, the development team has hired a new subcontractor to remove the asbestos, a procedure that is being closely monitored by the Massachu-

setts Department of Environmental Quality Engineering (DEQE). Harry Stoddard, attorney for the development team, told the Board that the asbestos removal was "on schedule" and the results from tests of an air quality meet Environmental Protection Agency (EPA) standards.

The second question raised by the Board on June 25th, dealt with the payment of prevailing union wages to laborers hired by the development team. Stoddard stated the development team has written into their contract with the contractor a clause stating laborers will be paid at the prevailing wage rate and that Boston residents, minorities and women will be given hiring preference.

Richard Dennis, acting Chairman of the Board, stated since the Board had settled the community debate over the placement of the parking garage egress, the Board could vote on the petition by the Graham Gund Associates with the inclusion of the two requested provisos, namely that the asbestos removal was in accordance with EPA and DEQE standards and the laborers be paid the prevailing wages.

Past BOA hearings, at which the Graham Gund Associates have requested variances for this development have attracted many Charlestown residents.

Board member Chia-Ming Sze stated he saw no reason to deny Graham Gund Associates further "since half of Charlestown is not here."

The Board then voted to allow Graham Gund Associates to renovate the former high school into 44 apartment units.

### APPLICATIONS FOR BHA SECTION 8 RENTAL ASSISTANCE

The Boston Housing Authority will be taking applications for the Section 8 Certificate and Voucher Demonstration Programs from Monday, July 29 through Wednesday, July 31, from 9:00 a.m. to 7:00 p.m. at the Plaza Castle which is located at the corner of Arlington Street and Columbus Avenue, diagonally across from the Park Plaza Hotel. The Arlington Street MBTA station on the Green Line is the closest MBTA stop.

Both programs provide rental assistance for low income families, the elderly (age 62 or older) and the handicapped in privately owned housing. (Single people with no dependents who are not elderly, disabled or handicapped are not eligible.) ## Representative Voke Announces Fire Fighter Exam

Representative Richard A. Voke has announced that examination applications are now being accepted for the Municipal Fire Fighter Test that will be held on September 14, 1985. According to Representative Voke, this examination is held to establish eligible lists for Fire Fighter and for Call Fire Fighter for all cities and towns in which either or both of these positions is classified under Civil Service.

While no formal educational qualifications are necessary, a number of requirements do exist for potential candidates. Applicants must be at least 19 years old and not yet 32 years old at the time of the late date for filing applications, which is August 16, 1985. Applicants who pass the written test will

be required to pass a physical strength and agility test. In addition, applicants selected for appointment will be required to pass a medical examination, which could include psychological evaluation. Possession of a valid Massachusetts motor vehicle license may be required, and a candidate may be disqualified for character unsuited for fire fighting service, following a hearing by the Personnel Administrator.

The written examination consists of multiple choice questions which test for abilities required for success as a fire fighter. Questions will test abilities such as reasoning, reading comprehension, understanding tables, mechanical and spatial ability. According to Representative Voke, for a

more detailed description of the examination, all applicants can refer to the "Entry Level Fire Fighter Examination Orientation Booklet" which may be obtained at the Information Center, located on the second floor of One Ashburton Place, in Boston.

Representative Voke noted that preference is available in three categories: Disabled and Regular Veterans; Special, in case of the applicant being the son or daughter of a fire fighter of police officer who was killed or died of injuries received in the performance of duty; and Residency, for municipalities that have requested that residents be given a preference over non-residents.

Application cards may be obtained and filed at the Department of Personnel Administration, One Ashburton Place-Second Floor, Boston. There is a \$10.00 examination fee required at the time of application submission.

## World War II Paintings At The Charlestown Navy Yard

Boston National Historical Park has an exciting new exhibit of original paintings and drawings of life aboard a destroyer during World War II in the Pacific. Entitled "Sailor's Diary, Aboard the USS LAVALLETTE, 1943-1945", the exhibit contains fifty-six drawings by George Eisenberg. "Sailor's Diary" is free and open from 9 a.m. to 5 p.m. every day until October 20, 1985.

The drawings, some done under actual combat conditions, are accompanied by Eisenberg's personal recollections of the events and people dramatically depicted in each drawing. South Seas artifacts collected by Eisenberg during the war and pages from his diary are also displayed with the drawings.

George Eisenberg is a professional artist living in Marblehead. He grew up locally in Nahant and attended the Massachusetts School of Art and Boston University. After the Japanese attack on Pearl Harbor, he enlisted in the Navy, serving the next four years as a radarman on the USS LAVALLETTE where he captured the war through his sketching. Following V-J Day he became a freelance illustrator. Eisenberg's work has traveled to many parts of the country and has won numerous awards.

The exhibit is particularly appropriate to the Charlestown Navy Yard, where hundreds of destroyers similar to the LAVALLETTE were built or repaired during the war and later years. The USS CASSIN YOUNG, a sister ship to the LAVALLETTE, is on permanent exhibit at the Navy Yard. Together the CASSIN YOUNG and the exhibit of Eisen-

# Charlestown Police Line

On July 5, 1985 at 1:00 a.m., a man walked into Area A, and reported that while at Sheafe Street, he was assaulted and beaten about the head and shoulders with a baseball bat by a male suspect. This suspect was later identified and placed under arrest at the scene of the incident. The suspect was taken to Area A and booked for assault and battery with a dangerous weapon.

\*\*\*\*

On July 5, 1985 at 4:50 p.m., police officers responded to Walford Way on a radio call. On arrival, the officers spoke to a woman who stated that a male suspect had violated a restraining order issued at Charlestown District Court. The suspect, still on the premises, was placed under arrest, and taken to Area A. He was identified as a 34 year old Charlestown resident.

\*\*\*\*

On July 5, 1985 at 8:15 p.m., police officers, while on routine patrol at Cook and Medford Streets, observed a man leaning into the driver's window of a motor vehicle. The officers observed this suspect pass something to the operator, who in turn, passed it to the occupant of the passenger seat. The officers approached the vehicle, asking the occupants to alight. After searching the vehicle, the officers found three packets of white powder believed to be cocaine. All three suspects were placed under arrest, and taken to Area A. The first suspect, a 20 year old Charlestown resident, was booked for possession of a Class B substance with intent to distribute. The other suspects, both of Arlington, were booked for possession of a Class B substance.

\*\*\*\*

On July 6, 1985 a police officer responded to a radio call relative to a vandalism report at Main Street. On arrival, the office spoke to the owner of a business who stated that she closed her shop at 9:00 p.m. and upon returning at 9:00 a.m., found the front pane of glass shattered, and an inside shutter broken by person(s) unknown. These unknown suspects had apparently been attempting to gain entry, but were unsuccessful in the attempt.

On July 7, 1985, a woman reported that while her motor vehicle was parked on Warren Street, person(s) unknown broke the passenger window and entered the vehicle. The suspect removed an AM-FM cassette stereo and damaged the dashboard.

\*\*\*\*

On July 8, 1985, a police officer responded to a radio call for a break at 56 Roland Street on arrival, the officer spoke to a woman who stated that on July 7, 1985, unknown person(s) came through a temporary wall, where construction is being done, and entered the third floor offices. These suspects damaged filing cabinets, and removed a computer and U.S. currency, among other items. This incident is currently under investigation by detectives of Area A.

On July 8, 1985 at 10:00 a.m., detectives arrested a 46 year old Beverly man on a warrant for assault and battery with a dangerous weapon and unarmed robbery. This arrest took place at City Square.

On July 13, 1985, the Boston Police Department sponsored a Community Field Day at the Bunker Hill Mall which was attended by several hundred Charlestown residents. Those attending enjoyed pony and motorcycle rides, a K-9 dog show, refreshments, and a close-up inspection of a Police Mobile Center and a Health and Hospitals Ambulance. Police officers and emergency medical technicians were also on hand to talk to residents and answer questions. This is a yearly event and has been quite a success. We look forward to seeing you next year.
