Deloitte has failed to disclose its association with Silverglades, an Indian real estate firm, which has been found to be the primary beneficiary of the fraud done by the executive management of IL&FS

How did you become aware of this concern

Details

Silverglades is a real estate firm based in India. It and its subsidiaries (e.g. Emerald Lands (India) Private Limited) have been found to be the main beneficiaries of the fraud done by Mr. Ramesh Bawa, ex-CEO of IL&FS. This can ascertained from the forensic audit done by Grant Thorton and the subsequent affidavits filed by IL&FS in connection with the ongoing investigations.

Silverglades is a client of Ms. Parul Jain, who is a partner in the Tax practice of Deloitte India (Gurgaon office). This fact can be ascertained from the attached document which is a communication from Ms. Parul Jain to Silverglades regarding set up of off shore structures in Cyprus for the entity which received funds from IL&FS. This document is part of documents that Ms. Parul Jain and Ms. Shefali Goradia (Partner Mumbai office) had stolen to poach clients from a law firm. This matter was reported vide report no. 331037840902 on this portal, and the documents were provided by a witness, but Deloitte did not take any action to the best of my knowledge.

NFRA has been investigating Deloitte's role as an auditor in the IL&FS scam, and the associated conflict of interest / independence issues as Deloitte has been providing other consulting services to IL&FS in addition to audit services. Deloitte should have disclosed its relationship with clients such as Silverglades and others who have been beneficiaries of the irregularities done by the IL&FS executive management that the auditors overlooked. To the best of my knowledge, Deloitte has not fully disclosed its relationship with such entities that are beneficiaries of the IL&FS scam.

On further investigation I have found documents (uploaded separately) pertaining to IND-BARATH POWER INFRA LIMITED etc. in documents that Ms. Parul Jain and Ms. Shefali Goradia had stolen to poach clients from a law firm. IND-BARATH POWER INFRA LIMITED also appears as the beneficiary of the IL&FS scam as per the forensic audit done by Grant Thorton. Furthermore, these documents show that investment funds Bessemer, Sequoia and UTI (now Ascent) are primary investors in IND-BARATH POWER INFRA LIMITED. All these funds have been clients of Ms. Parul Jain and Ms. Shefali Goradia (as per the stolen documents) and are also presently their clients. The uploaded documents also show that IND-BARATH POWER INFRA LIMITED is (or has been) a client of Ms. Parul Jain and Ms. Shefali Goradia.

Therefore this is another case of conflict of interest that Deloitte failed to report to the regulators.
