Major Types of Citation Styles - Brief Overview

Almost every student and researcher has to conduct research and write many research papers and essays at a university level. While an essay may have more leeway, writing a research paper requires a thorough understanding of specific citation styles. A research paper can be written in different citation styles such as MLA, ASA, AMA, Chicago, Harvard, APA, etc. Writing a research paper is tricky in the first place. Writing it in a specific citation style becomes more challenging at times, so students take help from a **paper writing service**. In this post, you'll get a brief overview of the major citation styles. There are many <u>cheap paper writing service</u> are available on internet.

Any citation style is a patterned set of rules about citing sources or references in academic writing. Every time we use or allude to someone's work, we must give a citation to avoid plagiarism. All the citation styles have specific formats for writing or structuring a research paper and adding references - in-text citations, footnotes, endnotes, and bibliography. Some of the most commonly used citation styles include:

- APA style in psychology or education.
- MLA style in humanities.
- Chicago author-date in sciences and notes & bibliography in history.

Every essay writer uses any one of these or some other citation style to cite sources in their papers. Before explaining the details that involve differences, it should be noted that all these formats use double spacing, one-inch margins on all sides, a 12-point legible font such as Times New Roman, indented the first line of each new paragraph, page numbering, and normally one space after punctuation marks. Their specifics are given below.



APA

It was developed by American Psychological Association. Originally, it was used in psychology as well as sciences. But today, a lot of disciplines use it. Some of its common features are:

- Includes a separate title page. You can also take help from the essay writer service.
- The title page contains the research paper's title, name of the writer, institutional affiliation, course title with a code number, instructor's name, submission date, page number, and running head in the header.
- 'Running Head' is the shortened title written in the upper left-hand corner in the header section. The right-hand corner includes the page number.
- After the title, the page contains the page number. The title of the research paper should be boldfaced and centered on the top. The introduction starts with the first line indented below the title.
- It provides the use of up to five levels of headings and subheadings.
- It uses in-text citations in the text with the name of the author and year of publication.
- It uses a 'References' list at the end for all the sources used in fuller detail.

MLA

It was created by the Modern Language Association. It is commonly used in literary studies and languages. Some of its common features are:

- The first page includes the name of the writer, the name of the professor, the course code, and the date written and aligned towards the left. It doesn't require a separate cover page unless specifically asked. In that case, the cover pages will include all this aforementioned information.
- The title is aligned in the center, written after the submission date.
- The introduction starts below the title with the indented first line.
- The header includes the last name of the writer with page numbering aligned towards the right.
- It uses in-text citations containing the name of the author and page number(s).
- It includes works cited page where all the references used in the paper are included. If you hate it, put an expert writer on it. Say <u>write my paper</u>.

Chicago

It was published by The Chicago Manual of Style involving two versions, i.e., Chicago author-date - parenthetical citation in the text with a bibliography of all references at the end, and Chicago notes-bibliography - citing in footnotes in the document with a bibliography of all references at the end. Some commonly accepted formatting measures of Chicago style used by any essay writing service, researcher, instructor, or institute are as follows:

- A separate title page includes the title of the research paper (in upper case letters), name of the writer, name of the teacher, course, and code, and submission date.
- The page number is given at the top right corner of each page, along with the writer's last name.
- The page after the title page directly starts with the introduction with the indented first line.
- The author-date version uses in-text citations during the text with the name of the author and page
- Notes-bibliography version includes footnotes at the bottom of each page.
- All the references are given in the Bibliography at the end.

These were some of the major citation styles of writing a research paper used in different fields. However, many students and even some researchers find it tricky to format the paper themselves. When I was made to write my essay for the first time, I did not know what I should do as it was challenging for me. So,
