5 The Court has reviewed Plaintiff's Complaint, Application for Temporary  
6 Restraining Order and Order to Show Cause Re: Preliminary Injunction, the Supporting  
7 Declarations, Plaintiff's Supporting Memorandum of Points and Authorities and heard  
8 arguments of the Parties.

9 The Court finds that Plaintiffs are likely to prevail on the merits of this case and  
10 unless a Temporary Restraining Order granting appropriate relief is issued immediately  
11 before the matter can be heard on notice, irreparable injury would result to the interests of  
12 the Plaintiff, International Center for Integrative Medicine. Defendants threaten to engage  
13 in actions that appear to violate multiple provisions of California law and that threaten  
14 great and irreparable harm to the Plaintiff and the public. Given the nature of the harm  
15 pecuniary compensation would not afford adequate relief. Good cause appearing,

16 **IT IS HEREBY ORDERED**, that ~~for \_\_\_\_\_ ( ) days from the entry of~~  
17 ~~this Order,~~ or until this Court rules on Plaintiff's pending Application Re: Preliminary  
18 Injunction, whichever occurs first, the named individual defendants, as well as, the  
19 organizational entities and their officers, directors, principals, agents, servants, employees,  
20 attorneys, successors and assigns, representatives and all persons acting in concert or  
21 participation with them, are HEREBY RESTRAINED AND ENJOINED from the  
22 following:

- 23 1. Any insertion of acupuncture needles, including but not limited to the  
24 Myotech Dry Needle, into humans that is not performed either by a medical  
25 doctor or acupuncturist licensed under California law as required in the  
Medical Practice Act, Bus. & Prof. Code, § 2052(a); 2061, and the  
Acupuncture Licensing Act, Bus. & Prof. Code, § 4927(d); 4935.
2. Any delivery, distribution, conveyance, sales (including on-line sales),  
offering of samples, mailing or other furnishing by any means of  
acupuncture needles, including but not limited to the Myotech Dry Needle  
within the State of California. This injunction includes but is not limited to

1 an injunction on the delivery of acupuncture needles to the site of the 2016  
2 CSM conference at the Anaheim Convention Center ("Conference Site");

3 3. To the extent any acupuncture needles, including the Myotech Dry  
4 Needle, have already been delivered to the Conference Site Defendants  
5 shall immediately remove such needles from that Site.


6 **IT IS FURTHER ORDERED** that the named defendants, appear at Orange  
7 County Superior Court, Central Justice Center, (700 Civic Center Drive West Santa Ana,  
8 CA 92701) Civil Dept. ~~C-03~~ <sup>C31</sup> on 3/16/ <sup>1:30 PM</sup>, 2016 at or as soon thereafter as the  
9 matter may be heard, to show cause, if any they have, why the injunction and restraints  
10 sought in Plaintiff's proposed preliminary injunction should not be entered against  
11 defendants, their principals, agents, servants, employees, attorneys, successors and  
12 assigns, representatives and all persons acting in concert or participation with them, during  
13 the pendency of this action, together with any other injunctive relief as appropriate.

14 **IT IS FURTHER ORDERED** that a copy of this Order, Plaintiff's Application  
15 for Temporary Restraining Order and Order to Show Cause, and all supporting papers, be  
16 served upon defendants not later than fourth week, 2016. All defendants who reside  
17 in the United States, and as to whom Plaintiff has identified a street address or post office  
18 box, are to be served by return-receipt mail via the United States mail. Additionally, all  
19 defendants who reside outside of the United States shall be served under procedures  
20 applicable to such service. Plaintiff will also effect service of the above-mentioned papers  
21 on all defendants by sending the papers via e-mail to their web site addresses..

22 **IT IS FURTHER ORDERED** that defendants serve by (i) personal delivery upon  
23 or transmittal by mail, facsimile or electronic means if agreed to by the parties, to Craig A.
