The Right to Reproductive Freedom with Protections for Health and Safety

SUMMARY

The Amendment would amend Article I of the Ohio Constitution by adding Section 22, titled "The Right to Reproductive Freedom with Protections for Health and Safety."

The Amendment provides that:

Dealing with Sex or Sex Organs

"Not limited to" means anything beyond the text dealing with sex or sex organs

"Least restrictive" Legally means if the state can do

Every individual has a right to make and carry out one's own reproductive decisions, including but not limited to decisions on contraception, fertility treatment, continuing one's own pregnancy, miscarriage care, and abortion. All restriction is on the state

The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against either an individual's voluntary exercise of this right or a person or entity that assists an individual exercising this right, unless the State demonstrates that it is using the least restrictive means to advance the individual's health in accordance with widely accepted and evidence-based standards of care.

However, abortion may be prohibited after fetal viability. But in no case may such an abortion

be prohibited if in the professional judgment of the pregnant patient's treating physician it is Legally means "Emotional Health" "Mental Health"

necessary to protect the pregnant patient's life or <u>health</u>. As used in this Section, "Fetal viability" means "the point in a pregnancy when, in the

professional judgment of the pregnant patient's treating physician, the fetus has a significant likelihood of survival outside the uterus with reasonable measures. This is determined on a caseby-case basis"; and "State" includes any governmental entity and political subdivision.

This Section is self-executing.

"Political subdivision' means anyone the state delegates it's authority to: including all cities, counties, municipalities, state-run healthcare, & education.

HOW THIS WILL LEGALIZE PROSTITUTION:

So if a woman claims, "It is my reproductive decision to have sex and get paid for it." The state can not make any law against it. "The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against" this newfound "right."

HOW THIS WILL LEGALIZE PEDOPHILIA:

If an adult can convince a child, it is his or her reproductive decision to have sex with him, and can convince the child to say it is his or her "own reproductive choice" then the state can not make any law against that.
