**Minutes.** The council approved the minutes of November 22, 2000.

**MEC00-703 Mission President Status Sheet.** The status sheet was reviewed and approved to be forwarded to the First Presidency and Twelve as an information item.

**MEC00-704 Mission President Candidates Unable to Serve at This Time.** A report was reviewed and approved to be forwarded to the First Presidency and Twelve as an information item.

**MEC00-705 Setting Apart MTC Presidents and Visitors' Center Directors.** Elders Wirthlin and Holland selected MTC presidents and visitors' center directors they would like to set apart.

**MEC00-706 Mission Presidents for Exploratory Interview.** Information on 12 candidates recommended for exploratory interview was approved to be forwarded to the First Presidency and Twelve: Scott Wallace Cameron, Federico Fabian Costales Jr., David William Eka, Max A. Jensen, Del R. Jones, Leroy Michael Kaleihoku Keone, Larry Ray Lawrence, James C. Mooring, Rikuo Touma, David Allred Whetten, Robert Bruce White, and George Allen Young.

**MEC00-707 Mission Presidents for Call.** Information on ten interviewed candidates recommended for call by the First Presidency was approved to be forwarded to the First Presidency and Twelve: Curtis Robert Bennett, Raymon Botterell, Glenn A. Hansen, Gary LeRoy Poll, Albert Roy, Jimmie A. Sanders, Gerrit Mark Steenblik, Stephen Mark Studdert, Wesley Miller White, and Marion Darryl Woods.

**MEC00-708 Family History Training at the Provo MTC.** A memorandum was approved to the Temple and Family History Executive Council concerning no longer providing family history training at the Provo MTC. There was also considerable discussion of a concerted family history initiative in the California Sacramento Mission, a lack of convert baptisms attributable to family history efforts, family history as a missionary tool, and the use of family history to get people to turn to members rather than missionaries.

**MEC00-709 Missionary Transgressions.** There was considerable discussion of how to encourage missionaries to be obedient, the desirability of sending a problem missionary home rather than having him influence many other missionaries, and having stake presidents take a sense of responsibility for sending out missionaries who have problems.

**MEC00-710 Number of Missionaries.** The weekly chart, showing 60,379 missionaries currently serving, was reviewed. The decline in elders being called should begin to become evident during the coming year. There was also some discussion of the recruitment of missionary couples.

**MEC00-711 Key Missionary Cases.** Letters should be prepared to two former missionaries, Orin A. Voorheis and David Evan Pruner, who have lingering health challenges. Elder Dickson will visit Elder Voorheis at his home in Pleasant Grove.

**MEC00-712 New Move-Ins.** Elder Tingey shared an idea, mentioned by a brother who contributed \$50,000 to the General Missionary Fund, about having missionaries help people move into new homes. Elder Tingey will recommend an in-house task committee that might look at possible initiatives with new move-ins.

**MEC00-713 Digital Presence of the Church.** Elder L. Tom Perry and Brothers Franklin Lewis and Paul Hansen from M-Star met with the council to present information about the Church's use of the Internet and obtaining approvals to place web sites on the Internet.

**Minutes:** The council approved the minutes of its meeting held on Wednesday, 29 November 2000.

**PEC00-242 Preparing Young Men for Missions.** The council postponed consideration of this item.

**PEC00-243 Internet Guidelines for the Priesthood Executive Council.** Elder Jensen and Brother Lifferth reviewed proposed guidelines for the council to use in recommending materials to be posted to the Church Internet site, lds.org, and reviewed a sample of such materials for the Young Women. The council cleared the guidelines to go to Correlation Evaluation. As an information item, Brother Knighton reviewed the status and needed actions to complete posting the scriptures, Church curriculum, and Church magazines to the Church Internet site as directed by the First Presidency, particularly in non-English languages.

**PEC00-244 Addition to the Temple Recommend Questions.** Elder Jensen reviewed a proposed addition to the recommend questions to help priesthood leaders identify and help members who are struggling with pornography. The Priesthood Department will redraft the proposal and bring it back to the council.

**PEC00-245 2001 Young Women General Meeting.** Elder Jensen reviewed a Young Women request to change the opening hymn of the previously approved program from "Oh May My Soul Commune with Thee" to "I Know That My Redeemer Lives." The council approved the request. He reviewed also the proposed General Authorities who will participate in the meeting. The council cleared the proposal to go to the 14 December 2000 temple meeting. Elder Ballard will present it.



**PEC00-246 Letter Announcing the Videotape for Parents and Youth.** Elder Jensen reviewed the proposed Quorum of the Twelve letter. With revisions, the council cleared the letter to go to the Communications Correlation Committee. **Minutes.** The council approved the minutes of December 20, 2000.

**MEC01-001 Mission President Status Sheet.** The status sheet was reviewed.

**MEC01-002 Mission Presidents for Call.** Information on two interviewed candidates recommended for call by the First Presidency was approved to be forwarded next week to the First Presidency and Twelve: Roger Paul Christensen and William Blood Mansell.

**MEC01-003 Suits for Missionaries from the Dominican Republic.** The council concurred in a recommendation from the North America Southeast Area Presidency that elders called from the Dominican Republic to serve in the Dominican Republic not be required to purchase a suit. No action will be taken, however, until after the Missionary Department studies other similar situations where native missionaries serve in areas where suits are rarely or never worn.

**MEC01-004 Water Purification Units for the Philippines.** A request from the Philippines Area Presidency, endorsed by Elder Richard G. Scott, for water filters for missionary quarters in the Philippines was approved.

**MEC01-005 Pre-Mission Training for New Mission Presidents.** A copy of the orientation videotape and the other training materials being sent to newly called mission presidents should be provided to each Area Presidency.

**MEC01-006 Quorum of Twelve Letters for the Call Packet.** Proposed letters for couples who do not serve in regular missionary assignments were taken for further review and will be discussed again next week.

**MEC01-007 Reimbursement of Expenses for MTC Presidents.** A request from James R. Palmer in the Brazil MTC to be reimbursed for various expenses was considered. Approval was given to reimburse him for medical insurance costs since May 2000 according to the policy approved by the First Presidency and Twelve on May 25, 2000. A general recommendation to provide MTC presidents and visitors' center directors with the same benefits as mission presidents was not approved.

**MEC01-008 Task Committee Status.** Elder Tingey reviewed the status of the various task committee initiatives.

**MEC01-009 Operating and Project Budgets for 2001.** The First Presidency's notification that the Missionary Department budgets were approved by the Council on the Disposition of the Tithes was noted as an information item.

**MEC01-010 Temple Square Timeline.** A revised schedule, showing the closure and reopening of the visitors' centers on Temple Square, was noted as an information item. Elder Oaks will circulate this to the First Presidency and Twelve for their information.

**MEC01-011 Church Registration in Kazakstan.** A report that the Church has been officially registered in Kazakstan was noted as an information item.

**MEC01-012 Media Bible.** Copies of the new edition of the Bible published by the Church as a media response item were distributed. If the Bible is reprinted, it should use the same binding currently used for the Spanish Book of Mormon.

**MEC01-013 New Testament Murals on Temple Square.** A report that the murals had been vandalized by someone running a razor blade across them was noted as an information item. The murals will be repaired as a part of the renovation of the center.

**MEC01-014 Number of Missionaries.** It was noted that 60,419 missionaries were serving as of December 29. The issue of confirmations not being performed or reported was also discussed.

**MEC01-015 Missionary Arrivals and Departures.** A revised letter was reviewed and with one addition will be considered again next week.



**MEC01-016 Stake Mission Task Committee.** It was noted that the issue of name tags for stake missionaries needs to be addressed if stake missions are not discontinued. This item should be reported to Elder F. Melvin Hammond.

**MEC01-017 How We Refer to the Church and Its Members.** Brother Allen will meet with Bruce Olson to draft a joint recommendation that can come forward through the Public Affairs Committee and the Missionary Executive Council to the First Presidency and Twelve.

**MEC01-018 Preparation of Missionaries.** Elder Oaks reported that Elder M. Russell Ballard is pursuing this matter through Priesthood Executive Council channels. Peter B. Rawlins is the Missionary Department's staff contact in this effort.

**MEC01-019 Reassignment of Missionaries.** Elder Wirthlin mentioned that reports show that most reassigned missionaries complete successful missions.

**MEC01-020 Unrest in Haiti.** Elder Wirthlin reported that the mission president appears to be on top of the situation in Haiti.

**MEC01-021 Information Sheet.** Brother Cleverly highlighted the differences between the Information Sheet and the Church-Service Candidate form. Elders Oaks and Wirthlin will follow through.

# REFERENCES TO THE CHURCH AND ITS MEMBERS

January 12, 2001

This document is a synthesis of discussions and recommendations of the Public Affairs Committee and the Missionary Executive Council. It is submitted to the Quorum of the Twelve and the First Presidency as an aid to their discussions. We request their direction on these subjects. (DHO)

## 1. References to the Church

- A. The official name of the Church (D&C 115:4) should always be used by the Church and its members, and we should urge the media to use this official name in their reporting.
  - An example of implementation with the media would be to include this statement on Church news releases: The Church of Jesus Christ of Latter-day Saints is the official name of the Church whose members are sometimes referred to by others as "Mormons." While the Church does not shorten its official name, the contractions "the Church" or "the Church of Jesus Christ" are acceptable in news stories when required by space limitations.
  - An example of implementation with a Church-sponsored media ad would be: "You might know us as the Mormons, but chances are you don't really know us at all. We are your friends [or neighbors], The Church of Jesus Christ of Latter-day Saints."
- B. The Church should never use "Mormon Church" and should strongly discourage the use of this term by the media and others.
- C. "LDS Church" or "LDS" should not be used in Church news releases and other communications to refer to the Church. ("LDS"



tends to shift the focus from "The Church of Jesus Christ" to "The Church of the Latter-day Saints.")

- D. LDS.Org is the official website address of the Church. Should that be changed to "The Church of Jesus Christ" with appropriate cross-references from "LDS.Org," "Mormon.Com," etc."

## **2. References to Members of the Church**

- A. The Church prefers that its members be referred to as "members of The Church of Jesus Christ of Latter-day Saints."
- B. If a shortened reference to members is needed in news reporting, "Latter-day Saints" is preferred (e.g., D&C 121:33, 128:24, 135:3), but "Mormons" is acceptable. ("Mormons" is a nickname others affixed to early members because of their belief in the *Book of Mormon*, which is named for its editor, a valiant ancient prophet.)

## **3. Other References related to the Church and its members**

- A. The use of the term "Mormon" is acceptable:
- when used in official names such as the "Book of Mormon" or the "Mormon Trail."
  - when used as an adjective in such expressions as "Mormon pioneers."
- B. The term "Mormonism" is acceptable in describing the effect of doctrine, culture and lifestyle (e.g., D&C 135:7).
- C. The term "Mormon fundamentalist" is specifically discouraged

because it implies a connection with the Church by third parties who have no such affiliation and who espouse beliefs and engage in practices like polygamy that are forbidden by Church doctrine.
