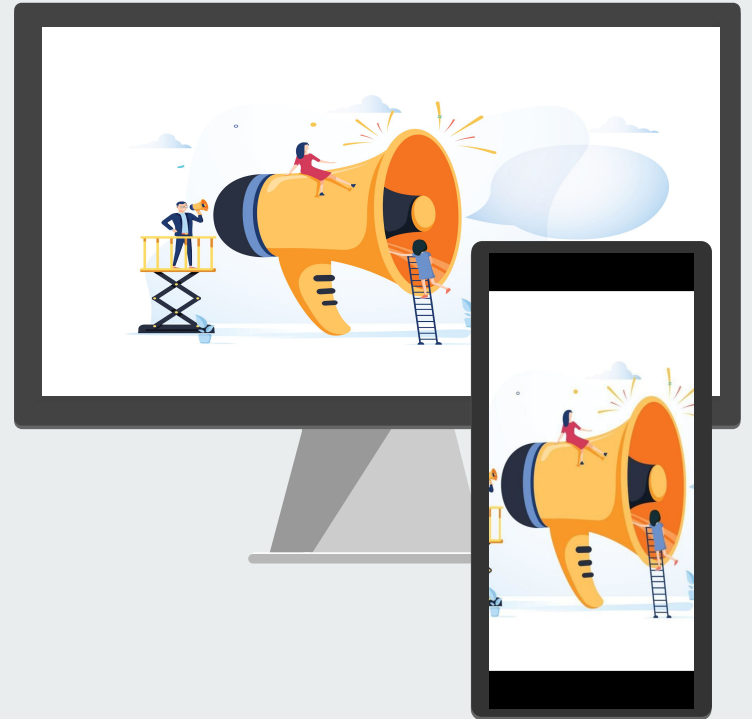
# Why Become a GEM.Crypto User?
