Residents Bring Questions And Concerns To CHAD-Sponsored Community Meeting

Peter Looney, Charlestown Against Drugs (CHAD) chairperson, opened the March 30 community-wide forum at the Knights of Columbus Hall for nearly 150 residents to discuss Charlestown's issues with alcohol and other drugs, overdoses, violence and murders. The meeting was a collaborative effort between CHAD and other organizations, including the Charlestown District Court, Charlestown Pop Warner, St. Catherine's CYO, the Bunker Hill Associates and the Healthy Charlestown Coalition.

"We've all sat in the coffee shops and talked about it," said Looney, "we've talked about it in the bars, and we've talked about it in Johnnie's. Now let's talk about it as a community."

Widely attended by residents with a range of concerns, Boston Police Department representatives and neighborhood organization leaders, the

two-hour meeting was at times emotional, tense and an example of basic community problem-solving at work. The public forum was an effort to steer clear of blaming the police and courts for not eliminating the effects of increasing substance abuse and violence in the neighborhood.

"Let's not pass the buck here," Looney said. "Let's talk about what we, as a community, can do."

Several residents spoke

openly about their personal battle with addiction, suggesting support for a sober house and sober clubs in Charlestown. A sober house, which would take at least two years to establish, would provide supportive drug-free living for people who have a certain length of sobriety, such as six months. Sober clubs provide a social alternative for people in recovery so that they have an open drug-free environment.

Father Ron Coyne of St. Catherine's said he supports such efforts to provide sober living and recreational places for those in Charlestown working on their recovery. He spoke specifically about young people who leave town for rehabilitation settings, are returned home and have little to no support for continued recovery because they go back to the very same place of their addictions.

Annual Firefighter's Communion Breakfast



Basic Services Committee Meeting

Chairman Bill Galvin has announced that the Basic Services Committee will meet at 7 p.m. on Monday, April 10 in the Hull Room, Building 5, in the Charlestown Navy Yard.

The meeting will focus on the petition of Angelo and Sippio Trodella who will go before the city of Boston Licensing Board on Wednesday, April 12 seeking to obtain a 7-day malt and wine license for their new Italian restaurant, Cafe Luna, which will be located at the site of Blossom's restaurant in the Charlestown Navy Yard.

Angelo explained at Tuesday night's CNC meeting that they are planning to operate a full-service restaurant with luncheon and dinner six days a week. Food would be served from 11 a.m. to 10 p.m. weekdays and to 11 p.m. on weekends.

Galvin said that a vote of the CNC Executive Board will be taken on April 11 and the results forwarded to the Licensing Board prior to the hearing.

Public Safety/Boston Police Community Relations Meeting

The monthly meeting of the Public Safety/Boston Police Community Relations Committee will be held on Tuesday, April 11 at 7 p.m. at the American Legion Hall, 23 Adams St.

The community service officer from Area A of the Boston Police Department will be joined by a representative of the Municipal Police to discuss concerns that have been brought up on drinking and vandalism on the grounds of public buildings, particularly the Edwards Middle School.

Also on the agenda will be the petition from Warren and Pleasant streets and Monument Avenue residents relative to a petition presented at the March Public Safety meet-

ing asking for support for the installation of a stop sign on Warren at Monument. Safety issues, particularly with the speeding vehicles on Warren Street, have brought this problem to the forefront.

At that meeting, John Keough of the Boston Traffic Department told residents that a stop sign is installed to control traffic, not to control speed, adding that speed is an enforcement issue and a sign would not be approved. Also, in response to a question from a resident, he told the group that the speed limit on most all city streets is 30 MPH.

After much discussion at that committee meeting, a motion was taken requesting a "No Parking" zone be posted on Warren Street 20 feet back from the corner of short Monument Avenue. Another would be requested on Warren Street, 20 feet back from the corner of Pleasant Street, which would be in front of Monument Properties. Residents felt that these would improve the view of oncoming traffic and improve safety.

It was also included in the motion that a traffic light be requested for Pleasant Street at the corner of Warren. The thought behind this was that the light would slow the Warren Street traffic without a backup of traffic blocking Main Street.

This motion from the committee that was presented to the CNC took area residents by surprise, and most expressed opposition to a traffic light on either corner, however, the majority favored eliminating parking for 20 feet on both segments of Warren Street.

The vote by the CNC on the motion came to a 7-7 tie and was tabled until the April 11 meeting for further discussion on this traffic and safety problem.

Basic Services Meeting

On City Square Traffic & Bus Stops
Bill Galvin, chairman of the Basic

Services Committee, has announced that a meeting focusing on the traffic and bus stops in City Square will be held at 7 p.m. on Monday, April 24 at the Mary Colbert Apartments, 20 Devens St.

At the April 4 CNC meeting, member Ken Stone had handed out a 13-page packet on the relocation of bus stops in the City Square area. The CNC members expressed the opinion that they could not act on the information in the packet without having read it. This meeting will allow for a review of the material which includes the relocation of the bus stops at Chelsea and City Square streets and changes that will be forthcoming with the construction of City Square Park.

Monthly Meeting

The monthly meeting of the CNC will be held at 7 p.m. on Tuesday, May 2 at the K. of C. Hall, 75 West School St.

The CNC meetings are open to the public, and all are welcome to attend.

Mayor Menino Brings City Cabinet To Charlestown



RESIDENTS recently had the opportunity to meet Mayor Thomas M. Menino and his cabinet officers at an open forum at Charlestown High School. Questions and comments on city government were submitted to the panel and residents were able to meet with the mayor and the cabinet members on a one-to-one basis follow-

Over 100 people gathered at the Charlestown High School auditorium on March 23 when Mayor Thomas M. Menino brought his cabinet officers to meet with residents. Comments and questions were submitted to the mayor and the panel in writing with Judy Evers, community liaison from the Mayor's Office of Neighborhood Services, acting as moderator.

Members of the cabinet present and their areas of responsibility were: Ann M. Maguire, Health & Human Services; Michael Galvin, Basic Services; Marisa Lago, Economic Development; Chief Operating Officer Robert Ciolek, a Charlestown resident; Boston Police Commissioner Paul Evans; Cathy Douglas Stone, Environmental Services; Chief Financial Officer John Simmons; and Boston Fire Commissioner Martin Pierce, a native of Charlestown. This was the sixth area of the city to host a cabinet meeting. Also present was District One Boston City Councillor

Diane Modica.

Questions directed to the cabinet covered such areas as speeding, street reconstruction, zoning, Boston Housing Authority renovations, code enforcement, air quality and community policing.

It was reported that the Bunker Hill Street reconstruction, a \$1 million project, will begin in the spring. The hold up now is gas lights vs. another type of lighting.

A comment was brought forward that the community has been working for the past 30 months on zoning the City Square parcels "and now the state wants to change it." Lago said it was "news to her." She said that with the Boston Redevelopment Authority's Board adoption of the zoning, design guidelines will follow.

It was recommended that street cleaning be extended three weeks in the fall as the many leaves have been clogging the streets and plugging the catch basins.

The question arose on the air quality in Charlestown, particularly when the biggest bridge in the world

will be constructed adjacent to City Square. Stone told the residents that the Mayor's Environmental Hotline may be called for individual problems. She noted that "the bridge will be of concern" to the city. Menino added that he is "going to be asking the state to install an air quality mechanism in the town."

It was suggested that more code enforcement is needed relative to litter and trash. It was reported that a concerted effort has been undertaken to identify the people leaving trash on the sidewalks and in public barrels. Code Enforcement Officer Jim Cahill, who is working on this problem, can be reached at 635-4896.

Evans was asked when Community Policing will be implemented. He said it would be implemented by Capt. Ron Conway with the help of local people, noting that plans are now being put in place and it is hoped they will be set by June with Community Policing to get underway in September.

The question was raised on the issue of Charter Schools, scheduled to begin in the fall. The mayor stated that these schools will take \$6 million out of the budget of the Boston School Department with the result being that some programs won't be in the public schools next fall. He added that these schools have some good points, but the money for the schools averages out to \$7,000 per student.

The national Contract with America was brought up. The mayor said, "The Contract with America is not a contract - it is a sentence." He went on to say that it was a "short-sighted contract" that will result in such things as a loss of summer jobs, meals on wheels, the elimination of the Department of Education. He stated that they "must get sensibility into the issue."

A question was raised as to whether recycling education would be presented in the elementary schools.

Stone said that a recycling clown is visiting schools throughout the city, with nearly 100 classrooms visited to date. The clown has coloring books for the younger children and work books for the older students.

The problem created by the sale of Silly String, particularly in last year's Bunker Hill Day Parade was brought up as the ordinance voted by the city council last fall wasn't enforced in the South Boston parade. The mayor said that code enforcement could be out early on parade day to get to the vendors. Also, he added, this prohibition could be included in the vending license.

Menino reported on Capital Plan projects in Charlestown from 1996 to 2000. A total of \$126,100 will be recommended to upgrade Sullivan Square with new lighting, seating, drinking fountains and trees.

He said that \$97,550 will be recommended to install a water system, repair the stairs and reconstruct

the base of the Civil War monument at Winthrop Square.

The Charlestown Branch Library has a budget of \$748,700 for a project currently in design. Construction is expected to start in 1996.

In the Charlestown Navy Yard, plans are to stabilize decaying sections of Pier 4 and reconstruct 450 feet of the pier as envisioned by the Harborwalk Plan for a total of \$299,000. An additional \$200,000 is being recommended to design improvements at the waters edge which will allow pedestrians access to the harbor and the water shuttle stop planned for Parcel 5. A previously approved project which is nearing completion provided \$200,000 for critical repairs to the dock, park, improved lighting and security systems.

At the conclusion of the meeting, the mayor stated that the questions submitted to the panel had been most diverse, covering over 40 issues.

Simpler Times

I cannot say when I first heard them harmonize the old Danny and the Juniors hit, "At the Hop," but I do know it was at a St. Catherine's dance some thirty odd years ago. Many years passed and then one Saturday night in 1985, they were reunited for another rendition of the old favorite. That was the occasion of the first Hayes Square Reunion, and the few moments of reverie were so well received that when the next gathering of these Charlestown kids of the fifties rolled around in 1990, it was expected that they'd sing again. They did.

It was now a Saturday night in 1995, and these same kids were living in an old Hayes Square reborn again for a few hours. Thoughts of listening to Richie Powers, Paul Troy and Walter Papisadoro performing as they did in the days of Fathers Smith and Gallagher played happily upon the minds of those who would attend this latest reunion.

The crowd began to gather early, but it was not long before it would become apparent that one third of the musical trio would not be there. Plans had long been made by Walter Papisadoro and his wife

Jane to take a cruise. The plans had been made so far in advance, that a conflict with the reunion could not have been anticipated.

It is really odd, but for some strange reason, even in Walter's absence, the words to "At the Hop" raced through our minds each time our eyes scanned the room and focused on either Richie or Paul.

"At the Hop" may have been missing from the third and latest Hayes Square Reunion, but it seemed nothing else was. Pictures lined the walls and reminded us of what was, and bulging waistlines and eyeglasses reminded us all of what we had become.

Now our own children are older than the people we looked at in the pictures, but the images on the walls reminded us of friendships that had begun some forty years ago and had grown stronger with time. They reminded us of a time when this one square mile of real estate we call Charlestown was a single entity, and that spending much of his or her time in one particular part of the town did not prevent him or her from visiting another.

It was a time when ball fields and

dance floors provided common grounds amicable to all. Baseball and football teams consisted of boys from each corner of the town, and girls from Walford Way dated boys from Elm Street. It did not matter then where our house might be located, for wherever it might be, our home was Charlestown.

Of course, the times were more innocent then, and growing up in the fifties was, undoubtedly, a wonderful experience. It was the decade before drugs became a scourge on society and, thankfully, we were the last to avoid that ugliness.

It was a time when we had a high school which not only served as a viable educational facility for those in the community who chose to be part of it, but it served a social vehicle as well. Those who did not attend Charlestown High School followed the exploits of those who did, for they were friends.

It was a time when we were in love with a different person every week, or so it seemed. It was a time when unrequited love broke our hearts every week, or so it seemed. It was a time when not walking a girl home from the Friday night dance symbolized social failure, or so it seemed.

It was a time when boarding a rented bus on a Sunday afternoon in the fall to watch the local team play a park league football game was a given.

It was a time when Revere Beach in the summer was our answer to the most exotic of tropical beaches.

It was a time when winter nights were spent skating across a flooded "Oily."

It was a time when springtime filled the ball parks with kids whose bats and gloves had only been resting temporarily throughout the cold winter months.

It was a time when it was absolutely unheard of for a young man to curse in the presence of a female. Often we could hear ourselves say, "Watch your language. Here comes a lady!"

It was a time between Korea and Vietnam. It was a time when we did not experience international conflict.

It was a time that reflected a certain innocence and, although none of us welcomes the thought of getting older, it was a time of which we were fortunate to experience.

The Hayes Square Reunion is more than a reunion. True, we do renew old acquaintances and we do relive moments of the past, but more importantly, the reunion serves as a reminder, a reminder of how it was when we were kids. A reminder of simpler times. A reminder of how fortunate we were not to have to face many of the difficulties which confront the young people of today.

Yes, we were lucky, and the Hayes Square Reunion arrives every five years to tell us just how lucky we were.

USS Constitution Welcomes Paul Revere Jr.

Paul Revere Jr. of Revere Copper Products Inc., a direct descendent of Paul Revere whose foundry in 1794 provided most of the copper and brass bolts, spikes, nails and other ship fittings, visited the USS Constitution on April 4.

Revere, along with Constitution's commanding officer, Cmdr. Richard B. Amirault, drove in the first few nails which will hold one of 3,200 copper sheets lining the hull of "Old Ironsides." The copper sheathing prevents water-

borne parasites from burrowing into the hull of the wooden warship and damaging the precious wood.

Although today's Paul Revere does not reside there, the Paul Revere House, which was built in 1680 and is located in Boston's historic North End, served as home for the patriot and silversmith from 1770-1800. He left from there on his now-famous "midnight ride" on the evening of April 18, 1775.

In 1905, when the building was scheduled for

destruction, Paul Revere's great-grandson, John P. Reynolds Jr., organized support to save the house. Since that time, it has been restored to reflect both its original 17th century appearance and the later Revere period. The Revere house is also the only 17th century structure remaining in Boston today.

Paul Revere Jr. is the current president of the Paul Revere Memorial Association which owns and operates the Paul Revere house.

**NEED MORE TIME TO FILE
YOUR 1994 RETURN?**

You may have a good reason for not filing your 1994 tax return by the April 17 deadline. Perhaps you have financial transactions or joint ventures that didn't get summarized in time. Or perhaps you simply haven't had the time to pull all your tax information together.

To avoid penalties for filing your 1994 tax return later than April 17, you must file an extension request and show an estimate of your tax liability. If your estimate of the total taxes due exceeds the amount you have already paid in, you are required to send the difference along with your extension request. If your tax estimate on the extension request is less than the tax on your final return, you may be subject to penalties. The extension request does not ask you to explain why you want additional time to file.

The first extension must be filed on or before April 17, the normal due date of your tax return. It gives you until August 15 to file your return. Additional time beyond August 15 can be obtained by filing a request for a further extension. This second extension requires that you state the reason for the delay.

It's better to file for an extension than to simply file your tax return late. For every month your tax return is past due without the formal extension, the IRS will impose a five percent penalty (up to 25 percent of the total amount due) and will require that you pay interest on any taxes owed.

"One of the greatest things we can do is encourage people in recovery," Coyne said, "so they become part of the solution rather than the problem." However, Coyne and others discussed criticism they had heard among residents who would be against a sober house in the neighborhood because it would house addicts and alcoholics who might be a negative influence on their children. One of the sites unofficially discussed among Coyne and other supporters recently is the former St. Catherine's Convent, which no longer houses the nuns.

Coyne said that ideas to put the convent to use were put on hold because of opposition. "People threatened to take their kids out of (Charlestown Catholic) school if the convent was used," he said, adding that he would not jeopardize the school's enrollment.

Coyne also noted that he had sent home notices to every Charlestown Catholic parent about this pub-

lic meeting. He asked for a show of hands, counting only eight such parents who were not against considering a sober house in Charlestown.

According to Looney, a sober house could be part of a larger community solution, but not the only solution.

"We want to send a message outside of these doors to our young people that the adults are talking about the realities of drugs and alcohol," Looney said.

Other ideas suggested included a symbolic neighborhood march, nightly group walks in the areas of known outdoor drugging and drinking, the return of a police substation in Charlestown, getting angry and taking the streets back, support for parents' shame rather than blame for having addicted sons and daughters, no longer tolerating adults' inappropriate use of alcohol in public parks, and overall community support for the many different ideas and approaches to solving neighborhood problems.

Looney noted that there will be a follow-up meeting on June 12 to come up with a CHAD-led plan of action. For those with specific concerns with the police, he encouraged people to attend the community Public Safety meetings with BPD representatives, the next one being Tuesday, April 11 at the American Legion Hall, 23 Adams St. at 7 p.m.

And some residents said they were ready to do something now, saying that waiting until June is just delaying the process.

Judge Peter Agnes, presiding justice of the Charlestown District Court told those attending that "this is an important first step." He encouraged residents to discover their own solutions for "dealing with something that has the power to make your children lose sight of any and all values ever taught."

Many residents spoke out emotionally about their personal and family experiences with substance abuse, violence and death, at times bringing

themselves and others to tears.

But perhaps the most moving moment came when Terry Titcomb, the mother of a young adult who lost his battle with addiction and was recently killed, read a letter to the Charlestown community telling of her experience. Detailing her son's seven-year addiction and the family's efforts to keep him off drugs, Titcomb pointed out that no amount of love seemed to help because, as much as he wanted to, it was just too hard for her son to stay straight for any length of time.

Titcomb's message brought the two-hour brainstorming and discussion to a somber, respectful close. Her story brought home the real loss a community suffers due to alcohol and other drug abuse, young people overdosing, and the violence and murders that substance abuse brings.

"We have to talk about this," Looney stated earlier, "and we have to understand that sobriety is a tough thing to do."

'Talking Dog' To Teach Fire Safety At Warren-Prescott School

A talking dog will visit the Warren-Prescott School in Charlestown. Well, not a real talking dog, but Fire Inspector "K-9 Phil" comes pretty close.

The Boston Fire Department has asked this button-nosed, floppy-eared and dapperly dressed canine to visit the Warren-Prescott School to teach children about recognizing and preventing fire hazards as well as the proper reaction in the event of fire. Fire Inspector K-9

Phil is very effective in reaching children because he captures their attention and makes a lasting impression.

The highly acclaimed program is sponsored by Creative Safety Products, a Shrewsbury-based firm, which specializes in the design of innovative school-based resource programming that acts as a bridge between community officials, educators and children. K-9 Phil will be teaching at the Warren-Prescott School

tomorrow, Friday, April 7.

"It's often forgotten that schools teach much more than the 3 R's," said Warren-Prescott School Principal Dr. Domenic Amara.

"We have a responsibility to teach the whole child and safety is just one facet. In this case, we're making use of a resource offered by the Boston Fire Department and Creative Safety Products with teachers reinforcing the lessons taught."

Teens Share Views On Alcohol And Drugs At Charlestown Teen Day

On Sunday, April 2, nearly 100 teens gathered at the Preble Room in the Charlestown Navy Yard to celebrate Charlestown Teen Day. The day was sponsored by CHarlestown Against Drugs (CHAD), Healthy Charlestown and the Drug Enforcement Agency (DEA). Speakers talked about self-esteem, cultural diversity, drugs, alcohol, violence and dating issues.

A. J. Brown, the Urban Youth Coordinator from the Archdiocese talked about how drugs and alcohol affected him and his family and how he had to drop out of school because of it.

Father Ron Coyne talked to the teens about the community-wide meeting held last Thursday night where residents of all ages were able to voice their concerns. On Sunday, the teens got a chance to express their concerns for the town and how they felt about the drugs, alcohol

and violence throughout the community.

The teens were asked what their ideas of a perfect world was. In a perfect world there would be: no greed, no drugs, no alcohol, no pollution, you could walk down the street without being hassled and people would mind their own business.

Steve Moriarty of the DEA wanted to know what teens think of the job he is doing. Do they feel he is doing the right thing by trying to get rid of drugs? He asked them how they feel about violence, drugs and education. One major question he asked was why do people take better care of their cars than themselves?

There were also speakers from the Bunker Hill Health Center. They discussed issues such as adolescent problems, sexually transmitted diseases (STDs) and smoking. They wanted the teens to realize there are many doctors that are willing to

help them with any problem they may have.

Following a day of workshops, the teens got together and watched the Improbable Players, an acting team of four recovering alcoholics and drug abusers. They portrayed a family growing through the years. In the family, the mother was an alcoholic and the son abused drugs. After their performance, they talked about themselves and answered any questions that people had.

After the play, the teens settled down to a hot meal, prepared for them by Boston Chicken. As soon as everyone had finished eating, the night continued with a dance. A great time was had by all.




