### Facts About Drugs -F. A.D.

There are many common myths surrounding our national pasttime: drinking.

"Alcohol is a stimulant." Alcohol actually is a depressant. The first area of the brain alcohol affects is the area which regulates inhibitions, judgement and self-control. It is the lack of such restraints that causes the uninhibited behavior.

"Alcohol warms the body." Alcohol makes the drinker feel warmer because it causes blood to rise to the skin's surface. However, when this happens, the body temperature is actually lowered because the surface heat is lost. The image of the St. Bernard with a cask tied to his neck is not a symbol of life, but potential death to the freezing person.

People believe that it is possible to sober up with food, coffee, cold shower, fresh air. The only real effect is to produce a wide awake drunk. Time is the only method for sobering up. And the body eliminates alcohol at the rate of about one drink per hour.

'Alcohol increases sexual ability." No. It may lower defenses, but it does not improve performance.

"Mixing drinks causes greater intoxification." This is another myth. It is still only the total amount of alcohol one consumes that counts.

"Alcoholics are morally weak." Wrong again. Alcoholism has been medically and legally classified as an illness and the alcoholic is no more responsible for his drinking once he starts, than a person with T.B. is for his coughing.

"Alcoholics drink every day." Wrong. Some alcoholics drink only on weekends; some abstain for months. Alcoholism is not determined by how often a person drinks, but whether or not he can control his drinking once he starts.

"Alcoholism is inherited." This has never been proved. It is generally agreed that psychological and sociological factors are responsible for the development of alcoholism. There are learned by the next generation. There is a higher degree of alcoholism in certain families and research is still going on in this

The biggest myth of all: "I will never become an alcoholic." Anyone can become one with time, patience, and exposure.

### Snow Emergency Information

Mayor Raymond L. Flynn announced that the City of Boston Snow Emergency Center will operate again this winter until April 1 during declared-emergency storms.

During snow emergencies only, a 24-hour telephone number-725-3050-available to receive calls from Boston residents requiring assistance such as towing of vehicles interfering with snow removal, removal of debris from public ways, and providing shelter for stranded residents or commuters.

The Snow Emergency Center is located in City Hall and serves as a clearinghouse for all snow-related emergencies, alerting appropriate departments and agencies to solve the problem.

The Center, which is staffed by regular Department of Public Works employees, stays open until a significant number of calls decrease.

A snow emergency is declared by Public Works Commissioner Joseph Casazza in conjunction with the Highway Superintendent and Police Commissioner.

The Center is set up at the discretion of Commissioner Casazza if 4-6 inches of snow are forecast and automatically if 6 or more inches are forecast.

Snow emergency notes: ·During snowstorms all snow-related emergencies in Boston should be reported to the City's Snow Emergency

•From now through April 1, the Highway Division of Boston Public Works puts into effect a snow emergency standby operation consisting of three shifts of 15 persons each, 24 hours a day, seven days per week.

. During a snow emergency, public service announcements are issued through the media by the Department of Public Works, the 24 hour Hot Line and the Mayor's Office.

·During a snow storm snow emergency calls should come to 725-3050 in City Hall rather than to individual

### by Charlie Ross REMEMBERING JENNY HORN

Our column has often carried updated information on NF, and placed pertinent facts before the public eye on the necessity and urgent need for a National Commission to research and develop an eventual cure of this dreadful, debilitating disease. House H.R. 1676 and Senate S. 1623 address this important Act, which all hope will soon be brought to fruition, and, proudly, we pass along the report that "Massachusetts has the best record in the country for co-sponsors of the NF Bill." Sadly, its enactment will have come too late for Jenny Horn!

In its Fall Newsletter, The Massachusetts Chapter of Neurofibromatosis (AKA Recklinghausen's Disease) carried the text of an article which ran in the Lexington Minuteman on May 10, 1984. It was written by Niela Miller (Jenny's mother), and salient parts thereof are reprinted here following:

"My daughter, Jenny Horn, is currently dying after a lifelong struggle with neurofibromatosis, complicated in recent years by cancer. She grew up in Lexington, attended Bowman, Clarke Junior High and Lexington High School. Her first semester at Rhode Island College was spent on crutches after a leg operation (Note: amputation eventually ensued). She had to spend a few hours each day going for radiation treatments. Last year she transferred to Indiana University. She spent her first (and only) semester there wearing a wig and recovering from chemotherapy. She is now bedridden at Massachusetts General and has only a short time to live.

Jenny's goal was to work with children who were emotionally disturbed or had other special needs. She won't get to do that. But I think it would make her happy to know that other children who are born with her affliction will be helped by the donations of her friends and neighbors. Certainly, for me, her mother, it is one small

consolation in a heartbreaking time."

It hurts to report that Jenny was "called home" last August. She left a legacy of courage, optimism and bravery of spirit, having lived with a disease that is totally unpredictable and devastating, and will be greatly missed by all who loved her and had to endure with her the pain of a life destroyed by this disease.

In thanking Doris, the President of the Alliance, Mrs. Anita B. Pyatt, noted: "You have participated in a historic turning point in the treatment of the mentally ill in the Commonwealth. You will be long thanked and remembered.

Doris, who was instrumental in legislation prohibiting abuse of the mentally ill, was also thanked for his work in establishing guidelines for the treatment of youth in acute psychiatric emergencies. These guidelines are similiar to

# Charlestown Police Line

From the Desk of Deputy Superintendent Joseph V. Saia, Jr. Commanding Officer, Area A

On December 28, 1984, a woman came into Area A to report a larceny. The woman stated that while her motor vehicle was parked and unattended on Rutherford Avenue, some unknown person(s) entered the vehicle and removed a suitcase belonging to the victim. At this time, there are no witnesses to this incident.

On December 28, 1984 at 10:07 p.m., police officers responded to 500 Rutherford Avenue on a larceny report. On arrival, the officers spoke to a woman who stated that while her vehicle was parked at the above location, person(s) unknown broke a window, entered the vehicle, and removed a Blaupunkt Radio. These suspects also did damage to the dashboard and the paint of the vehicle.

On December 29, 1984, police officers, while on routine patrol, were stopped by a woman at Starr King Court. This woman stated that while she was sleeping, some unknown person(s) threw a rock through the kitchen window of her home. This incident will be further investigated.

On arrival the officers spoke with a woman who stated that while she slept, some unknown person(s) entered her home through a rear patio door. On arrival, the officers observed a broken window on the side of a building located on Sullivan Street. After further investigation, the officers found a beer bottle, which apparently had been used to break the window. A white male suspect was seen running from the scene by witnesses. The witnesses were unable to give the officers any further description of the suspect. A search of the area was to no avail.

On December 30, 1984 at 10:15 p.m., police officers responded to Mead Street on a radio call of an assault. On arrival, the officers observed two white males running from the scene. The officers spoke to the victim who stated that two white males had vandalized his van. When confronted, these two suspects had beaten the man with their fists. The two suspects have been identified, and the victim will seek complaints at Charlestown District Court.

On January 1, 1985 at 6:30 p.m., police officers observed

a motor vehicle being operated the wrong way on a one way street. The vehicle was stopped at One O'Reilly Way. At this time the officers discovered that the operator of the vehicle was wanted on a Default Warrant issued from South Boston District Court. 
Lecture Series
