Violations of international rules and political principles. Fully violation of the UN Charter, violation of the basic paragraph 1 and 2. Violation of the UN Charter and the section that speaks about the obligations of members of the United Nations in the interest of safety and respecting the rights of other bodies, other states and community status, rights abuses and Declaration commitments, violation of Sections 53 and 107, other, creation of criminal values that overtakes statistic's of fascism and such value crime.

Violations of the International Declaration of Human Rights, the Declaration for the prevention of genocide, the Declaration on the rights of persons to freedom of movement and trade, the Declaration on the Rights of Persons for their political activities, violations of military law and international humanitarian rules, violations of economic agreements between the two countries and strategic international monopoly that is about silence
