### Police, Teens And Parents Meet To Discuss The Issue Of Drugs

The Teen Connection of the Charlestown Community Schools made up the majority of the audience at the monthly Police/Community meeting held on January 12th as the topic of the gathering focused upon drug abuse.

Boston Police Officers Richard Gannon and Tom Settiani from the School Program to Educate and Control Drug Abuse (SPECDA) spoke to the teens and pre-teens gathered, about drug addiction, criminal actions undertaken to support drug habits and methods of saying "no" to the pressures of using drugs.

In addition to the dialogue between the police and the youths, the audience, which also included a few parents, viewed a television program entitled "Wasted: A True Story." The video chronicled a family's difficult experience when the young brother used drugs to a point where he stole his mother's car, chased his older sister around the house with a knife and lost any interest in school, friends and sports. The police officers also set-up a display showing what some drugs look like and the tools used to prepare drugs for consumption.

Gannon said that drug problems exist in Charlestown, Boston and worldwide. The police use a "three prong" approach to

dealing with drug abuse, he added, that includes enforcement, prevention and an educational component. SPECDA targets fifth and sixth graders to speak to because this is the period when youngsters are introduced to drugs, Gannon said.

The SPECDA program commenced in Boston's public and parochial schools in January of 1987, according to a booklet distributed at the meeting. This program originally began in New York City in 1983 as a partnership between the New York City Board of Education and the New York City Police Department.

### Doe Presented Achievement Award From Rehabilitation Commission

Those who were lucky enough to attend an awards presentation for Charlestown resident Kelly Doe at Barrett's on Boston Harbor recently, experienced a special lesson in courage.

Doe, a 25 year old quadriplegic, received a high

achievement award from Elmer Bartels, commissioner of the Massachusetts Rehabilitation Commission, an achievement award from Senator Francis Doris for overcoming her handicap and praise from City Councillor Robert Travaglini. Like Doe, Bartels is a

quadriplegic.

This young Charlestown resident has been in a wheelchair since diving into shallow water at Revere Beach in July of 1978. Yet, Doe hasn't seemed to slow down at all and those who speak about Doe quickly (continued on page 6)

## BRA Presents Tentative Zoning Plans For Entire Town To Committee

The Planning and Zoning Committee of the Neighborhood Council met on January 7th as the staff of the Boston Redevelopment Authority (BRA) presented the tentative zoning plans for the whole of Charlestown before the committee.

The committee began its meeting, however, by first discussing how they should expand their winter and spring agendas to better include and involve each neighborhood of the Town and its residents.

Committee co-chairperson Kathryn Downing said that rumors are circulating around Charlestown that the committee spends too much time discussing the Navy Yard zoning and spends too much time in the Navy Yard. (The committee meets the first and third Thursday of each month in Building 34 in the offices of the BRA.) Downing continued by suggesting that the committee widen its forum and meet in such places as the high school on Medford Street or the Harvard/Kent School in Hayes Square.

While committee chairperson Dennis McLaughlin said that he had no problem holding future meetings in various Charlestown neighborhoods, other committee members spoke in favor of keeping the meetings in the Navy Yard.

Fellow committee members stressed factors for keeping the Navy Yard meeting location such as parking availability; easy access to information by the BRA staff in their own of-

fices; less confusion if the gatherings remain on a consistent schedule of time and place; and bringing residents into the Navy Yard to see the services available to the community (such as the BRA) as well as joining the Yard with Charlestown proper since the two are thought of as separate areas.

Resident Linda Smith, who also works for The Raymond Group, the largest developer in the Navy Yard, said that it was her understanding that the committee would move out into the neighborhoods depending upon a particular issue that needed discussion. Panel member Virginia Gosciniak suggested that the committee concentrate on zoning issues rather than individual neighborhoods as each section of the Town will have issues in common with other areas.

Committee member Stephen Spinetto said that the committee should proceed with its present agenda and make changes later.

McLaughlin stressed that zoning Charlestown will be a long process and could be more difficult to address in the future if neighbors do not involve themselves in the early stages to adequately have their say.

Dave Armametti, a special assistant at the BRA, distributed three booklets to the audience present at the meeting. These booklets included a framework for discussion of the Charlestown plan; a breakdown of the open space areas, such as the playgrounds and various squares throughout the Town; and a description of

the Maritime Economy Reserve (MER) Zone.

Armametti then reviewed the 11 major elements of the Charlestown plan.

One of these elements includes creating affordable housing reserve zones within the Interim Planning Overlay District (IPOD) to meet future demands on the neighborhood. Armametti said that housing comprises almost 35 per cent of the neighborhood's land area. He added that while not much more land is available for housing, 15 sites have been tentatively identified as potential housing sites. He listed an area along Rutherford Avenue, various parcels throughout the Town and possibly some on-site affordable housing when the new day-care center is rebuilt at the old Kent School in Hayes Square, among the potential affordable housing sites. Should these sites not prove feasible, then the committee should say so, Armametti said.

He added that approximately 1,200 units may be built on the 15 sites with a percentage of the total set aside as affordable housing.

Continuing, Armametti said that further traffic and parking studies will be conducted. In addition to the parking needs of residents, the BRA staff recognized the traffic impact from "ongoing roadway and development construction projects." Cambridge Systematics will conduct a traffic study on the neighborhood, while Vanasee/Hangen will

study City Square.

Additionally, the Charlestown plan packet states that a transportation master plan will be conducted that will include analysis of the Central Artery/North Area (CANA) Project and other infrastructure projects "as they relate to traffic generation and flow; a study of Main, Bunker Hill, Medford and Chelsea Streets and Rutherford Avenue as Boulevard Planning Districts to protect and promote these thoroughfares as gateways and mixed-used commercial centers of the community; a study of the Terminal Street - Medford Street truck route and its connectors to determine if realignment or changing of the route is desirable or feasible; a study of the feasibility/coordination of the four proposed water transportation sites in Charlestown and their potential as transportation alternatives; and the requiring of individual transportation access plans and parking plans for all development projects totaling over 100,000 square feet."

The residential core restrictions implemented "to protect the character and scale of the residential core of Charlestown while preventing overcrowding and apartment additions/conversions" would include restrictions on occupancy, roof additions, deck additions, height, density, and apartment additions.

The BRA staff also noted that a new master plan would be created for the

Navy Yard. As the Charlestown plan packet lists density, height, uses, traffic,

parking, design and environmental impacts as the (continued on page 13)

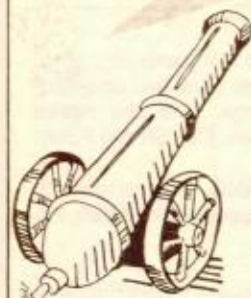

I wish to register my opposition to the recent MDPW proposal, announced at the December 9th public meeting in Charlestown, to construct the new northbound viaduct of I-93 150 feet closer to the community. The residents of Charlestown, by means of the North Area Task Force (NATF), have worked long and hard with your department to ensure that this project best meets the transportation needs of the greater community while limiting as far as possible the huge impact it will have on their own. To further encroach upon the community by moving this structure nearer its center would be a major violation of this planning process. I strongly request that any planning changes be first approved by the Charlestown community.

In a related matter, please find the enclosed copy of a letter sent to me by Mr. Robert Wallace from Charlestown that appeared in the **Charlestown Patriot** on December 17. Mr. Wallace raises serious questions regarding the move and the project as a whole and possible health risks to the community. I further request that these concerns and others like them be fully researched and answered.

In my roles as Charlestown's City Councillor and Chairman of the Boston City Council's Committee on Commerce and Transportation I will be monitoring the CANA Project very closely. I know that I share with you a commitment to ensure that the welfare and the needs of the residents of Charlestown are fully served by the planning process.

point out her positive attitude, an attitude she has shared with individuals fortunate enough to come in contact with her.

Jack Millerick, director of the Life Focus Center, said that 75 per cent of Kelly's potential is in herself. Millerick added that Doe shares a private part of herself as she works with other quadriplegics with problems such as depression.

For the past seven years, Doe has spent a great deal of time at the Life Focus Center, at first performing volunteer work such as reading to the children and later directing activities with the retarded adults, such as teaching songs. During the award ceremonies, Millerick noted that

because Kelly could not chase them around the room, she often had to keep hyperactive, retarded children in line with just her voice — which was an accomplishment in and of itself.

Since June 1st, she has been employed at the Center working on the computer, following completion of a computer course offered at Life Focus. Doe operates her computer by using a mouth piece to push the keys down on the keyboard.

While presenting Doe with her award, Bartels noted a number of times how positive it is to see a fellow quadriplegic working. He said that his first job in 1964 was also in computers. However, 24 years ago the machines Bartels said he worked with were large and

to operate them meant feeding the computer cards, waiting 15 minutes for the computer to return the cards, and then taking the cards over to the printer. Today, Kelly has the same capacity at the keyboard, he added.

Bartels told Kelly that she is on the cutting-edge as she pushes the rehabilitation business as an answer for quadriplegics. He added, "There are worlds of opportunities for you, Kelly."

Travaglini added that Doe is a pioneer who is setting the groundwork for others to pattern and that she sets a standard of excellence that those who follow her will be measured by. The City Councillor also said that he believes that she is pursuing higher goals and suggested that the community "keep

an eye on her."

In a more recent interview, Doe spoke of how she accepted the accident and moved on with her life. "There's no sense crying for the rest of my life," she

said, noting that family support has played a major role for her.

Doe added that she was "shocked" at the awards she received. Instead of getting the beautiful plaques,

Kelly said she expected little certificates.

As for the future, Doe said that she will probably remain at the Life Focus Center, becoming more advanced with computers.



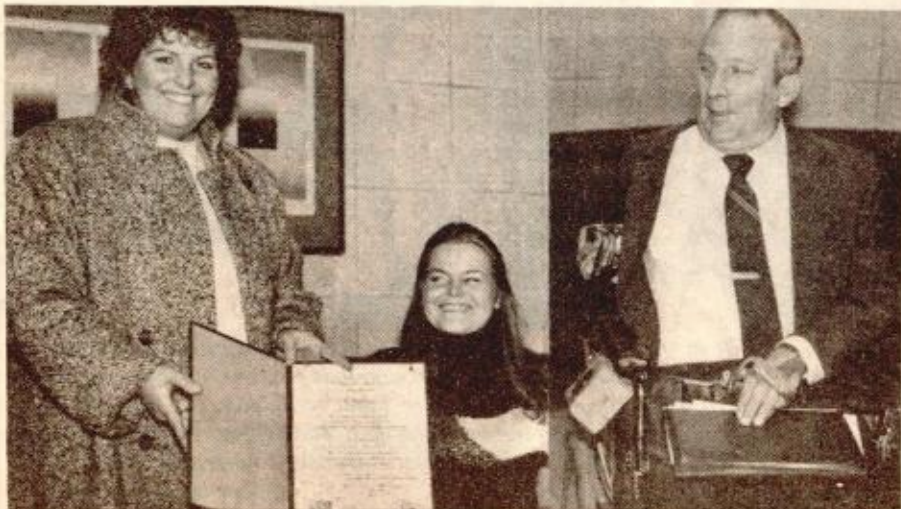

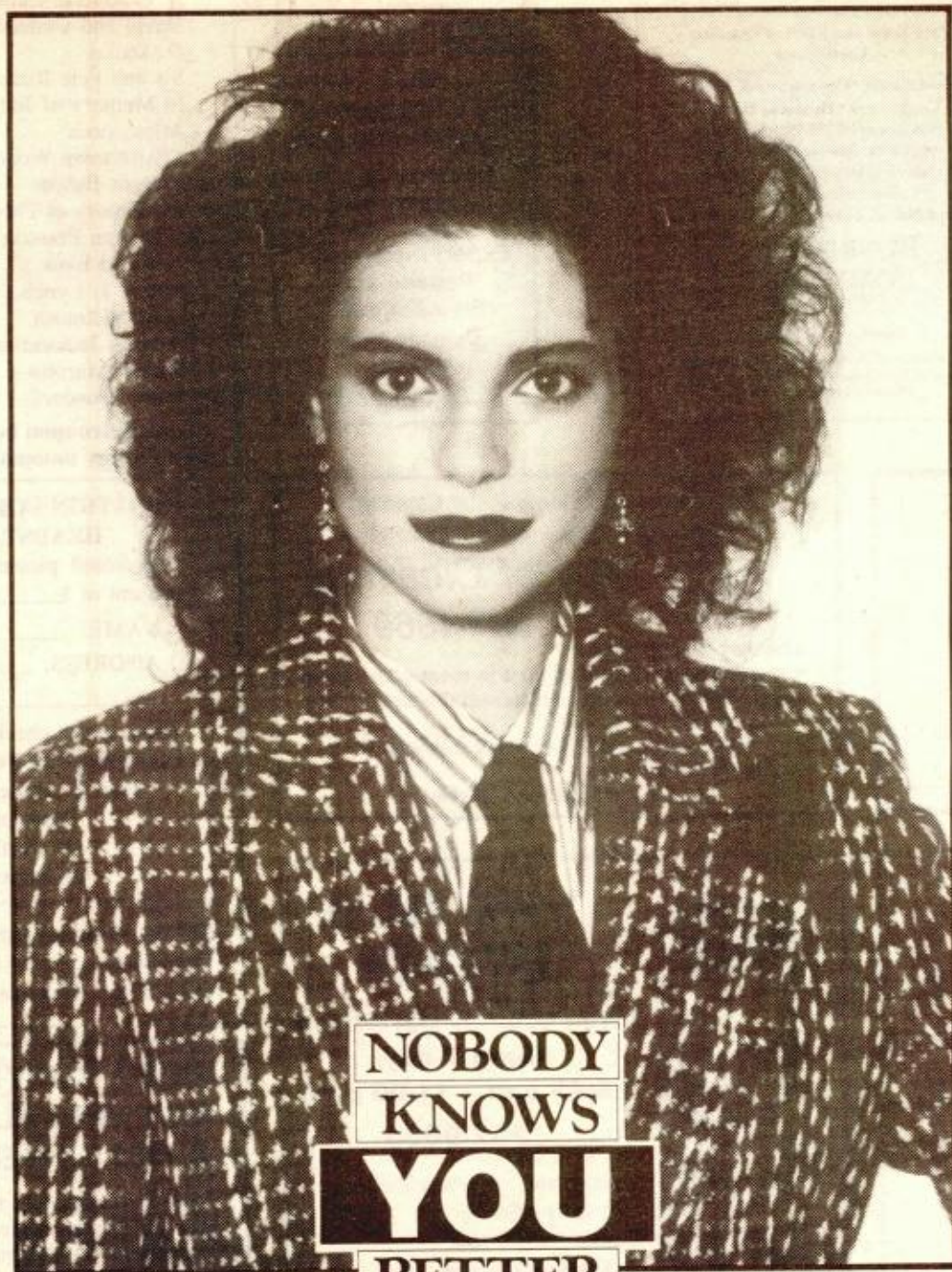

## Local Man Dies Following Stabbing

A Saturday, January 9th stabbing at a party on Pearl Street has left one Charlestown man, a municipal patrolman, dead and his girlfriend wounded.

According to Area A Boston Police Officer Joe McNulty, the stabbing death of Robert McGrath, age 25, occurred at a small party at 16 Pearl Street. The Pearl Street address is the

home of McGrath's girlfriend, Laura Murphy, who was also stabbed. McGrath lived at 16 Prospect Street.

Another Charlestown resident, Richard E. Woods, age 27, of 24 Prospect Street has been charged with the murder of McGrath and assault and battery with a dangerous weapon on Murphy.

According to the police report, the incident occurred

at 2:42 a.m. on January 9th and when the police officers answered the call, they found McGrath on the doorstep with wounds in his chest. Murphy had been stabbed in the back of her right arm, McNulty said.

McGrath died on Sunday, January 10th at 2:15 p.m. at Massachusetts General Hospital.

According to the police report, Murphy said that after her doorbell rang she and McGrath answered the door together. She added that McGrath had a fight with the person at the door, but Murphy could not name or supply police with a description of the person. She did report the stab wound in her arm. After questioning, none of the guests at the party could give a description or identify the person at the door.

At 10:30 p.m. on the 10th, the identity of the alleged suspect was given

in at the Area A Police Station and Woods was arrested by detectives at his home at 11:30 p.m.

Woods was arraigned at Charlestown District Court on Monday, January 11. He pleaded innocent to the murder and assault and battery with a dangerous weapon charges and was held without bail at Charles Street Jail.

McGrath is survived by his parents, Robert and Irene McGrath; two sisters, Kelly and Tracy; a brother, Brian; and his grandmother, Catherine McGrath, all of Charlestown.

He was a graduate of Saint Clement's High School, Class of 1979, and was a member of the City of Boston Municipal Building Police Department.

Funeral services were held at Saint Catherine's Church on Thursday, January 14th.

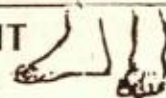

## BRA Presents Tentative Zoning Plans For Entire Town To Committee

factors to be studied, Jim English of the BRA said that the BRA would like the Neighborhood Council to focus upon height, density and use in particular. He added that in the future, instead of presenting a development plan to the community to find what the pros and cons are, the authority would already have restrictions.

Armametti spoke briefly on historic preservation, in particular the Monument area, Thompson Square and the Harvard Mall areas. Specific guidelines will be

established to "preserve and protect historic areas, buildings, facades and elements from demolition or change through future development." These guidelines will be in addition to the already general historic preservation guidelines proposed city-wide.

Open space reserve zones will be enacted to "protect and maintain the valuable open space and recreational resources of the neighborhood." According to Armametti, open space would include such areas as the Paul Revere Landing Park, the piers, parks and City Square. He noted that

maintenance of the existing open space, a goal of Mayor Raymond Flynn's administration, will have a major impact on the Town.

Specific sites will also be reserved in Charlestown for waterfront industrial and water-dependent uses as the BRA proposed the ten Maritime Economy Reserve (MER) Zones. Those ten zones include Mystic Piers 1, 49-50; Catalano Brothers; U.S. Gypsum; Moran Terminal; Schiavone/Massport; Charlestown Commerce Center; Atlantic Cement; Somerville Lumber; Revere Sugar and Amstar Sugar. The Neighbor-

hood Council endorsed these selected sites in August, 1987.

Of a manufacturing/industrial reserve zone, the Charlestown plan packet states, "In order to protect and preserve desirable industrial and manufacturing uses in the neighborhood from encroachment by competing land uses or displacement through resulting increases in rental rates, certain areas can be set aside as manufacturing/industrial reserve zones. This measure would reserve specific sites or areas in the neighborhood solely for selected manufacturing and industri-

al uses."

The Charlestown plan packet also called for a waterfront/Freedom Trail pedestrian access plan that includes connecting the Charlestown Bridge and City Square with the waterfront and improving access along the Revere Landing and Boston Sand and Gravel.

And finally, last on the list are the special study areas chosen because of their size and "special potential for development." These areas include: City Square Development Parcels, which Armametti said would be examined although another group (the

North Area Task Force) is already doing so; the Charlestown Navy Yard; Boston Sand and Gravel Property, although the company has no plans of moving, Armametti said it should be examined in the event that this changes in the future; Rutherford Avenue Corridor; and the Massport Corridor under the Tobin Bridge.

The next meeting of the Planning and Zoning Committee will be held on Thursday, January 21st at 6:30 p.m. in Building 34, on First Avenue in the Navy Yard.



## Police, Teens And Parents Meet To Discuss The Issue Of Drugs

classrooms, teaching eight different lessons concerning drugs. Gannon stressed two of the eight topics in particular, namely self esteem and peer pressure. Gannon said that because police officers deal with drug problems first hand on the streets of the city, they can talk to students about drugs with instant credibility.

A key to the SPECDA program, according to the officers, is to change attitudes about the social ac-

ceptance towards drugs and to build the self esteem of young people so they learn to say "no" to anything harmful to them. The police department has learned that the scare tactics used in the past do not work in the fight against drug use.

Another program used by the police is Drug Abuse Resistance Education (DARE) which follows much of the same pattern as SPECDA.

The young boy in "Wast-

ed: A True Story" recovered and once again became part of the family unit. However, Gannon said that many police officers could recount stories of following ambulances to Boston City Hospital with people who did not recover. In fact, most drug users that overdose die alone because their "friends" abandon them, he added.

Some of the students asked police what to do if friends are using drugs. Gannon told the youths to

do what they could to help their friends, but it comes to a point where nothing else can be done if friends don't want help.

Settipani added that friends should help friends. Using a more graphic example he said that friends would pull other friends out of the way of a car heading for them. Friends using drugs, Settipani said, have a locomotive heading for them.

Carolyn Wrenn Shannon of the Teen Connection ask-

ed the police for suggestions to answer young people who make a lot of money dealing drugs and don't want to work for less money at fast food restaurants. She added that in Charlestown, the heroes are the people involved with crime.

Gannon answered her by asking who thinks these people are heroes and stating that eventually the criminals "fall on their faces." Settipani added that drug dealers should be asked how they sleep at night knowing the police or federal agents could appear on the doorstep or that a friend "could do them in."

Charlestown resident Bobby Wallace said that police should stress the progression of drug use from

smoking marijuana to using pills to shooting up with needles that could lead to the killer disease AIDS (Acquired Immune Deficiency Syndrome). Although Wallace said that more scare tactics should be used because today's youths have a high awareness of social issues, Settipani said that he probably could not scare one youth attending this meeting. Gannon added that the police don't need scare tactics to get the message across, youths learn the plain truth of how to get AIDS and that they can die from it.

Settipani said that as corny as it sounds, children are the future and it is important to spread the word now to say "no" to drugs.

# Charlestown Police Line
