Representatives will explain how the program will work and the streets that will be affected.

All interested residents are encouraged to attend.

City Council Hearing In Charlestown On Road Reconstruction Impact

The Boston City Council's Committee on Commerce and Transportation will hold a public hearing at the Charlestown High School Auditorium, 254 Medford Street on Tuesday, May 12 at 7:30 p.m.

Committee Chairman Robert Travaglini has announced that the hearing will concern the impact of the proposed design of Interstate 93 and Route 1 on the Charlestown community.

The Councillor felt that it was imperative to hold a public hearing on the many problems Charlestown faces regarding traffic and the impact it may have on this

community. The traffic concerns are compounding with the start of construction by the Massachusetts Department of Public Works on the North Area/Central Artery Project, the proposed expansion of the Massport's Moran Terminal, the recent vote by the Massachusetts Water Resources Authority to locate an equipment transfer site in the community, as well as the proposed expansion of development within the Charlestown Navy Yard by the Boston Redevelopment Authority.

Powers Claims Class Action Suit Was "Worth The Battle"

On Wednesday, May 6, Judge John J. Irwin, Jr. of the Suffolk Superior Court denied the request made by nine Charlestown and one North End resident to postpone construction of the Central Artery North Area (CANA) project. However, the Judge directed the defendants, the Massachusetts Department of Public Works (MDPW) to "closely supervise the traffic management program . . . to alleviate the public safety consideration addressed by the plaintiffs."

The residents sought to stop the start-up of the project, scheduled to get underway on Thursday, May 7, due to their primary concerns of the accessibility of emergency vehicles in and out of Charlestown and the necessity of having appropriate police details in the construction area.

At the hearing on Wednesday, Terry Murray, Director of Traffic Management for the MDPW, stated that the Boston Police Department guaranteed that the posts will be filled.

Michael Powers, Charlestown resident and attorney for the plaintiffs, stated, "It was worth the battle. I am very happy that

mittee to clear out as much of the scrub growth as possible to draw attention to the park's significance and to enhance the neighborhood.

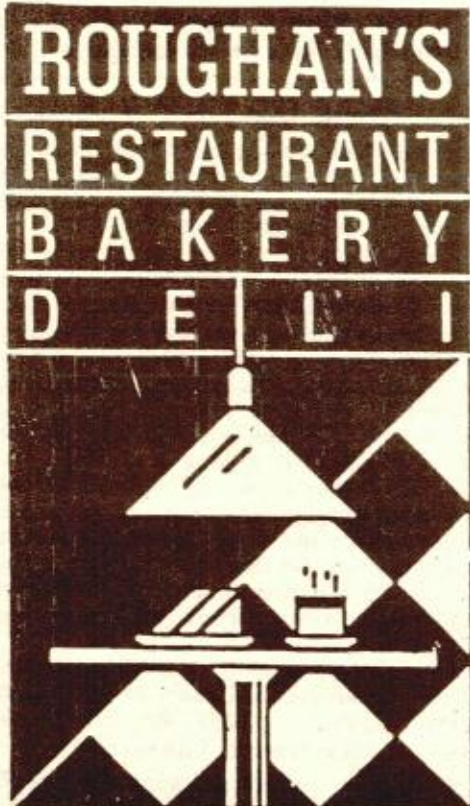

Construction Of North Area Roadway Reconstruction To Begin Today

by Chris Nicastro

With construction on the first phase of the Central Artery North Area (CANA) project scheduled to begin Thursday, May 7, Massachusetts Department of Public Works (MDPW) Commissioner Robert Tierney announced Tuesday the final plans for ramp and lane closings on the \$250 million project.

Tierney said that the ramp connecting southbound I-93 with Route 1 north and the Tobin Memorial Bridge, along with the

off-ramp from Route 1 North to Chelsea Street/City Square will close early Thursday morning. Tierney stated, "From Thursday morning, there will be no direct connection between southbound I-93 and Route 1 north. Nor will there be direct access to Charlestown from I-93 and the Central Artery."

Tierney also stated that the car-pool lane on Route 93, currently used as a route into Charlestown, will be closed except during morning rush-hour

from 6:30 to 9:30 a.m.

These closings will allow the DPW to begin the construction of a temporary detour structure, the first phase of the CANA project. In Spring 1988, when the detour is completed, the DPW will begin the project's three other major phases: construction of new viaducts, the tunnels under City Square, and an approach ramp to the Tobin Bridge. The project, the largest one the MDPW has ever undertaken, is scheduled to be finished in

1991.

According to Tierney, it will solve safety problems at the merge area where Route 1 and I-93 join to cross the Charles River. Used by over 175,000 motorists everyday, the interchange has one of the highest accident rates in the state.

"The major advantages of this \$250 million project are that we will be increasing this merging, weaving battleground which is now about 600 feet to about 1,800 feet long," said Tierney. "Motorists will have the ability to make safer and easier merges and lane changes in this section of highway."

In order to mitigate the traffic headaches expected to accompany this project, Tierney said the MDPW has hired forty police officers to monitor traffic throughout the area. Tierney added that the number of "fixed post" traffic of-

Neighborhood Council Seats Four

On Tuesday, May 5, the Charlestown Neighborhood Council sat four new members: Petie Hilsinger of the Navy Yard, Donna O'Brien of Monument Avenue, Steve Spinetto of Sullivan Street and Tom White of Mount Vernon Street.

The Council recommended the BRA advertise for the development of single family homes on the vacant parcels at 41 Old Rutherford Avenue and 36 Belmont Street.

It was voted that a letter be sent to the BRA on the Tremont and Prospect Street Parcel R-87, recommending that the plan for individual house lots to be awarded in a lottery system, with a park, 689 special needs housing and linkage funds applied to support affordable housing.

In other action, the Council voted to support the efforts of Bunker Hill Community College, as presented by Vice President Mon O'Shea, to secure a long-term lease from the BRA for the student parking lot. They also voted to support the Main Street merchants in their efforts to retain the "neck downs" and keep the sidewalks at their present width.

Navy Yard residents also expressed concern to the Council on the effects of the proposed expanded Navy Yard development.

According to the DPW's Terry Murray, the police base will allow the officers to coordinate their traffic monitoring activities and also mark the return of a police presence in Charlestown.

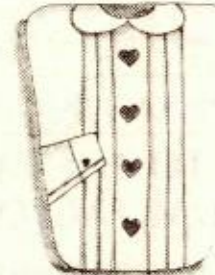

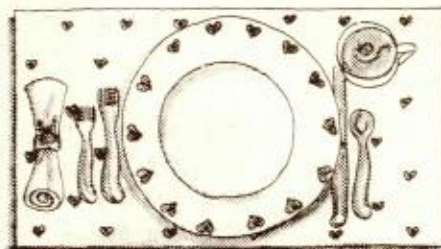

Tobin stated that all events, with the exception of the opening reception,

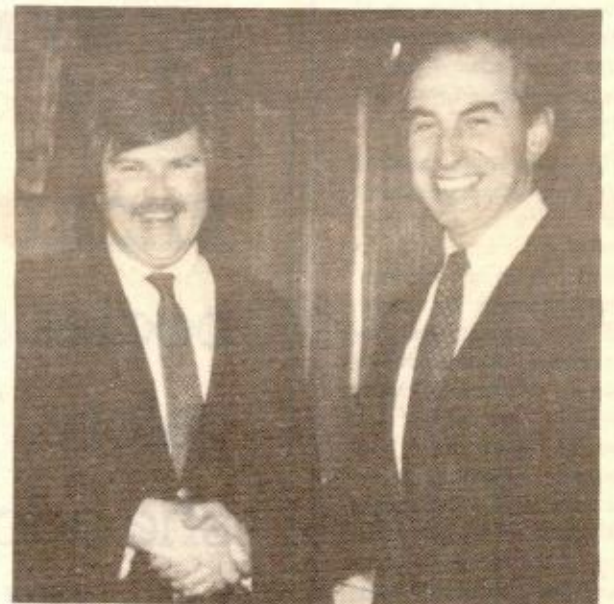
are free of charge. He did note that donations would be welcome.

Massport Concerned With MWRA Impact At Charlestown Site

This is a follow-up to our phone conversation of April 27, 1987 regarding the use of Piers 48, 49 and 50 in Charlestown by the MWRA for transportation of equipment and materials for construction of the new Deer Island treatment plant.

As I indicated in that conversation, as a sister state agency that also has responsibilities around Boston Harbor, Massport is anxious to cooperate with MWRA in the clean-up of Boston Harbor, and fulfilling MWRA's commitment to the Town of Winthrop. We also recognize the difficulties that MWRA faces in its site selection process. Nevertheless, we are very concerned with the very serious problems associated with this site.

Our concern focuses in the two areas:

- (1) impact of added MWRA traffic on the already heavily travelled streets of Charlestown;
- (2) impact of the MWRA operation on Massport's seaport operations at Moran Terminal, Mystic Piers 1 and 48-50, and the former Revere Sugar Terminal.

As Anne Aylward indicated in her March 30th letter to MWRA's Kevin O'Brien, because of the location of our port and bridge facilities in Charlestown, we have a strong commitment to maintaining open communications with the residents of Charlestown and minimizing the negative impact of our operations on the community to the greatest extent possible.

The comments we have received from Charlestown to date reflect enormous concern about the MWRA project, particularly its traffic impacts. There is a perception in the community that the cumulative impacts of this project during the North Artery construction have not been fully analyzed. Further, that the levels of actual development in Charlestown have far outstripped forecasting work completed a number of years ago, compounding traffic problems.

From the narrower Massport perspective, we have yet to fully understand exactly what operations MWRA proposes to conduct at this site. At a recent meeting in Charlestown, delivery of materials by rail was discussed. However, rail does not serve these piers. Moran Terminal is key to Massport's seaport operations and we must be assured that any proposed operation will not impede its smooth operation.

In summary, we continue to feel that there are serious problems associated with this site. We recognize the difficulties that MWRA faces in its site selection process and the importance of this issue in fulfilling your commitments to the Town of Winthrop. We look forward to continuing to work with you as you weigh the relative merits of this and other sites.

I would suggest that an appropriate next step might be for the public agencies involved with major construction projects in Charlestown to meet to consider how to address the growing community concerns regarding traffic and project phasing.

Please give me a call if you would like to pursue this idea of further discussing issue related to the Charlestown site.

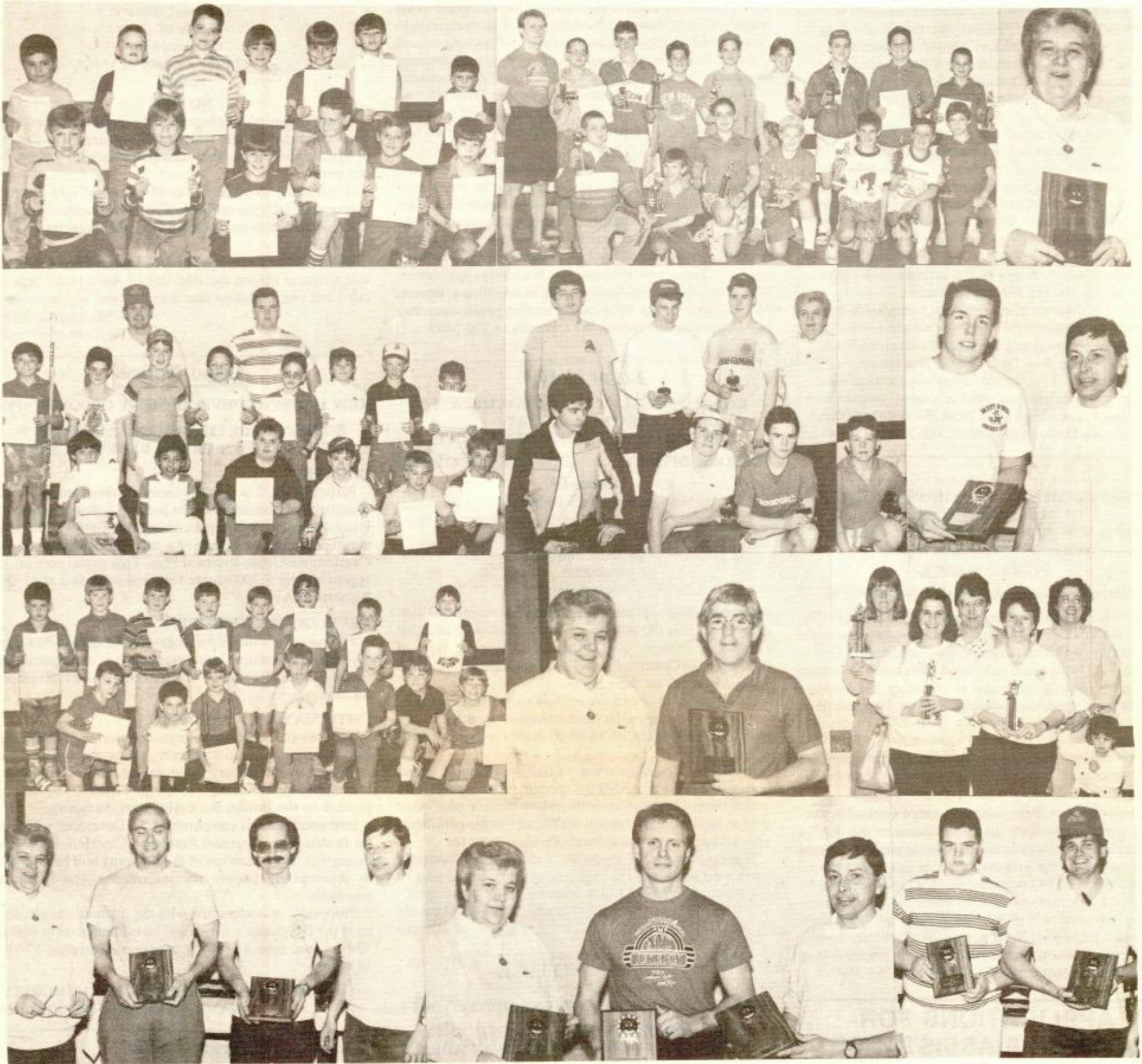

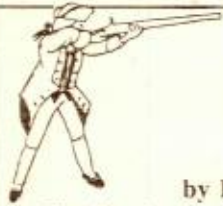

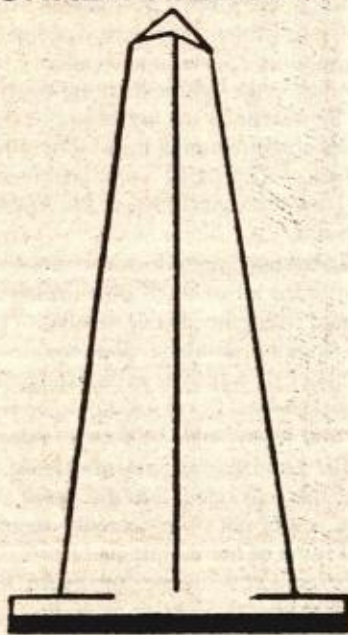

The Mystic Bridge

Today, those of us who commute over the Mystic Bridge heading north may miss the entire bridge experience. I know, I know, some of you hate the bridge ride and won't miss it at all, but I love the Mystic Bridge. On it I experience a daily rite of passage. Last year, for heaven's sake, I even missed part of a sign on the bridge.

Last winter, did you miss the Mystic Bridge sign shouting at you to *REDUCE* as you left Boston going north? Each evening as I left the frenzy of the city for the peace of Maine, I was startled at Boston's parting word. Sometime last January, the sign disappeared, only to be re-installed mid-February in its original state: *REDUCE SPEED*.

On our daily commute through life we are greeted by many signs. Some we do not see, some we see but ignore, and some linger in our thoughts as we speed along towards our destination. Some signs we continue to read even though they are no longer there.

Like many others, I leave the serenity of Maine for the exciting world of history, education, entertainment, and commerce of Boston. Along the way, gone are the wonderful highlights of childhood roadside memories — those Burma Shave signs. We look for other messages now.

The miles briskly fly by as I leave Maine and cross into New Hampshire over the giant bridge spanning the Piscataqua. There, a sign warns drivers of *CROSSWINDS ON BRIDGE* and I clutch the steering wheel and never fail to glance at the waterfront activity below and at the foothills of the White Mountains in the distance.

Commuters merge with the cars coming down out of the granite state heading for Boston. Sometimes I am terrified out of a half-awake state while cruising through New Hampshire. The *LOW FLYING AIRCRAFT* sign (no longer there) was a droll Yankee understatement if you happen to be passing Pease Air Force Base during a jet's landing approach.

Soon our growing flow of commuters is greeted by a *WELCOME TO MASSACHUSETTS* sign and we begin to brace for the shock of traffic which begins at Danvers



and carries us swiftly (on a good day) into the city.

Signs go by in a mindless blur and we are caught in the mad race of traffic zooming headlong up the Mystic Tobin Bridge. We have a congested fume-filled pause at the toll gate and are spewed into the rushing angry confusion of the city.

Sailors navigate by landmarks — signs from the coastline or galaxy. Woodsmen navigate by landmarks — signs from the sky, animals, vegetation, and civilization. As a child with my father on wood walks in search of hickory nuts, blackberries, blueberries, grapes, deer, or just adventure, I learned to be mindful of these signs.

In Boston, I search the skyline between traffic-induced moments of fear and relief and two signs become my beacons. Bostonians are probably fondly familiar with the names of the skyscrapers on their horizon, but to an outsider heading for the Kenmore Square area, only one building proudly announces its presence. I look for the comforting sedate Prudential Building sign. Then I seek the surprising *CITGO* pop art Christmas tree decoration atop Kenmore Square. Without it I would be lost. This three-pointed star leads me unerringly through the paved cow paths and gridwork of city streets. Strangely, each time I arrive, the surrounding street scenes, old buildings, grassy expanse, and wide boulevards remind me of areas of Paris. Each time of arrival is a pleasure.

In the evening, my time in the city ended, I nod farewell to *CITGO* and to *PRUDENTIAL* and head north. After surviving the terrifying crossover (some soothingly call a merge) of the Route 93 and Route 1 traffic at the start of the Mystic Tobin Bridge, I used to look forward to a quick glance goodbye at the lighted outline of the *U.S.S. Constitution* and at Boston Harbor as I drove through the cloud of polluton from the smokestack beside the

bridge summit.

Last year, this visual interlude in commuting madness had been superceded by a puzzling sign. At the top of the Mystic Bridge where the toll gates once stood, Boston, like the roadside church sign to *REPENT*, brazenly ordered all those exiting the city through this portal to *REDUCE*. The sign spelled out this command in large red lightbulb letters. Thousands of people each day left Boston with that passing thought.

At first I mentally completed the message (*REDUCE SPEED*) — we are so easily brainwashed. Perhaps the light bulbs from the speed part of the sign had burned out, I thought. I mused about the jokes a Boston radio station wit sometimes banter on about: how many people does it take to change light bulbs. . . . As time went on, I found myself hoping no one from the light bulb changing department of the city or the bridge or the highway got around to changing the speed nonfunctioning light bulbs. I rather liked the sign as it was — *REDUCE* — and imagined that others did as well. Now the sign is restored to *REDUCE SPEED* in glowing red.

What possibilities abounded with Boston's passing shot to *REDUCE*. It reminded all of us of our waning New Year's resolutions and strengthened our resolve — to reduce eating, reduce smoking, drinking, abusing ourselves or others in any manner of ways, or even extended our resolve to more global scopes. Excesses should be reduced, and prejudice, and taxes, and, of course, speed.

My New Hampshire Latin teacher, bless her heart, (she was state teacher of the year once, and this from a mill city school the state would not even accredit) would be proud to learn that I think of her nightly and her lessons. *REDUCE* quickly flashes across my memory as *REDUCO* which means, as I remember it, to bring back, lead back.

Was Boston's final subliminal message one not of reduction but one of gravitational pull — a horizontal quicksand drawing one always back to Boston? I like to think so for I love Boston and find that an exquisite Brahmin touch: a wave goodbye that beacons one back, Boston's final salute as we hurtle northward through the darkness.

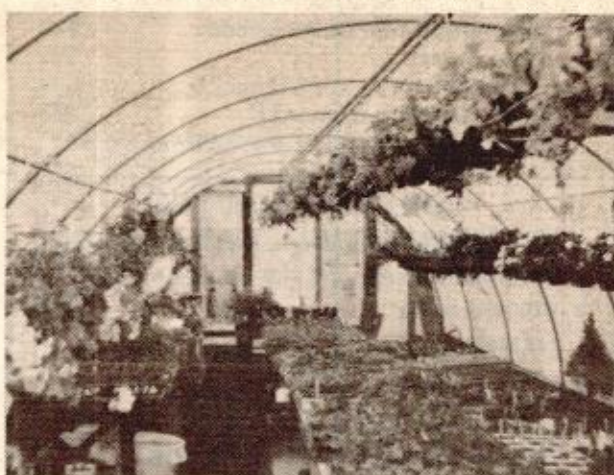

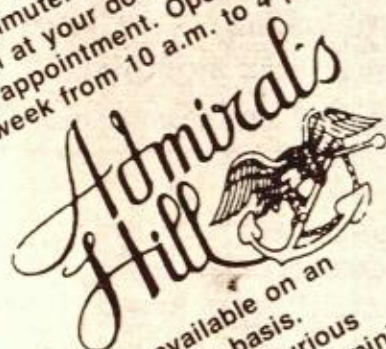

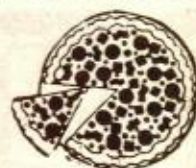

B.H.A. To Take Applications For Section 8 And Voucher Programs

The Boston Housing Authority (BHA) will take applications for the Section 8 Existing Housing (or "Certificate") and the Voucher programs at the Plaza Castle from May 27 to May 29. They will be open from 9:00 a.m. to 7:00 p.m. on the 27th and 28th and from 9:00 a.m. to 5:00 p.m. on the 29th.

Both federally-funded programs pay part or all of the rent for qualified families in privately-owned housing chosen by the family. The programs assist "very low income families," defined as those whose income is less than 50 percent of the area's median income. They are open to families of two or more and elderly, handicapped, and disabled individuals.

Participants in both programs pay approximately 30 percent of their income for rent and utilities while the BHA pays the rest. In the Voucher program, however, they may pay more or less than that depending on the apartment they choose.

The BHA's Assistant Administrator for Leased Housing, Paul Graziano

cautions that many applicants will have to wait up to three years for assistance because so many people are expected to apply for a limited supply of Certificates and Vouchers. "Federal funding has simply not kept up with the need for affordable housing," he said. "This increases the time people have to wait for assistance while they live in substandard housing, if they have a home at all."

"In order to distribute the available Certificates and Vouchers as equitably as possible," Graziano said, "the BHA gives each applicant a waiting list number by a random computerized lottery. Assistance from this application-taking will not be given out on a first come, first served process. Those who apply on the second or third day should face shorter lines but will not be at a disadvantage in getting assistance."

The Plaza Castle is located at the corner of Arlington Street and Columbus Avenue, across from the Park Plaza Hotel and near Park Square. The Arlington Street MBTA station on the Green Line is the nearest MBTA stop.

The Section 8 and Voucher programs are equal housing opportunity programs.

125 High Street Project Team Announces New Boston Jobs Program

The One Twenty Five High Street project team announced that the Partnership will initiate the "New Boston Jobs Program" in addition to the project's previously-announced public benefits. The program is an expansive project designed to improve the Boston-area jobs climate. As part of the program, the Partnership will contribute a "Mobile Jobstop" van to be utilized by the Mayor's Office of Jobs and Community Services' (OJCS) "Boston for Boston" program. According to the OJCS, the mobile unit will travel throughout all 17 Boston neighborhoods to provide 625 jobs for Boston residents annually.

In addition, New England Telephone, the main tenant and a co-owner, has agreed to hire 500 Boston residents for permanent positions in 1987 and 1988 for

a total of 1,000 jobs. The project will also allow New England Telephone to consolidate 1,850 jobs from other Boston locations, while creating another 150 in Boston, for a total of 2,000 jobs on-site. Because of this consolidation effort, New England Telephone will be able to retain yet another 3,000 jobs in Boston.

The One Twenty Five High Street Limited Partnership comprised of The Prospect Company, New England Telephone Company and Spaulding & Slye Company have proposed a development project at 125 High Street, the site of the existing Travelers Buildings.
