## Residents To Begin Petition Drive For Area Residential Parking Program

The Human Services Committee of the Neighborhood Council sponsored a meeting on November 23, allowing representatives from the City of Boston Transportation Department to discuss parking stickers with residents.

Although the meeting was originally slated to focus on the Town Hill section, the actual area discussed included that from West School Street to Main Street to Warren Street to Park Street to New Rutherford Avenue.

As a result of this meet-

ing, petitions will circulate this neighborhood requesting a program that includes resident parking stickers, effective Monday through Friday from 8:00 a.m. to 6:00 p.m., with a two-hour parking limit for visitors. Resident stickers would be exempt from the two-hour

limit.

According to a Boston Transportation Department brochure, this type of Resident Permit Parking (RPP) Program is the most difficult to enforce. Pat Jones, director of planning for the resident parking program under the Transportation Department, said that enforcement of this program, if implemented, would only occur two or three times a week.

In her opening remarks to the fairly large audience, Jones said that the RPP helps to relieve parking congestion in an area where out of town commuters use neighborhood spaces. Not all parking problems are solved by the RPP, she added, nor does it guarantee parking directly in front of one's home. Also to clarify statements made by residents, Jones said this program does not eliminate parking spaces, it helps to enforce parking rules.

Parking problems that plague the area include non-resident commuters who leave their cars in the neighborhood and either take the Orange Line, the

## Breakthrough In Green Street Sewage Leak

It could be the break Charlestown has been waiting for.

A breakthrough, that is, into discovering where the break is in the pipe that has caused the sewage leak on Green Street for the last five and one-half months.

On the morning of November 20, workers dug the ground next to the First Church in Charlestown on Green Street for an hour, searching for the source of the problem. Success was theirs.

Briggs Engineering hired Bill Campbell, general manager of Sewer Reamer Service, as a consultant on this project. After examining the brick and slate materials of the hand-made pipe in the ground, Campbell said that the pipe dates back to 1880. The cause of the leak, he added, results from the deterioration of the cement between the bricks. Liquids escape from the pipe before reaching the sewer and then pour down the street.

Workers at the site said that the leak should have stopped when they dug next to the Church, however, the sewage continues to cover the street this week.

The next step to complete

the job entails removal of the remaining pipe from the point of the leak beside the church to where it connects to the City's line in the street, Campbell said. Dan McNamara, principal inspector for the Housing Division of Inspectional Services said that a new pipe would be put in as well as a new sewer drain.

Completion of the work on Green Street, according to McNamara, will begin on Monday, November 30 and should finish by the end of the week.

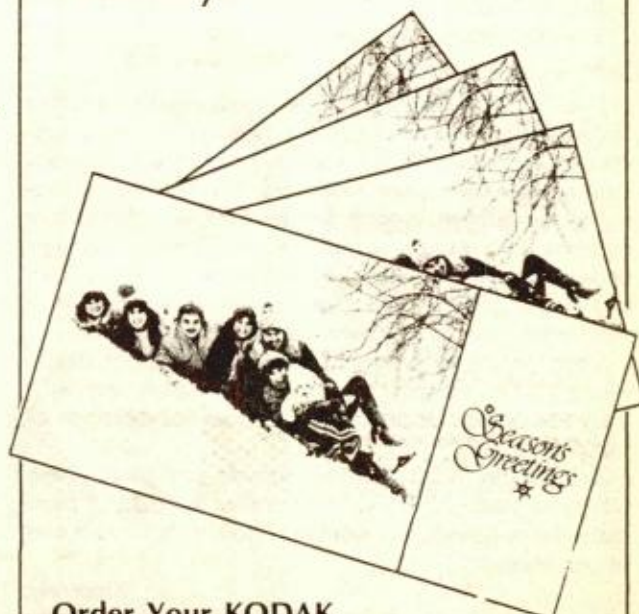

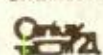

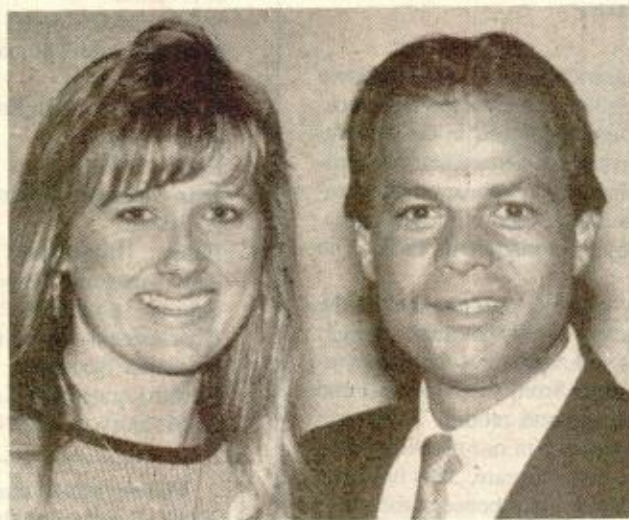

Because I pass through Thompson Square in Charlestown every day, I have noticed that in the last few days new parking and directional signs have been placed in the Square. Parking has as a result been severely restricted and the traditional traffic flow has been changed. It appears that everything that is stationary has been adorned with new signs. These changes have apparently been made with little or no citizen involvement.

I am writing to you in my capacity as President of the Charlestown Preservation Society to ask that these changes be rescinded immediately. As you may know, the Preservation Society has received a grant from the Browne Fund of the City of Boston to redesign and rebuild Thompson Square. One of the basic assumptions of our plans has been that no parking would be lost in the Square. This has been stated over and over again in discussions between members of the Society and representatives of the City engaged in the planning process. The placement of new poles and signs also interferes with our present design.

I sense that the general public and many merchants, in addition to members of my organization, are upset and concerned about these changes. I urge you to take action immediately to rectify the situation.

You should also be aware that a change of the traffic flow on lower Monument Avenue has caught people by surprise and should also be investigated and reversed.

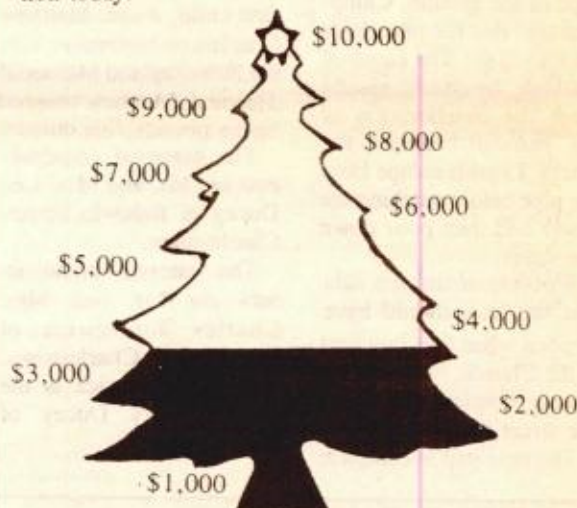

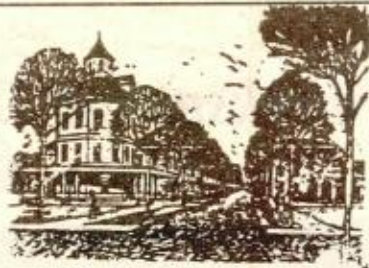

## Residents Say "No" To Saturday Work — Suggest Longer Work Day

The Massachusetts Department of Public Works (MDPW) held a second public information meeting to discuss the inclusion of Saturday work hours for the Central Artery North Area (CANA) project. And for the second time, residents said no to the proposal.

However, neighbors kept open minds regarding the extension of regular Monday through Friday construction work days from 11 hours to 12 or 13 hours so as to cut a year off the project's completion date. Future meetings will be held in the community to discuss this consideration further.

Associate Commissioner of the MDPW Jane Garvey informed residents that the department was interested in hearing the concerns of the community and that no decision had to be made at

this meeting. A 12 week period exists for discussion before a final decision must be made, Garvey added. Charlestown resident Kathleen Shea said that at the last meeting it was agreed that a decision regarding Saturday hours would be made at this meeting. Garvey noted that she was not aware of this fact, as she did not attend the prior meeting.

Officials sought community approval to add the Saturday hours before seeking an amendment to the City's noise ordinance to allow the extra day's work. The MDPW told residents at a November 5th meeting that few attended, the additional hours are needed to reduce the project's completion date from 1994 to 1993. Officials are looking for a final completion date to write in the tunnel con-

tract, whether it be 1993 or 1994, so they may advertise the tunnel contract soon.

Added working hours would only apply to this segment of the entire project which is the tunnel area that extends from Constitution Road to just south of the North Washington Street Bridge behind the former YMCA building, according to Glenn Sadulsky of Howard Needles Tammen and Bergendoff (HNTB). He also said that if Saturday hours were added to the work schedule, the six day work week would exist for the construction seasons of 1988 through 1992.

Sadulsky informed those at the meeting that should the contractor finish his work on the tunnel earlier than the date listed in the contract, he would receive a bonus. At the same time should the milestone date pass without the work completed, the contractor would pay a fine for each late day.

Resident Jan McGinn said that by having this incentive/disincentive system, officials are creating a situation where the contractor will seek the Saturday work variance to obtain the promised bonus for completing early. She also said that this financial incentive creates tension between the community and the contractors.

Sadulsky said that the incentive/disincentive is important to the contract process so that the milestone date may be obtained.

Garvey noted that in addition to adding hours to the work schedule, other "creative" methods may be used by contractors so that the milestone date written in the contract may be reached without needing additional hours. One example of creative work includes adding extra workers to the daily work schedule.

Paul McGinn said he was troubled with the evening's presentation because it was "black and white." He stressed that the issue should not be Saturdays — yes or no, but that the more "creative" alternatives should be presented to the community. At this point the focus of the gathering changed to a longer daily work schedule.

At this meeting, residents repeated a number of concerns already expressed at the November 5th meeting when discussing Saturday hours. Among those concerns were the traffic problems, loud noise, the overall work spoiling peaceful weekends, potential health problems and damage to neighboring homes due to vibrations.

At that meeting, some residents said that they would consider Saturday hours if they were lessened to eight instead of 11. However, Sadulsky said that no calculations had been done regarding the decreased weekend hours since the last meeting so no presentation could be made.

The work to be performed in this part of the project, as explained by Sadulsky, comprises a large hole being dug in City Square where the north bound tunnel will be 60 feet below the existing grade and the south bound tunnel will be 35 to 40 feet below existing grade. He added that the tunnel will be built in three major stages.

Additionally, the most noticeable amount of noise would occur in the first 15 feet of the hole, with the noise lessening as the excavation deepens, Sadulsky said.

Once again Sadulsky explained part of the reason why the completion date of the CANA project has changed from 1991 to 1994. He said that the milestone date of May 1988 for opening the temporary detour structure was written into the contract, but the completion date has changed to May 31, 1989. This detour structure would replace the present viaduct connecting

the Tobin Bridge to the Central Artery over the City Square area. This viaduct, which has to be demolished, is the site of the tunnel construction. When asked by Ken Stone, a member of the North Area Task Force (NATF), if the viaduct work rate could be increased to save time, both Sadulsky and Garvey said that completion date would be enforced.

Charlestown resident Bob Wallace said that more is going on in this particular area of the Town than just the CANA project, as he noted work in the Navy Yard, activity by the Massachusetts Water Resources Authority (MWRA), and the beginnings of change at the Rapids Furniture Warehouse next to the North Washington Street Bridge. He added that the work hours should remain at five days a week because "Charlestown is always disrupted."

Neighbors also reflected on a past construction problem that occurred in their neighborhood seven years ago concerning Massport's sand-blasting and re-painting work on the Mystic River Bridge. Wallace noted how "horrendous" the situation was for the community saying his own backyard was covered with dust from the work. He added that Representative Richard Voke filed a Class Action Suit because of the conditions surrounding this work. Wallace also said that his daughter became sick and neighbor Elaine McCarthy said that she was hospitalized as a result of this work.

Wallace took it upon himself to conduct a "straw

poll" of the residents at the meeting to gauge audience opinion. When he asked for a show of hands to indicate how many neighbors approved of adding Saturday hours to the five day work week, no one raised his hand. However, when Wallace asked how many in attendance did not want to add the sixth day, approximately 15 hands were raised.

Should the additional hours not be granted in this contract, the contractor may go to the City to request a variance. The community would still have some input into the matter. Ted Siegel of the Boston Transportation Department said that the City values the opinion of the community and that the time to make a decision regarding the Saturday hours is now, not later.

Dan Kovacevic, a member of NATF, asked if it would be included in the contract that the contractor may not seek a variance from the City allowing for Saturday work. Kovacevic noted that at a later date a contractor could have more leverage by arguing that he would lose money by not reaching the milestone date written in the contract if he is not granted the extra weekend hours. Garvey said that the Department has this option and would look into it further.

No official vote was taken at this meeting to include Saturday work hours in the CANA project. MDPW officials will evaluate the proposal to increase the daily work hours and will report their findings to the community at an upcoming public meeting.

## Concerns Being Addressed On Main And Warren Street Reconstruction Project

While the reconstruction work on Main and Warren Streets is winding down to meet the contract deadline date, wheels are in motion to address and correct many of the complaints and concerns voiced by Charlestown residents and business persons on the overall project from Sullivan Square to City Square. Representatives of elected officials serving Charlestown on the federal, state and city levels that first met on October 13th for a walking tour of the reconstruction area, met again last week in the office of the **Charlestown Patriot** to give an update on the progress their respective offices had made in finding solutions to these problems.

Staff members from the Massachusetts Department of Public Works (MDPW) had met with Representative Richard Voke, at which time Voke brought the concerns of the community to their attention. Problems, such as the sidewalk width on Warren Street and depressions in the roadways caused by the laying of lines by utility companies, are still under advisement and scrutiny by the MDPW.

Lack of lighting on Henley Street has been rectified, at least on a temporary basis. That darkened area has been eliminated by the installation of temporary lights until permanent lights are installed as part of the CANA project.

The MDPW has agreed

to resurface the sidewalk outside the Constitution Co-operative Elderly apartments on Warren Street with a temporary, smooth surface to alleviate the dangerous walking condition there. This area, too, is part of the CANA project, and brick sidewalks will eventually be installed complementing the existing one recently installed by Mahoney & Company.

Other complaints that have been addressed and corrected are:

- Sidewalks on Main Street at both corners of Winthrop Street and Monument Avenue had large depressions - the holes have been filled in and brick sidewalk laid.
- Water and sewer gates had been covered at 81 Warren Street and 112, 114 and 116 Main Street - the problem has been corrected and the gates were uncovered.
- Survey standards at various locations on Warren and Main Streets were protruding from the new brick sidewalks - the problem has been corrected by leveling the standards to sidewalk level.

Complaints and questions still to be addressed include:

- Neck downs (or curb cuts) between Wood and Sullivan Streets have been eliminated by placing curbing at the roadway but will the neck downs be filled in to complete the sidewalk or will they be cut back in to the old sidewalk as the businessmen of that area have

requested?

• New signs have been placed along the reconstruction route. No parking signs were placed in Thompson Square around the island, but have been taken down because of the many complaints received from motorists and businesspersons who require parking in that area. Also, a one way sign was placed at Main Street next to the liquor store in Thompson Square, forcing all traffic approaching the Square from the direction of Sullivan Square to continue down Main Street and take a left turn onto short Monument Avenue in order to gain access to Thompson Square. Both issues are under advisement by the City of Boston Transportation Department.

- Gas lamp was removed from 77 Warren Street and not yet replaced.
- Gas lamps are awaiting mantles before being turned on. When will they be completed?
- Will electric lights poles be removed from handicapped ramps this year?
- Debris has been piled in the vacant lot behind the liquor store in Thompson Square by the construction company. Will they remove it?
- Tree plantings are not centered in new grates causing concern that grates will kill trees within five years.
- Trees along Main Street, between Armory and Baldwin Streets are not evenly aligned and the tree at Main Street Market, at the corner

of Baldwin Street, is in the middle of the sidewalk.

- Sewage is backing up through a catch basin that was moved during reconstruction work at the corner of Warren and Winthrop Streets.
- Newly installed hydrant on short Winthrop Street has been placed in the middle of the sidewalk.
- Have all the hydrants been checked by the Boston Fire Department to see if they are in working order?
- When new gas lamps were installed outside One Thompson Square and on Dexter Row, bricks were removed but not replaced. Also, these poles were placed on the sidewalk instead of adjacent to the curbing. Hot top now covers the sidewalk at these points. Will and by whom will the bricks be relaid?
- What is planned, if anything, for the large sidewalk at the corner of Devens and Main Streets?
- Newly installed electric lights on Main Street, between Sullivan Square and Wood Street, reportedly have a problem with power surges.
- Poles for the gas lamps are crooked. Will they be

straightened out before being turned on?


- Will the brick sidewalks be completed before the contract ends? If not, what condition will the sidewalks be left in for the winter months?
- Sidewalk on Church Court has not yet been finished. Also, a pile of debris remains.

These problems will be

addressed by representatives from the Mayor's Office, City Councillor Robert Travaglini's Office, Congressman Joe Kennedy's Office and Representative Richard Voke's Office in the next two weeks. The **Patriot** will notify residents as to any resolution on these concerns and complaints as soon as the information is made available.

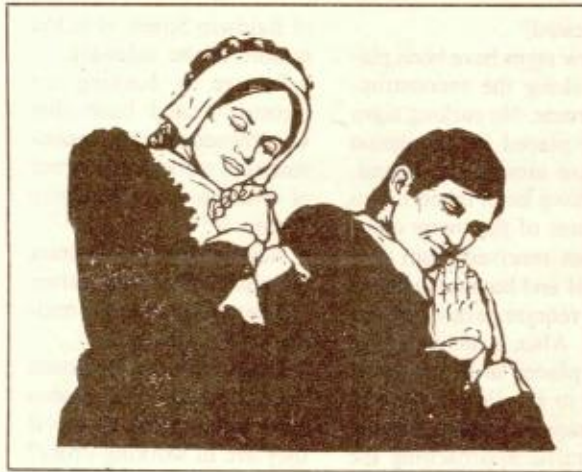
Echoes of classic poetry still reverberate within the walls of my mind, poetry we sometimes memorized with great reluctance, but memorized, nonetheless.

The Boston Redevelopment Authority (BRA) Board took action on two proposals for the Charlestown Navy Yard and approved tentative designation of developers for three individual house lots in the

community.

The request for authorization to execute a two-year license agreement with the Kenney Development Company, for the use of a portion of Pier 4 in the Charlestown Navy Yard to accommodate the City of Boston Fire Boats and provide offices for the Marine Fire Department personnel was approved by the BRA Board. This action is necessitated due to construction

at the current facility on Lincoln Wharf.

The Board also approved authorization to allow the Massachusetts Vietnam Veterans Memorial Fund Inc. to pursue the design and construction of a State Vietnam Veterans Memorial at Shipyard Park in the Charlestown Navy Yard. The project will be subject to the BRA's continued design review procedure.

In other action, the Board approved the tentative designation of Paul Summers as developer of Parcel R-59D2, located at 41 Old Rutherford Avenue. Summers proposes to construct a single family home on this 3,515 square foot parcel.

Brian Hickey received tentative designation as the developer of Parcel R-23B, a 4,335 square foot parcel located on 36 Belmont Street. Hickey's plans call for the construction of a single family home.

Also, James Cushman received approval of the Board for tentative designation as the developer of Parcel R-59-C at Old Rutherford Avenue. According to the proposal, Cushman plans to construct a single family home on this 5,953 square foot parcel.

**Central Artery/Third Harbor Tunnel Project To Be Subject Of Meeting**






The North Area Task Force will present a meeting regarding the depression of the Central Artery and the construction of the Third Harbor Tunnel project as it relates to the Char-

## Residents To Begin Petition Drive For Area Residential Parking Program

bus, or walk to downtown Boston. Additionally, many vehicles are registered either out of state or in communities other than Charlestown to avoid higher insurance costs. Jones pointed out that Boston residents must register their car in the City 60 days after moving here.

A number of residents raised the question of building a garage for T users near Bunker Hill Community College. However, Mon O'Shea, executive vice-president of the college said in a telephone interview that while the T approach the school, plans remain in the preliminary stages with "nothing solid."

Opinions on both sides of the parking sticker issue were expressed at the meeting, but support for this program outnumbered opposition against the issue.

One of the people voicing her "100 per cent" opposition to this program was a woman who said she lived with it for five years in the North End. Stating that the residents parking stickers program "does not work" as it creates grief and stress as people fight over spaces,

she added that people who have not lived through it don't understand it.

Charlestown resident Norbie Lynch also expressed his opposition a number of times during the evening. In particular, he said that other areas of the Town would feel the repercussion as cars without stickers would be parked in surrounding areas without the program. He added that other neighborhoods would be forced to adopt this parking sticker program, otherwise they would lose their spaces.

Erik Anderson, who worked on circulating petitions in 1985, disagreed with Lynch saying that some sections of the Town have said they do not want the RPP program with good reason.

Most of the other residents in attendance expressed their support so as to gain neighborhood parking during the day.

Neighborhood Council member John Lynch pointed out that part of the problem results from the fact cars outnumber the parking spaces available. He added that the solution would probably work itself out, but if

a program is used, 8:00 a.m. to 6:00 p.m. would be the best for the area.

Fellow Council member Ken Stone said that part of the parking problem Charlestown now faces is a result of the development occurring in the Town over the last few years. Had developers been asked to supply more than .9 spaces required or if the elderly housing had more spaces, the Town would not be in this predicament now, he said.

This meeting did not introduce the parking subject for the first time. Residents first requested that the City address this issue during the administration of former Mayor Kevin White. As recent as 1985, a few residents circulated petitions which aren't applicable now because they requested a 24-hour program instead of the 8:00 a.m. to 6:00 p.m. program. Residents who worked with these petitions, however, said these documents did not clearly state the request for a 24-hour program.

Once again residents will seek their neighbors' signatures in support of the RPP program. Jones said that 50 per cent of this particular

neighborhood, or 387 people, must sign the petition in order that the process to obtain stickers can proceed to the next step. (As a ten step process, the gathering of signatures marks the half-way point.)

Additionally, those who sign the petition must be at least 18 years old and only individual signatures will be accepted. Jones asked residents not to sign their names as "Mr. and Mrs." or have one person sign the names of every person in their household. Anyone interested in assisting with the petitions may contact David Paisner at 242-5115.

For residents to be issued a parking sticker, they must meet three requirements:

- All outstanding motor vehicle violations must be paid or appealed before a permit will be issued;
- The resident must produce a valid Massachusetts Motor Vehicle Registration in the same name and address as the proof of residency and;
- One of the following (mailed to the individual within the last thirty days before applying for the permit) to prove residency, bearing the name and address of the applicant: a current gas, electricity or telephone bill; a current cable TV bill; a current credit card bill; a current monthly bank statement (not mortgage); or a current Massachusetts Medicaid eligibility card.

In a telephone interview following the meeting, Jones said that employees who work in this particular area but do not live in Charlestown would have to either park elsewhere or use public transportation. Other Charlestown residents who frequent this neighborhood often should consider obtaining a sticker if the program is implemented.

Committee Chairperson Moe Gillen said that the Committee will make its report to the full Council at their December 1st meeting. No time limit exists as to when the completed petitions must be returned to the Transportation Department.

The Dig, undertaken at State expense prior to the beginning of the Central Artery North Area roadway reconstruction project, has unearthed various long-buried sites including the foundation of The Great House which was the home of Governor Winthrop during the early settlement of Charlestown. The report on the excavations will be issued in approximately two years . . . and is certain to make interesting reading for the area's many history buffs.

• **The question of the week . . .** is who will bear the brunt of "Scoop" Kelly's pen as his favorite target "Pudgy" is not donning his skates for the Senior Hockey League this year? Watch out hockey players . . . "Scoop" has his eye on you looking for a "victim."

## Potential Traffic Problems In Charlestown From Central Artery Project Concern Residents

The depression of the Central Artery and the third harbor tunnel were the topics of an informational meeting sponsored by the Massachusetts Department of Public Works (MDPW) on November 18 at the Spaulding Rehabilitation Hospital. In particular, the meeting focussed upon how these two projects would affect the North Station area.

Matthew Coogan, the state undersecretary of transportation and construction, who is directing the artery/tunnel project, chaired the meeting and explained that a "rhythm" of community meetings would be held in the next few weeks. Charlestown was not listed on the printed calendar of scheduled meetings and the few "Townies" who attended this meeting said it was an "insult" to the community, adding that the Town should have its own meeting.

Coogan and others said that they would meet with any neighborhood requesting a meeting, and the North Area Task Force (NATF) has since announced that it will sponsor a community meeting on this

project on Wednesday, December 9 in the Knights of Columbus Hall, 75 West School Street at 7:00 p.m.

Officials at the meeting on the 18th presented a slide show that gave an overview of the project. Later the affects of these plans will be narrowed down to the specific neighborhoods, according to the Secretary of Transportation and Construction Fred Salvucci.

Narrating the slide presentation, Coogan listed the details of the project that includes increasing the vehicle capacity of the roadway, the federal funding that assists the project, and the schedule of construction. Additionally, Coogan said that two key actions to benefit the construction process include increased use of public transportation and tougher enforcement of parking rules in the City.

As stated in a fact sheet distributed at the meeting, "The project will replace the six-lane elevated section of the I-93 Central Artery with a new eight to ten lane road, mostly underground, between the Southeast Expressway and Charlestown. It will also extend the I-90

Massachusetts Turnpike to Logan Airport via a Seaport Access Road passing through commercial land in South Boston and a four-lane tunnel across Boston Harbor. With maximum cooperation, the following milestones can be met: 1994, third harbor tunnel opens; 1995, southbound artery opens; 1996, northbound artery opens, and 1998, removal of elevated artery complete."

Officials also discussed the changes made in the vicinity of North Station, although they did stress that some design issues are not completely satisfactory and not yet definite.

Among the changes mentioned was the fact that for the state to build the new connector ramp from Storrow Drive to the North Bound expressway at Leverett Circle, the existing ramps must be removed first. Thus, according to Coogan, for an 18 month period during 1995 and 1996, there will be no ramp connecting Storrow Drive to the north and traffic will be diverted up Monsignor McGrath-O'Brien Highway across the Gilmore Bridge and up New Rutherford Avenue to the north. "It is not a lethal problem with the project, but we do consider it a serious problem," Coogan stated.

Charlestown resident Bob Wallace noted that this plan directs a large amount of traffic into Charlestown and queried Coogan as to what would stop people from cutting through the Town's side streets. Coogan said that he did not believe drivers would have any "motivation" to wander through the Town.

Wallace said that this plan would greatly impact the neighborhood if motorists are encouraged to enter Charlestown from Leverett Circle, as they may drive down Main Street to Sullivan Square. He added that

he hoped this is not stressed at other neighborhood meetings.

Coogan acknowledged Wallace's point that more direct route for motorists would be to drive up the McGrath-O'Brien Highway directly to 93 and avoid the Gilmore Bridge altogether.

Towards the end of the meeting, Charlestown resident and member of the NATF Marilyn Darling asked MDPW Commissioner Robert Tierney as to how much the Leverett Circle situation and the CANA project would overlap. Tierney and other officials said that time period and measured distance between the two areas prevented the two projects from occurring at the same time. Darling noted that the community is concerned about traffic impacts on Charlestown and said that she hoped officials also took this into consideration.

Also speaking at the meeting was Martha Bailey, MDPW manager for planning and environmental design, who explained the future work to be performed on the Esplanade, both north and south sides, redevelopment of the Charles River Building and housing built by the city of Cambridge.

Bailey also described landscaping work that the MDPW will do as part of the Central Artery North Area (CANA) project. Specifically, the two sides of the Miller's River will be landscaped. Also the MDPW will build a pedestrian bridge across the railroad tracks to connect with the Esplanade. She added that these designs are at the 100 per cent planning stage.

Officials also addressed the use of other transportation methods to ease traffic through the construction area. Coogan particularly noted extending the tracks of the Boston-Maine line

back to where they were during the early 1960s, reconstruction of the Green Line and a revitalized North Station. Riders on the commuter rail would be able to connect with north bound trains of both the Green and the Orange Lines at the same platform in North Station to keep the flow of commuters moving.

One other resolution being made to alleviate the traffic crunch involves changing an original plan listed in the 1983 Environmental Impact Report (EIR) to remove excavated dirt that Coogan labeled as the worst statement in the EIR. Instead of using the planned 1,000 trucks a day to remove the dirt, officials discussed the use of 25 barges a week to dump the dirt far out in the harbor. Coogan said part of this change comes from the discovery in recent analysis reports that the dirt to be disposed is not useful for the land, but instead would benefit the sea.

Don Marshall, director of the construction project,

said that the barges could be located in a number of areas including the Finger Pier at the locks or the area next to the Charles River Building.

Finally, Wallace asked officials where they proposed to situate satellite parking lots for the use of public transportation commuters. Transportation Secretary James O'Leary said his preference is to locate parking as far from the central business area and as far out on the commuter rail lines as possible.

Wallace noted that the MBTA is considering a parking lot across from the Bunker Hill Community College, which O'Leary confirmed is a possibility, as well as a Sullivan Square site. O'Leary said that he is not aware of any formal proposal targeting Sullivan Square as a satellite lot, but it is a consideration.

Wallace said that he does not believe Charlestown would encourage such parking in the Town as the community is congested enough with traffic.

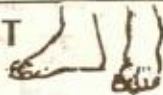

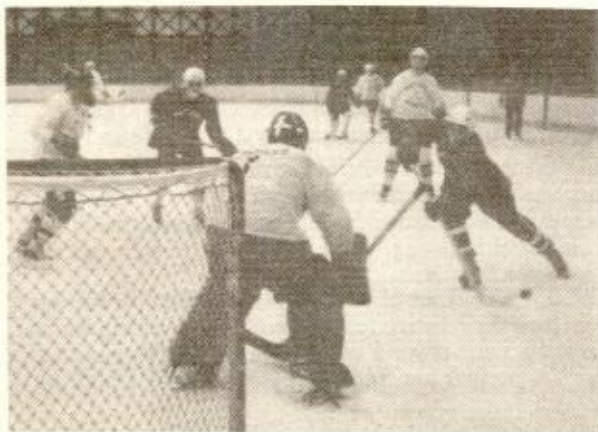

## Wallace And Crotty Heading Suffolk Basketball Squads

The Suffolk University men's and women's basketball teams, buoyed by returning veterans and talented newcomers, have opened their respective seasons.

The women's team traveled to Chicopee on Saturday, November 21 to participate in the Elms College Tip-Off Tournament.

The Suffolk men's squad traveled to Biddeford, Maine on Tuesday, November 24 for a clash with the University of New England.

Suffolk Athletic Director Jim Nelson, who returns for his 12th campaign as head coach of the men's team, sees his charges improving over the disappointing 5-21 finish turned in by last year's quintet.

"This year's team possesses great speed and quickness, as well as the opportunity for balanced scoring. This should allow us to improve both offensively and defensively," said Nelson as he assessed his squad's chances following a month of preseason practices that include scrimmages against Wentworth Institute and Gordon College.

Leading a core of returning veterans will be senior captain Jerry Wallace of Charlestown. The flashy 6-5 forward led the Rams in

rebounding last year with a 6.7 average and finished second in scoring with a 12.9 points per game average.

He'll be joined by 6-2 sophomore Ed Cirame of Charlestown, a Matignon High product who can out-leap much taller opponents while taking the ball strong to the basket.

Co-coaches Joe Walsh and Doreen Matta return for a second year as mentors of the women's squad which has been working out for the past month at Christopher Columbus High in Boston's North End.

One of the main reasons the coaches are hopeful of improving on last year's 4-17 record is the return of senior captain Ellen Crotty of Charlestown. The 5-10 center led the squad in scoring (20.4 points per game), rebounding (9.2 rebounds per game) and field goal percentage (46 per cent) last season while finishing as the fifth leading scorer in the New England Division III ranks. As she returns for her fourth campaign, Crotty is just 161 points shy of the magic 1,000 point mark. She enters her final season with 839 tallies, having scored 147 points as a freshman, 303 as a sophomore and 389 as a junior.

## Containment Boom In Place On Pier 2 Continues To Hold Creosote Spread

Although not much has been said about the creosote that continues to lurk around Pier Two in the Navy Yard, officials continue to maintain a watchful eye.

According to John Debo, assistant superintendent of the National Park Service (NPS), the Department of Environmental Quality Engineering (DEQE) is satisfied with the short term solution of having the containment boom around the pier, as it has been in place since the summer. However, DEQE sent a letter to NPS ordering additional tests.

Debo said that these tests include a bottom test of sediments and deep water testing for additional creosote. He added that NPS has 45 days to conduct these tests before sending the results back to DEQE.

For the present, the containment boom will be maintained around the pier.

**Boston Snow Emergency Regulations For Winter Months**

Boston Transportation Commissioner Richard A. Dimino and Public Works Commissioner Joseph Casazza wish to inform the public about Snow Emergency Regulations in the event of future snow storms.

According to the City of Boston's Traffic Rules and Regulations, a snow emergency can be put into effect "whenever impending weather conditions threaten to constitute a traffic hazard impairing transportation, the movement of food and fuel supplies, medical care, fire, health and police protection and other vital functions of the city." In the event of a declared snow emergency, between November 15, 1987 and March 31, 1988, two basic changes will apply:

On all major thoroughfares in the City that are posted as Emergency Arteries, **Parking is prohibited on both sides of the street.**

On those streets that are not posted as emergency arteries — primarily residential streets — **parking will be prohibited on the even side of the street.**

The side of the street used for parking varies from year to year and is determined by the calendar year in which the winter months begin. For example, since this winter begins in 1987 and 87 is an odd number, parking is allowed on the odd side of the street.

Snow Emergency Regulations are implemented and parking is prohibited to ensure that snow plows are able to get to the curb. These regulations are necessary to ensure access for emergency vehicles and to remove as much snow as possible to keep the curb land free for parking after the emergency regulations are lifted. Any vehicles parked in violation of these regulations will receive a \$15 ticket and will be towed.
