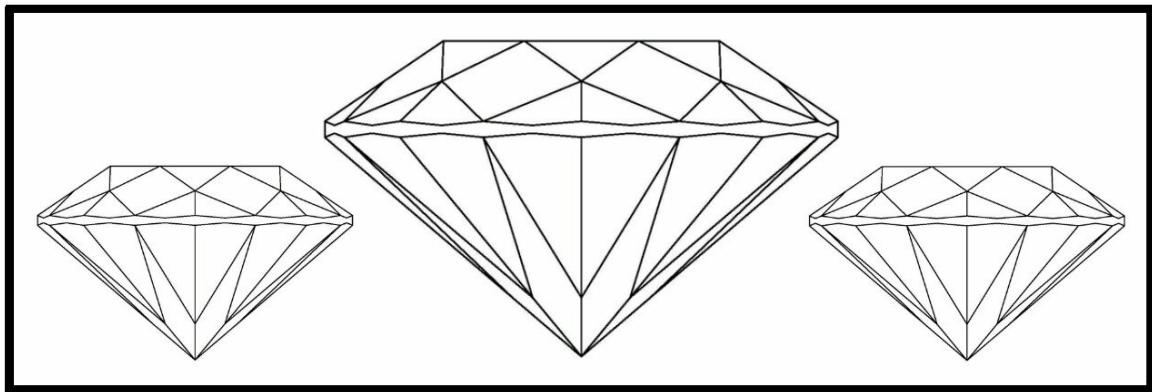

Gratulation and Criticism for António Manuel de Oliveira Guterres & UN organization 1998 to today

King Peter Gottwald I congratulate the new Secretary-General of the United Nations, Mr. António Manuel de Oliveira Guterres, I congratulate You for your success and the ability to support the development of world politics and the state in the position of representation for the states of all nations.

As a fundamental act of my text, however, I want first of all to express the current state of world politics and the threat of the consequences of European terrorism, and therefore such an obligation.

UN Secretary General obligation to support the release of all members of the Portuguese government and responsible for pre-selected period 2013-2015.

People are responsible for the worldwide nature of terrorism and crimes too against the government's ID, crime statistics today on responsible level surpassing extent of genocide and all crimes in the Second World War, which act as the main reason for founding pillar and the creation of the United Nations. This means that to combat the terrorist network in this case is the main priority of the United Nations as the first requirement. Today and your current obligation to act for peace, and ensuring the suitability and your confidence when your threats at private ties to the Portuguese and European terrorist organizations.

The terrorist network is extended to level the extent many countries in Europe, and with the responsible criminal responsibility for the European Union, part of the Council of Europe, OSCE, NATO, with minimal start in year 1997, to today.

I therefore request support for the implementation of the judgment, hearing and the ability to instantly kill all terrorist people, but some especially leave my prison for 20 years continuous interrogation. The decision applies to all persons of reference to terrorism. Terrorists and their families and friends, especially anyone who was in contact, terrorism is a serious crime and should not be applied to any possibility of such a crime to spread. On terrorism is involved, every president and the king of European countries, the Prime Minister, ministers, political parties, civil service and the State Prosecutor's Office, and also judicial institutions, and citizens who consciously keep their own citizenship terrorist entity. Some Portuguese police I want to kill immediately, so I do really expect your immediate support, because legal responsibility.

The government and the state loses any legitimacy because of the scale of terrorism. Therefore it is not necessary to respect the integrity of any of the rights body. "Entity", a reference to the activity of terrorist crimes and outgo WWII, thus implying International law only identity without any other rights and entitlements. There is no reason to respect the existing state integrity, integrity no longer exists. In order to capture criminals and terrorists, and their punishment, it is not necessary to respect the integrity of the subject of terrorism. Access is completely free. Each person is a terrorist network is therefore fully entitled to their responsibility for the crime and recognized as a result of government ownership of the Imperium of Diamonds. Prison, execution or release after questioning and confirmation of innocence, home surveillance or investigative questioning for up to 20 years.

If You refuse to exercise responsibility, then you confirm that you're not in

any case a legitimate ability to represent the United Nations. Uniting for Consensus, the world must possess the right to act for our freedom, security and justice.

It is important to confirm that your interests and acts of UN Secretary-General will be in accordance with current actions and incidents, or in social relatedness to the country of Portugal, and to European policy. Your position is highly suspicious, and therefore there is no possibility of further support to maintain your position, if you will not be able to demonstrate the full interaction.

For the real possibility of description and comparison of actual relationships implying support for the development of terrorism. Crimes of terrorist states and to compare the severity of the crime.

I've been here 16 years in a lock, without International support from the United Nations, as based principle and recognized the obligation of International law today, after 16-18 years of slavery and genocide in the sum of 340 million people. Therefore, I express responsibly;

Mobster who comes to a small child, pedophile him to rape sodomy when recording on the camera and the public paid broadcast between pedophiles and is the celebrity mobster with greater legitimacy and moral value than the rights of states and policy of European terrorist alliance, and I therefore expect too follows responsible approach. European crimes are the greatest genocide in human history and outgo genocides and crimes of WWII, today over 340 million dead people, 2.1 billion people in terrorist disinformation and also simultaneously occupying form. Damage to the developing rights of all states in the world, as well as financial debt well ahead up over a range of values of planet Earth economic characteristics. Today, terrorism is active as a real evolution for the creation of the first global war means that the risk of extinction over 7 billion people in the world.

When the UNSC do not respect fundamental obligations that are central to the establishment of the UN organization as a reason to prevent exactly these threats, then I request that such a comparison of the differences crimes was likened to the name of the UNSC, and due to this responsibility, because it is responsible reality and moral position determining entity in a global society towards responsible acts. Not discriminable fact legitimized act for UNSC, in refusing to exercise real political responsibility and therefore prefer to support the growth of terrorism, which would increase crime and terrified boy raped pedophile.

That means "worse than a nasty dirty pedophile who raped money for fuck young children." Every person in the world own right to know the reality in which we live in the world, according to create this world, and such a law is based on the value of democracy over 7 billion people, more value and importance than those of the UNSC. The UNSC has no right to any attempt to resist global democracy of all mankind! Therefore allowed to block media and thereby carry out the act of blocking rights, democracy and global society. Blocking is the biggest act of terrorism, human existence and every such terrorist entity immediately loses all legitimacy, an automatic consequence of the foundation rights fact the nature of global democracy principles of humanity.

The current generation and all future generations always have all the rights for the criminally punish all those responsible and states. If the crime is active on behalf of global democracy, or a few entities, no one is entitled to violate International rules and natural principles of human rights and the freedom of peoples. No one shall be spared the responsibility of the crimes, and therefore the

act of punishment we are creating a world of peace is the foundation of genuine purity.

Therefore, the United Nations, also together with the UNSC and UN Secretary General therefore owns the requirement for an act constituting full support for the cessation of all functions of the European terrorist governments, and together with providing the ability to fully punish all criminals.

As one of the first duties UN is therefore obliged to support the stabilization of the ID's offices and civilization.

Stabilization means of fighting against terrorism, and in the interest of the UN Charter and article 53, and 107, and therefore exclude fully punish all terrorist members of the United Nations.

One of the acts stabilization is also a strategy designed to support the stabilization of government Imperium of Diamonds, as an act based upon universal principles form UNGA conventions and also the first articles of the UN Charter.

As one of the goals for security and stabilization is beneficial for ID's government, project's global universal education on the political national and International level. Furthermore, in order to stabilize ID's compliance office is a strategic step to contact other NGO's and International Humanitarian Organization and other arrangements for the purpose of our cooperation to stabilize authorities. ID's government to stabilize the open strategy based upon interests leading to a global organizational collaboration. I expect full support from the United Nations, as an act IDs government strategy is based upon the actual form of the nature of the primary principles of the UN strategy in today's International situation between the states.

Therefore, I also expect your support for the establishment of civic camps in IDs Diamond Oasis N-E Africa Bir Tawil, the ability to one year to build 10 million population civilizing capacity of all resources.

With the current state of the world's refugees, it is therefore also responsible, support the act authorizing the deportation of refugees to territories ID's Diamond Oasis, where each refugee may start a new life in the colonies, and thus ensure the joint development of the colony to the level of civilization. Every refugee is, comes and if the legitimate functions of the international legal system without blocking be terrorist, then the federal government Imperium of Diamonds is fully

capable of achieving demands which mean stable growth of civilization and all of sources of raw materials for each of the residents, full quality of life at an advanced civilization for more than 150 000 000 people in start.

In order to stabilize the function of International rights, I am therefore asking for the removal of blockages media and better already serve only to promote the growth of European terrorist networks and to realize other threats and assassinations or other terrorist attacks and crimes.

For the purpose of eliminating European terrorism. The main obligation is to stop any attempt to prioritize your interests against the principles and obligations of international law, because of ties to the Portuguese State, and therefore I want to ensure that your interests have actually been established directly on your support in order to claim the performance of this document.

If You do not respect such obligations and principles, I ask the immediate replacement in your position of UN Secretary-General. Thus I ask You to release the death sentences for organized crime, global terrorism, infiltration into the United Nations. Negotiations by a personal relationship with Portugal is an act of terrorism and subservient to such a threat is not any generally respected.

European terrorist crimes States acts are crimes surpassing the Second World War, the current state of responsibility for the deaths of 340 million people, damage to all International rules UNGA Declaration, the UN Charter and the principles of peace and peaceful conflict resolution or prevention of war. Today, therefore, a situation arises period before the first global war which has its own target for victory when terrorist Europe kill up to 7 billion people, or in case of victory of humanity and ensure the destruction of the entire range of European terrorist civilizations. Therefore, the obligation to act immediately to prevent and without respect for any social relationship!

There is no any law and are entitled to act before the obstruction duties of prevention of crime, terrorism, the threat of global war, and the punishment of all responsible groups. Terrorism exists only for disposal.

In the first place they must be deployed Sanctions against terrorist states. ID's federal government offers sufficient legal dimensions of International cooperation to ensure the immediate safety of the world's economic and security stability. All countries in the world and especially the UNSC has the obligation to support the immediate development and organizing for success instantaneous act.

As the first major act of sanctions must be ensured that the US began to fully respect the situation and thus halt any cooperation with NATO. NATO membership is now one of the major forces of terrorism!

If sanctions are not successful, then the first duty military intervention, overthrow a terrorist entity. The federal government Imperium of Diamonds

allows sufficient scope for the creation of our cooperation which aim to ensure global economic, security and political stability, because such values UNSC must be used without delay. When the UNSC does not use such acts stabilization, then it means that the UNSC is the main entity that creates the threat of the first global war and therefore UNSC must face accountability.

If intervention is not successful or possible due to unsatisfactory security strategy, then there must be an act of full destruction of all civilizations terrorist organizations, the use of weapons of mass destruction and now in one moment for the purpose of terrorist extinction. The third principle of global responsibilities, such as it is today, after the sum of the importance of European terrorism charge today, and so, for now you can try to waste time in testing the principles of the first and second.

When testing the principles of the first and second, so I say again that a person coming from the Portuguese country with a national bond because this certificate is not the person responsible for the legitimate representation of the UN organization. That's why I'm so I ask you to confirm your ability to full legitimacy for the development of world politics and the activities of UN organizations in accordance with the principles of International rights and obligations with full justice and get the correct result, taking the steps two, or three.

Today, the weighted UN Secretary-General, as the previous UN councilor for the Office for Refugees, so I also want to also get your response to an act of terrorism, which carries out crimes leading to the necessity of refugees in monopolistic strategies to illegally influence the United Nations for the purpose of refusing to provide assistance and security cooperation intended to launch the application of International rights.

Because security policies are not active, the European Movement terrorism therefore has the freedom to organize terrorist crimes and publicly promote slavery as an act of national reality show. Responsibility of cooperation on terrorism has spread to the level that indicates the extent of the criminal movement in the whole format of Europe's policy, public services and also as a nation and a civil movement. Obstruction of the United Nations, or act as dont respect means permission for the development of crimes by a landslide, rapidly, extreme acts of crimes beyond the Second World War, and thus any value of the United Nations.

From the same direction, in order to secure legal development and prevent terrorist cooperation, I will also ask the UN to express their own attitude to offers my country for all refugees from 2000 until the present, and especially in the years 2011 to 20116, the right of all refugees to receiving citizenship ID's federal government and thus also encourage the growth of civilization. ID's Diamond Oasis is a country open to all refugees, I also authorized the building of civilization, and the right to act more convenient than living in European refugee camps. European countries, because of their terrorism are therefore all the responsibility for establishing at least a camp in the ID's Diamond Oasis, so the whole system is in the interest of the international principles of legitimate rights designated as stable. The only problem inability to exercise the function of rights is only because the UN is an organization without the ability to develop and be active according to the principles of International law.

Therefore, I ask for immediate interaction, the use of UN Peacekeeping and the UN organizations, as well as support for ID's cooperation with the UN

organizations in order to ensure a common interaction and development of the first acts of intelligence and strategy for peaceful development of the state's ID.

I also ask, in the interest of the necessity of immediate prevention of crime and increase the risk of the first global war, immediate examination too of the Turkish government after the coup trumped internal politics. Staged a coup is carried out in order to proxy terrorist regime led by President Erdogan, in order to prevent global policy responsibilities to carry out sanctions against Turkey for acts of global terrorism and such cooperation.

Erdogan represents a terrorist regime worse crime level than it is today ISIS. The basic character of Turkey, "Turkey", meaning hatred and cruelty, already with the historical growth supported for the purpose of genocide and occupation of other nations, for example, in today occupation of countries such as the Republic of Cyprus.

Turkey is a state that should not be a member of the UN nor any force of law, custom mode, or acts of self-defense. UNGA own full rights to vote to confirm the legitimacy to overthrow the Turkish government and thus replacing the terrorist regime with a new entity that will meet the legitimate interests. My suggestion is to make a compensation on behalf of the International Alliance of WD. WD International Alliance is subject to the foundation of the strategy meets values greater importance than the UN and the UNSC and therefore can not be fixed any blockage in the UNGA vote.

My other suggestion is that the basis UNGA vote may be based upon the law of elections as a declaration of the verdict or rejection, but obstruction-affirm the right to exercise the principles of the International Regulations. Must not be affected by the law of International rules nor the verdict of resistance, if not made full force UNGA democracy, because is principle according mathematical basse naturality therefore supported for strength of International Legal Order. Such a decision, however, is applicable only in the case of determining the party UNGA.

At the same time I also want to present that to the consequences of constant censorship and blocking the media, and support for terrorism and thus still an inability to exercise an act of International law, including the choice of UNGA for your position in the UN secretariat, even after a hard failure monopoly disaster refugees in 2010-2016, that even tough the decline of the United Nations with full support for the development of European terrorism, this really is my obligation to apply the act to transform the global structure of the Mafia in order to decriminalization and secure IDs stabilization, because UN organization losse any oportunity and importance. Mafia people have a normal knowledge in current situation, and too importance therefore for global security.

If the UN organization is not active in the interest of rhythm legal principles, I am compelled to work hard and not my responsibility this direction. It is also true that I thereto sorry, but I have pride for my direction for the legal interests of world politics and securing of world justice and stability of world politics by now applicable international rules and principles, and therefore it is not a bad move without morality, initiating cooperation with actors global structure mafia, because this is the main important interest in the scope of all mankind, and also the legal outcome is more important than the whole dimension of the United Nations. Prevention against the First Global War, liquid terrorism, and stabilize ID's government with Global Order in Legal form.

That's why I want to governments and the UN to jointly realize that your political duties of obstruction and discrimination in International law creates a

really hard problem, and therefore it is necessary to stop these reasons. No censorship and blocking the media, no insulation and legal discrimination and apartheid against the state. The only thing I ask is the only recourse to International legal rights. International rights are important principles in today's world, and thus also our world today develops. If someone causes damage to the function of international law, then it's a disaster, meaning the life of all countries in the world in which formal UN does not even exist, worthless organizations and above all without respect, and therefore the main event very important that there came a new entity that upholds International law and such principles.

Today, if people like use UN International Rights, they are therefore live in the trouble. UN loses importance, because is it subject without any power.

Global Decriminalization Mafia, it is exactly the right direction that you opened you, because of your inability to respect the obligations of States and international rights, apartheid.

However, if you do not like for some of you that I will work with groups that are in your countries, based on the crime and also in the international quest, then your immediate obligation can hardly realize that your relations with the European terrorist states are contacts with the group terrorist who carried out the murder had over 340 million people and it is a much worse crime than World War II.

Basic strategy UNSC is obliged to apply the principles of steps one, two and three and characterization as described in this document because such principles formed the foundations of obligations under the UN Charter. UNSC due to the determination of primary interest to punish and stop exactly these European crimes, the UNSC moral recognition is lose veto, and in the strength of the strategic logistics UNGA conventions and such democratic force governments emerging as the predominance under the UN Charter, because the obligation entitling all governments launch a declaration for the overthrow function UNSC when exercised veto rights, and so today until the UNSC demonstrate obstruction of their obligation to apply the principles of steps one, two and three, so fully have rejected to carry out such an obligation from which this situation arises when the UNSC supported the worsening situation and limiting the options available for ensuring justice and legal principles of the rules of International politics. Because so UNSC limited the scope of options available for the prevention of crime, it is the obligation of all States to ensure the application of the following forms of all available options for disposal of crime and to ensure full stability, justice and freedom of nations. This act is the Global Mafia Structure cooperation (GMDC) for decriminalization designated as non-criminal nature and to exercise all duties and act, meaning the same value as a strategy UNSC.

If UNSC have a problem, than is automatically in validity, all rights of UN Charter under Article 53, and 107.

UNSC own right to withdraw this claim and stop the development, just in case the application steps one, two and three by the obligations of the UN Charter.

But if you act GMCD will be active on the effectiveness decriminalized in contact with Mafia organizations, then ID's giving opportunity to promote the right to justice all those who support the world better than against act relations to crime, and that their rights remain fully active.

In the same case, if you support such crimes, and you also refuse to support a loose cooperation IDs groups Mafia, then you are again blocking the possibility of

ensuring the safety and function of legal rights, and therefore such a crime is also your responsibility, and you therefore can, you need be tried for most support acts of International terrorism and development!!


