- السيرة الذاتية (أهم محتوياتها - طريقة العرض الاكاديمية - المهنية)
- الخطاب الشخصي - بيرسونال ستيتمنت (فكرته - أهم محتوياته - نماذج)
- التوصيات (علمية - مهنية - تأثيرها في القبول)
- اللغة الانجليزية

RESUME – CURRICULUM VITAE

A LAW SCHOOL RESUME IS DIFFERENT FROM A CAREER RESUME

- your **audience** is the admissions committee, and **not** a future employer.
- Be careful: **word choice, skills & accomplishments**.
(all **match the qualifications** that law schools are looking for)
- note **your passions** while illustrating how you spent **your time in college**. Any leadership **positions**, professional **responsibilities**, and **volunteer** experiences could be beneficial to highlight.

- **Work skills** are **not** noteworthy to law schools. ??
- You can then note your **most relevant** professional **experience**.
- Resume should **matches** your **personal statement**. You want to be **transparent** and **cohesive** about who you are.

- “The **biggest mistake** you can make in a law school resume, is **not** putting enough effort and thought into it”
- “the **goal of** a law school **resume** is to show you are **prepared to hack it** in law school and could **thrive** as a law student”

RESUME ORDER – (AMERICAN STYLE)

- 1) Education
- 2) Honors & Awards
- 3) Bar Admission
- 4) Publications
- 5) Presentations
- 6) Relevant Experience
- 7) Professional Associations & Memberships
- 8) Languages
- 9) Activities

PERSONAL STATEMENT

- A short **essay** in which you articulate **who you are** and **why** you want to go to **law school** —
- Allows an admissions officer to understand your **motivation** to attend law school, **AND**
- The **reasons** why you want to attend **their** school, **specifically**.

WHY DOES THE LAW SCHOOL PERSONAL STATEMENT MATTER?

- As ad. committees decide between students who have similar stats (GPA-LSAT), they might turn to a **tiebreaker**: the personal statement.
- lawyers *have* to **write**, and to come up with **creative argumentation** to support a variety of claims.
- you're not only a **rigorous, clear thinker** but also a **pristine writer**, so make sure you don't leave any **typos** for an **eagle-eyed** admissions committee to **nitpick over**.

WHAT SHOULD A LAW SCHOOL PERSONAL STATEMENT DO?

- **P.S.** should tell the ad. committee something outside academic qualifications (GPA / LSAT) or work experience (i.e., law school resume)
- An opportunity to showcase your **personality**, reflect on the experiences that **led you to apply** to law school, and demonstrate how you will make a **great addition** to the school's incoming class.
