14	§2-9-1(D) of the city code states: "The board may make and adopt such design guidelines it
15	deems necessary to guide development occurring within the city; and
16	
17	WHEREAS, the Downtown Littleton Design Standards were adopted by the
18	Planning Commission and ratified by City Council in 2018; and
19	
20	WHEREAS, on December 10, 2018, the Planning Commission held a regular
21	meeting on the proposed boundary extension and voted to support PC Resolution 35-2018
22	recommending Planning Commission adopt the amended Downtown Littleton Design Standards,
23	with the revised Subdistrict 3 boundary extension and a noted condition:
24	
25 26	The proposed boundary extension would not be applicable to the existing development
27	application that is in the city's development review process and has received the first round of review comments. It is important to note, however, that this application is subject to the
28	Downtown Neighborhood plan, which also references design and character elements to be
29	met for this location. Also, in the future, any new development application for an expansion
30	of the footprint of an existing building in this location would be subject to these design
31	standards as specified in the Littleton Downtown Design Standards. Additionally, any future
32	sign permit application would also be subject to these standards.
33	
34	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
35	THE CITY OF LITTLETON, COLORADO, THAT:
36	
37	1. The amended Downtown Littleton Design Standards and extended
38	boundary of Subdistrict 3 are hereby ratified.
