## UNIVERSITY ISSUES:

University culture & Avoidance of Scandal

1. Culture centered on high achievement in academics, research

Eligibility to enter university, take pride that required more than for student athletes, success with honor; however the quality of student athlete brought in - success with honor is academic & personal integrity -

Student Athletic Center created 1987 (Academic Support Center) for all athletes- morphs into Morgan Academic Center but the Morgan employees are at Lasch - standards but good, two NCAA studies suggest football - Schools moving toward reducing isolation of football students athletes from other

We have two reports - from NCAA suggesting they move back together  $\,$ 

Example: Doolin interview re Morgan Center ppl go to Paterno's house for discussion & he's not interested in supporting program - didn't want Brady orourke; There are four study facilities - Reintegrate space, academic counselors - (some counselors did only football per Paterno & Paterno would discipline his players if went to other counselors - they were to only go to Don Farrell - Make him do 6 am workouts; 2 for football w/2 grads, 9 for 30 other sports - When told to go to one person that's an issue

Culture changed when wanted to win sears cup; Paterno went to admissions to get in certain athletes who didn't meet the academic standards

O'Brien says he has more student academic problems than he thought

Culture on high academics - PSU has higher academic standards for student athletes;

Look at Spanier's speeches regarding the high academic - Look at world news, large dollar value of grants re - research

Rise in rankings, more demands, graduates most hired

Examples of protecting the brand - What is the brand - PSU, football, Paterno, revenues from football can't exist without Paterno's name, revenues play into the University - without football no status for University

Power reduces if lose the revenue stream

If there were no football team - would have smaller student population, not on national television, wouldn't be in Big 10, televisions contract, lower donations,

Paterno raised over 352 million

How does University maintain its brand: Spanier's acitivites, support community projects, ie Second Mile;

What did they do to bad to protect the brand -

~continued to use JS to promote brand even after what he did, especially the football brand

Exhibit A: 1998 handling of incident & further promotion of JS vis-à-vis his retirement package - car, emeritus he was never penalized

Was their sense of urgency important - unsure

Long term employees

Lesser tenured employees had other experiences & brought in insight, some of these people weren't well received, called "outsiders" "don't understand the Penn State Way";

Reluctant to hire from outside - when they did hire from outside it was to the benefits

Others who stayed longer Curley, grad ass- athletic director in 10 years,

Loyalty & longevity of higher value

Need to search outsiders, use firms for highest levels, train people in new positions, cross train & move around; send people out to benchmarking

Have to have a better balance, people have to be qualified for the jobs, should have broadened search & training - ex no orientation training in Ath Dept.; HR should be independently reviewing hiring - HR gives advice, not direction -

Paterno was de facto athletic director & put lots of people in place

Kretchmar said all big decisions Curley bounced by Joe Paterno - ex. Men's & women's basketball

Curley was more independent as time went on

Solid line to Athletic Compliance to PSU Compliance

Curley lacked leadership in Ath Dept in 1998, thus Schulz & Curley go along with Paterno

Example: Went to JP for additional guidance on Sandusky matter re: reporting,

Sue Paterno influence?

Relationship between Tom Bradley with Scultz & Curley;

Jay's Paterno - violate nepotism policy so he reported to Ganter instead of his father (not that unusual)

Relationship between Garban, Spanier friends between Trustees & administrators,

Oversight responsibility - Friends shouldn't oversee

Shultz/Courtney

Schultz/Garban

Joyner/Clemons

People owe their loyalty to Paterno, sch. Etc. Protect the people instead of the institution

In 2001 - weren't considered about University "humane way" to handle Sandusky

Law enforcement reported to Schultz & he keeps up to date on everything, administrators tryied influence police activities

MOC case 25,000\$ items stolen, Schultz writes to Stormer about press release - coordinate with public relations

Schultz

Use embezzlement cases of potential to cross line between usurping between oversight

Ex: ganter tells police he's not here to help him, Deboeuf, student affairs have to be present when University police interview the students; Spanier changes procedures about not suspending expulision (Secor changes)

Paterno text to not cooperate with judicial affairs

Overrepresentation of athletes in criminal violations - deboeuf, might be just word of mouth, illegal only if he's told to use them & they weren't charging him, there's a letter, athletes represented more often - DON'T USE THIS ONE

Culture - reluctance to have candid discussions, ie presidents council, bot meetings, people didn't challenge one another, Curley's meetings, examples provided by people from other places, people have said they learned not to speak up; Wideman, Sims etc. Said why should they go, agendas closed, no input, enforces "rainbows and no rusty nails" (hehteringon)

Paterno's control of program, kept the kids away from media & don't put names on backs of their jerseys - Kept boosters & agents away

JP kept JS around because he was of some value and raising it outside would bring bad scrutiny to Joe's Program

No one logical conclusion; multiple motivations -

With respect to football, an inordinately low number of secondary violations - not enough monitoring in place "only university - 1 man to keep up with 800 student athletes, Stolberg has stuff in place, Bove 2000-09 he didn't check logs, recruiting logs & calls;

Academic - check re Grimes - included

Liars & influence of what happened to mcquery when he talked, not want to get involved because it may impact their jobs & lives: Diehl - re didn't know about JS showering with kids - trying to protect football, which now creates an NCAA problem

Richardson: said he didn't know anything - just got a new job at UNC,

Dick Bartolmea - knew about the Vienes report & stopgap plan (shields) child neglect charge, - didn't tell interviewers

Mark Sherbune - painted rosy picture for summer camps but he knew there were problems

Jeff Nelson - there was a group that met after the stories and he said he didn't meet with anyone - later disproved by Guido et al & his emails

George Salvaterra - said student athletes were allowed to see Kristine Clark - Clark said no football came to her office

Bill Mahon -

Kirsch - possibly lied re: retiring from 2nd mile; can't prove

Bradley - told Big 10 something different about knowing JS - but he didn't say that in his interview - Check re: Fletcher interview - but Diehl, Venterino, Spider said all the coaches knew he was showering - complete moral failure to see adult in shower with kids

Spider says there were rumors before 2011; mcqueary told the lunch bunch

PSU reputation & success - one of reasons that Joyner and Baldwin said trustees left the athletic department alone cause things were going well

Examples of discipline & misconduct & discipline

He doesn't remember DPW - note email says not report;

Said he didn't recall 98 incident; but it is mentioned on 2.12 notes
