
- (1) THOMAS JAMES BROWN©®™ TRUST have engaged in any of the conduct you have alleged in the COMPLAINT; and

## PRE-OFFSET NOTICE FOR BALANCED BOOK ADJUSTMENT





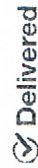
