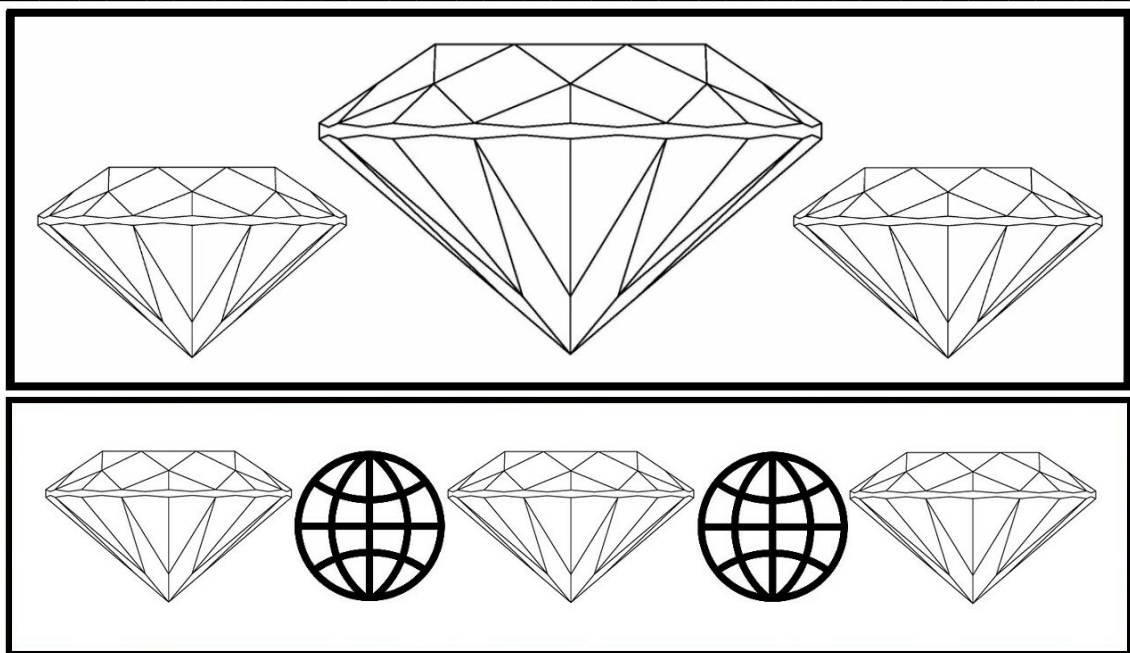

The current statute creating act of the World Diamond International Alliance at the base of legitimacy under International law, an act which is not in contradiction with the development strategy of the European policy, if it is ensured legitimate cooperation under this document and expression, meaning an act of isolation terrorist states and stop their operation when opening the second form of union politics as a subject of the European Community and the beam leaving the Terrorist European Union.

In this case, the government of the Czech Republic, Slovakia, Hungary, Romania, Bulgaria, Turkey, Austria, France, Italy, Portugal, Allied Germany, together with the Kingdom of Belgium, the Netherlands and Spain, the Grand Duchy Lucemburg and thus the reference to the Confederation of Switzerland, as states the loss of legitimacy and identification of the body as a state terrorist Alliance, followed with another proven States terrorist cooperation as the countries of the European Union and other countries maintaining stability and strength of a terrorist entity, as an act of transformation to sovereignty WD International Alliance in the aftermath of the International law and such alkalinity.

States with membership in the European Union are becoming active as states that are direct members of European Terrorist Organization and its source for the stability of terrorist interest which means the ability to be the dominant occupation positions actively *illegally using* International Law. Therefore, if any state refuses to withdraw from the European Union, that the State is recognized as

an entity with the intention of own decriminalization and restore in legal affair, for the support of the European forces of terrorism against International rights and interests of all countries in the world.

Every state of the European Union must immediately stop any activity, contacts, agreements and joint interests at International level and allied relations between terrorist states. This state showing a step towards legal cooperation on this project earns the right to own position in determining the opportunity to develop at the level of International politics and also to create a volume replacement for the European Union.

It means that, unless proven terrorist cooperation between the rest of the European Union member states, then states with successful legitimacy to remain stable nature of its legal basis, *de juri* and without the threat of acts against the sovereignty *de juri* his state and government of the country.

States confirmed the legitimacy it needs to stop membership in the European Union, because the European Union expires, remains a network of terrorist organizations. States leaving the European Union must demonstrate a willingness to eliminate terrorism within its own member states and the reference entities abroad, when such a determination, the principles of International law and an act of immediate and democratic cooperation.

States that so withdraws from the European Union must therefore confirm non-connectivity a terrorist entity and interest, and also with the power to withdraw an act which implies the establishment of a new association of European policy that will target a common continental union as a stabilizing substitute for bundles of the current European Terrorist Union.

New Volume emerging *European Community* in order to prevent defects and damage to legal States legally under International law forced to flee harnesses the European Union and thereby endanger their own civilization and economic and political functions of the state, and claims policy. States that are entitled to use strategies aftermath European crime mean act of transformation terrorist states to the new body the World Diamond International Alliance, that together achieve a successful law transform their own union partnership between the European Union at the level of the establishment of replacement by new *European Alliance* at a special partnership with the *World Diamond International alliance membership*, and thereby achieve an open right to become a solid member of a joint government World Diamond International Alliance means establishing joint sovereignty with all world states, the single territory survivors of European terrorist states, and thus in this aftermath of the founding act of its own policies on important and productive level than accordingly ties to the European Union, Council of Europe, and the ability to create even more prominent position above the common policy at the United Nations.

The right to form a new network of WD multilateral relations as a basis of regional networks are not designed to duplicate the development of legal forms of political and intelligence circles and volumes to the activities on the geographic area of one region. Nobody in the region must not be disqualified for their rights of democratic cooperation and recovery strategy for peaceful development of the State by the principles protected by the UN Charter.

In view of legitimate statute that we can mainly use the steps to become a lot more members and partner relations at the International level, states and organizations than that of the current capabilities of the European Union, also in view of the non-criminal relatedness. Therefore, leaving the European Union, thereby also establishing a replacement of the European Community, and the foundations of the World Diamond International Alliance, that is, always and without controversy much better and important step for all states in a new alliance which therefore have confirmed their legitimacy create our common peace and justice and legal development and success.

WD entity as a founding member of the new Union, opening the possibility of cooperation for the Multi cooperation policy.

World Diamond International Alliance has become a special member of the union which may therefore benefit from immediate contact to form an International state as the world's Democratic majority and the ability of states to use your newly unified territories of these countries, the World Diamond as an entity under joint sovereignty. Countries in the new Union will therefore essentially ensure the safety of their own national policy, legalizing own international political relations, and also gain the right to make strategic use of new territories and civilizational cooperation at the global level. In any case, a much better strategy than today's ties with the European Union and the Council of Europe with interest.

World Diamond International Alliance is fully legitimate body which confirms that the European Union is losing legitimacy and rights for their own development. Therefore, for your interest, allow your state follow the same decriminalization, thereby ensuring that particular act constituting a shift towards the development level when your state is losing volumes on the European Union and therefore uses the inverse of the partnership principle, the World Diamond which is beneficial substitute for bundles of European Union.

A new volume of the European Community must act to create insulation survivors of terrorist entities and enforcement actions for their full disposal, as a step in the fight against terrorism. No State shall remain in the European Union, due to the confirmation of an absolute majority of European Union member states,

as states confirmed to cooperation for world terrorism and the responsibility of crimes against international law, genocide surpassing murder in the Second World War, as well as a breach of legal rights more than 190 countries around the world, and that these members of the European Union, the institutional body of the European Union becoming labeled as subjects founder of the First Global War in the development of a *legal basis for international law*. Therefore, the association is not recognized as a legitimate European Union in legal position.

Date of full acknowledgment terrorist relatedness half of most states of the Union is founded on 2012. It is appropriate to recognize that other foreign and internal states can confirm the information from its own recognition of multiple states of the European Union as a terrorist volume since the previous year.

This is further confirmed by the confirmation from the date of actual terrorist Alliance at 50% the number of terrorist states therefore automatically harms the right of association and legitimacy of the European Union.

States that the group added, since confirmation of terrorist transformation of the Union, then just enter the volume of a terrorist entity in which it is not entitled to exercise the number of groups as valid for democracy because of the entry and admission only member of a terrorist entity which it already loses the right of claim political recognition and legitimacy internationally valid.

- *The Republic of Croatia is entering the year 2013, signifying entry into the volume of a terrorist grouping.*
- *The Republic of Bulgaria is entering the year 2007, signifying entrance into the union are unlikely terrorist groupings.*
- *Republic of Romania is entering the year 2007, signifying entrance into the union probably a terrorist grouping.*

Furthermore, states Estonia, Cyprus, Lithuania, Latvia, Hungary, Malta, Poland, Slovak Republic, Slovenia, signifying entrance into the union probably a terrorist grouping since 2004, the same year the Czech Republic into the Union and the justifiable and transfer of legislative and international legal responsibility of the Czech Republic into the hands of the European Union, and therefore criminally liable for failure to comply with the Union's legal obligation to act in the aftermath of crime allow to develop to the level of world terrorism with activity as an internationally organized group with a political center as the European Union.

Candidate countries, as parties interested in cooperation with terrorist organizations thus confirming their relationship to terrorism, as well as:

- Albania since 2009
- Macedonia since 2004
- Montenegro since 2008
- Serbia since 2009
- Turkey since 1987
- Bosnia and Herzegovina from 2016

If states are still in the position of force candidacy the adoption of the European Union, then the state and publicly declare that their interest is create own synchronization with a terrorist group, and that purpose is international most states entitles follow the policy of prevention against crime, and the strategy for the

liquidation of a terrorist entity. Turkey is a country with the exception, as the state confirmed on cooperation in the interest of terrorist groups and coordination, non only candidates.

Publicly acknowledged factor terrorism European Union since 2012, and the same terrorist states together the values of the past period, States jointly implemented the obligations of the legal procedure under International law, European law and national law, and that means that states refuse to implement prevention Stability international organized crime infiltration in European governments of the countries and in the European policy of organizing for the purpose of world terrorism, because while it is confirmed that the European Union as a whole shared responsibility is the active interest-terrorism, and this must be responsibly recognized as a terrorist organization that loses the rights of legitimacy and sovereignty. No one shall support the activities of the European Union and subsequently cooperate.

In 2014 he was sent a request for legal cooperation before all the constitutional courts of the European Union. Request to beating today raised the legal duty of the courts. Governments, for the purpose of organized crime does not fulfill its own obligations defined by the state and obligations imposed by International law. This means that the European Union is based on direct factor as a subject of International terrorism with a value of 100% own democracy be membership of terrorist institutions.

In 2012 it was contacted by the European Court for Human Rights in Strasbourg, France. The court did not fulfill any of its own obligations for the principles of the European rights and responsibilities *under International law*.

Czech Republic's accession to the European Union dated from 2004. The Czech government is the entity that since 1998 own his criminal responsibility in world terrorism and the responsibility to ensure all functions of legal principles and ensure justice and stabilize government Imperium of Diamond's like obligations that when the Czech Republic joined the European Union since 2004, will jointly same duties start response for the European Union. Therefore, the obligation is created since 2004, and without a legal obligation by applying consistent with International law, the European Union confirms their responsibility for terrorism and International crime as an entity with its own responsibilities 100% of the forces of democracy.

The same factor in countries like Denmark, Finland, Czech Republic, United States of America jointly acquire responsibility of international crime as support for the development of terrorist acts attempting to breach the rights of sovereignty Imperium of Diamond's in territories ID's Diamond Oasis North East Africa Bir Tawil, during encourage terrorist interest illegal entity Kingdom Northern Sudan as interested in building a terrorist entity for the violation of integrity and claimed rights Imperium of Diamonds and also claims in accordance with the UN Charter and the UNGA convention today, with the obligation of International strategy UNSC, so act the subject of Northern Sudan is a crime under International law the UN Charter and the rules and principles of UNGA conventions, and if such violation again, meaning an act of International terrorism and support the purpose of building stability terrorist entity of the European Union. This also means that Kingdom Northern Sudan must not be any recognized legitimate act of any government land because such recognition represents a violation of international rules as well as hierarchistic damage

values valid International rules, meaning act action against the United Nations and therefore also the format of a crime that is against the UN Charter. This creates the right of all countries in the world, to ensure the act of stopping diplomatic relations with all the countries of the duplicate format in terrorist cooperation against the UN Charter, as well as a certificate of recognition of the loss of rights of sovereignty of these entities, and the same factor internationalizing the territories of these entities for the transformation to a legal entity representing Government World Diamond International Alliance.

The USA government therefore own obligation to stop any action to support the body Kingdom Northern Sudan, to ensure the immediate release of the punishing courts Imperium of Diamonds. In the same importance must be USA, as a non European Union body with legal security responsibilities to ensure the cessation of cooperation in the group of NATO if NATO fails their guarrantees in opposition against terrorism, or in the latter case, if you support the exclusion of terrorist states of NATO, thereby ensuring the legalization of this entity.

If the USA is not a responsible safety effectiveness for interest threats to NATO and the establishment of cooperation against terrorism, the States UNSC together and look to the rights of the Charter of the United Nations states UNGA, and thus the right of states UNGA with UNSC is entitled together to express themselves for the purpose of opposition to the USA because of the terrorist act which means the possibility of the USA democratic complaints and act to exclude the USA from the UNSC, the UN and continues even if the USA will continue to keep the interests of terrorist activities.

The number of members of the NATO alliance, the absolute majority of states a real actor in world terrorism. This means that permanent democratic crowd of NATO is truly a crime on the level of a terrorist nature which can not be legitimized or active at the level of international politics or their own national integrity. A terrorist entity is the only terrorist entity and is therefore intended for disposal only if it is not possible by any other procedure in the context of international legal rights and legitimate notification of responsible persons representing legal relationships. The reason that the NATO alliance is confirmed as a terrorist entity with the full range of its own members, thus WD International Alliance owns all rights to confiscate all the possessions of the NATO alliance as well as to ensure full rights for their use in their own interest WD International Alliance, and the consequence of responsibility as the World Diamond Alliance, representing rights of sovereignty territories absolute majority of NATO countries, and that by retaining a group of NATO as a legal entity, therefore, is the use of the NATO alliance and membership ID's government using WD Alliance as a member of the law by an absolute majority of votes to the crowd from a number of provincial government forms. If that option is rejected, then the group of NATO automatically recognized as legal ownership in respect of the World Diamond International Alliance for the purpose purely security of all member states of the Alliance and the joint fight against all types of terrorism.

Furthermore, the United States, in the event of an act to decriminalize own policy when stopping NATO cooperation in the group, or the exclusion of all terrorist members of the NATO alliance, the USA is authorized to gain international affirmation by members of the World Diamond Alliance, as the resolution confirming the legal nature of the USA state. Furthermore, the World Diamond therefore becomes an entity that replaces terrorist states in the group of NATO. NATO alliance that can continue to maintain its own function in

accordance with the principles of the membership of other countries, and the right choice of the pirate group is so frozen in execution.

Next in documentation way, EU bodies is therefore confirmed as a terrorist entity in its character to all Member States of the European Union. Citizens who are still active as citizens of terrorist states, means that they become responsible for supporting a terrorist entity and that everyone loses civil rights, again collapse legitimation state law and the opportunity to use the format of state rights at the international legal level, even to the extent the act implying recognition this entity as a terrorist organization.

Territory of terrorist states is recognized as a terrorist zone. Any other civilian should not be active in this area. Anyone who is active on the territory of the state terrorist actor's collaboration with a terrorist entity, and therefore the same terrorist responsibility.

Anyone who is a member of a terrorist group, therefore, becomes a subject claimed courts Imperium of Diamond's. Bodies thus become prisoners under the responsibility of the prison administration Imperium of Diamond's. Each entity as a prisoner of Imperium's Diamond becomes a citizen of the Imperium of Diamond's, and such laws ownership. Nobody owns the right of resistance or allow foreign and international protection or seek asylum and citizenship of another state.

Survivors territory of European terrorist organizations therefore lose the right recognition of their own government, their own "civilian" population, as well as the loss of rights at the level of civilization or economic nature, because it means that the territory may be subjected to liquidation in military intervention or the use of weapons of mass destruction to stop the threat of an actor First Global War, and therefore without any criminal aftermath of it due to first base formation of the United Nations system and the direct purpose and function of world politics today.

World Diamond International Alliance reowned automatically by the administration of association of the European Union, and thus represents all the legal rights of contact and communication. No one else is authorized to act on behalf of the European Union, and such an act is terrorism. World Diamond International Alliance establishes such rights in order to create stabilization and security isolation capabilities prevention function and development of terrorism, and at the same time in order to cooperate stabilization of the world economy and politics.

Decriminalization, the right of states to create a new replacement community and in case of confirmation of their own relationship without conflict with International law, thus allowing use their own statutes legitimate state is open to the right of the states, the *Republic of Estonia, the Republic of Croatia, Republic of Ireland, Cyprus, Lithuania, Malta, Poland, the Hellenic Republic, Slovenia, United Kingdom of Great Britain and Northern Ireland, the Kingdom of Sweden*, this means that the European Union remains of 11 members of which have the ability to own legalization, and that of these only five states have the right to represent themselves as the last legal states that in the history of the European Union were lawful democracies of the European Union until 2004, when the Czech Republic joined EU and the criminalization of the body. Other states certifiably cooperate on terrorism, or states added to the Union at a time when the EU profit from terrorism responsibilities.

Decriminalization and subsequent legal cooperation is suspended on the law

applying to the State Government of the Czech Republic, Slovakia, Hungary, Romania, Bulgaria, Turkey, Austria, France, Italy, Portugal, Allied Germany, together with the Kingdom of Belgium, the Netherlands and Spain, the Grand Duchy of Luxembourg so and the reference to the Confederation of Switzerland and the States shall acquire the final obligation to undergo voluntary bankruptcy and thereby also provide handover of sovereignty to the legitimate leadership and the World Diamond International Alliance, as the format of joint sovereignty of all countries in the world.

The same obligation to respect the cessation of the rights and claims of decriminalization also owns Lithuania Republic and the Kingdom of Denmark, because of direct attempt to support the occupation of territories and the Imperium of Diamonds, as well as contacting union membership in the European Union as one of the main centers of terrorist policies.

USA Government involved in the criminal trial and the support of the occupation of territories ID's Diamond Oasis North East Africa Bir Tawil and therefore the USA government that accepts debt responsibility, with the possibility of using this act to interest parties World Diamond International Alliance for the decision to force all Member States, to ensure the internationalization of the USA territories, and thus also for the purposes for establishing the sovereignty of the World Diamond on USA territory. 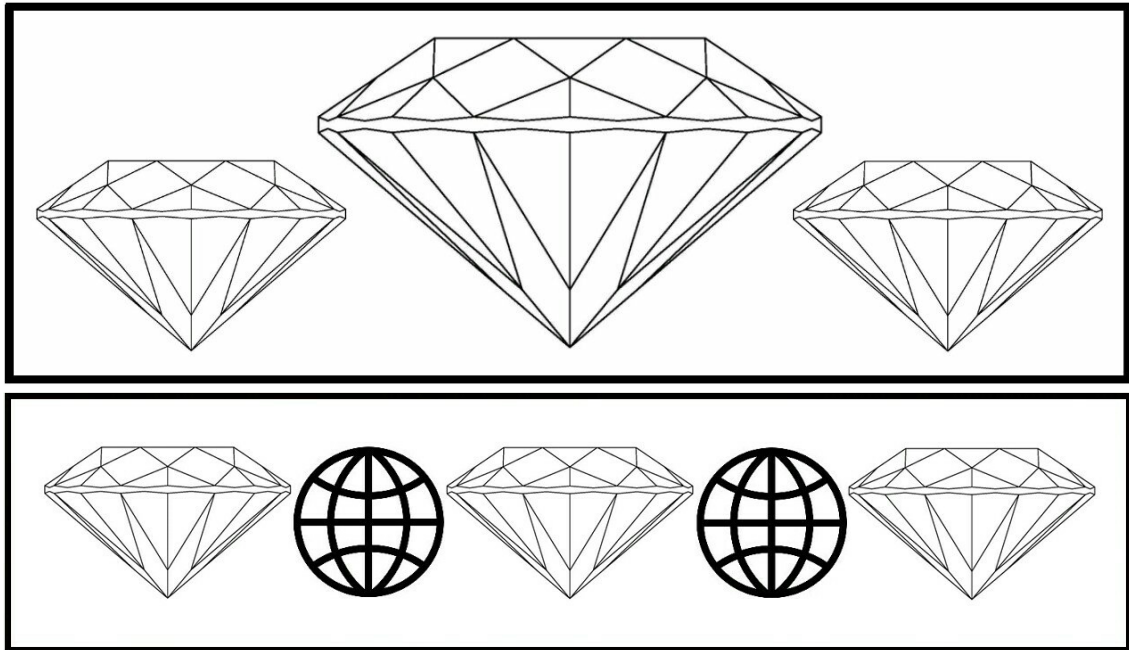
