

Diplomatic & Business comunication, active development of International site of Institution's branch and Corporate businesess in the whole world, all countries.



The institution is in the stage of establishing an organizational network, so it is necessary to ensure the function of own resources of finances, and global business sites which are dependent on their own Institutional activity and business performance, under the administration of the Institutional Department for Business Management under Document, Central Code of Institution ID's Global Security Concern of Private Companies.

The objective of organized co-operation of Private Societies is therefore to carry out diplomatic representation and protection of diplomats for the purpose of establishing legal co-operation with foreign state offices of trade and business right, in order to be able to co-operate Internationally, to develop, manage and represent new institute branch of business and comerce in all foreign countries and to enable the global branch development.

At a time when the ability to perform comercial branchs development, at the International level will be secured, the first time will allow payment for the diplomatic representation and security protection service, as a payment formsucessful goal.

If there is no open new comercial branch, it is possible to issue only an payment of profit only for primary activity of public representation.

- 1. The first step is to represent the Institution as a legal person, the purpose of establishing links with the authorities of the state of the foreign governments of the countries for the purpose of creating a contract on the right to establish a commercial branch of an institution in that territory.
- 2. In order to obtain the right of commercial performance, a commercial office will be created, the General Council will be composed of Private Security and Military Companies active in the country, as well as departments of logistics of the trade according to legally available options (analysis, organization, management of business enterprises and their registration, or a contractual partnership with other business offices in the country.
- 3. If it is not possible to set up a branch office in the interest of information provision number 2, it will decide on the intention to use the legal systems of the country to establish more business branches as an independent branch owned by the Institutions but to function as a joint venture contract of a tied branch with a common purpose function interest in the central seat of the Institution from the territory of the Federation and such production that can be lawfully applied in the territory of the State and such jurisdiction of the seat of the second branch.
- 4. The base of a business branch is established as the Second Registered Office of the Institution of the Principal Headquarters of the Institute in the Imperium of Diamond's Federation, and in the representative office of the Second Quartier as a Branch in the Management by the Members of the Country.
- 5. The contract price per company is € 10,000,000,000 in the IDMD currency, which means the use of funds to pay for the official service provided, the legal representation before the authorities, also the use of the purpose of finance for the payment of official state fees, and the establishment of the registered office of the Institution, buildings. If the balance of unused financial amounts is left, the remaining amount of the financial amount will be determined for payment for the provision of the official communication service in

- accordance with the information articles 15, 16, 17, 18
- 6. The financial amount provided for the purpose of the construction may be limited and regulated according to the legal use of the funds and the purpose of the construction.
- 7. The main strategy of using the payment for the establishment of a branch office headquarters is primarily in the form of creating its own corporate network according to information provision number 2, meaning the ability of organized development from own resources.
- 8. All steps of development, contact and business negotiations and branch operations must be in accordance with the jurisdiction of the State in which the branch is established. The Branch is not an exercise under the Central Code of the Institution and therefore the branch is limited to its own information, organizational and legal co-operation with the Institution unless the Government of the country grants full immunity to the seat in order to recognize a legal entity as an Institution.
- 9. Commercial Branch The institution is still the property of the Institutions' representation office.
- 10. A commercial branch may be entrusted to the administration by entities such as the Business Management Administration company.

Representative office

- 11. Representation Branch is an officially and commercially independent headquarters based on the company's presentation purpose, conferences, galleries, public centers of education, mobile centers, other purposes of representation, as headquarters which may also be established under the law of purpose for a contract to this agreement.
- 12. A representative office is established only as a public place serving as a business card, allowing its own function in the form of advertising for the public or for the purpose of private contacts and business conferences with partners and diplomatic relations.
- 13. A representative office can be established from the institution's own financial resources, from the financial resources of the Second Business Branch, and at the same time the purpose of establishing as a deficit from business management among other trading partners.

Corporate Networks Institutions under the Administration of the Business Administration of the Institutions


- 14. The institution has the right to establish its own business corporation's within the Federation, as a corporate network owned and managed by the Institutions.
- 15. Institutionaly owned corporations have the right to be expanded to the International structure of their own second-party affiliates abroad.
- 16. Business outlets abroad are based on information articles 1 to 13 and with the limitation of importance as independent business branches that are not representative of an institution but only in the management of the legal ownership of the Institution through the institution's corporate governance format in the corporate network of the institution and thus as a corporation-headquarters in the federal territory.
- 17. Branch offices abroad will be set up according to the information provision strategy with number 7.

- 18. Business outlets abroad can be used to sell Institutional products such as Corporate Networking, Business Services, and the establishment of industrial centers according to the Strategic Business Plan.
- 19. The institution establishes a plan for the establishment of affiliates according to the purpose of establishing a function allowing the national source of development to the countries of third world countries and countries in the form of their weaker level of development, leading the logistics of the development of corporate networks for the purpose of mutual benefit.

Payment for mission management

- 20. The payment for the services provided will be paid through a pay-out allowance from the profits of the affiliates.
- 21. The redemption of the mission can be further utilized responsibly from the establishment of Contract No. 01.
- 22. The contract No. 06 is therefore in an executive link to the Contract No. 01, as well as the contract number 02, and also for the purpose of extending the team of the Institution under the contract No. 05, or contract No. 7.
- 23. The payment for completed missions will be paid through completed business branches, if so in such an interest the decision of the General Council of the Institutions can be decided, or in accordance for information number 21.

Each section of a payment item must be recorded by a certification receipt and the submission of tickets and other certification accounts for the provision of a trade and with a confirmation from the financial office of the provider, the obligation to submit all sources of reference contracts and agreements, and photographs of the meeting and visits to certain locations. It is obliged to create a record of each meeting held and to ensure that the parties are signed to confirm the fact of the joint meeting.

Unless all responsible documents are presented, then the disputed right may also be the claim for payment of the work. It is necessary to maintain a thorough account management and ensure the function and photographic evidence.

The Office for Business Administration creates an office logistics management for the purpose of setting up information data on an appropriate strategy of geography Institutions, International interests, International competition, International maturity and also inspiration for future development, a partnership strategy and, according to these goals, the purpose of creating a Letter of Corporate Corporations owned by the Institution.

The Business Management Department is responsible for managing the Corporate Commercial Register under the administration of the Institution, such as the Business Register of the Institution, which allows the autonomous establishment and cadastral management of commercial corporations.

Business Register The institution is imprinted as the Federation's Trade Registry as it becomes part of it. All Business Corporations have their own branch in the Federation.

The list contains the name and identification data of all corporations, must be registered with the Official Offices of the Federation and thus form part of the Commercial Register of the Federation, which confirms the full legality of the legal status of corporations.
