

[New Zealand ETA Visa](#)

An electronic Travel Authorisation (eTA) is a new entry requirement that provides authorisation to travel to and enter New Zealand for short-term stays, tourism or business visitor activities. All non-citizens require a Visa or electronic Travel Authorization to enter New Zealand. Visitors and airport transit passengers travelling to New Zealand can enter the country with an NZeTA (New Zealand Electronic Travel Authority) before they travel. Citizens of 60 nationalities do not require a Visa to enter New Zealand. This facility is available from 2019. If you are planning a visit to New Zealand, then you may not be allowed to enter the country without an NZeTA. The New Zealand eTA (NZeTA) is an electronic authorisation, which provides you with the authority to enter New Zealand, allowing you to stay in New Zealand for up to six months within a 12-month period.

NZeTA eligibility

You must be from one of the 60 visa waiver countries.

You must be in good health condition, and not be arriving for medical treatment.

You must be of good character and not have any criminal convictions.

You must have a valid credit card / debit card / Paypal account.

You must have a valid email account.



Transiting New Zealand

If you are a citizen of New Zealand eTA (NZeTA) transit visa waiver country, then you can transit from Auckland International Airport without requiring a Visa for New Zealand. However, you must apply for New Zealand eTA (NZeTA) and not a Visa.

Validity of New Zealand eTA (NZeTA)

Once New Zealand eTA (NZeTA) is issued, it is valid for 24 months, and is valid for multiple entries. A visit per entry is valid for 90 days for all nationalities. UK citizens can visit New Zealand on NZeTA for 6 months. If you are a New Zealand or Australian citizen, you do not require a New Zealand eTA (NZeTA), Australian citizens do not need a visa to visit New Zealand. Australian citizens are automatically deemed to hold NZ resident status on arrival. When Australian citizens visit, they can visit, live, and work in New Zealand without acquiring a visa. However, Australia Permanent Residents (PR) do require a New Zealand eTA (NZeTA). [New Zealand Visa ETA](#)

Online process for New Zealand eTA

You can acquire New Zealand eTA online by filling an application form. This form will require a payment online from your debit / credit / paypal. You will need to fill in your name, surname, date of birth, address, passport details, travel details, health and character details. There are about 60 nationalities that are allowed travel to New Zealand, these are called Visa-Free or Visa-Exempt. Nationals from these nationalities can travel/visit New Zealand without a visa for periods of up to 90 days.

Some of these countries include United States, all European Union member states, Canada, Japan, some Latin American countries, some Middle East countries). Citizens from the UK are allowed to enter New Zealand for a period of six months, without requiring a visa. All the nationals from the above 60 countries, will now require an New Zealand Electronic Travel Authorisation (NZeTA). In other words, it is mandatory for citizens of the 60 visa-exempt countries to obtain an NZ eTA online before traveling to New Zealand.



Only Australian Citizens are exempt, even Australia permanent residents are required to obtain a New Zealand Electronic Travel Authorisation (NZeTA). Other nationalities, which cannot enter without a visa, can apply for a visitor visa for New Zealand. More information is available on the Department of Immigration website.

Requesting an NZeTA costs NZ\$12 via the official Immigration New Zealand website. Certain travellers entering New Zealand must also pay the International Visitor Conservation and Tourism Levy (IVL) which is NZ\$35 for all those travelling for tourism.
