Dear candidates from Ukraine,

We realize the difficult situation you're in and we, at Paysafe Bulgaria, would like to support you.

In case you're still in Ukraine and you want to evacuate to Bulgaria, you can reach out to the National Portal for the people affected by the war in Ukraine via the online form or the hotline: 029055555 or +380322465075.

Entering Bulgaria:

Since 2017, Bulgaria, as part of the EU, has an agreement with Ukraine on visa-free travel. It guarantees the opportunity for all Ukrainian citizens to enter the territory of our country only with their biometric passports and to stay for up to 90 days.

After Russia's attack on Ukraine on February 24, 2022, Ukrainian citizens automatically have the right to seek protection in Bulgaria without these conditions being met, that is, even if they do not have a valid passport to travel abroad.

Currently if you're a Ukrainian citizen, you can enter Bulgaria with one of the following documents:

- Passport with or without biometric data;
- ID card
- Driving license
- Birth certificate – for children up to 14 years
- If you do not have any of these documents, but have other official documents that prove your identity, such as certificates, passes, diplomas, membership cards, bank cards, employment records, property documents
- If you do not have any documents – an exception can be made after an inspection by Border Police officers

It is allowed to enter Bulgaria by car, regardless of whether or not it has international insurance

It is also allowed to enter Bulgaria with pets, regardless of whether they have identification with a chip, passports or vaccination certificates.



Upon arriving to the Bulgarian border, you'll have 3 options:

- 1.** Receive immediate temporary protection for at least 1 year
- 2.** Apply for a refugee or humanitarian status
- 3.** Be a guest of the country for the next 90 days

If you'd like to look for employment, receive healthcare and educational access, you can apply for the right to temporary protection. You'll receive a laminated document with a photo and QR code. The registration takes place at the border checkpoint or if you're already in Bulgaria – in the State Agency for Refugees.

Additional rights that you gain with the temporary protection are as follows:

- Remain on the territory of the Republic of Bulgaria
- Get access to appropriate accommodation
- Apply for social assistance
- Apply for free education for children under 18
- Apply for free kindergarten for children up to 6 years
- Apply for bank accounts and debit / credit cards – the Bulgarian government and banks will introduce a simplified mechanism for opening bank accounts by Ukrainian citizens (expect additional information on this)
- Return freely to the country of origin

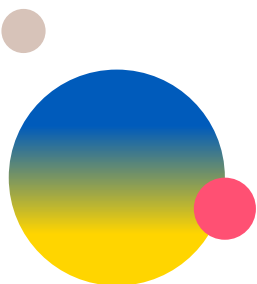
