

Historical RGV MPO Forms, Providing Millions in Funding Opportunities for the Region



Mayor Hernandez joins Governor Greg Abbott, Mayors Richard Molina, Chris Boswell, and Tony Martinez, Senator Juan "Chuy" Hinojosa, and Representatives Terry Canales and Bobby Guerra for the official signing of the merger at the Texas Capitol.

Mayor Ambrosio Hernandez, M.D. and the Pharr City Commission marked a momentous occasion in late April as they approved a resolution in support of the re-designation agreement and bylaws for the proposed Rio Grande Valley Metropolitan Planning Organization (RGV MPO) merger. Andrew Canon, Hidalgo County MPO Director, was present to accept the resolution and said, "We have come together collectively and will now be able to see an increase in discretionary funds that are available at TxDOT for many projects that will impact the entire region and everyone in our communities." He added, "I just want to say what a momentous occasion this is and it's in great

part because of the due diligence of Mayor Hernandez and his work as our Hidalgo County MPO Chairman in working with the other elected officials to be able to get all of them together to work towards this merger, which will have many positive outcomes for our region." The merger will allow the Rio Grande Valley to compete for millions more in transportation funding at both the state and federal levels. "This approval was the culmination of hard work, dedication, and commitment from our Hidalgo and Cameron county and city leaders to combine the three South Texas MPOs into the proposed Rio Grande Valley Metropolitan Planning Organization," stated Mayor Hernandez

"Thanks to all who made this possible for your commitment to advancing our communities through one voice and as one region! Our entire South Texas community will soon see the many positive results of this merger through improved transportation infrastructure, economic development, and quality of life!" Cities throughout the Rio Grande Valley will soon follow suit with similar resolutions up for consideration over the next few weeks. Surrounded by mayors, leaders, and officials from the Rio Grande Valley, including Pharr Mayor Ambrosio Hernandez, M.D., Governor Greg Abbott signed the merger into law on June 14, 2019.

Pharr EDC Promotes US Census 2020 Intiatives

Mayor Ambrosio Hernandez, M.D. and the Pharr City Commission approved a resolution creating a 2020 Census Committee. The purpose of the Complete Count Committee is to plan and conduct local educational initiatives, publicity, and promotional activities to increase community awareness and participation in Census 2020. Accurate census information is critical to planning for future growth, development, and the social needs of the City of Pharr through the disbursement of federal dollars, which are distributed based on population. Additionally, data collected by the census determine the number of seats each state has in the U.S. House of Representatives, the U.S. Senate, and in the state legislature. Pharr has experienced phenomenal growth over the last ten years and encourages all citizens to fully participate in the 2020 Census. The Complete Count Committee is comprised of city staff, local businesses, faith-based organizations, and community organizations. The Pharr EDC will work alongside the city in promoting Census efforts which aim to ensure that every person is counted. This is important to enhance funding and economic development opportunities for the city.

ECONOMIC TRENDS



Sales tax activity for the City of Pharr as of the month of July 2019 continues to show a positive upward trend, demonstrating a steady increase in sales activity. This report is the tenth month of the City's fiscal year and represents sales activity for the month of May 2019. The report showed an overall positive trend in sales tax growth in the amount of \$2,195,293, an increase of 15.06% for this time period. City sales tax collections also saw an increase of 5.33% (\$1,760,677) compared to last July 2018 (\$1,671,537). Pharr continues to rank first in collections year-to-date.



International Bridge

Pharr Bridge Launches Pilot Program, Announces Updated Hours of Operation

The Pharr International Bridge announces updated hours of operation to the temporary pilot programs designed to relieve congestion, increase truck throughput, and reduce border wait times at Pharr's international land port of entry. These pilot programs are being implemented as a result of the reduced Customs and Border Protection personnel at the port and deployed to the Southern border as mandated by the federal government.

In an effort to keep the public aware and informed, the Bridge announces the following new hours of operation, effective July 4, 2019.

The primary change to the schedule is that priority will be given to commercial traffic during regular business hours (Monday - Friday). Cars and passenger vehicle lanes will be closed for cars to give priority to commercial trucks. All cars and passenger vehicles will only be allowed to cross northbound on Saturday and Sunday from 4 pm to 11:59 pm.

THE FOLLOWING SCHEDULE APPLIES DURING THE TEMPORARY PILOT PROGRAM PERIOD:

SOUTHBOUND TRAFFIC (TO MEXICO) Hours of service remain the same

> Cars & Passenger Vehicles Monday - Sunday (6 am to 11:50 pm)

Commercial Trucks Monday - Friday (7 am to 11 pm) Saturday - Sunday (7 am to 4 pm)

NORTHBOUND TRAFFIC (FROM MEXICO)

Commercial Trucks Monday - Friday (7 am to 10 pm) Saturday - Sunday (8 am to 4 pm)

Small empty trucks and short trucks (no trailers) are authorized to cross through Car/Passenger Vehicle Lane (Estimated relief: 250 - 300 trucks daily) Monday - Friday (8 am - 8 pm) Empty Tanker Trailer Trucks are authorized to cross through Car/Passenger Vehicle Lane (Estimated relief: 250 - 300 trucks daily) Monday - Friday (8 am - 8 pm)

Cars and Passenger Vehicle Lane is closed for cars, giving priority to commercial trucks CLOSED Monday - Friday (6 am to 11:59 pm) OPEN ONLY Saturday and Sunday (4 pm to 11:59 pm)

This schedule will remain in effect indefinitely. All pilot programs will be reviewed by Bridge staff, trade partners, and relevant stakeholders to discuss feedback regarding the programs, make adjustments if necessary, and possibly plan for other contingencies. Bridge officials will continue to keep the public aware and informed as the pilot programs progress.

UTRGV Sports Medicine Institute

In May, the University of Texas System Board of Regents authorized UTRGV to accept a conditional gift of an approximately 10.5-acre tract of land located near the northwest corner of I-69C and Sioux Road in Pharr, from the City of Pharr for future programmed campus expansion, including a sports medicine institute. The Regents also authorized the university to enter into a license agreement, as licensee, with the City of Pharr for use of a to-be-built aquatic center on a tract of land adjacent to the 10.5-acre tract of land. "Plans are moving forward for the UTRGV Satellite Campus, which propose to include a Multi-Specialty Clinical Campus and a Sports Medicine Institute and Aquatic Center. These projects will enhance educational, health care and athletic opportunities, as well as contribute to having a significant economic impact in our area," stated Mayor Ambrosio Hernandez, M.D. during his Pharr State of the City Address in January. "Thank you to UTRGV for your continued partnership as we work to advance educational opportunities in the Rio Grande Valley, and especially, in Pharr."

Pharr Interchange Project Enters Final Stages

In June, the Texas Transportation Commission met to select the project designer, the last step before construction. The \$303 million Pharr Interchange Project is set to begin construction in August 2019 with an expected completion date of late 2022. The Pharr Interchange Project has been one of Pharr's key priorities under the leadership of Mayor Hernandez, who stated after the meeting, "I could not be more thankful, excited, and grateful as this project, considered one of the largest investments in our region, prepares to begin construction." The Pharr Interchange has long overgrown its capacity due to massive growth in population and vehicular traffic. "We are grateful that our state leaders in Austin have worked with us to make this project a priority," added Hernandez. As a vital lifeline for our region, the Pharr Interchange is crucial for commerce, trade, commuter, and international traffic, and also serves as an evacuation route for our area. Thank you to all our partners for making this much-needed investment in our region and in our city, which will improve our transportation capacity!
