ON JUNE 10, 2020, AT APPROXIMATELY 1600, PROTESTERS GATHERED AT THE TORCH OF FRIENDSHIP (401 BISCAYNE BLVD) REFERENCE THE MINNEAPOLIS INCIDENT WHERE MR. GEORGE FLOYD LOST HIS LIFE. AFTER A FEW MINUTES, THE PROTESTERS MOVED TO BISCAYNE BLVD AND 6 ST, AND TOOK OVER THE INTERSECTION. AFTER APPROXIMATELY ONE HOUR, THE PROTESTERS MOVED BACK TO BAYSIDE MALL AND GATHERED AROUND THE STATUE OF CHRISTOPHER COLUMBUS (REAR SOUTHSIDE OF THE MALL); THE DEFENDANT GAVE A SPEECH AND AFTER THE SPEECH HE PROCEED TO SPRAY PAINT THE MONUMENT OF CHRISTOPHER COLUMBUS IN RED COLOR PAINT. THE DEFENDANT THEN WALKED THE CROWD TO THE FRONT OF BAYSIDE AND MADE ANOTHER SPEECH NEXT TO THE TORCH OF FRIENDSHIP. DEFENDANT ENCOURAGED THE CROWD TO UNLAWFULLY DESTROY AND DEFACE THE MONUMENTS. AFTER THE SPEECH, HE MOVED TOWARDS THE STATUE OF JUAN PONCE DE LEON LOCATED ON THE NORTH SIDE OF THE TORCH AND BEGAN TO SPRAY PAINT THE MONUMENT WITH RED PAINT. WHILE THE DEFENDANT WAS GIVING HIS SPEECHES, ONCE AGAIN, HE KEPT ON ENCOURAGING THE CROWD TO BE AGGRESSIVE, AND TO DEFACE THE MONUMENT BY HIS COMMENTS AND ACTIONS. THE MARKED POLICE UNIT'S ARRIVED AT THE FRONT OF BAYSIDE, AND AT THIS TIME THE DEFENDANT BEGAN RUNNING AWAY FROM THE UNIT; I RAN AFTER THE DEFENDANT AND WAS YELLING STOP POLICE BUT DEFENDANT CONTINUED FLEEING FROM THE SCENE, AFTER A SHORT FOOT CHASE THE DEFENDANT WAS ARRESTED WITHOUT FURTHER INCIDENT.

UNITS WERE ASSIGNED TO THE MOBILIZATION TEAM ECHO. ECHO TEAM WAS MOBILIZED TO THE BOULEVARD AND 4TH ST. REFERENCE AN UNLAWFUL ASSEMBLY AND VANDALISM TO CITY PROPERTY. A BOLO (BE ON THE LOOKOUT) WAS GIVEN FOR, A WHITE MALE WEARING YELLOW SHIRT, BLACK PANTS HOLDING A BLACK BACKPACK, VANDALIZING A HISTORIC LANDMARK LOCATED AT THE BOULEVARD AND 4TH ST. UPON ARRIVAL CHRISTIAN DIAZ (DEFENDANT) WAS OBSERVED TAKING OFF HIS YELLOW SHIRT TO AVOID BEING RECOGNIZED BY MARKED POLICE OFFICERS. UPON OFFICERS EXITING THE MARKED POLICE VEHICLE IN FULL UNIFORM WITH CLEAR DISTINGUISHABLE POLICE INSIGNIA, THE DEFENDANT OBSERVED THE OFFICERS AND STARTED RUNNING. VERBAL COMMANDS TO STOP WERE GIVEN TO THE DEFENDANT "POLICE STOP!". THE DEFENDANT CONTINUED RUNNING THROUGH THE CROWD. AT THIS POINT WITHOUT LOSING SIGHT OF THE DEFENDANT A SMALL FOOT PURSUIT BEGAN. THE DEFENDANT COLLIDED INTO A CIVILIAN VEHICLE CAUGHT IN TRAFFIC AND UNITS ATTEMPTED TO DETAIN HIM; HOWEVER, HE WAS RESISTED BY BRACING AND TENSING, REFUSING TO BE PLACED IN HAND RESTRAINT. AFTER A BRIEF STRUGGLE THE DEFENDANT WAS HANDCUFFED. DEFENDANT ARRESTED.

SGT ARCIA 40733 REVIEWED THE CCTV FROM THE CITY OF MIAMI AND OBSERVED THE DEFENDANT SPRAY-PAINT A HISTORIC BRASS STATUE AT 401 BISCAYNE BLVD BEFORE POLICE ARRIVE THEN FLEE FROM OFFICERS ON SCENE. THE ENTIRE INTERACTION WAS CAPTURED BY CITY OF MIAMI CCTV.

WASHINGTON IBM #42778 WERE ASSIGNED TO RESPONSE PLATOON ECHO (RP-ECHO) DUE TO THE ONGOING PROTEST AND DEMONSTRATIONS THROUGHOUT THE CITY OF MIAMI AND MIAMI-DADE COUNTY. RP-ECHO WAS DISPATCHED TO BISCAYNE BLVD. & NE 4 ST IN FRONT OF THE BAYSIDE MARKET PLACE (401 BISCAYNE BLVD) REFERENCE TO APPROXIMATELY 60-70 INDIVIDUALS DEMONSTRATION THAT BEGAN TO DEFACE TWO (2) STATUES. ONE THAT WAS IN BAYSIDE PARK AND THE OTHER WAS ON BISCAYNE BLVD. & NE 4 ST. THE CITY OF MIAMI REAL TIME CRIME CENTER (RTCC) HAD POSITIVELY IDENTIFIED 3 INDIVIDUALS WHO WERE RESPONSIBLE FOR DEFACING THE PROPERTY IN SIDE THE BAYSIDE MARKET PLACE. AT WHICH TIME, RP-ECHO WAS DISPATCHED TO THE INCIDENT LOCATION TO TAKE THOSE SPECIFIC SUSPECTS INTO CUSTODY.
