## Notification of Marijuana Product Recall

The Marijuana Regulatory Agency (MRA) is issuing this health and safety advisory bulletin due to a confirmed complaint regarding pre-rolls contaminated with human saliva. The below packages of pre-rolls were manufactured by 3843 Euclid LLC (License Nos. PR-000098 and AU-P-000106) and dispersed to many marijuana sales locations.

All contaminated pre-rolls will have a label that indicates the license number of the marijuana business that sold the marijuana product as well as tag number assigned to the product in the statewide monitoring system.

**Note: An MRA investigation is still on-going and may result in additional future recalls.**
