## **SUB-DECREE**

ON

CONCESSION OF 126,928.39 HECTARES (ONE HUNDRED AND TWENTY-SIX THOUSAND NINE HUNDRED AND TWENTY-NINE POINT THIRTY NINE) HECTARES IN EIGHT PROTECTED AREAS IN KOH KONG PROVINCE AS THE STATE-OWNED LAND FOR DISTRIBUTION TO PEOPLE, WHILE RETAINING PARTIAL LAND AS PRIVATE PROPERTY TO BE HELD BY KOH KONG PROVINCIAL ADMINISTRATION

# HAS HEREBY DECIDED

# Article 1.-

Concession is made on the land area of 126,928.39 (one hundred and twenty-six thousand, nine hundred and twenty-eight point thirty-nine) hectares in eight national protected areas in Koh Kong province from the public property of the State as shown in the table below:

Into private property of the State for donation under the ownership of citizens while partial land being kept as the private property of the State owned by Koh Kong Provincial Administration, in which the map and coordinates are attached in letter no. 203 dated 02 February 2021 of the Ministry of Environment as the Appendices to this Sub-decree.

# Article 2.-

The mandate to occupy the private land of the State as stipulated in Article 1 of this sub-decree is delegated to State Land Management Committee of Koh Kong Province to apply for registration as the private land of the State for donation to citizens while partial land being kept as the private property of the State owned by Koh Kong Provincial Administration.

## Article 3.-

Land Management Committee of Koh Kong Province shall arrange the demarcation of border posts as stated in Article 1 of this Sub-Decree by deducting some suitable plots of land for public benefit, including the development of physical and social infrastructure, and shall carry out land registration and apply for land titles in accordance with the principles and procedures in force.

# Article 4.-

The Ministry of Environment shall prepare legal regulations to re-manage the natural protected areas in Koh Kong province in collaboration with the Ministry of Economy and Finance, the Ministry of Land Management, Urban Planning and Construction and Land Management Committee of Koh Kong Province in accordance with the laws and principles of the Royal Government.

# Article 5.-

Any provisions that are contrary to this Sub-decree shall be repealed.

# Article 6.-

The Minister in charge of the Office of the Council of Ministers, the Minister of Interior, the Minister of Economy and Finance, the Minister of Land Management, Urban Planning and Construction, the Minister of Environment, the Ministers of all Ministries, the Heads of all relevant

institutions and the Governor of Koh Kong Provincial Board of Governors shall be responsible for the implementation of this Sub-decree according to their respective duties from the date of signing.
