## Massport Inaugurates Buffer Zone In Charlestown

Massport Executive Director and CEO Stephen P. Tocco joined Charlestown residents on Oct. 27 to inaugurate the Medford Street Marine Terminal Landscaped Buffer Zone in Charlestown. The ribbon-cutting ceremony signifies the completion of the \$235,000 beautification project sponsored by Massport, with the help and cooperation of the Charlestown Neighborhood Council and Mitigation committee members.

At the newly refurbished site, which shields the neighboring homes from the former Revere Sugar site along the Charlestown harbor, there are flowering trees, shrubs and evergreens, allowing for year-round vegetation. The \$235,000 in construction funds, with \$30,000 from the Mass. Water Resources Authority as part of the community mitigation money, were provided for plantings, fencing and labor, in addition to necessary in-house contracts for building demolition and sidewalk and curb improvements. All Massport staff and community representatives negotiated objectives, criteria and goals for the buffer zone completion.

"Massport's responsi-

bility to energize the Port of Boston while being mindful of the needs and concerns of our neighbors is exemplified in the completion of this buffer zone," Tocco said. "The buffer zone not only mitigates the impact of our operational facilities, it also beautifies the area and upgrades the market value of abutting residential properties."

The beautification project began over two years ago. With the dedication of many people at Massport including Thomas J. Butler and Dorothy Steele of the Office of Government and Community Affairs, in addition to the Charlestown Neighborhood Council Chairman Peter Looney and Mitigation Committee Chairman Moe Gillen, the buffer

zone is now a reality.

It is a symbol of the commitment Massport has in being a good neighbor in the Charlestown community and it exemplifies the pride Charlestown residents have in preserving their neighborhood and surroundings.

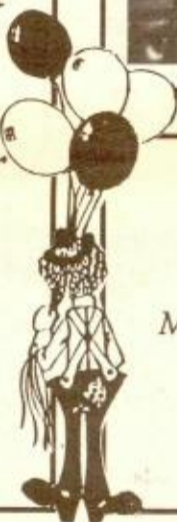

## JFW's Predictions For Election Day, November 8

### Statewide Results

2,486,250 registered voters will turn out for the state election on Nov. 8, (+/- 32,000 votes). Of the total number of Mass. registered voters eligible to cast ballots, 76.2% will turn out (+/- 1%). The turn out percentage will be the highest in 28 years, (78.62% in 1966) for a Mass. Gubernatorial-U.S. Senate final election.

Ted Kennedy will win re-election to the U.S. Senate over Mitt Romney. Kennedy will receive 57.3% of the votes cast to Romney's 42.7% (+/- 1%), a margin of 14.6% (+/- 1%).

Bill Weld and Paul Cellucci will easily win re-election to a second term as Governor and Lt. Governor over challengers Mark Roosevelt and Robert

Massie. The Weld/Cellucci ticket will receive 1,578,768 votes (+/- 25,000 votes). The Weld/Cellucci ticket will receive 63.5% of the votes cast for Governor/Lt. Governor (+/- 1%).

The Roosevelt/Massie ticket will receive 36.5% of the votes cast for Governor/Lt. Governor (+/- 1%).

In the Secretary of

State's election, former Democratic State Rep. William Galvin of Brighton will defeat Worcester Republican State Senator Arthur Chase 61% - 39% (+/- 1%).

Republican incumbent State Treasurer Joe Malone of Waltham will win re-election to a second term over challenger Shannon O'Brien, a Democratic State Senator from Easthampton. Malone will take 62% of all votes cast for Treasurer (+/-

1%).

Incumbent Democratic Attorney General Scott Harshbarger will win re-election over Republican challenger Janis Berry.

Incumbent Democratic State Auditor Joe DeNucci will win re-election to a second term.

### Suffolk County

In the Suffolk County District Attorney's election, Democratic nominee Gerry Malone will defeat Republican incumbent District Attorney Ralph

Martin. Malone will receive 53% of the votes cast for District Attorney (+/- 1%). He will win in Chelsea, Revere and Winthrop to off-set what will be an extremely close election inside Boston proper.

Of the city's 22 Wards, Martin will win in 13, Malone will win in nine. Less than 5,000 votes will separate the two candidates in the city. Each will receive 75-80,000 votes in Boston.

### Charlestown

71.4% of the registered voters in Charlestown will cast ballots on Nov. 8 (+/- 1%). The total vote will reach 6,330 votes (+/- 88 votes).

Ted Kennedy will top Mitt Romney in Charlestown 56% - 44% (+/- 1%). Kennedy will receive 3,545 votes (+/- 63 votes). Romney will receive 2,785 votes (+/- 63 votes). He will win one of Charlestown's seven precincts.

The Weld/Cellucci ticket will win in all seven precincts. Weld/Cellucci will receive 3,722 votes (+/- 63 votes) and take 58.8% of the Charlestown vote (+/- 1%). Roosevelt/Massie will receive 41.2% of the vote (+/- 1%).

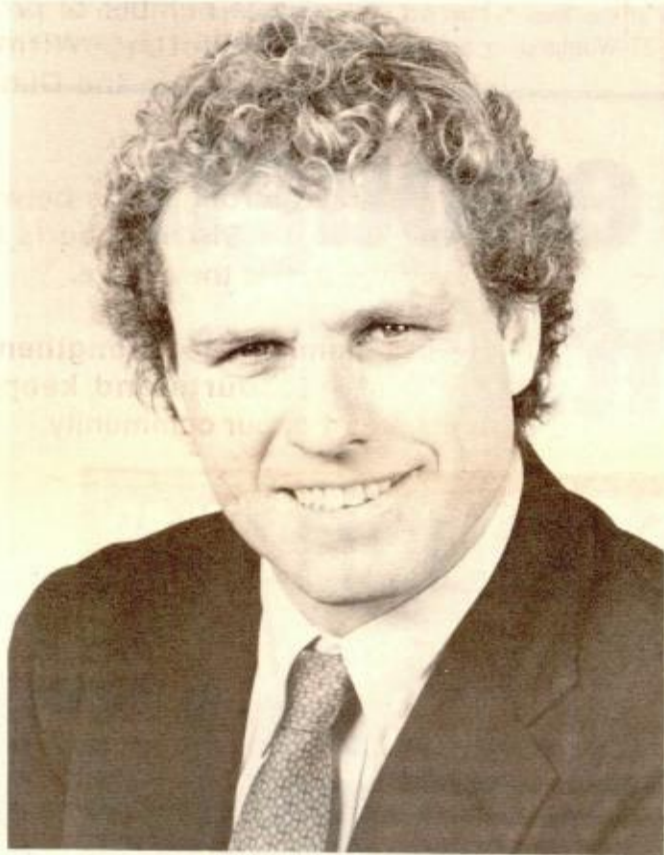
In the Secretary of State race, Bill Galvin will also win in all seven precincts. His vote in Charlestown will top 4,000 (+/- 63 votes).

## THERE'S STILL TIME FOR YEAR-END TAX PLANNING

As we near the gift-giving season, here's one present you can give yourself: a lower tax bill.

To start saving money, estimate your 1994 taxes. Then fine-tune your withholding and estimated tax payments. Your goal is to pay the IRS enough to avoid a penalty, without making Uncle Sam an interest-free loan.

If it looks like you're headed for an overpayment, consider skipping your fourth quarter estimate, or ask your employer to withhold less from your remaining paychecks. If an underpayment seems likely, increase your withholding, or consider making a catch-up estimate.

As a general rule, try to pull deductions into 1994, and postpone income until 1995. But consider the opposite strategy if you expect to be in a higher tax bracket next year, or if you're subject to the alternative minimum this year. Savings and 401(k) plans at work are excellent tax shelters, so consider participating to the maximum extent possible.

If you own stocks, bonds or mutual funds that have declined in value, consider selling them for a loss and replacing them with similar securities. This is called a "swap." But be careful not to swap for an "identical" security within 30 days, or the wash-sale rules will disallow your loss.

Up to \$3,000 of losses may be used to off-set salary, interest and dividend income. If you want to take even larger losses, consider selling some of your profitable holdings. Then, you may use an even larger amount of investment losses to off-set your investment gains. And since gains aren't subject to the wash-sale rule, you may immediately repurchase your winning positions.

### LAW PROPOSED BY INITIATIVE PETITION

#### Regulating Spending On Ballot Question Campaigns

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 4, 1994?

#### BRIEF SUMMARY

This proposed law would limit the way in which business and certain non-profit corporations could contribute to and spend money on campaigns involving an initiative, referendum or other question submitted to the voters at a state or local election. The proposed law would require ballot committees organized to support or oppose any question submitted to the voters to disclose promptly certain contributions made late in the campaign; would establish procedures that business and certain non-profit corporations would have to follow in order to spend money on ballot question campaigns; and would establish voluntary spending limits for

ballot committees.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would limit the way in which business and certain non-profit corporations contribute to and spend money on ballot question campaigns.

A NO VOTE would make no change in the way corporations may contribute to and spend money on ballot question campaigns.

#### Question 2

### REFERENDUM ON AN EXISTING LAW

#### Seat Belt Law

Do you approve of a law summarized below, which was approved by the House of Representatives on Jan. 4, 1994, by a vote of 105 to 49, and approved by the Senate on Jan. 4, 1994, by a vote of 26 to 11?

#### BRIEF SUMMARY

This law requires drivers and passengers in certain motor vehicles on public ways to wear properly adjusted and fastened safety belts. The law applies to persons driving or riding in private passenger motor vehicles or riding in vanpool vehicles or trucks under 18,000 pounds. It also applies to employees of cities, towns, counties and districts. The law does not apply to: (1) children under 12 years old who are required by another state law to use safety belts or other child passenger restraints; (2) vehicles manufactured before July 1, 1966; (3) persons certified by a physician as physically unable to use safety belts; (4) U.S. Postal Service rural carriers while performing their duties; (5) persons involved in operating taxis, liveries, tractors, trucks of 18,000 pounds or more, buses; or (6) passengers in authorized emergency vehicles.

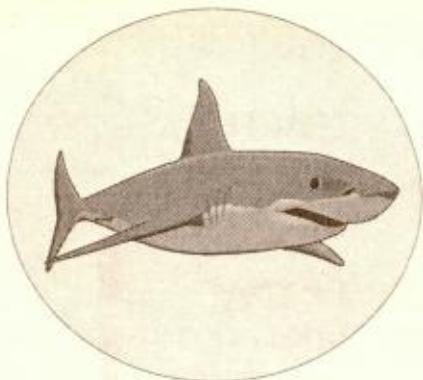
The law is enforced by law enforcement agencies only when a driver has been stopped for a motor vehicle violation or some other offense. A driver and each passenger 16 years old or older may be fined \$25 for each passenger between 12 and 16 years old who is not using a safety belt when required.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would continue the new law passed by the Legislature requiring use of seat belts.

A NO VOTE would repeal the new seat belt law.

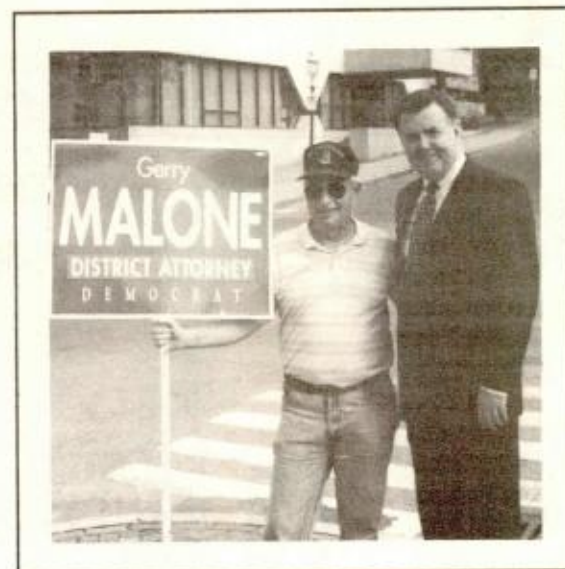

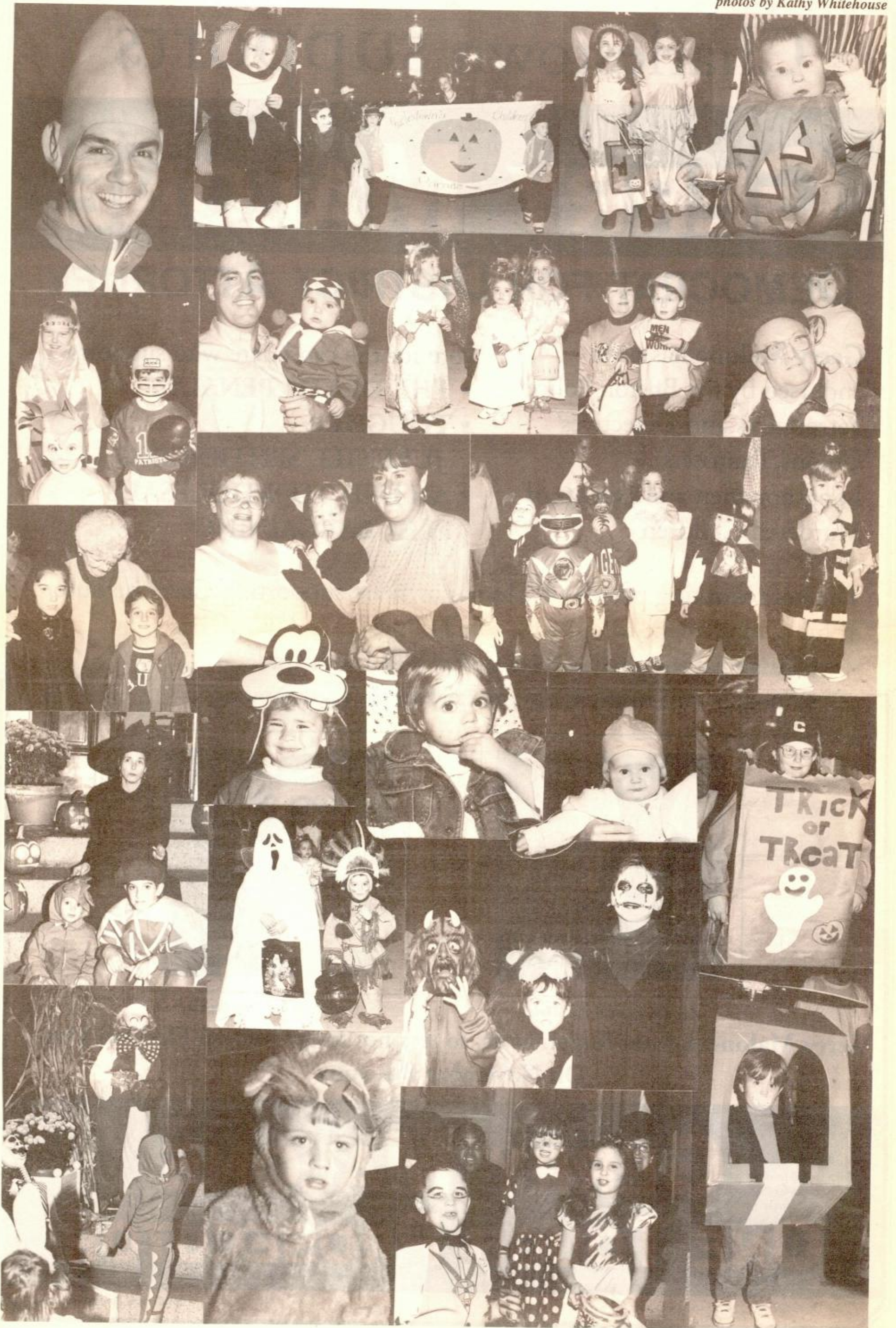



## Question 3

### REFERENDUM ON AN EXISTING LAW Changing the Law Regarding Student Fees

Do you approve of a law summarized below, which was approved by the House of Representatives on May 28, 1993 by a vote of 112 to 39, and approved by the Senate on June 23, 1993 by a vote of 20 to 19?

#### BRIEF SUMMARY

This law eliminates one of the two ways in which students may authorize fees to be assessed on tuition bills at state-operated colleges and universities to support non-partisan student organizations that attempt to influence state legislation.

The law applies to community and state colleges and the University of Mass. The law takes the place of previous law that allowed a student body, by a majority vote in an official student body referendum, to authorize a "waivable fee," or (at state colleges and the University) an "optional fee," to be collected for such nonpartisan student organizations. Under this law, the boards of trustees at community and state colleges and the University are prohibited from collecting waivable fees and may only collect optional fees for such organizations.

A "waivable fee" is collected when authorized by a majority of those students voting in an official student body referendum. A waivable fee is an amount payable on a tuition bill, appearing as a separately assessed item and accompanied by a statement that the fee is not a charge required to be paid by the student but rather that the student may deduct the charge from the total amount due. The tuition bill also explains the nature of the fee and states that the fee appears on the bill at the request of the student body and does not necessarily reflect the endorsement of the board of trustees.

An "optional fee" is collected when authorized by a majority of those students voting in an official student body referendum. An optional fee is an amount payable on a tuition bill, appearing as a separately assessed item and accompanied by a statement that the fee is not a charge required to be paid by the student but rather that the student may add the charge to the total amount due. The tuition bill also explains the nature of the fee and states that the fee appears on the bill at the request of the student body and does not necessarily reflect the endorsement of the board of trustees.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would approve the new law passed by the legislature that prohibits students from authorizing a waivable fee to be assessed on tuition bills at community colleges, state colleges and the University of Mass. for nonpartisan student organizations that try to influence state legislation.

A NO VOTE would repeal the new law regarding student fees.

## Question 4

### LAW PROPOSED BY INITIATIVE PETITION

#### Term Limits

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 4, 1994?

#### BRIEF SUMMARY

This proposed law would prevent the name of a person from being printed on a state primary or general election ballot as a candidate for one of a number of specified state and federal public offices, if the person had already served a certain number of consecutive terms in that office within a fixed period preceding the end of the then-current term of office. If such a person were still elected by write-in vote to one of the state offices (except the office of Governor), the person would serve without a salary, and in some of the state offices, without payment for certain expenses.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would prevent the name of a person from being printed on the state ballot as a candidate for certain offices if the person had already served a specified number of terms in that office.

A NO VOTE would make no change in the state election laws.

## Question 5

### LAW PROPOSED BY INITIATIVE PETITION

#### Opening of Retail Stores on Sunday Morning and Certain Holidays

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 4, 1994?

#### BRIEF SUMMARY

This proposed law would allow retail stores to open at any time on Sundays and on the legal holidays of Memorial Day, July 4 and Labor Day. It would not affect current restrictions on the sale of alcoholic beverages on Sundays and these holidays. Stores opening under the proposed law would be required to make Sunday and holiday work voluntary and would be required to pay most employees at least

one and one-half times their regular rate.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would allow retail stores to open on Sunday morning and on Memorial Day, July 4 and Labor Day.

A NO VOTE would make no change in the laws regulating the hours of retail stores on Sunday morning or on Memorial Day, July 4 and Labor Day.

## Question 6

### CONSTITUTIONAL AMENDMENT PROPOSED BY INITIATIVE PETITION

#### Graduated Income Tax

Do you approve of the adoption of an amendment to the Constitution, summarized below, which was approved by the General Court in joint sessions of the House of Representatives and the Senate on Nov. 16, 1992, by a vote of 132 to 39, and on May 25, 1994, by a vote of 119 to 73?

#### BRIEF SUMMARY

This proposed constitutional amendment would require Mass. income tax rates to be graduated, in order to distribute the burden of the tax fairly and equitably. The proposed amendment would require the rates for taxpayers in higher income brackets to be higher than the rates for taxpayers in lower income brackets. The proposed amendment would also allow the state legislature to grant reasonable exemptions and abatements and establish the number and range of tax brackets. The proposed amendment would eliminate from the Mass. Constitution the present requirement that income taxes must be levied at a uniform rate throughout the state upon incomes derived from the same class of property.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would change the state constitution to replace the current flat income tax system with a graduated system.

A NO VOTE would leave the state constitution unchanged, thus maintaining the current flat income tax system.

## Question 7

### LAW PROPOSED BY INITIATIVE PETITION

#### Personal Income Tax Changes

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 4, 1994?

#### BRIEF SUMMARY

This proposed law would change the state personal income tax laws if a proposed amendment to the Mass. Constitution requiring income tax rates to be graduated is approved at the 1994 state election. This proposed law would: (1) set graduated income tax rates to replace the existing tax rate structure; (2) change exemptions and deductions relating to dependents, child care expenses, head of household status and personal exemptions; (3) establish a property tax and water rate credit of up to \$200 for taxpayers below certain income levels; (4) increase the maximum income levels for no-tax status and the limited income credit; (5) establish a "capital formation incentive" to replace the existing capital gains exclusion; and (6) provide that taxpayers will not pay more than they would have paid under 1992 law, if their 1995 adjusted gross income is below certain levels. For instance, \$60,000 for single filers and \$100,000 for married couples filing jointly.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would enact into law graduated income tax rates, and would change certain deductions, exemptions and credits, if the proposed constitutional amendment requiring a graduated income tax system is approved.

A NO VOTE would make no change in the state personal income tax laws.

## Question 8

### LAW PROPOSED BY INITIATIVE PETITION

#### State Highway Fund Changes

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 4, 1994?

#### BRIEF SUMMARY

This proposed law would increase the portion of gasoline tax revenue that would be credited to the state Highway Fund; prohibit the transfer of money from the Highway Fund to other state funds for other purposes; declare that citizens have a right to a safe and efficient public highway, road and bridge system and require the state to develop a comprehensive seven-year state transportation plan; and make certain other changes in state finance laws relating to the Highway Fund.

The proposed law would require that the small portion of state gasoline tax revenues that is deposited in funds relating to the use of watercraft be deposited instead in the Highway Fund. No revenue deposited in the Highway Fund could be transferred to any other state fund for any purpose other than one for which the Highway Fund may be used.

#### WHAT YOUR VOTE WILL DO

A YES VOTE would increase the portion of gasoline tax revenue placed into the state Highway Fund, prohibit the

transfer of money from the Highway Fund to any other state fund for other purposes and require the preparation of a detailed plan for highway, road and bridge repair.

A NO VOTE would make no change in the operation of the Highway Fund, and would not require the preparation of a detailed plan for highway, road and bridge repair.

## Question 9

### LAW PROPOSED BY INITIATIVE PETITION

#### Prohibiting Rent Control

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 4, 1994.

#### BRIEF SUMMARY

This proposed law would prohibit rent control for most privately owned housing units in Mass., and would nullify certain existing rent control laws, except that cities and towns would be authorized to adopt a restricted form of rent control for a six-month period, after which compliance by property owners would be voluntary.

The proposed law would prohibit any city or town from enacting, maintaining or enforcing any law that requires below-market rents for residential properties. It would also prohibit the regulation of occupancy, services, evictions, condominium conversion, or the removal of the unit from rent control, if such regulation was part of a system requiring below-market rents. Existing state and local rent control laws would be nullified. The proposed law would not affect publicly owned or subsidized housing, federally assisted housing or mobile homes.

The proposed law would take effect on Jan. 1, 1995. The proposed law states that if any of its provisions were declared invalid, the other provisions would remain in effect.

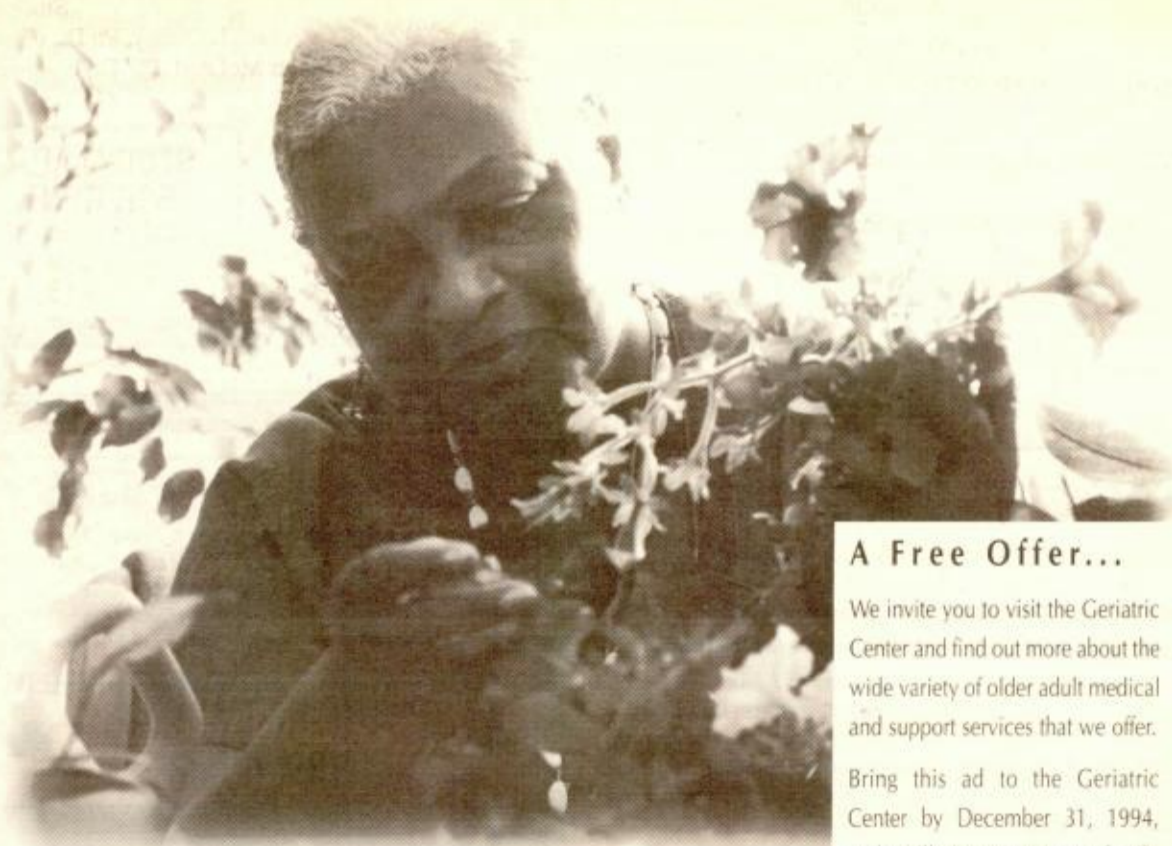
