- The network will carry out various activities for creating awareness, knowledge, data, intelligence, advocacy, and organize events and networking for promoting the industry growth


## **ABOUT SSC CONSULTING**

AVCA's 2016 H1 African Private Equity Data Tracker provides a summary of trends in private equity (PE) in Africa.


#### Key findings:

- 83 PE deals were reported in Africa during the first half of 2016
- Between 2010 and 2016 H1, there were 928 reported PE deals on the continent
- US\$0.9bn of reported PE deals were completed in Africa in 2016 H1. Overall, US\$22.7bn was invested in Africa PE from 2010 to 2016 H1
- 75% of PE deals completed in Africa in 2016 H1 were below US\$250mn in size; a similar trend was also seen in 2015
- In 2016 H1, Africa PE funds achieved a final close total of US\$1.1bn; 46% of the total
