The Flatley Company Donates Space To The Headstart Program

A ribbon cutting ceremony was held on Monday, February 29th at The Schrafft Center at Sullivan Square, marking the first day of classes for the Charlestown Headstart Program at the facility, in space donated by The Flatley Company. Over 2,000 square feet of classroom space, including two classrooms and an outdoor play area, has been donated to the program, enabling sixty-eight children to return to school for the first time since a three-alarm fire destroyed the program's facility on Moulton Street on December 17th.

It was evident that the children were very happy to be back to school. They were not particularly inter-

Who Will Develop Parcel P-2A?

Following a recess of the Charlestown Neighborhood Council meeting on Tuesday evening, March 1, council members were allowed to take a roll-call vote indicating their preference for a developer for Parcel P2-A, located at the intersection of Bunker Hill and Main Streets. This vote, according to Neighborhood Council Chairman Dennis McLaughlin, will not be considered a Neighborhood Council endorsement for any one particular developer, but solely a membership preference that will be forwarded to the Boston Redevelopment Authority

(BRA) along with the report from the Housing and Development Committee and a minority report submitted to the council and signed by ten council members.

This roll-call vote went as follows: Councillors Cullen, Cunha, Downing, Galvin, Golden, McClure, McHugh, Stone, White, Tobin and Spinetto voted in favor of Myerson/Allen; Councillors Lynch, FitzPatrick,

O'Brien, Page, Stillman, Vesey, Rodriguez, D'Ambrosio and Doherty voted for Gate 5 Associates and Councillor Mansfield cast a vote for the Crownshield Corporation; Councillors McLaughlin and Gillen abstained from voting and Councillor Whelan was not present.

This preferential vote (Myerson/Allen - 11 votes; Gate 5 Associates - 9 votes; (continued on page 10)

Democratic State Convention Delegates Elected At Ward Two Caucus

Over 150 Charlestown Democrats gathered at the Knights of Columbus Hall on Saturday afternoon, February 27th to elect delegates to the 1988 Massachusetts Democratic Convention which is slated to be held at Boston Garden on June 11.



KEVIN ROCHE, acting chairperson, read the rules and regulations to the Caucus prior to the vote for delegates and alternates to the Massachusetts Democratic Convention.

Acting chairperson Kevin Roche opened the floor for nominations. In all, six male and six female delegates and two male and two female alternates were elected. They will join some 3,500 other delegates, also elected throughout the state this past Saturday, to nominate a candidate for United States Senator and to consider amendments to the Democratic State Charter at the State Convention.

On hand for the caucus was Pat Chisholm of Everett, a member of the Massachusetts State Committee. She encouraged participation in the March 8 Presidential Primary and complimented the large turnout for this Ward Two Caucus.

Ward Two Committee Chairman John A. Whelan pointed out the importance of the March 8th Presidential Primary, telling voters to send Governor Michael Dukakis to Washington, following in the tradition of Adams and Kennedy. He also urged that voters cast a ballot for Representative Richard A. Voke, who is a candidate for State Committee Man, pointing out that Voke has done much for this community and deserves the support of the voters. Whelan also noted that the Ward Two Committee would also be on the March 8th ballot. He stated that there are twenty-one candidates for the twenty-one seats and that voters could cast their ballots for the individuals or pull the lever for the entire slate.

A slate of candidates had been circulated prior to the caucus and some campaigning had been done by several members of the slate — and that is the way the nominations went with six nom-

inations for the six male delegates, six for the six female delegates, and two each for the male and female alternates. By a two-thirds vote of the caucus, the allowed nomination speeches were waived and the election proceeded.

Residents Meet To Discuss New Parking Regulations For Charlestown

Parking — a word that send shivers up and down the spines of city residents — conjuring up images of circling the block in search of that elusive space, or maneuvering a station wagon into a space meant for a compact-sized car, or taking a lonely walk home after leaving that prized possession some blocks from your house.

The issue of parking was the focus of a community meeting on Thursday, February 25th as the Planning and Zoning Committee of the Neighborhood Council sought input from residents in establishing regulations as to the number of off-street parking spaces that should be required per unit of new residential and commercial development.

In order to familiarize the audience with the parking requirements that have been determined in other neighborhoods, hand-outs were passed out listing the ratio adopted in the Allston/

Brighton and Roxbury areas and those under discussion in East Boston.

Dave Armanenatti, special assistant with the Boston Redevelopment Authority (BRA), explained that the parking requirements would ultimately become part of the Interim Planning Overlay District (IPOD) for Charlestown that would guide development for two years until permanent zoning would be put in place, noting that the city had not been re-zoned since 1962. He said that the IPOD guidelines would evolve from the community through the Planning and Zoning Committee and then be approved by the BRA and Zoning Commission. He noted that parking is one of 12 areas that the committee will be addressing, along with working on a Master Plan for the Navy Yard.

The Allston/Brighton IPOD requirements for parking were the ones on

which most of the discussion was based. The ratio of newly created residential unit(s) to the number of off-street parking spaces were: one to three units — one off street parking space per unit; four to six units — 1.5 parking spaces; seven to nine units — 1.75 parking spaces; ten or over — two parking spaces. Also listed was the formula of one parking space for each affordable unit; 0.2 parking spaces for each elderly unit; and one parking space for every 300 square feet of retail or office space. These ratios would replace the current city zoning formula of 0.9 spaces per new unit.

Committee member Ken Stone stressed that these parking requirements would only be applicable to newly created units. As an example, Stone said that a new four unit building would be required to have six off-street parking spaces (four times 1.5), while a new 20 unit building would

have to provide 40 off-street parking spaces.

As for condominium conversions or the addition of apartments to a building, the parking requirements would apply to units created over the number originally in the building. As an example, a one family building being converted into a four unit building would require five off-street parking spaces (1.5 for each of the new three units).

Several residents felt that it was almost too late for such parking requirements — that development was proceeding at such a rapid rate that much would already be developed before such regulations could be put in place.

Mount Vernon Street resident Bob Wallace read a carefully prepared statement to the gathering. He stated, "In financial circles it is called economic growth, but to Mr. Jones on Monument Avenue and to Mrs. Smith on Bartlett Street, who have lived in Charlestown all their lives and who have sat back and and watched the over-development of their residential streets, the word is not economic growth, but greed."

Wallace continued, "Parking, housing and public safety are not three different issues . . . I don't believe you can address one without factoring in the other two. In the last few years,

major developments and developers in Charlestown found that the 'Townies' were finally addressing the parking issues, so the Old High School, Tontine Crescent, the Courtyard and all new large developments provide off-street parking with their units at 0.9, which covers the code."

"While these large developments were being addressed at public hearings," stated Wallace, "the more important and significant developments — the ones that would have the biggest impact on the residents of Charlestown — fell through the cracks. One and two family homes are being converted to three and four condominiums with no requirements to provide off-street parking. Think about it for a minute," Wallace told the residents, "if you have four or five conversions on your street, put them together as one and you have a major housing development that has not been made to address the issued of parking, not to mention public safety or affordable housing."

As for commercial parking, Wallace suggested that a parcel of land such as the vacant lot adjacent to the Knights of Columbus Hall on West School Street be paved and two hour meters be installed to service Main Street businesses.

Several issues were raised regarding the parking space provisions. Steve McHugh pointed out that it was one thing to create parking spaces and then sell the space at a considerable price. Stone added that a developer only has to provide parking, for as it stands now, the parking doesn't have to go with the unit. He noted that the Courtyard had 120 spaces and 80 units. He said that the abutters insisted that 80 spaces be sold with the units while the remainder could be sold to the public.

Committee Co-Chair Kathryn Downing stated that she felt that adopting these new off-street parking requirements would help address the problems created by the one to three condo conversions.

Duncan Gillespie said that the ratio of off-street parking to the number of units should be higher, noting that in units that sell for over \$175,000, there are usually two incomes which almost always means two cars.

Resident Dan Jaffe referred to the parking garage and lot at the Old Charlestown High School which he noted as being fairly empty as tenants are required to pay an extra fee for parking. He said that the result is that "neighbors are being locked out of street spaces while the garage and lot go empty."

Downing added that a problem with the developments such as Tontine Crescent, the Courtyard and the Old Charlestown High

School has been that there were no parking enforcement measures. Stone agreed, stating that these projects have to be overseen to ensure compliance with the parking provisions.

Ginny Goscinak noted the increase in the number of appeals to the Board of Appeal (BOA) for variances. She said that there seems to be a rush to get the variances as developers are aware that the IPOD is nearing.

Stone said that if such parking requirements are voted by the Neighborhood Council and a letter stating the results of such a vote was drafted, that the BOA would give strong consideration to such a vote, even before the IPOD was in place.

Co-Chair John Lynch questioned as to whether developers would then go before the BOA seeking variances from the parking on a "hardship" basis. Goscinak said that hardship before the BOA has to be on the condition of the land, not the developer losing money.

Terry Cullen stated that the BOA never asks the developer if the information presented to the Board is the same as was given to the community. He also suggested that the unit and off-street parking ratio be increased. He proposed that one to six units be required to have 1.5 spaces per unit, seven to nine have 1.75 and ten or more units have two per unit.

Some discussion occurred as to whether these regulations would apply to the Navy Yard. Armanenatti stated that these guidelines would be just for Charlestown proper and the Navy Yard would abide by existing zoning until the Master Plan has been established.

Several residents expressed frustration that parking issues would have to be considered twice — once for the community and again for the Navy Yard. Cullen pointed out that there is a problem with parking in the Navy Yard now and it is spilling out into the community. Wallace stated that he would like to see the "wall" broken down and these issues discussed as one. Lynch pointed out that the Master Plan for the Navy Yard is permanent, while the IPOD for the community is temporary and he stated that the Navy Yard has different considerations from Charlestown as a whole, namely fewer families and more commercial development.

The Planning and Zoning Committee will consider the various issues at their meeting, tonight, March 3rd at 6:30 p.m. in the BRA Offices, Building 34 in the Charlestown Navy Yard. They will then vote on a parking requirement plan for Charlestown. This, in turn, will be reported to the Neighborhood Council at their April 5th meeting for a vote by the full council.

Warnings Out — Fines In As City Code Enforcement Patrols Town

The City's Code Enforcement Department has undertaken a strenuous program to secure compliance with the City's regulations concerning trash and the condition of the sidewalks throughout the neighborhoods, including Charles-

town. Complaints were registered this week by several residents who found \$25 tickets attached to their property, citing various violations.

Carl Salvi, supervisor of Code Enforcement for the

City, stated that after two years of posting warnings on the property of violators, Code Enforcement will be issuing tickets.

Salvi said that the objective is a cleaner City and in response to a question on whether this was a means of generating revenue for the City, he responded that all money realized from Code Enforcement goes directly to the State's General Fund — not to the City.

There are several general categories that are being cited, stated Salvi. These include placing trash on the sidewalk for pick-up too early, the improper storage of trash, dirty sidewalks and failure to shovel snow from sidewalks. He said that the ticket fee varies as to the offense and whether the violator is a commercial establishment or a residential dwelling.

As for commercial establishments, Salvi stated that the improper storage of trash carries a \$50 fine. He said that every business

must have their own commercial contractor to pick-up their trash as the City doesn't collect commercial waste. He said that commercial trash can't be put out on the sidewalks before 6:30 p.m. and must be collected prior to 7:00 a.m. He noted that no loose cartons or paper bags with trash are allowed.

He also pointed out that a commercial violation for failure to sweep the sidewalk carries a \$25 fine and failure to shovel snow from the sidewalks is a \$15 violation.

As to residential dwellings, Salvi stated that trash may be put out on the sidewalk after 5:00 p.m. the day before the scheduled collection and may remain there until the City picks it up on collection day.

He said that improper storage of residential trash carries a \$25 fine. Salvi stated that three-ply or heavy duty plastic bags, cardboard boxes that are sealed and trash cans with

covers may be placed out on the sidewalk. He cautioned that paper bags, loose cartons and thin plastic bags are prohibited. He added that newspapers and magazines should be tied securely or placed in plastic bags.

Salvi warned that if trash is put out in advance of 5:00 p.m. on the day prior to collection, the violator could receive a ticket for each day that the trash remains on the street.

As to determining liability, Salvi stated that Inspectors will go through trash that has been the subject of a complaint or that the Inspectors view as being placed on the sidewalk on other than collection day and try to find a name and address within the trash. He said that if a name is found, that person will be cited. If no name is found, the landlord of the property on which the trash has been placed will be cited, stated Salvi, as the ultimate responsibility would lie with the owner of the property.

Salvi also noted that residents may also be cited for failing to clean or shovel snow from their sidewalks.

As for complaints from residents on violations, Salvi said that residents should report them to the Code Enforcement Office at 725-4896, Monday through Friday between 7:00 a.m. and 5:00 p.m.

He said that an Inspector would be sent out to evaluate the problem and a copy of the findings would be sent to the person making the complaint to apprise them of any findings and/or actions taken by the Department.

Salvi said that chronic violators are taken into Housing Court and, usually, a Clerk's hearing is held at which the violations are spelled out. He noted that such cases are kept on file and followed closely for six months. If violations continue, the case is then brought before a Judge at the Housing Court for further action.

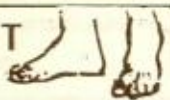

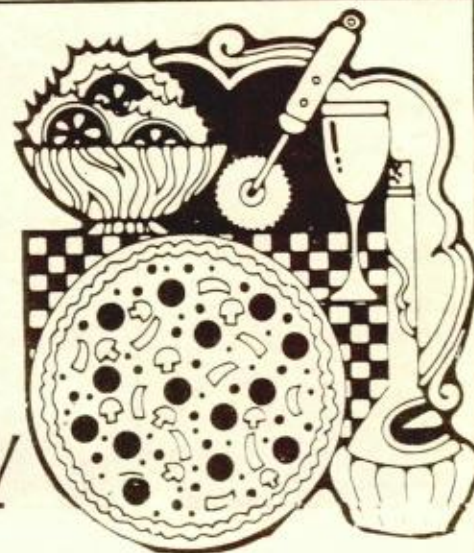

"picking themselves up by their bootstraps" to fight back in order to keep the program alive. Kennedy stated that when the word went out and the need was made apparent, "Tom Flatley saw the need and took it in a very personal way," noting that "it took an individual like Tom Flatley to give up space — space that could be rented out — to help out the people of Charlestown."

Kennedy also noted that the Headstart Program, nationwide over the past twenty years, has shown a return of \$4.75 for every dollar spent. Referring to a study taken of past graduates, he stated that compared to children not enrolled in the program, Headstart gradu-

ates are more likely to attend college, stay longer on a job and there has been proven to be a greater reduction in the number of teen pregnancies as well.

Thomas Flatley, president of The Flatley Company, remarked that "it was a call from (Congressman) Kennedy's office that got the ball rolling." He stated that when he found out the great need, "it was very important to us to find out how we could help out in this situation."

8th to benefit the Headstart Fire Fund. The celebration, which is being co-sponsored by The Raymond Group and Mayor Raymond L. Flynn, is entitled "The Place To Be On April 8th." It will take place in the Atrium of Building 149 in the Charlestown Navy Yard.

The goal of the event is to raise a considerable amount of money in order to make a major dent in the \$500,000 that is needed to rehabilitate the Old Kent School. The committee is seeking the participation of Charlestown and City-wide businesses in supporting and attending this \$100 per ticket event.

Who Will Develop Parcel P-2A?

and Crowninshield Corporation - 1 vote) differs from the Housing and Development Committee's vote taken on February 17th, which gave Gate 5 Associates - 7 votes; Myerson/Allen - 5 votes and Crowninshield Corporation - 3 votes. Thus, the ultimate decision as to who will receive tentative designation to develop this important parcel of land has been left in the hands of the BRA.

The minority report read into the record by council member Tom Cunha and signed by councillors Galvin, Tobin, Downing, Cunha, Stone, Golden, Spineto, McHugh and White, stated their preference for developer Myerson/Allen for the following reasons:

Myerson/Allen offered 16 affordable units compared to Gate 5 Associates' 14 affordable units; Myerson/Allen offered more open

space per square foot, including a tot lot and a small park, with those amenities not present in the Gate 5 Associates plan; Myerson/Allen presented a varied architectural scheme with a variety of housing types compared to Gate 5 Associates repeat of the same facade 28 times; Myerson/Allen offered a first view to a passer-by of a row of townhouses with Gate 5 Associates having no buildings facing Charles Street and presenting a view of back yards, clotheslines and parking. The letter expressed the ten councillors' overall concerns, stating that "the size of the parcel makes it our best hope of high quality affordable housing in Charlestown in the near future. Its location in Sullivan Square makes it a highly visible gateway to our community," and hoped that these "observations would constructively contribute to the development

of this parcel."

The morning after the meeting, Judy Evers, Community Liaison for the Mayor's Office of Neighborhood Services, stated, "The Mayor's Office of Neighborhood Services feels this is a win for the community. Many months of work have gone into this process. There was a close vote from both the Council and Housing and Development Committee, who listened to the concerns of the abutters on February 17th, and brought it to the full Council on March 1st. This vote proves both proposals are good. The BRA will review the proposals from a technical point of view. They will take into account the impact from the Neighborhood Council and the community in making their decision."

Senior Planner for the BRA, Larry Brophy, stated that he was "appreciative of the input from the community. The Authority staff will now evaluate the results of the reports submitted by the Council and make amendments to the proposal."

From the opening of the Council meeting until the recess was called, disputes took place on motions being accepted or not accepted. Repeated requests from members to be given an opportunity to vote on Parcel P-2A were dismissed as out of order by the Chairman. Efforts to have the Housing and Development Committee report on the Parcel accepted were met with a great deal of opposition.

Member Terry Cullen requested three times that the Chairman outline the process that would take place before the council members would be allowed to vote their recommendation of a developer for the Parcel. Cullen stated that he was "afraid that the opportunity will not present itself (to vote) and this report will become a defacto recommendation of the council when, in fact, it isn't."

At this point, member John Tobin, noting that the

hall was full of residents interested in the P-2A Parcel, asked that the floor be open for anyone to make additional rebuttal comments. Member Julia Rodriguez stated that she felt, as chairperson of Housing and Development Committee, that the meetings held by the committee had given the community enough of an opportunity to express their concerns. Member John Lynch agreed with her. Chairman McLaughlin also agreed with Rodriguez and ruled Tobin's motion out of order and called for a vote to approve the Housing and Development Committee's report.

Member Bill Galvin stated, "The apprehension the council has on passing the committee report is, would it be an endorsement for a particular developer?" McLaughlin then asked, "What is the difficulty of accepting this report on what the committee did?"

Tobin stated "The issue is that in the past, whenever a recommendation has come from the committee, it's been voted on. When are we going to vote on a recommendation on P-2A? We always have had a vote in the past" Cunha then added, "The Neighborhood Council would like to vote for an endorsement on P-2A. That is the next step in the process."

In anticipation of allowing the council to vote, a motion was made to accept the Committee report as read. A roll-call vote on the matter ended in an 11-11 tie. McLaughlin then voted in favor of accepting the report to break the tie.

When asked for a council vote on the parcel at that time, McLaughlin stated that "we are an advisory body, not a decision-maker. I can't suggest that such a body endorse anybody." Member Steve McHugh noted that under similar circumstances in the past, the council was allowed to vote. McLaughlin then stated that "the Committee has made their preference known by a roll-call vote."

Peter McClure asked when a vote by the council

Voke Cautions MWRA On Trucking Impacts In Charlestown

I am writing you regarding the Massachusetts Water Resources Authority's proposal to site an on-shore transfer facility at the former Revere Sugar Terminal in Charlestown. Having been involved with this issue for sometime now, I again feel compelled to offer my observations as to the needs of those I am elected to represent.

As you may have gathered from the recently conducted community meeting, the residents of Charlestown have no desire to further burden themselves as a panacea site for the ills of the Commonwealth. Besides your proposal of an on-shore staging area for the Deer Island Sewerage Treatment Facility, Charlestown is in the midst of the Central Artery North Area Re-Construction Project, currently taking place in City Square. Construction in this area is scheduled to last until 1994. In addition to this major project, the Charlestown Navy Yard is about to dramatically increase construction in this area, which is expected to further exacerbate local congestion problems.

There are several reasons for local opposition to trucking material into Charlestown. First and foremost among them is traffic. With the previously mentioned construction projects currently occurring, the streets of Charlestown are beyond capacity limits. Although MWRA representatives note the possibility of using off peak hours, I would suggest that the Charlestown experience indicates that travel during these times is also most difficult. Furthermore, there is no guarantee or protection that truckers faced with heavy traffic will not seek and use small residential streets which are not on designated truck routes.

As a family oriented community, many of Charlestown's 15,000 residents have children. Heavy trucking at anytime of day poses a very dangerous situation. Please note that both the local high school and community school are located on Medford Street, only a short distance away from the proposed MWRA site. With children using this area for both play and travel, I fear they will be forced to dodge trucks and subject them to possible harm.

The current trucking load makes for unbearable noise levels from 7:00 a.m. to 9:00 p.m., Monday through Friday. Any addition to this already excessive load would push the residents of Charlestown to the limit. Any proposed trucking after 9:00 p.m. would further burden these people during their only quiet time of the day. Aside from noise levels, which are detrimental to one's health, the pollution given off by these trucks would add to already high health hazards. As I have reported in my previous contacts with the MWRA, the initial results of a health study I commissioned have indicated that Charlestown does suffer from above average mortality rates for certain diseases. While we have a follow-up study currently underway to give us more information as to the causes of these rates, the issue should nonetheless be noted and addressed.

This leads me to perhaps the one feasible form of transportation into Charlestown — the railroad. The idea of using a railroad first came up at a small meeting the MWRA hosted with local activists and political leaders in April of 1987. The Maguire Group report on the feasibility of rail service shows this idea to be quite possible. Train usage would eliminate many of the previously mentioned objections to an on-shore staging area. It is my belief that rail service is most suitable to the needs of MWRA and more importantly to the safety and convenience of the residents of Charlestown.

Before proceeding further on the facility, it would appear that a full examination of the issues and alternatives I have mentioned should take place. Thank you in advance for your anticipated cooperation on this matter.

Abutters Of Main Street Parcel Compile Initial Development Guidelines

Dear Mr. McLaughlin:

At the Tuesday, February 23, 1988 meeting of the Development Committee of the Neighborhood Council, you asked that the abutters to 127 Main Street prepare some development guidelines for this important parcel in Thompson Square. It is our understanding that your instructions respond to our ongoing concern with Richard Held's plans for the site and his apparent inability to respond to the neighborhood concerns.

On Sunday evening, February 28, the undersigned abutters met to develop initial development guidelines for the site. These guidelines are as follows:

1. The buildings on the site should be no higher than 35 feet.
2. Structures should be built out to the street lot lines.
3. Parking ratios should be consistent with those proposed by the Zoning Committee of the Neighborhood Council and should be similar to those adopted by the Allston/Brighton IPOD. In this case, if more than ten units were proposed for the 127 Main Street site, two spaces per unit would be required.
4. Off-street parking provided for a unit must be deeded with that unit.
5. The design of the building(s) must be consistent with the existing structures in the neighborhood. In particular,

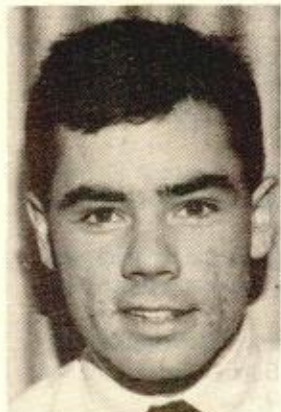

we recommend careful selection of materials, forms, scale, and historic images in the design of the structures. This is particularly important because the new building(s) will be located adjacent to a National Historic Register District and within the proposed City of Boston Landmarks District.

6. Pedestrian entrances and exits should be placed along both the Warren Street and Main Street facades so as to encourage activity throughout the day and evening along those streets.

7. Open space, by which we mean green space, should account for 20 percent of the lot size. Such open space should be placed at the interior of the parcel in keeping with the typical treatment of Charlestown yards.

8. Any garage doors must face towards the present liquor store.

9. An all-residential development is preferred over a mixed-use development on the site.

Given the time constraints we have worked under in responding to your instructions, we have prepared these initial guidelines for your working committee. We would recommend that the BRA design staff evaluate these guidelines and present to the abutters and the Neighborhood Council actual design options and schemes which would be possible under these guidelines. Then, the review process for Mr. Held's proposal would be a well-informed one and in everyone's best interest.

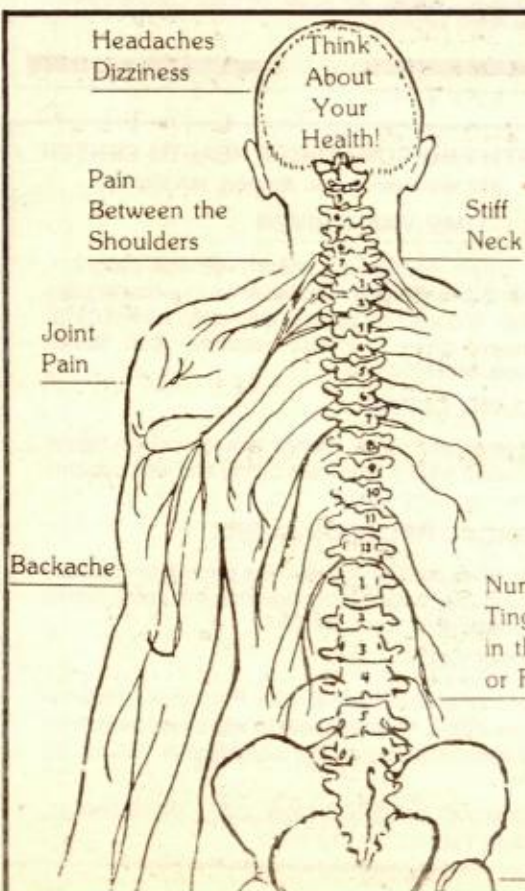

would be taken and Tobin asked, "why is this council being deprived of making a choice this evening? I want to vote to choose a developer." McLaughlin ruled the requests out of order. Tobin then requested a council vote be taken on the out of order ruling in asking for a vote on P-2A. A vote was then taken and could not be carried because it lacked the two-thirds majority necessary to over-rule the chairman. As a result, no council vote, therefore, was allowed to be taken on P-2A until after the recess and under new business. At that

time, the Chairman declared it a "membership preference vote" rather than an official council vote.

Other business discussed at the monthly council meeting included a report from the IPOD committee on a meeting held at the High School to discuss the parking issue in Charlestown. Committee chairman John Lynch stated that it was agreed upon to request on all new developments, including condo conversions, that 1.5 off-street parking spaces be required for developments with one to six new units; 1.75 spaces for seven to nine units; and

2.0 spaces for ten or more units. It was also recommended that affordable units have 1.0 spaces for each unit, elderly units have 0.2 spaces each and all commercial spaces have one parking spot for each 300 square feet. This committee discuss these recommendations and will meet with representatives of the Transportation Department on Thursday, March 3rd.

Basic Services Committee Chairman Moe Gillen reported on upcoming meetings with the Election Department to discuss polling places, the Bunker Hill Health Center to discuss the upcoming Health Fair and the Inspectional Services Department to discuss the possibilities of protecting the community against rat infestation as a result of all the construction work taking place in the community. When these meeting dates have been established, the **Patriot** will list them in the Calendar of Events.

Gillen also reported on a meeting held at the BRA office to discuss linkage monies. A new source of linkage monies discussed at this meeting was the possibility of charging a user's fee on all boat slips in the Navy Yard. This fee would be put into a fund and then distributed back into the community. Further meetings will be held to discuss the feasibility of this proposal.

The Housing and Development Committee also made a report of their February 23rd meeting on the proposed development at 127 Main Street. Following that meeting, the Committee voted to ask the council

chairman to write to the BRA and Board of Appeal requesting that no hearing be held on this proposal by Dick Held until after the April 5th Council meeting to give the community and Council more time to discuss the plans. A letter from abutters was read into the record stating their overall concerns with the plan including height, parking, design, and pedestrian entrances. It was also requested that Held include any future plans for the liquor store in the entire development plan. Another meeting with the developer is being planned. When the meeting date has been set, a notice will appear in the **Patriot**.

The MWRA Mitigation Committee report given at this Council meeting will be reported in the next edition of the **Patriot**.
