

Spiritual Capitalism

"In the beginning was the Word (Jesus Christ) and the Word was with God, and the Word was God. The same was in the beginning with God. All things were made by him, and without him was not anything made that was made." (John 1:1-3) King James Version (KJV) of the Holy Bible. Everything animate or inanimate that is within creation is controlled and owned by the Lord. Therefore, one should accept only those things necessary for himself which are set aside (by God) as man's quota, and one should not accept other things, knowing well to whom they belong. However, if man cannot acknowledge God's sovereign property rights, who will ever be able to respect the human rights all men are entitled to before and after birth?

Property rights first begin with God. The Lord is the Supreme Controller of everything that exists, so there is nothing in the creation that does not belong to the blessed Lord. Absolutely everything is the property of the Supreme Being, therefore, He is the only owner and self-sufficient, inexhaustible supplier of all living entities' insatiable needs, i.e. our supply and demands. "I am come that they might have life, and that they might have it more abundantly." (John 10:10b) KJV. Thus, there are no shortages in the Lord's creation; any shortage that we may experience in our personal lives or as a society is due to our violation of God's laws, or our interference with the inalienable secondary property rights of man, i.e. our bureaucratic interference with the principles of the free market economy. At the core of man's interventionism is the deep-seeded need of some (usually those who claim a false power or need) to steal the rights, goods, or property of others: "knowing well to whom they belong." "The thief cometh not but for to steal, and to kill, and to destroy." (John 10:10a KJV). Disregarding "He that will not work shall not eat." (II Thessalonians 3:10) (KJV).

Now, quotas vary from person to person. Many factors may or may not be considered under nature's stringent law of causality. Initiative or lack thereof is always rewarded whether its mundane or spiritual. You reap what you sow. Certainly, in order for man to prosper materially, the economic laws of God's nature must be obeyed. When considering a political or economic way of life, man's place within nature must be discerned. How should men relate to one another? What kind of political environment is necessary to successfully execute man's ambitions and elevate the needs of the body, mind, and spirit? Of course, man has the capacity to exist under almost any governmental system or condition, but why choose to suffer when there are other alternatives? Our answers rest in the manner in which God reciprocates with us. As living individual eternal beings, God gives us certain inalienable rights such as free will. We can either love and obey Him, or hate and disobey Him, His creation, which is His property which also includes man. The politics of envy does not recognize or

respect man's free will. The Bible and consequently, the Declaration of Independence (law of the land), recognize and respect this facet of God and man's relationship. "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain inalienable rights, that among these are life, liberty and the pursuit of happiness. That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed." A man's "right to life", and his freedom to choose, is granted by God and is not a privilege derived from government or mob rule. Inalienable rights mean "not to be transferred to another." The right to life, liberty, and the pursuit of happiness means that God has given man the freedom to produce wealth to sustain one's body, mind, and spirit for the furtherance, fulfillment, and enjoyment of one's earthly existence. Governments are established among men merely to secure, not to legitimize these rights. After all, governments are merely made of men, and no one man or group of men, can give sanction to one's right to exist. Flesh and blood people have a mind and a spirit which are covered with certain types of bodily forms and possess particular types of mentalities, requiring specific conditions for survival. Man functions best as a trader of goods and services, separate and distinct from animals and predators, whether two-legged or four. Therefore, he requires freedom of movement and choice. Since only dictatorial governments and mob rule can prevent this, man requires a social-political environment that recognizes, respects, and defends his rights against internal (domestic) and external (foreign) enemies via police force or military power. Freedom from government intervention is an essential prerequisite for strong economic development. God, who is the most intelligent and powerful being, as well as a benevolent spiritual autocrat, understands this, yet, possessing unlimited power, He does not cast aside our free will. Deep state corruptible government officials who fail to understand this and refuse to follow the Lord's example, usurp the people's sacred God-given rights and in turn rebel against the authority of the Holy Bible and the Declaration of Independence. The Bill of Rights was written by America's Founding Fathers to counteract this tendency and keep such perpetrators under the control of Constitutional Law as servants of the people.

Let me illustrate an extreme situation to help you to fully comprehend. Imprison and chain a creative and productive innocent man's arms, hands and legs. Shut off his mind by confining him to a cubicle without books of information. Restrain his free will via mind and body in totality. What would be the logical outcome? He would wither and die without the ability to create and produce. Now free this constricted man and observe his unlimited possibilities. He has the freedom to carry out the simplest to the most complex activities, engaging in life, liberty, and the pursuit of happiness, accepting only those things which are necessary for himself and those he loves. This free man is finally left unhindered to earn his quota and explore his own creative possibilities; to explore the unlimited inexhaustible wealth of God's material world which lies dormant until God's laws and principles of the free market (laissez-faire capitalism) allow it to manifest. Thank God for Capitalism. Thank God for Freedom, and thank God for the following story, "A Microcosmic Lesson"... Amen.

Survival

Once upon a time somewhere in the not too distant past or near future, a ship of 300 hundred or more diverse, sovereign-minded, freedom-loving, over regulated and over taxed citizens, secretly set sail for a new and promising land. They had become fed up with the New World Order's welfare state and with its over-bearing political power brokers. Except for two unlikely stowaways, the new life seekers were good-natured and peace-loving people, as well as pious, creative, productive, and staunchly independent. The stagnant and stifling political and economic atmosphere that they had renounced was virtually intolerable for such souls..."in such a place one should never live." They desired a breath of fresh air and a new lease on their economic life. Possessing a variety of skills, abilities, and high expectations, the competent voyagers had ultimately set sail for a new life. In due course of time, their ship sailed into a tumultuous sea storm which caused it to steer off course and flounder into unknown waters. They shipwrecked before reaching the new land. However, to their pleasant surprise the sea travelers were forced to land on a wondrous island of considerable size. Most of their worldly goods, personal property and provisions were salvaged before the ship sunk--leaving them forever isolated. From that day on, they were known as the "Isolationists."

This rich tropical island, bursting forth with lush green forests, a multitude of fruit trees, fertile soil, fresh drinking water, brooks, rivulets and rivers, was plentiful in minerals, metals, radiant sunshine and various living entities--all of which were our Lord's natural benedictions. This was nature at its finest, devoid of man, a virgin offering for humanity's ingenuity.

Aware that their provisions would not last very long, each person and/or family had to allocate necessary supplies for their needs. In other words, because they were human beings and not animalistic predators, they had to work. Pooling their resources, abilities, learned skills, natural skills and by applying trial and error, the resourceful group struggled for mere survival and thanked God for the opportunity. By utilizing a division of labor, they readily conquered the pangs of hunger and thirst. Cultivating the land, gathering fruits, vegetables, grain, and channeling for pure water, the little island community traded freely with one another. Those equipped with carpentry skills constructed shelters in exchange for other goods and services. Any particular trade or proficient endeavor became a marketable, eagerly acceptable commodity by the islanders. Demand was insatiable and the opportunities were unlimited. The enthusiasm was stimulating. The supply, due to human productivity, was ever increasing, and the rewards were more than sufficient. Life was tolerable under this simple barter system. Not everyone was equal in skills or abilities, but they all had equal, unhampered opportunity. That is to say, all were free to pursue their goals without hindrance, but no individual was required or obligated to provide a living or employment for another.

They recognized that man was not by nature a selfless dependent, but an independent volitional being who expressed this aspect of his nature in relation to other men as a free trader. The prevailing outlook was not "from each according to his ability,"

to each according to his need," (Karl Marx) but rather, each individual accordingly was willing to make do through his own independent, personal effort or perish. The thrifty islanders understood that they had no business trying to assist any adult who did not value his own achievements. It was considered immoral and dangerous to promote someone who refused to advance himself. They knew that attempting to alleviate a person of his self-inflicted indolence would only give him an excuse to evade responsibility.

Some individuals worked harder than others and consequently accumulated and stored a surplus of goods beyond their basic needs. This status freed them from mere animal survival and allowed them leisure time to develop spiritually and to pursue more creative and lucrative callings. Generally speaking, in this open, free, and moral social-economic structure, scarcely a soul begrudged his neighbor, because everyone was free to acquire as much or as little as they desired through their own endeavors. It was a volunteer society based on a freedom of choice.

One ambitious individual discovered a track of land rich in gold. Staking a discovery claim, he mined the product and opened the island's first mineral-ore trading post--thus establishing his property rights. To everyone's satisfaction, gold became the medium of exchange. Due to its essential nature of intrinsic value, all were willing to accept gold in exchange for numerous goods and services. The ability and desire to trade, gather and accumulate a hoard of gold for reciprocal transactions, raised the standard of living from a barter economy to a sophisticated, hard-money exchange system. As a result, a man's wealth could be measured by a durable asset rather than by perishable consumable items. Capital goods, such as various foodstuffs stored for rainy days, were naturally expendable. Gold, a durable commodity, did not spoil with the passage of time. This divine, precious metal was acceptable universally, malleable, coinable, portable, and scarce. It could not be multiplied or produced rapidly, thus negating its capacity to be inflated like paper currency on a printing press. Beautiful and useful for art, jewelry and industry, this most durable metal became the official money for this little island society. Thus, the island economy was protected by the gold standard. Production increased and everyone's standard of living escalated by unimaginable leaps and bounds.

As prosperity increased, many of the productive island citizenry saw the need to safeguard their hard earned wealth because they understood that gold could be a temptation to those who were willing to take it by force. Just as gold attracted the attention of good, industrious men, it also had the tendency to attract evil, lazy men.

The wise gold merchant purchased and converted an old grain warehouse into a secure gold storage facility. Island residents deposited their gold with the owner of the warehouse and were issued warehouse receipts, which guaranteed that the depositor had a certain quantity of gold in storage. The gold receipts were tradable for goods and services. A signature on the receipt by the receipt holder transferred his claim on the gold in storage to another person. Transactions became easier and less cumbersome, since it eliminated the carrying of heavy gold from one market to another. Eventually the

receipts became the major medium of exchange as the residents honored the receipts rather than the gold it represented. However, anyone could redeem their gold on demand simply by presenting their receipts.

Subsisting in the midst of this productive island community were the two rascal stowaways--Mr. Impulseo, a common criminal prison escapee, and Mr. Parasitetal, a corrupt ex-public official. Parasitetal, a most unsavory character, had been ostracized from the government by like-mined political rivals. He had been accused of misappropriation of funds, favoritism, kickbacks, conflicts of interest, employing relatives, cronies and flunkies. In addition, he had also been under the gun for drug abuse, womanizing, slum lording, lying and cheating. His accusers were also as guilty, but they were protected by government immunity. After he was indicted by a grand jury for taking public funds under the pretense of official government business, he decided it was in his best interest to vanish. Slithering away like his brother in spirit, Mr. Impulseo, the two rogues sought refuge amongst the hardy seafaring islanders.

Incapable of surviving in honest, laissez-faire capitalistic surroundings due to being "lazy-unfair" and having no marketable skills, Parasitetal and Impulseo were always looking for a handout or an opportunity to steal something of value from their fellow islanders. These dacoits and "range of the moment masters of the unearned," were the island's first and only unofficial "welfare cases." Both men possessed incurable criminal mentalities. In essence, they rationalized that what was yours was theirs. Mr. Parasitetal was obviously the more cunning and subtle of the two. He actually felt-being a man of feelings rather than thought--that working was beneath his dignity. Mr. Impulseo, on the other hand, was simply an outright thug. One day, while acting on an instinctive and purely impulsive whim, he committed a vile act of robbery and murder by breaking into the gold warehouse and stealing the gold supply and killing the gold merchant. As Impulseo was fleeing with the stolen gold, he was apprehended, booked, and jailed. After being given a speedy and fair trial, he was found guilty and immediately executed.



The Seeds of Government

In order to handle future disturbances, a governing committee of the most responsible islanders was elected. Philosophically inclined men pondered the nature of man and the proper laws for man based on his nature as a volitional being. They reasoned that there were certain inalienable rights that all men possessed--life, liberty, and property rights being the foremost. No man or group of men had any more rights than others. As such, any governing body's rights were limited by the individual's or minorities' rights. Even when the majority ruled, the rulings could not violate the minorities' rights--"for the smallest minority in the world is the individual." (Ayn Rand)

Individual rights were considered sacred. No group or great numbers, nor any governing body of people had rights greater than the individual or people who were governed. In fact, such a body derived its reason to exist from the permitting individuals which it represented. In order to progress in a society or just to live under normal peaceful conditions, violence and force had to be eliminated from human relationships. Government served that purpose. The taking of an individual life was the ultimate abuse of rights, the islanders reasoned. By virtue of their right to self defense, several men volunteered as protectors or policemen. They were supported by volunteer funds. Almost everyone with something to lose chose to support the island's enforcers or police. Those who did not do so were not forced to, thus they retained their right to choose for or against an issue.

The islanders chose to rule by law; the power would rest in a written constitution. The powers of government would be curtailed so that the citizens would retain the maximum amount of personal freedom. They understood that "a government governs best that governs less." All would remain free if all men confined their actions to that which did not injure others. An individual's rights could only be violated by another individual or group of individuals. The citizens obeyed and preserved this principle and law of the island. As a result, they continued to prosper as a free society and increased in number and in wealth. This story would end here except for one thing--Mr. Parasitetal was still around.



A Political-Economic Conspiracy

Parasitetal had managed to survive by nefarious means throughout the years. He was a lazy man and extremely envious toward industrious and work-ethic people. To him, such people were the embodiment of everything he hated in man. Expert in projecting a false image of goodness with a duplicitous smile, no one could actually imagine that this secretive evil-minded man was simply a perpetually plotting thief. He was a grinning jackal with a hearty handshake and a natural propensity for politics. He was a "Demon-ocrat." Sometimes he switched to "Reproachlican." He preferred government rule of the people--the mindless masses or a "mobocracy." Through such a vehicle, he envisioned anarchy (political disorder and confusion), ruled by one, one such as he, larcenous in mind and heart, a ruthless depraved despot who invariably meditated on the island's gold reserves. Being a coward, however, he could never do what Mr. Impulseo had done. Besides, he remembered well the swift island justice that had been dealt the unfortunate Mr. Impulseo.

A devout advocate of the New World Order's social welfare state, Mr. Parasitetal entered into the political arena. In a free society this is allowed, but it's the responsibility of the constituents to fully understand the advocates of such malignant philosophies and what they are really after. Skillfully, Parasitetal manipulated voters to get himself elected to the island's governing council. "He spoke one way but he looked another." In other words, Parasitetal employed an age-old conspiratorial tactic to get elected. He spoke of limited government and free enterprise from his political platform--which helped to win the votes of honest men. After he was elected, he proceeded to methodically eliminate the rights of man through the political apparatus of conspiratorial unlimited socialistic government.

Parasitetal surreptitiously took office, which by the way did not pay a salary--a system devised to ensure that the governing body spent less time in public affairs and more time as productive members of society. Parasitetal had to change that because he was not a productive member of society. So he started a campaign for bigger government with big, big salaries for elected officials. He actually wanted to make politics a "profession," a previously unheard of phenomenon. The Parasitetal platform called for a redistribution of wealth from the "haves" to the "have nots." He justified his claim "in the name of the needy." Someone pointed out to the "Parasite(tal)" that under their unregulated laissez-faire market system, there were not any needy except for perhaps the nonindustrious Mr. Parasitetal. Parasitetal on the other hand claimed to be a public-spirited altruist whose sole concern was for his fellow man's welfare. The proud and self-sufficient islanders additionally informed Parasitetal that everyone was responsible for their own welfare and were able to take care of their own and liked doing so. Those who were legitimately less fortunate, like the mentally and physically disabled and the elderly, were supported on a volunteer basis by private funding from foundations, churches, families, good natured individuals and other private sources. Public dole-outs

were the exception rather than the rule and was not a fruitless pastime indulged in by gullible men. Mentally and physically healthy souls either worked or starved--with everyone's blessings.

The islanders were deeply aware that New World Order welfare programs did not work. They knew that you could not give a man something for nothing, and that a person should be allowed to starve. By experiencing the pangs of hunger, one acquired the incentive to work. (Thus, there would be no need for work incentive programs. Nature attested to that through stomach cravings.) Once a person who had an unnatural inclination not to work began to work (any kind of work), he would want to improve his lot. Work itself was therapy for the lazy. Thus, a man next needed to acquire knowledge, either formally or through self-education, in order to raise his standard of living. This was his responsibility, and his alone. To have denied this with give away programs would have done a man the gravest injustice. The islanders understood that a system, person, family or country that supported dependency destroyed the recipient's independence. Supporting idleness encouraged uselessness and human waste. They showed their love and support for their fellow man by allowing him to starve. "He that will not work will not eat (except for sickness or disability), for the labors of 30 or 40 honest and industrious men will not be consumed by 150 idle loiterers." (II Thessalonians, 3:10). "A man cannot even maintain his physical body without work." (Bhagavad-gita, 3:8)

Regardless of the overwhelming evidence presented against New World Order government interventionist policies, Parasitetal arrogantly persisted in having his way. He knew that in time he could wear them down and "good men would do nothing.". Eventually, many of the less intelligent islanders, some who were inclined toward brainlessness, began to listen to and even support Parasitetal's tranquilizing "verbalage." Influenced by the mode of ignorance, some of the islanders abandoned their common sense under Parasitetal's sway. His unscrupulous suicidal agenda demanded that every aspect of the citizens' lives come under New World Order government control and regulation. "One chain for the neck of humanity." (Stalin) Parasitetal offered compulsory social security, socialized medicine, and various social programs as bait. In other words, he offered socialism. Everything was to be "free." Of course, "free" was another word for tax. For "the public interest," Parasitetal's social policies demanded programs with him as the programmer (taxer) and the populace as the programmed (taxed). Ownership of private property decreased, while public property increased in areas of public utilities, public libraries, public schools, public housing, public health services and public servants, spearheaded by that "great" public tax regulator and "social metaphysician," Parasitetal. He was the epitome of Marxism, "from each according to his private ability, to each according to his (Parasitetal's) public needs." Of course there were many who did not fall for this nonsense, but their voices of reason were belligerently silenced by the mindless majority of "newly enlightened," overbearing loud mouth masses who no longer chose to think for themselves. Their minds, wills, and souls had been sucked in by the thirsty Parasitetal, who operated under the guise of New World Order governmental decrees.

Parasitetal was gifted with other inner qualities that would well serve his conspiratorial purposes. A pragmatist by nature, he knew that in order to actualize his policies he had to control the economy's money supply. How else could he steal and remain free from danger of exposure? Therefore, he employed two methods of operation: taxation and inflation. Parasitetal was a skilled politician who knew that outright continuous taxation would arouse the anger and protest of the island citizenry. He knew that they would start redeeming and hiding their gold out of self-preservation, thus refusing to be taxed (and this actually happened). So, Parasitetal resorted to devaluing the money supply of the people by inflation. He would inflate the money by artificially increasing the supply through illegal and "legal" counterfeiting. Parasitetal understood the envious philosophy of evil advocated by the Marxist-Leninist school of thought, which was that inflation would destroy the free market. Parasitetal's first plan of action was to gain control of one of the island's private gold warehouse reserve banks by creating a crisis for which others would be blamed. Next, he would offer as a solution to the evils--which he had actually orchestrated--a Federal Deserveboard Reward known as FDR. He knew that gold was scarce and that the quantity was limited and impossible to counterfeit. So for the sake of expediency, he bribed and blackmailed (through hidden channels) one of the gold warehouse bankers into issuing more gold receipts than there was actual gold in the warehouse. The banker became a receipt counterfeiter via Parasitetal's government influence. The Parasitetal government now had the ability to inflate the money supply which they did in a rapid and unrestrained manner. quantity of paper gold receipts in circulation accelerated to such a degree that prices all over the island suddenly rose. Through various secret Parasitetal government funnels, counterfeit gold receipts were popping up everywhere. Legitimate gold receipts holders panicked as their wealth and consumable goods began to disappear right before their eyes. They lost confidence in the real gold receipts and returned to the warehouse to redeem their gold. But as more and more legal paper receipt holders asked for their gold, they discovered that there was not enough gold left in the warehouse to support the demand being made. They were attempting to keep the warehouse banker honest by endeavoring to redeem their gold, thus restraining the inflation and forcing a return to a strict gold standard where gold would become the actual money supply. Unfortunately, Parasitetal's operatives had made an illegal "run" on the gold reserves and had cashed in with the counterfeit receipts. The warehouse banker had to declare bankruptcy. Parasitetal's hidden hand remained undetected in the matter and he personally led a public crusade to prosecute the gold warehouse banker for fraud. The duped banker was arrested, tried, convicted and sentenced to a long jail term. Meanwhile, the Parasitetal government stashed the gold.

Parasitetal was a hero in the incomprehensible eyes of the people. This was fertile ground for the calculating charlatan to introduce part two of his plan--governmental inflation, which was the <u>only</u> agency that could "legally" counterfeit. He surmised that the mindless majority were ready to commit moral suicide due to his previously undetected inflationary scheme which had forced the economy into a depressed state. Now he could introduce the Federal Deserveboard Reward (FDR) as a solution. In reality, this would be a <u>private centralized bank</u> with the veneer of Federal legitimacy.

Parasitetal's government would legislate into existence a bill known as the Federal Deserve Act 1-9-1-3. Parasitetal's plan was simple. He wanted to gain control over the entire island treasury, i.e., "go for the gold," and to bring an end to the gold standard and institutionalize controlled inflation, thus enabling him (through scientific inflation), to reallocate unearned income to others, and more importantly, to himself.

All privately owned gold receipts were declared invalid or just a collector's item. Parasitetal explained that this was a "service to the public" that was granted in order to prevent future counterfeiting by unscrupulous warehouse bankers. "The gold standard had been given a chance and it has failed," Parasitetal resoundingly preached. Island legislation called the "New Peal" was introduced and ratified by a new governing body of leech-like men of Parasitetal's caliber. Such opportunists always surfaced to the occasion whenever and wherever there was a decline in civilization, eventually replacing the original limited government advocates. Some of these new governors now holding public office were the perpetrators and members of Parasitetal's previous warehouse gold receipt inflation gang. They promoted costly programs and policies which they claimed were necessary for economic crisis' recovery, reform, relief and social secureness. These were crises that they had purposely orchestrated. That was the essence of the New Peal. Through their Federal Deserve Act 1-9-1-3, the Parasitetal government became a "legal counterfeiter."

Parasitetal established himself as National Treasurer. The gold standard was officially ended and all privately earned and owned gold was declared illegal, nationalized "in the name of the people," confiscated (stolen), melted down and stored in a remote, heavily arm guarded island "asylum" called Port Knocks. Legitimate gold receipts were called in and a new medium of exchange, toilet paper certificates, were printed by the island Treasury Department and issued by the Federal Deserve. The front of each note read "Parasitetal Deserve I.O.U. Note," "Legal Tender For All Debts, Public and Private." The back of each note read, "Not Redeemable in Gold - Trust Me." The Parasitetal government rolled out the printing presses and increased the money supply, and as a result, the island economy was engulfed in toilet paper certificates. False prosperity pervaded the economy. The people were blindly exchanging real goods and services for unbacked toilet paper. They were assured by Parasitetal constituents that the government's magical printing press was all the backing they needed, because gold (a real commodity value) was outdated.

Rampant inflation eventually overwhelmed the entire island economy. Goods gradually ceased to appear in the marketplace. Bad money drove away good money. A productive man would go to the marketplace to transact business, only to have inflated paper money to devalue his spending ability and consume the goods and services before he could make a purchase. He was unfortunately left holding Parasitetal's I.O.U. notes with very little purchasing power and no product. Some islanders saw this inflation for what it really was--a sneaky method of taxing or stealing the real wealth of the people.

Many tried in vain to redeem their "Parasitetal Deserve I.O.U. Notes." Instead of their gold being relinquished, they were issued more inflated paper in exchange. This time the paper was entitled "Convertible Parasitetal Deserve Note." The people had been "legally" robbed by their government.

The Parasitetal government managed a disinformation campaign and shifted the blame of inflation onto everyone from the budget conscious housewife to the unsuspecting businessman. No longer did anyone understand simple economics. Many desperate islanders had hidden some of their gold coins and traded on the black market, which unofficially became the real market. Parasitetal's government constantly threatened them with "fines and/or imprisonment," but these last vestiges of free marketers were hard to control. So, Parasitetal counteracted their defiance by summoning the ancient technique of coin clipping. He gradually confiscated the precious gold coinage, melted it down, merged it with a cheap metal, recoined it exactly as before, and finally passed it off in unlimited quantities as the original. The Parasitetal government had become the ultimate counterfeiter.

By now Parasitetal was in total control of the money supply. He could do anything he wanted with the people, even though his power was false. However, there were certain economic laws that he could not defy. For instance, he could not instill real value in his worthless pieces of toilet paper. His paper money worked for a while only because it use to have value as it rode on the current of a strong but wavering economy. Real value or wealth was nurtured in an environment of freedom and was born of hard work, personal initiative, inventiveness, creativity and production. Real wealth did not come from a printing press or from government decrees which carried no legal requirements to have collateral behind the paper.

Unsurprisingly, Parasitetal's economy collapsed. His dollar was more worthless than the paper it was printed on. He responded to this dilemma by issuing more toilet paper. The value of the paper depreciated further and consequently prices continued to rise as the people rushed out to spend their toilet paper before it depreciated even further. The stench of inflation was answered with more manufactured inflation. "Issue more tissue," screeched Parasitetal as the money supply was allowed to increase without restriction. Such artificial wealth enabled Parasitetal to finance all of his New World Order governmental pet projects, but at a tremendous price to the island economy. Hyper-inflation was the result of this unrestrained increase in the money supply. This tremendous flood of fiat money which caused price inflation put a strain on the island's marginal producers. To disguise the effect of this policy, Parasitetal's government imposed price controls. However, his price controls, like all price controls never ended inflation but created shortages and/or forced price controlled commodities off the free markets. When the official free markets were regulated and controlled out of existence, underground markets or black markets emerged. The paper flow then altered the course from Parasitetal's controlled economy to the uncontrolled economy. Parasitetal counteracted--as he did with his coin clipping scheme--by enforcing more paper expansion, thus causing even the prices of the uncontrolled goods to rise rapidly.

Parasitetal's "solutions" were the source of the problem--solutions which had created more problems. Underground market prices were in proportion to the risk the black market entrepreneurs had to take. The risk premium went from high to enormous, for Parasitetal had devolved to a new low in "solutions" by imposing draconian penalties on the black marketers.

Eventually, a national emergency was declared and rationing was inflicted as part of the "new solution." The people stood in long food lines for long hours, with long inflated money and long faces, longing for what was not to be. To deal with the commodity shortages and consequential job layoffs, an improvised economic contradiction called "government employees" was established--an army of non-electives known as civil servants, a new working class that was dependent on the Parasitetal government. Of course, he had to inflate and levy taxes from free-market employees to pay their non-productive salaries. Basically, these wards of the state were masters of paper pushing, shuffling, red tape and BS. As the ultimate bureaucrat, Parasitetal insisted on rigid adherence to rules, forms, boring routines and laborious details. Naturally, this need to follow complex ritualistic procedures impeded effective action; but of course, everything was now ineffectual. Also, these made-to-work recipients obviously did not manufacture any tangible products. They were, shall we say, social economic anarthas (an unwanted thing). Since there was no profit motive or need to produce a purposeful commodity or service, nor any incentive to be inventive or creative, none of these tiny bureaucrats really cared abut their dried out government jobs. They were spiritless, inefficient, unenthusiastic, clueless, thewless, spineless, lazy, pretentious, wasteful, careless, puffed up with false position, arrogant, angry, rude and mouthy to the very public they claimed to serve. The means of production and its by-products were not privately owned by the bureaucrat so they felt no real obligation to serve--bureaucracy was their only stock and trade.

This bureaucratic burden put an additional strain on capital for real business expansion and invariably real jobs. Parasitetal taxed and redirected business profits ("the redistribution of wealth") from the useful producer to the useless bureaucracy. Consequently, new businesses ceased to manifest into actuality. The people had forgotten what their predecessors "had set sail for" and were dubious that such a state ever existed or could exist. "How quickly they forgot." Only Parasitetal's government jobs and his New World Order socialistic welfare redistribution schemes could satisfy their sense of "false" security and desire for mediocrity. They had literally become an alien species--walking, breathing, tax embodied burdens. It was hard to believe that they were once a free, productive, and independent island (country), that was now reduced to being dependent on the government dole.

Further solidifying his power, Parasitetal passed government monopolistic legislation that prevented honest free market entrepreneurs from entering and freely competing in various fields. The government wanted to completely control transportation and utilities. To encourage and finance these fields of endeavor, Parasitetal passed a progressive tax law called "The More You Make, The More We Shall Take Reserve

Act." The revenue acquired from this bill was then used to compete against the victims of the bill--the free market capitalistic businessman--who had become a forgotten endangered species. A new type of special interest businessman "oozed" from this "(b)ill," as the once productive free market businessmen were eliminated because of it. Incapable and fearful of competing on the open free market, for this new species of political power broker "businessman," success was dependent on lobbying for government grants, loans, protectionism, subsidies, favoritism, and all manner of special interest influence legislation. In order to expand his business, at the expense of the real market, heavy progressive taxes on productive free market entrepreneurs were levied, which also supplied the "new businessman" with his so-called grant money (taxes) and government loans.

When private lenders or banks refuse to employ their funds with a particular individual after scrutinizing their credibility or credit, it is to be understood that such a person is considered to be a bad risk. Due to self-preservation, private lenders must be cautious in making loans, and a banker in particular is the guardian of other people's wealth. Credit is not something a banker or a private lender gives to a person, but on the contrary, credit is something an individual already has because he already possesses marketable qualities of a superior monetary value than the actual loan for which he is requesting. Any individual who is qualified for a loan brings his character and or past business record of success. This is why a lender risks a loan. The lender feels secure of repayment; he does not give something for nothing. If the lender makes a mistake, he not only suffers, but goods that were supposed to be produced are not produced and resources that could have been used more efficiently are wasted.

Parasitetal's government grants and lending apparatus did not operate by the same strict practical standards as private sources. After all he could dip deep into the well of public funds. Parasitetal's grants were a complete give away. His government loans rested on Karl Marx's altruistic philosophy of "From each according to his ability, (the producer or lender) to each according to his need," (the wasteful, unqualified borrower). Parasitetal's argument was that he was only making loans to people who could not get them from private lenders. This was his way of saying that his government bureaucratic lenders were willing to take risks with the taxpayers' money that the taxpayers were not willing to take.

The Beginning of the End

Curiously, Parasitetal's standard of living improved. His "new businessmen" also prospered. Parasitetal and his government accepted off-the-record payoffs and on the record privileges and benefits from these economic scavengers in exchange for continued government favors. As a result, the people went from prosperous to poor. As a "solution" to their poverty, Parasitetal passed the "Money Tree Act." As a spendthrift, he was a believer in credit expansion for solving economic ills. He fantasized creating credit from nothing since it was "official" that wealth no longer came from productivity, but from deficit spending and a government printing press. Predictably, Parasitetal's credit bubble collapsed. The market system had become so altered by the non-producers that it could not function properly. It could no longer give something for nothing. Out of fear and desperation, those who had once supported Parasitetal's policies, now demanded back their gold. Parasitetal no longer disguised his motives with "solutions" or even bothered to issue useless I.O.U. Notes or Convertible Notes as before. He simply refused to return the gold, being the thief that he was.

Parasitetal's government stood on the threshold of the end of an industrial economic age. As events were marching on, his government would not and could not "protect" the people from the inevitable yet irresponsible contrived downturn of an economic cycle. It was a time of widespread suffering as the once beautiful tropical island had become a nightmare jungle of New World Order governmental conspiracy, inflation, deflation, censorship, regulations, controls, credit over expansion, protectionism, favoritism, nepotism, housing subsidies, welfareism, deficit spending, borrowing, insurmountable national debt, interest on the debt, interest on the interest, paper money without gold backing, socialistic legislation, and taxation. It was a complete breakdown in civilized society. Chaos reigned supreme in the streets. Riots, looting and war between the "haves" and the "have nots" was the order of the day. Yet, in truth, there was no war between the two groups, the "haves" and "have nots" (what they "have not" is a free market). But the people no longer realized this factor. Geographical areas throughout the island became ungovernable. Warlords and thugs began to surface. Arson, rapes, robberies, drug trafficking, massive unauthorized animal slaughter, racism, illicit sex, abortions, diseases, gambling, fraud, stabbings, shootings and murder flourished. The most ruthless criminals became rich and powerful under the Parasitetal influence. Island politicians and common criminals became strange bedfellows, as revolving door justice ruled the courts. A criminal could kill a man, steal his property, molest his children, rape his wife, be out on bail the same day and have his case dismissed within a week on a technicality, regardless of the overwhelming evidence. This liberal new way of handling criminals was done in the name of "penal enlightenment," so they said, but the real reason was to keep the citizenry controlled through fear and manufactured crises. Of course, if a crime was committed against a politician or deep state the criminal was thoroughly, effectively, and immediately sought, arrested, prosecuted, convicted and sentenced. To add insult to injury, honest citizens no longer had a right to bear arms for their protection and were subject to unreasonable fines and imprisonment if they violated the political council's unconstitutional gun control laws. In this regard, politicians

absolutely refused to see a difference between the criminal and the lawful citizen wanting to protect his own. Yet even the most restrictive gun control laws failed to keep criminal gun killings from getting out of control. Anyone with an ounce of sense knew the reason--punish the gun toting criminal not the citizen for bearing arms for self-defense. Meanwhile, honest businessmen were strangely prosecuted for what was called "economic crimes" or anti-bust laws as the real criminals enjoyed a reign of terror. Parasitetal, adding more insult to injury, abolished capital punishment in the name of "man's inhumanity to man." No one challenged this law or remembered the victims or even considered what such a policy would mean to future victims. Consequently, violent crimes multiplied while court judges played havoc with citizens' lives as they recklessly re-interpreted the island constitution in favor of the criminal. No one knew how the judges came to acquire so much power and indiscretion. They were out of control. They could not be checked and balanced.

Civilization had been surrendered to the suit and tie barbarians and the local thug. Citizens were bled from every fiscal artery. Muggers relieved them of their wallets at the point of a gun and their paychecks were mugged by public officials in the name of taxation.

The jaws of depression were inevitable. Without a stable economy, i.e., currency, business as usual could not continue. The country was bankrupt and the economy collapsing. Numerous government study groups and politically correct review committees and councils were formed to deal with the crisis, thereby creating an increasingly larger bureaucracy. The political boondogglers hatched more foolish "feel good" social schemes. They first and foremost voted for themselves a 50 percent pay hike on a deficit budget and then expressed shock and indignation when the public objected as they simultaneously pork barreled their constituents. They fought among themselves and scrambled for more power, stopping only long enough to think of new ways to squeeze the people dry. It was an endless, vicious cycle. Eventually, the powerful Parasitetal was dethroned by the bullet of an assassin, who was obviously impervious to the gun control laws. No one, not even Parasitetal's mother, mourned his death. Neither friend nor foe knew who had done him in (so they claimed). It did not matter as he was replaced by someone just as corrupt. His policies as well as the policies of all deceased bureaucrats, lived on, and a song was composed in his dishonor, "Hail to the Thief."

In the thick of all the madness, a small group of remaining freedom lovers escaped to the west of the island. They resurrected their original constitution. A new and free society was formed. They documented the tragic events that had transpired. They had hopefully learned a lesson from their history. They appreciated and revered their restored isolationism and freedom and guarded them with a vengeance....and with intelligence. They slowly rebuilt a strong healthy economy which could function anywhere and at anytime under the proper conditions. Occasionally they were attacked by the old envious eastern Parasitetal-blocked island. Like starving plunderers (Nazi-Germany, the Soviet Union), only unproductive slave societies would invade like predatory animals for their

survival. Of course, they were no match for the economically sound free society. Many of their enslaved people tried to escape to the new free west. To prevent this, a large wall lined with barbed wire was erected (the East Island Wall) and manned with armed guards. Anyone who could survive and escape from the East to the West was given sanctuary. Interesting that no one from the West ever tried to "escape" to the East.



Epilogue (Ayn Rand's words rearranged with a Christian perspective)

A government derives its power and right to exist from a free people. A government that enslaves and is not a limited constitutional entity, does not serve its proper function and therefore has no legal and moral right to exist. A government consists of people and no one person or group of persons has any more rights than another. As such, the protection of the life, liberty, property and religious freedom of the citizen from those who would violate these sacred values, is the only and appropriate action of government. "That to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed." (Declaration of Independence, July 4, 1776)

A lone man on an island needs not to worry with rights or a government to protect those rights. There is no one to take his life, jeopardize his liberty or to steal his property or opportunities. Only when another individual or group of individuals join him in his environment does consideration of rights become necessary. No individual or group calling itself proletarians, comrades, the New World Order, the union, club, gang, task force, government control board, Board of Trade, the people, the hood, "The Great Society," the Council, the League of Nations, the United Nations, the assemblage, the state, etc., has the right to violate another's rights. Men of common sense who understand this principle, and depending on the degree of the violation, realize that they have by nature an unquestionable right to "flight or fight," i.e. self-defense. This is the meaning and validity of the constitutional maxim, the "right to bear arms." Self defense implies force. Force is morally legal only when an individual or a group of individuals are under attack by aggressors. There is no dichotomy between morality and legality when the goal is to curtail an aggressor's field of activities. This is the meaning of the Biblical axiom "an eye for an eye." Group protection of an individual's rights is moral and proper, and for the sake of self-preservation a group can become a governing body. A governing body of people or government is justified to preserve the citizen's individual rights by acting as an agency of coercion. This coercive power is expressed and implemented through its police, military, or when necessary, the militia (able-bodied citizen soldiers).

A government has only those rights that each individual of society has. A government proper <u>cannot</u> have rights outside of or in violation of an individual or group of individuals it represents. Government is made up of mere men who do not become magically transformed into demigods with their appointed positions. Therefore, the Bill of Rights, which is a declaration of rights restricting those in power, was specifically written to protect man from his government because such a power structure left unchecked is even more dangerous than the lone violator.

Those who wish to engage in force or fraud from within or without a nation as an invading army or as a common terrorist, must as justice demands, face the consequential legal violence of the police, military, or if necessary the militia. Initiators of violence and force are called criminals. A criminal is a criminal, whether born within a nation or outside in a foreign land. A criminal's violations must be emphatically answered with a

moral, authorized, constitutionally justified violence, which is the natural right to self defense, and "a right to bear arms". "An eye for an eye" is ordained by God as a recognition of a person's inalienable right to life and self-defense. In retribution or retaliation, police, military, or when necessary militia force, are only to be used on behalf of a nation's law-abiding citizens, that is, against all internal and external aggressors.

When invading criminal armies or international terrorists are ordered by international despots to attack and plunder the wealth of a nation, then the property rights of the residents of that nation are violated. A citizen's rights are additionally violated when some local or federal government figure prevs upon his life and/or property through political dictates. "Without property rights there are no rights." Property rights are land, food, clothing, money, savings, and machinery, etc. Ownership, use and disposal of property means life. Therefore, a proper government must act forcefully to protect, not take, its citizens' property and their lives. That is the nature of government by virtue of its might. If that same government's power is not limited by constitutional provisions, it will ignore its real purpose and meddle and redirect its energy into other areas that it has no right to intrude, such as education, housing, banking, science, medicine, sports, the arts, transportation, utilities, employment, finance, or any household or business enterprise. In these unauthorized areas, meant for private industry and action only, government will continue to act according to its caustic nature and become a threat and danger to the people's survival and the free market. A is A. A thing is what it is. A hawk cannot be a dove or act like one. The nature of government is to force, intimidate, hamper, threaten, restrict, violate, restrain, check, chastise, and punish with imprisonment or to execute--a necessary evil and strong-arm deterrence factor meant only to counteract predatory perpetrators. Clearly, when government intervenes in the free market transactions of law-abiding citizens, it will always have by virtue of its might the last word and "legal" right and muscle to force its will regardless of the free market Free market essentially means freedom from government interference. Laissez-faire capitalism is an expression of man's God-given free will in economics.

Laissez-faire means, "Leave us alone." Many decades ago in France, a group of "well-intentioned" city officials decided to take it upon themselves to stimulate the economy. So, many controls and regulatory laws were enacted by them until the market took a dip. To patch up their blunders, new laws and controls were created. The economy took a greater dive. Frustrated and confused, the bureaucrats approached their fellow citizen-merchants, asking them what should they do to help. They were told by the blunt Frenchmen--"LAISSEZ-FAIRE!"

Basically, there are only two ways for individuals to associate with government--either as free men or as slaves--voluntarily or coercively. Coercive control over an individual's life, liberty and property, through the agency of government are the essentials of totalitarianism in any form, be it socialism, communism, fascism, new world orderism, or even feudalism, which differ only by degree. The ultimate destination of all such systems is absolute control over the individual or the people in general.

Coercion holds that man has no rights--that his body, mind, intelligence and spirit, and their by products belong to the government or some special interest bunch, and that these collectivist agencies can, by the coercive authority of their political power, police power, influence, prestige, or strength in numbers (the vote, legislation, or point of a gun) do whatever it pleases to an individual, by justification of their own welfare or special, local, national or international interest. Each person is viewed as a natural resource or public asset and exists merely by the permission and at the mercy of the government and/or controlling mobocracy for its use, warped pleasure and disposal.

"Volunteerism," or freedom, maintains that each living being possesses nontransferable or inalienable, self-evident birth rights. These rights are not subject to violation by force, fraud, or vote at any time or place, for any purpose, or under any circumstance by an individual, group or government. Therefore, each person is created by God to exist for his own good, sake, and right, and not by the sanction of the government or the mobocracy.

Every law that has been passed in the history of man has been based on one or the other: 1) volunteerism (freedom); or 2) coercion (slavery). History speaks well for the right and wrong of both respectively. A volunteer society is a free society, whereas a coerced society is a slave society. Man is by nature a volitional being--a creature of choice. This attribute of man's nature should be a major consideration when establishing the basis of government. Certain truths about man are self-evident--either he is free or he is a slave. The original framers of the American Constitution--who were at one time the indentured servants and slaves of European monarchies--understood this principle and wrote in the Declaration of Independence:

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain inalienable rights, that among these are life, liberty and the pursuit of happiness, that to secure these rights, governments are instituted among men...."

However, it is unfortunate that the framers of our Constitution did not originally recognize the rights of some--specifically the Native American Indian and the African slave. The prerequisite for <u>all</u> mankind's survival and prosperity in a free society is government subservience to man's nature as a volitional being. Without the freedom to choose in one's interrelationships, the freedom to act on one's moral choices, and the freedom to benefit from those choices and actions, the inalienable rights of life, liberty and the pursuit of happiness have no meaning.

Human activity without the right or freedom to choose is simply slavery. Coercion or forced activity is slavery. Volunteerism, choice and liberty are freedom and the antithesis of coercion, i.e., the juxtaposition of sharply contrasting ideas. As such, the alternatives are clear and the <u>choice</u> is yours. Declaration of Independence

IN CONGRESS, July 4, 1776.

The unanimous Declaration of the thirteen <u>U</u>nited States of America,

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life. Liberty and the pursuit of Happiness.—That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, -That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.-Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government.... all having in direct object the establishment of an absolute Tyranny over these States. Entreprenuer Pledges to Put Local Youths In Business in '96

elvin Coles stands in the middle of his mod est manufacturing plant in Northeast Washington and takes inventory not of his products, but of himself.

Coles is president of the House of Mohan Corporation, a wholesale/retail company that sells essential oils, rare exotic incense and other products. In addition, he is a street vendor who imports special incense and manufactures multistick wooden incense holders and wooden oil rack displays. Among his clients are a vast network of street vendors and stores.

Coles is not just a successful business man who converted a curb-side vending stand into an international import company, he says that he is also a man on a mission to give his life more meaning than money can provide. He wants to give something back to the community that enabled him to become financially independent.

During these terribly tough economic times, clouded by government shut downs, downsizing and political upheaval, outreach efforts by Coles and others may serve as essential community-based self-help methods for generating extra income for struggling families.

"I look forward to reaching out to young people throughout the area and offering them the opportunity to build businesses," Coles says. "To me, this is the duty of every successful business person. If we do not show the next generation how to make money legally, we doom them to a life of subservience, crime and degeneration." Coles says, he will start teaching classes in business development that focus on the often painstaking, step-by-step process of launching and building enterprises. He says, he will use the case study approach in his classes, focusing on scenarios he has confronted first hand during his 25 years in business.

In addition to lessons in business, Coles also hopes to teach youths lessons in life. He stresses that strong faith is often the difference between success and failure in both personal and professional affairs.

For him, the journey to owning a thriving enterprise has been chock-full-of tough times and good fortune. His accomplishments read like a classic novel about a successful sales-

man. "I know the magic of starting small and thinking big," he says quietly, with a modest smile.

Coles, who started his first business as a teenager while living in Mayfair Mansion, a public housing development in Northeast, adds, "A good start is essential for success in business." He launched his business by selling products on foot, carrying an Anacostia High School gym bag to various street corners. He invested 50 cents into his venture and made \$3.00. He reinvested that into inexpensive perfume and colognes and eventually went door-to-door to build a route of more than 300 fragrance customers.

Coles learned early that after a solid start, "expansion is key." Thus, to expand his fledgling business, he bought a bicycle and put a small store on wheels. Chain medallions hung from the two mirrors on either side of the handle bars. Two metal baskets in the rear were filled with men's socks and ladies' panty hose. Rings were safety pinned to a bath towel with black velvet material sewed on to it, which he would roll out on the ground or the hood of a customer's car.

In 1972, when the Washington vending scene was still a sleepy Southern-style mixture of fruit and flower stands and souvenir vans, Coles saw a Muslim vendor named Ayub selling silver jewelry from a large, attractive table in front of a black jewelry shop in Georgetown. Within months, he had joined forces with Ayub and other vendors and expanded on the concept by opening a "vendors mall" in the heart of

downtown, outside the old Hecht Co. building. The mall featured high quality general merchandise and jewelry made by local master craftsmen.

Soon afterwards, Coles expanded again, opening seven vending stands on upper Georgia Avenue. From 1975 to 1980, Coles operated a store called the Price is Right in suburban Maryland. In 1977, as natural foods were becoming very popular, Coles, along with two of his brothers.

and Sanata opened a nonprofit vegetarian restaurant on Capitol Hill.

Soon afterwards, Coles opened a vending business at 17th and K Street N.W., featuring gold and silver products. In 1984, Coles became one of the first non-Muslims to sell body oils in D.C.

He plans to revamp his showcase vending stand at 17th and Connecticut Avenue, N.W., in front of the Farragut North subway station, using a colorful display case with 400 bottles of essential oils made by master craftsman Daniel Israel. His most popular incense, Khush, Meditation, and Vibration, also will be sold at the stand, which is managed by William Burts. Coles hopes to market his products through major chain stores soon.

His incense is in high demand, he said, because "It's fresh, pure,

clean, and customers, retail and wholesale, say it's the best they ever had, and that they will use no other." He sounds like a pitch man, but to prove that it's not all hype, he pulls out a thick wad of "thank you" letters. "I believe that the main reason for this love for my product is because it is of the highest and purest quality made in India for the workmanship of the supreme Lord.

"I want to teach youngsters how to promote their businesses by providing the best service available so as to encourage others to rave. I will also teach them that their research and study skills can help them to become experts in their fields." With that, he rattles off interesting facts about the incense he sells. "Meditation is a Sandalwood base stick, hand rolled in the finest ingredients in what is called the Marsala process. Khush is a black medicinal charcoal stick dipped in a secret pure essence known only to a certain family of a biochemist in India . . . Thanks to one of my brothers. Shambhu, who lives in India, I have been designated as their distribution representative for America. Now, I have customers all over the country ordering from me."Other incense he sells include Jasmin, Musk, Rose, Sandalwood, and Frankincense and Myrrh.




