6. Petitioner has never been convicted of a felony.


7. Petitioner is not requesting this name change to defraud creditors or for some other fraudulent reason.

4 9. On August 9, 2021, Pro-gun Vegas notified me that I was no longer
5 welcome at their gun range, apparently having been approached by the man who
6 posted the original video.

8 10. On or about August 13, 2021, I was made aware that my apartment complex
9 was being "google review bombed" for allowing me to stay there. That same day I
10 received un-ordered cupcakes by delivery with harassing messages on them.

12 11. On August 17, 2021, someone called the police to my residence, alleging I
13 was a pedophile. It is upon informed belief that this same individual accosted the
14 Staff of my apartment complex this same day.

16 12. On September 20, 2021 a California attorney notified me that my apartment
17 complex is seeking to evict me due to the collateral harassment.

19 13. On September 23, 2021 I signed paperwork voluntarily vacating the complex
20 on November the 21st.

22 14. It is reasonable speculation that publishing of my name change will result in
23 similar conduct no matter where I relocate to. Such conduct places me in
24 reasonable fear of my personal safety, mental wellbeing, and the well being of
25 collateral third parties.

27 15. The preceding **Petition** is accurate to the extent of my knowledge and is not

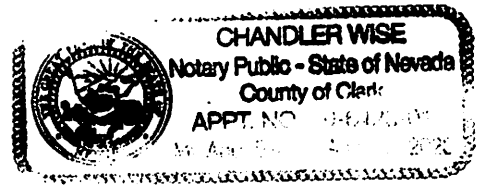

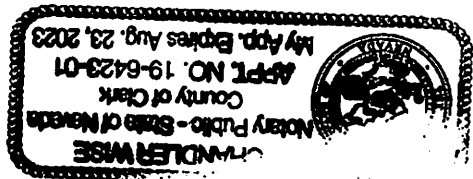

Mr. Campbell,

This firm is legal counsel for WestCorp Management Group. My client is the property management firm retained by the owner of The Spur Apartments to manage the community on its behalf. My client was advised of your representation of Mr. Bryant Moreland and requested I write you in pursuit of opening up an earnest dialogue regarding Mr. Moreland's residency in the community.

As you may know, Mr. Moreland recently relocated from California and entered into a 12-month lease agreement for an apartment in Henderson, Nevada, in the multifamily residential rental community of Spur Apartments. Already in Mr. Moreland's short residency in this community, staff have become victims of harassment and business operations have been grossly disrupted. The community has experienced an overwhelming influx of calls and online messages regarding Mr. Moreland's discovered residency in the multifamily community and has experienced multiple instances of persons storming the corporate office and the local community's leasing office and intimidating staff into fear of carrying out their job duties. The issue is bound to escalate as others have been encouraged to continue this behavior online.

As you may imagine, Mr. Moreland's attempt to solicit guests to visit his apartment by posting on the community discussion board invitations to come to his apartment, offering "doggy treats" as he is "the puppy/dog whisperer," have not improved the situation or eased tensions with staff and residents in this community.

Management is therefore reaching out to facilitate discussions of Mr. Moreland's amicable departure from the community in the interests of the safety and well-being of all staff working at and families residing in this community. Management is interested in providing a reasonable time-frame for the departure of Mr. Moreland, but due to the sensitive nature of the issue at hand considers this a matter of urgency and will need to include discussions of Mr. Moreland's conduct in the meantime.

Accordingly, my client seeks your prompt response in the matter and urges communications via email at nicholas@scottclarklaw.com. Management will consider failure to respond to this letter by Friday, September 24, 2021, as a refusal to engage in mutually agreeable discussions and will proceed with legal action to terminate Mr. Moreland's lease contract under Nevada law.
