

Plea UN deport, depending on the rights and obligations of the UN Charter and the International Declaration's

Good day for the United Nations, UNGA and UNSC, my name and the title is King of the federal government Imperium of Diamond's, Peter Gottwald.

Today I am King for the federal government Imperium of Diamond's by all political principles and entitlements of eligible legal force values and principles, Global Right's and Political Obligation's. I am a caregiver who own legal territory as its own territories and without competition from another legal entity. That is why my request for helping deport of ID's States, the application is underpinned by the principles of the UN Charter and standard duty performance in the interest of the activities on dimensions such situations, and in the interest recognized demands of an international policy rules and all the declaration and the rules of which are confirmed by the UN Charter and duty of all members of the United Nations. Other other rights which will be discussed in personal contact.

Today I am not in any case be of interest in widespread conflict and my desire is to build good results, not on grounds of terrorism are not able for such activity. Therefore, I ask enjoyment Article 11. Rights and thus ensure the ability to organize cooperation against global terrorism of Europe and their global crime which is now really the biggest threat to the emergence of the First Global War, after than today that I soutstriped every values of The World War II.
