There appear to be ongoing issues.

I do not know the details of the formal review.

I believe that a dossier of abuse was shown to Dr MacGregor (Director of Surgery) early last year.

I repeat, that one of our senior trainees, after 8 years of surgical training and passing her fellowship exams, was prepared to give up surgery, rather than go back to work at Redeliffe.

I am very upset about this, and am prepared to take this all the way! At the same time, I wish to protect the young women, already traumatised by their experiences at your hospital.

There was a formal review of such matters two years ago and this matter was formally processed via the appropriate mechanisms and since that time we have not had further issues raised that I am aware of - I would be most interested to hear of any recurrence.

- > A female PHO in surgery complained of serious sexual harassment to Metro North 2 years ago. Brie and other trainees gave statements condemning his behaviour, to an "official enquiry", and nothing was done. I gather this girl has now given up surgery.
- > Another female reported genital rubbing behaviour to the director of surgery at Redcliffe, when being "taught" colonoscopy, with the surgeons arms wrapped around her. Nothing was done, save "we better keep female trainees away from him".

- > These girls feel scared to speak up, firstly for fear of being
- > labelled as complainers, and secondly, because when they do, nothing
- > is done. They feel betrayed. This is horrible. (Brie, having passed
- > her fellowship and accepted on to colorectal training, is prepared to
- > come forward, with my full support)

- > I have spoken to many people about this and all seem to suggest it is someone else's problem.
- > It is now my problem and your problem.
- > This egregious behaviour pattern warrants mandatory reporting.
- > I want the college, GSA and Metro North to act ASAP.
