- 3 Q: So you guys had all access to the same -
- 4 A: (indiscernible).
- 5 Q: electronic items?
- 6 A: Right, yeah.
- 7 Q: So in the Search Warrant or the Probable Cause Affidavit for the arrest for the
- 8 charges that you are facing right now -
- 9 A: Right.
- 10 Q: it says that you had turned over a bunch of electronics when they first searched
- 11 your home?
- 12 A: Right.
- 13 Q: And when they did that Search Warrant on your home did you know that that was
- regarding Abby and -?

- want and I have a friend in Texas that's texting me and telling me hey you're on
- 21 the news here.
- 22 Q: Yeah and now it's all over.
- 23 A: Yeah.

- 1 Q: It's national news.
- 2 A: Right.
- 3 Q: Have you talked to any other reporters?
- 4 A: No I have -
- 5 Q: Since this happened?
- 6 A: not. No I have not.
- 7 Q: Do you have any interview requests?
- 8 A: I mean I'm open to anything and, but no.
- 9 Q: Okay. Umm so have you been cooperating with the investigators?
- 10 A: Yeah one hundred percent. Anything they asked me to.
- 11 Q: And when was the last time you talked to any of these investigators?
- 12 A: This would have been, Monday. They came to the -
- 13 Q: So -
- 14 A: jail on Monday.
- 15 Q: And what did they want from you on Monday?
- 16 A: A uh polygraph test.
- 17 Q: And what did you say?
- 18 A: I said yeah. And they jogged me around for over an hour and my lawyer was in
- there and I told him hey like three or four times hey give me the polygraph test
- and he won't, he didn't. He kept saying no I got more stuff to ask you.
- -21 Q: So you've never been polygraphed?
- 22 A: I have one time. When it -
- 23 Q: Well-

- 1 A: happened. 'Cause immediately I was like, well give me a polygraph test, a
- D.N.A. whatever you want I'll do anything. And -
- 3 Q: And you have (inaudible). You did give them your D.N.A.?
- 4 A: Yeah, yep. And a hair follicle test.
- 5 Q: Okay. So what kinds of things have these investigators been talking to you about?
- 6 A: Uh about more about my case here and then my involvement with that. With the
- 7 Delphi.
- 8 Q: Okay.
- 9 A: Yeah.
- 10 Q: And have you been to Delphi?
- 11 A: No. I was in Delphi in high school for a football game, but that's the only time
 - 12 I've ever been to Delphi.
 - 13 Q: Have you been out to the Monon High Bridge?
 - 14 A: I have no clue where it even is, I'm, I couldn't even tell you how to get to Delphi.
 - 15 Q: So why do you think investigators are putting so much focus on you right now?
 - 16 A: I have not a clue. Because they, I think it's because they said I was the last person
 - to talk to her. Is what they've told me.
- 18 Q: Oh. And then she shows up at the bridge and they're abducted and later found
- 19 dead?
- 20 A: Right.
- 21 Q: And that was not you?
- 22 A: No, one hundred percent no. They have my G.P.S. the whole day.
- 23 Q: And how do they have your G.P.S. for the whole day? From your phone?

- 1 A: Well from my phone, yeah.
- 2 Q: Okay.
- 3 A: They can, I don't know how they do it but, yeah.
- 4 Q: (indiscernible)
- 5 A: And he's shown me, he's shown me that day all my G.P.S. locations. You know
- 6 what I mean.
- 7 Q: And none of them were in Delphi?
- 8 A: No, not even close.
- 9 Q: Do you think investigators are thinking that your dad could be involved in the
- 10 murders?
- 11 A: Well I know about two Fridays ago, or it was, yeah I think it was two Fridays,
- three Fridays ago they raided him and I'm not sure what it was about or what but
- on the news I saw them show the house and then his neighbor uh talked to the
- police and said, or talked to the reporter and said uh that he was raided. But I, I've
- tried to contact him, he won't contact me back so. I don't know.
- 16 Q: So what is your relationship like (inaudible) today?
- 17 A: We uh today with my dad uh we're -?
- 18 Q: Yeah.
- 19 A: we don't talk at all. But up until -
- 20 Q: And why is that?
- 21 A: I don't know, up until about two, three weeks ago he would talk to me every day.
- Come out and view me at the visit or have a visit with me all the time.
- 23 Q: Um hum.

- 1 A: Few times a week. He'd put money on my books, I mean we would talk every
- day almost.
- 3 Q: And so he has been sort of ghosting you then -
- 4 A: Yep-
- 5 Q: since -?
- 6 A: yep.
- 7 Q: the last what, two weeks?
- 8 A: Yeah. Yeah.
- 9 Q: Since that raid on his -
- 10 A: Yeah.
- 11 Q: house?
- 12 A: Yeah.
- 13 Q: Does that sound to you like he's scared?
- 14 A: I, I would think. 'Cause I have no reason why -
- 15 Q: Do-
- 16 A: he wouldn't talk to me you know what I mean. I'm his only child. I mean we
- had a great relationship.
- 18 Q: Do you think he's the type of person who could have killed these girls?
- 19 A: I don't think so because I was with him, you know what I mean, so I know it
- wasn't him. But in his past he's had, like he's beaten up his ex-wife, I mean he's
- 21 held guns to us as, when we were kids you know what I mean like, he's not really
- a great person you know what I mean.
- 23 Q: So he's been violent -?

- 1 A: Yeah -
- 2 Q: -in (inaudible)?
- 3 A: Definitely yeah.
- 4 Q: Can I ask you do you know who Ron Logan is?
- 5 A: No I don't.
- 6 Q: Ron Logan is the property owner where the girl's bodies were found out by the
- 7 bridge.
- 8 A: Oh okay.
- 9 Q: Do you know if your father knows him?
- 10 A: I have no clue. I've never heard that name before.
- 11 Q: Interesting. So has your father ever stopped communicating with you before this?
- 12 A: No. When I got arrested, uh in August 19th, 2020 he didn't talk to me for about
- five months and then just one day, I think it was April, he just started talking to
- me again. But. Yeah I mean my whole life we've always had a great relationship
- my whole life. Besides when I was -
- 16 Q: And, and -
- 17 A: a kid, you know.
- 18 Q: who, and what do you mean besides when you were a kid?
- 19 A: (indiscernible) -
- 20 Q: Was he abusive?
- 21 A: Yeah, yeah. Real bad.
- 22 Q: In what way?
- 23 A: Physical and emotional. A lot, pretty much emotional my whole life.

- 1 Q: So, how, and so tell me about the 13th, what were you guys doing all day that you
- 2 know for sure he was with you the whole day?
- 3 A: Well he doesn't work on Mon- Saturday and Mo- or Sunday and Mondays so we
- 4 would always just hang out at the house, go to my grandparent's, but I remember
- 5 that day we watched a wrestling pay per view. That night. And -
- 6 Q: And -
- 7 A: he was at my grandparent's with me around five and six and then the rest of the
- 8 night but he usually sleeps, you know 'cause he works third shift so -
- 9 Q: Okay.
- 10 A: he normally sleeps until about one or two and then we wake up, get lunch you
- 11 know, stuff like that.
- 12 Q: Okay. And so you know that he was with you from one or two, Monday the
- 13 13th?
- 14 A: Right.
- 15 Q: Throughout the evening?
- 16 A: Right, yeah.
- 17 Q: So how, how do you reconcile this in your head, this focus on you?
- 18 A: I have no clue. I've asked them, I'm like what else do you want me to do you
- know what I mean and it's like they're harassing me, they will not stop. It's like,
- I've done everything they want. They've went through all my phones, they know
- 21 everything about me. They've talked to people that I know, you know what I
- 22 mean it's like, they will not stop.
- 23 Q: But you (inaudible) involved in child pornography?

- 1 A: I-
- 2 Q: You -
- 3 A: the charges against me, yeah.
- 4 Q: So and one of those ch (inaudible), trying to solicit a child to meet you for sex?
- 5 A: That's what they said but the evidence on, in my thing doesn't show anything like
- 6 that.
- 7 Q: Okay. But maybe somebody else was using -?
- 8 A: Right.
- 9 Q: that profile and trying to do that?
- 10 A: Right.
- 11 Q: But your dad would be the only other person who -?
- 12 A: Yeah.
- 13 Q: would have access to that profile?
- 14 A: Yes.
- 15 Q: What would you like to ask your father right now?
- 16 A: Uh umm really I just, I texted him the other day and just asked like why are you
- believing everyone over your own son, you know what I mean, like I don't get,
- he's my, I'm his only son or and daughter. I'm an only child it's like why are you
- just giving up on me over nothing. Well I mean I get it's not over nothing but
- why, we were fine two weeks ago and then they raid you and it's like, now you're
- 21 not going to talk to me?
- 22 Q: Do you remember who the investigators were that came to talk to you?
- 23 A: Uh, it was one, you mean last week?

- 1 Q: Yeah.
- 2 A: Yeah uh Trooper Vido is his name, V-I-D-O.
- 3 Q: Okay.
- 4 A: Yeah.
- 5 Q: And so he was by himself and he came and saw you on Monday?
- 6 A: Yeah.
- 7 Q: And then they said we're going to release something tonight?
- 8 A: Yeah.
- 9 Q: Were they trying to get something from you that day?
- 10 A: Yeah because uh I was supposed to do a polygraph test that day.
- 11 Q: And you said you agreed but -?
- 12 A: Yeah.
- 13 Q: then they didn't follow through?
- 14 A: Three or four times I said are you gonna do it and he just keeps, bring, like
- dragging it on and dragging it on and I told him, hey I'll do it right now just give
- me the polygraph test. And he wouldn't. And then they take three guys out of my
- cell block down there to ask them questions about me. That night.
- 18 Q: Do you know what they said?
- 19 A: I don't know, I'm not sure.
- 20 Q: Have you followed the case of Abby and Libby at all?
- 21 A: No not really.
- 22 Q: Since it happened?
- 23 A: No. Hum-um.

- 1 Q: What do you want people to know about you?
- 2 A: That I'm innocent of this and I would love to find out who did it, that's two kids
- that died. You know what I mean and I just want them to know it's not me and
- 4 I've gave everything to the State Police that they've asked. Everything.
- 5 Q: There was, when they collected your electronics back in twenty, was that 2017 -?
- 6 A: Yeah.
- 7 Q: they took all your (inaudible)?
- 8 A: Yeah.
- 9 Q: And one phone you, you said you found a few days later and you called them and
- 10 you said I have this?
- 11 A: It was immediately after I got home. I, they did a whole interview with me and
- 12 then took me home. An officer did. And it was right on the counter. And I was
- like, what the hell? So I called them immediately from my dad's phone and told
- them, hey there's a phone that you guys didn't get. They came the next day and
- 15 got it.
- 16 Q: And you had deleted some things from some of your electronics?
- 17 A: I deleted an application, yeah.
- 18 Q: And what app was that?
- 19 A: Uh I think it was Kik, K-I-K.
- 20 Q: And why did you delete that app?
- 21 A: I don't know. I really don't know. But they got me for obstruction of justice for
- 22 that. There was a woman that I talked to there and uh, her name was Tracy it
- started with a K but she was with a child protective something and uh, I was like

- well if I, I'm, she goes just be done with it and I was like well I'm going to delete
- everything and she goes, yes that's fine just and so I did that they still hit me with
- 3 obstruction of justice two times, for that. Even though she said it was okay to do
- 4 that.
- 5 Q: Hum.
- 6 A: I told her, hey this is a big wake up you know what I mean.
- 7 Q: And so your, attorney (inaudible) -?
- 8 A: Yeah Achey. Andrew Achey.
- 9 Q: Achey?
- 10 A: Yeah.
- 11 Q: And what is he telling you about what's going on?
- 12 A: Well see he's not my attorney for Delphi. The Delphi case so he can't really talk
- to me about it.
- 14 Q: Oh.
- 15 A: Yeah so I have no legal -
- 16 Q: So you don't -
- 17 A: representation or nothing.
- 18 Q: Oh so you don't have a lawyer with you when you're talking to them?
- 19 A: No I did that last time, he s-, he sat in but like he told me before I'm not your
- lawyer for this so, I'm just gonna sit here.
- 21 Q: Oh wow.
- 22 A: Yeah.
- 23 Q: So do you feel like you're, you're being pegged for this murder?

- 1 A: Yeah.
- 2 Q: Do you -?
- 3 A: And they've contact my whole family, all my friends and now no one talks to me
- 4 anymore. Because of this. 'Cause they all think I'm some terrible person or
- 5 something.
- 6 Q: Well and they're, they're, I mean, you were committing crimes -?
- 7 A: Right.
- 8 Q: against children?
- 9 A: Right.
- 10 Q: You were asking children to send you inappropriate images, correct?
- 11 A: Right, yeah.
- 12 Q: So I mean, you were doing some things wrong?
- 13 A: Right.
- 14 Q: But you draw the line at you never met these girls -?
- 15 A: Yeah never.
- 16 Q: were -?
- 17 A: No.
- 18 Q: After this happened did, did your father follow this case at all? Do you know?
- 19 A: Not that I know of no.
- 20 Q: And tell me about Anthony Shots, why did you create that profile?
- 21 A: I don't, I don't really know. I was just lonely you know what I mean. Just talking
- 22 to people, I don't know why I did it really.
- 23 Q: Where did the name come from?

- 1 A: My middle name is Anthony.
- 2 Q: (inaudible) on your profile were they true? Did you own a marijuana delivery
- 3 business at one point?
- 4 A: Yes I did.
- 5 Q: (inaudible), you did?
- 6 A: Yeah in Las Vegas yes.
- 7 Q: Okay and, and what years was that operating?
- 8 A: 2017 to 2018.
- 9 Q: And so when did you move out to Las Vegas?
- 10 A: Like June of 2017.
- 11 Q: Okay. And you worked as a casino dealer out in Vegas as well?
- 12 A: Uh no I didn't.
- 13 Q: Okay and what about armed security guard, did you ever do that?
- 14 A: No but I worked, well not really no so, no. But I did uh help one of my friends I
- was a bounty hunter out there. But no I wouldn't say that, I didn't pay taxes or
- anything for it so.
- 17 Q: Okay.
- 18 A: You know what I mean.
- 19 Q: Umm -
- 20 A: Technically it wasn't a job.
- 21 Q: so you weren't like licensed or anything as a bounty -?
- 22 A: No-
- 23 Q: hunter?

- 1 A: no, no.
- 2 Q: Okay. Were you carrying a weapon?
- 3 A: Uh yeah.
- 4 Q: Okay umm, I, I wasn't expecting and, to hear any of this umm, from you umm I'm
- 5 surprised that you don't have an attorney representing you on these charges.
- 6 A: Yeah.
- 7 Q: Umm, so there is a podcast that's been released where one of your friends
- 8 supposedly talked to a podcast host and said you were into all kinds of dark
- 9 things, you were out on the dark web, umm is that true?
- 10 A: No. Dark things? What (inaudible) -?
- 11 Q: Well I mean you know so to some people child pornography would be, a dark
- thing. Umm -
- 13 A: Yeah but I didn't discuss any of that with any of my friends or nothing like that.
- 14 Q: Okay so but that was something you and your father both shared? You knew that
- about him, he knew that about you?
- 16 A: I wouldn't say that he knew that about me, I wouldn't, 'cause he told the officers
- 17 that he didn't know. So I don't know.
- 18 Q: (inaudible) into child pornography?
- 19 A: Right.
- 20 Q: And how long have you known that about your father?
- 21 A: I mean I can remember being around 20 years old and him having sex with one of
- 22 my friends, that was underage. I was about 19 I'd say and she was about 17.
- 23 Q: Oh.

- 1 A: Yeah. And he's a grown man. He's in his forties probably by then.
- 2 Q: Do you know what age he prefers?
- 3 A: I do not, no.
- 4 Q: But he likes young women?
- 5 A: Right.
- 6 Q: And he has been violent with some of those women?
- 7 A: Yeah, his ex-wife yeah. He's been to jail over beating her up, yeah.
- 8 Q: And does he have any substance abuse problems?
- 9 A: Umm, I mean I know he takes prescription pills, I'm not sure if he abusing 'em or
- not. I don't, that I don't know.
- 11 Q: Does he drink alcohol or use any drugs?
- 12 A: Not anymore but I know he used to, yeah.
- 13 Q: Okay. So as, I mean when did you first find out that, that your name was out
- there? Was that yesterday or day before?
- 15 A: It would have been Tuesday, Tuesday night at seven on the news. It was what
- opened the news was my face and them talking about me.
- 17 Q: And what went through your mind when you saw that?
- 18 A: That that's crazy. That they're putting this out there. Because they've done this to
- a few other people, with the Delphi case. Put their face out on the news and
- 20 everything.
- 21 Q: And so you think you're just the lastest target?
- 22 A: Right.
- 23 Q: How much did you weigh in February of 2017, do you recall?

- 1 A: How much did I, I would say 300, 310 maybe.
- 2 Q: And how tall are you?
- 3 A: I'm like five eleven, six foot.
- 4 Q: And how tall is your father?
- 5 A: Uh about the same height.
- 6 Q: And what is his weight, do you know?
- 7 A: Umm now I would day pr-, I'm not sure 280 maybe.
- 8 Q: Okay.
- 9 A: Yeah.
- 10 Q: And I mean I know you say he was with you that day but would your father be
- capable of going out and walking this bridge and killing two girls? Would he
- physically be capable of doing that?
- 13 A: Yeah, yeah. He hunts and he's got to pull out deer so I mean, yeah I would think
- he would be capable of doing it but, yeah.
- 15 Q: But you know he was with you?
- 16 A: Yeah. (inaudible)
- 17 Q: I'm, I'm worried that our, the clock is going to run out on our interview here pretty
- soon, umm is there anything I haven't asked you about that you want people to
- 19 know?
- 20 A: Just that I'm innocent, that's it.
- 21 Q: And do you think you're going to be charged with anything related to Abby and
- 22 Libby's murder?
- 23 A: No. No I don't.

- 1 Q: So they haven't, the State Police haven't threatened that?
- 2 A: No. No.
- 3 Q: Do you feel like they're trying to get you to pin this on your dad?
- 4 A: Yes. Yes I do.
- 5 Q: And that's probably why he's not speaking to you?
- 6 A: Right. 'Cause when I first got arrested they told me that they knew it was my dad
- and if th-, if I tell 'em all my charges will be dropped.
- 8 Q: They told you that last year?
- 9 A: Like go, not dropped but go away. Pretty much is what they said. (inaudible)
- 10 Q: And they told you that, last year when you were arrested?
- 11 A: Yeah. August 19th.
- 12 Q: Interesting.
- 13 A: Yeah.
- 14 Q: Umm I'd like to set up another int, interview with you tomorrow if that's -
- 15 A: Oh-
- 16 Q: okay with you?
- 17 A: Yeah that's fine.
- 18 Q: Is there a time of day that's best for you?
- 19 A: Umm probably around the same time, if that's possible.
- 20 Q: You cut out.
- 21 A: Probably about -
