The name of the Society shall be **CHRIST THE KING CHURCH.**

2. REGISTERED OFFICE

The registered office of the Society shall be situated at **VILLAGE NAYAGAON, TEHSIL : KHARAR, DISTT : ROPAR, PUNJAB.**

3. AREA OF OPERATION

ENTIRE STATE OF PUNJAB.

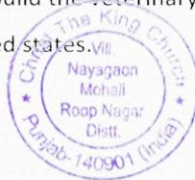
4. AIMS AND OBJECTS

- (i) The society shall create a sense of brotherhood, cooperation, mutual harmony, love and affection amongst its members and also amongst the general public.

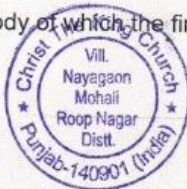
- (vi) The society shall spread the message of Christ as enshrined in the holy Bible.

5. **OTHER TIMPORTANT CONDITIONS REQUIRED TO BE FULFILLED
UNDER THE SOCIETIES REGISTRATION ACT, 1860**

- (i) The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the Memorandum of Association and no portion thereof, shall be paid or transferred directly or indirectly to the members of the society.
 - (ii) No member of the Governing Body of the Society shall be appointed to any salaried office of the Society or any office of the Society paid by fees, that no remuneration shall be given by the Society to any member of such governing body except repayment of out of pocket expenses and interest on money lent or spent for premises/ demises to the society.
 - (iii) The Society by its constitution is required to apply its profits, if any or other income in promoting its objects.
 - (iv) If upon the winding up or dissolution of the Society, there remains after realization of its debts and liabilities any property whatsoever the same shall not be paid to or distributed among the members of the Society, but shall be given or transferred to some other institution having objects similar to the objects of the society to be determined by the members of the Society at or before the time of dissolution.
6. The management of the affairs of the Society is entrusted in accordance with the rules and regulations of the Society to a Governing Body of which the first members are:

RULES AND REGULATIONS OF CHRIST THE KING CHURCH.

MEMBERSHIP

The Society shall constitute of persons who are interested in charitable work. Persons seeking membership shall agree to abide by the Rules and Regulations of the Society, should be of the age of 18 years or more, Caste, colour, creed, sex, education, property or social status are no bar to seek membership. The membership of a member shall be approved by the Governing Body of the society.

1. MEMBERSHIP FEE

Any person seeking membership of the Society shall be required to pay membership fee of Rs. 100/-

2. CATEGORIES OF MEMBER

There shall be following categories of members of the Society.

i) Ordinary Members :

All members who pay Rs. 100/- as membership fee, annually, shall be designated as Ordinary Members of the Society.

ii) Life Members:

All members who pay Rs. 1000/- as membership fee, annually, shall be designated as Life Members of the Society.

3. RESIGNATION / EXPULSION / VACANCY OF MEMBERS

A member may be expelled from membership of the society by 2/3rd majority of members voting for the resolution, if he is found not abiding by the Rules and Regulation of the Society or is found engaged in activities against the aims and objects of the society. A member also loses his membership if he resigns, becomes of unsound mind or convicted of a criminal offence by a Court of Law in India. A person

ceases to be a member in case of non-payment of membership fee or fine thereon. A person also loses his membership if he does not attend three successive meetings of the society.

The membership of a person comes to an end in case any member dies. Such a vacancy or vacancy created by aforesaid reasons shall be filled by 2/3rd majority of members voting. The membership in case of death of a member is not hereditary.

4. **GENERAL BODY:**

i) **Formation:**

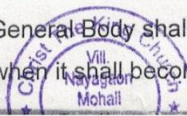
The supreme authority of the society shall vest in the General Body, which will consist of all the members of the Society.

ii) **Powers and Functions :**

- a) The General Body shall elect Office bearers of the Governing Body from amongst its members by secret ballot.
- b) The General body shall receive and adopt the Audited Statements of Account and the Annual Report of the society by 3/5th majority of the members present and voting.
- c) The General Body shall have the power to enact new Rules, and amend and rescind any of its existing Rules and Regulations by 3/5th majority of the members present and voting.
- d) The General Body shall have the power to dissolve the society by 2/3rd majority of the members present and voting.
- e) The General Body shall have the power to transact such other business which may be brought up at its meeting.

iii) **Meeting:**

- a) General Body shall meet at least once every year at a time and place fixed by the President of the Society.
- b) A special meeting of General Body shall be convened by President of the society as and when it shall become necessary.

iv) **Quorum:**

Minimum of 2/3rd members at any meeting shall constitute the quorum of the General Body meeting.

5. **GOVERNING BODY**i) **Formation:**

There shall be a Governing Body of the members to assure and fulfill the aims and objects and carry out its business and other affairs. The Governing Body would be formed/ elected from amongst the members of the General Body.

ii) **Meetings:**

Meetings of the Governing Body shall be convened at least once every month. It may even meet more than once if it deems necessary to carry out the business of the society. Under normal circumstances a notice of 3 days shall be given to convene a meeting of the Governing Body. However, in case of emergency a short notice of 24 hours can also be issued.

iii) **Quorum :**

A minimum of 2/3rd members present at a meeting would be enough to constitute the quorum of the meeting of the Governing Body.

iv) **Strength:**

The society shall have the following members as the Governing Body deemed in accordance with the Rules and Regulations of the society.

- a) President
- b) Vice President
- c) General Secretary
- d) Joint Secretary
- e) Cashier
- f) Executive Members – 2

v) **Mode of Election /Tenure of Office Bearers**

The members of the Governing Body shall be elected out of the General Body by secret ballot. Each office bearer shall be elected for a term of 5 years. On the expiry of 5 years the new body shall be elected within the framework of the Rules and Regulations of the society till such time a new body is formed. As soon as the new body is elected the old shall cease to function and would hand over charge to the new body without delay. In case of death of an office bearer, his office would be fulfilled by electing another member by 2/3rd majority of the members voting. The post of office bearer is not hereditary.

vi) **Powers of Office Bearers:**

President

- a) He can use his discretionary powers for the betterment of the society activities.
- b) He can convene the emergency meetings of the society members.
- c) He will chair the meetings of the governing body of the society.

Vice President

- a) He will discharge the functions of the President during his absence or such work as is delegated to him by the President.

General Secretary:-

- a) He shall supervise the functions of other secretaries.
- b) He shall maintain peace during the functions.
- c) He shall announce the programme of the society.
- d) He shall convene meetings with the consent of the President of society.
- e) He shall receive and welcome VIP's and guests.
- f) He shall issue notices after the passing of resolutions.

Joint Secretary :

- a) He shall perform such functions as are delegated to him by the General Secretary.
- b) He shall perform all the functions of the General Secretary during his absence.

Cashier:

- a) He shall deal with financial matters of the society
- b) He shall maintain the accounts of the society and prepare its balance sheet.
- c) He shall prepare the statement of estimated expenditure of each function.
- d) He shall operate the Bank account with signatures on cheques of any two out of Vice-President, General Secretary and Cashier.

Executive Member :

- a) The society shall have two Executive Members.
- b) The Executive Members shall exercise such powers as are entrusted to them by the President or the General Secretary.

Finance/Income / Expenses Audit of Accounts**Finance:**

- a) The Governing Body shall submit its budget statements year-wise for its programmes every year in the month of February. However, a supplementary budget estimate if any can be considered as and when necessary.
- b) All receipts and expenditures will be maintained under heads under the budget provisions.
- c) The President shall have the power to sanction any expenditure upto Rs. 2000/-.
- d) The financial year of the society would be 1st April to 31st March every year.
- e) The annual statement shall be presented by the Cashier to the General Body for its approval.
- f) The Governing Body shall maintain its accounts in the name of the society, with any scheduled bank of India. All funds shall be remitted in the Bank account and shall be withdrawn under the joint signatures of any two out of the President, the General Secretary

- g) The Audited Accounts together with the Auditor's report will be presented before the General Body.
- h) Assets of the society at the time of dissolution can be transferred to any similar educational society as decided by the Governing Body subject to the approval of the President who is the final authority.

Income

- a) The ways and means of the Income of the society will be from donations, funds, special funds etc. Emergency fund can be created.

Expenses

- a) The income and property of the society shall be applied solely towards the promotion of the aims and objects of the society as set forth in the Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly in any way.
- b) No member of the Governing Body of the society shall be appointed to any salaried office of the society.
- c) The society of its constitution is required to apply its profits in promotion of its aims and objects.

Audit of Accounts

- a) The accounts of the society shall be audited by the Auditor and the report submitted to the General Body of the Society for its approval.

viii) **Enacting / Amending/ Rescinding of Rules and Regulations:**

- a. The Governing Body shall have the power to make if necessary such Rules and Regulations for conducting its programmes for its aims and objects with final approval of the Hon'ble President.
- b. These Rules and Regulations may be audited /Rescinded/ Amended/ Additions made any time by 2/3rd majority of the members of the General Body, with consent of the President. However the President is fully empowered for making such alterations / amendments/ additions whenever he feels necessary.

c. Such alterations/ amendments/ additions of the Rules and Regulations of the Society shall be intimated to the Registrar of the Societies under the Societies Registration Act, 1860 within 2 weeks of doing so.

ix) **Dissolution:**

- a) The society shall be dissolved by 2/3rd of the members of the General Body voting on this account.
- b) The society shall be dissolved if majority of the members of the General Body feel it is not possible to fulfill the aims and objects of the society or there is a paucity of funds necessary to run and organize the day to day functions and working of the society etc.
- c) After the dissolution of the society the property, assets and income of the society left after liquidating the debts and liabilities of the society shall be given to or transfer to some other institution having objects similar to the objects of the society.

x) **Maintenance of Register:**

The General Secretary of the society shall maintain the following Registers for keeping upto date information of the respective areas of the working of the society.

- a) Register carrying the names and addresses of all the members of the society.
- b) Minutes book for keeping records of all the meeting of the society.
- c) Account books that is Cashbook and ledger shall be maintained by the Cashier of the Society.
- d) Stock Register shall be maintained by the General Secretary of the Society to maintain a record of the entire inventory of items of the assets of the society.
