

# Ohio Abortion Amendment will Legalize Prostitution, Pedophilia, Incest, and Abortion To Birth.

## **THIS CONSTITUTIONAL AMENDMENT WILL DO MORE THAN LEGALIZE ABORTION!**

### **This evil and sinister Constitutional Amendment will do many things:**

- First, it will legalize adult **PROSTITUTION** and **CHILD PROSTITUTION** in the state of Ohio.
- Second, it will legalize adult/child sexual relationships (**Pedophilia**) in Ohio.
- Third, it will legalize **abortion** through all nine months of pregnancy if a woman can claim it is for her mental "health" or emotional "health."
- Fourth, it will remove parental rights for minors with gender confusion or minors seeking abortion.
- Fifth, it will enshrine **trans and same-sex anti-discrimination** into law, also known as legalized persecution of anyone who has a religious or moral objection to same-sex or transgender ideology.
- Sixth, because the "state" is defined as "any political subdivision" which according to the Ohio revised code means anyone to which the state delegates its power: all cities, counties, municipalities, state-run hospitals, state-run education systems, state-run healthcare systems, etc. will be restricted from making any law that will, "directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against" these new "right"s.

### **Evidence that this will legalize prostitution, including child prostitution:**

In 2020, Under the headline: "Sex work is real work and it's time to treat it that way" the ACLU's own website claims, "The ACLU has supported decriminalizing sex work since 1973, and it became an official board policy in 1975. Since then, affiliates across the country have advocated for decriminalization at the **state level** by striking down laws restricting sex workers' rights..." (emphasis added) Found at:

Under "Recommendations" The brief states on page 18, "The ACLU is committed to sex work decriminalization..." The third paragraph down on page 18, the ACLU boldly states their goal: "Decriminalize all consensual sex work, including prostitution among adults. Fully decriminalize by eliminating all penalties for sellers and buyers." Then the ACLU tells us they are going after the children, it continues, "Also remove criminal penalties for **YOUTH** who participate in sex work" (emphasis added).

**WE CALL THAT CHILD PROSTITUTION, CHILD SEX TRADE, AND CHILD SEX TRAFFICKING!**

Remember: Child Sex Trade is always called Child Sex Trafficking because, "CHILD SEX TRAFFICKING: refers to the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a minor for the purpose of a commercial sex act. **Force, fraud or coercion do not need to be present for the crime to be considered child sex trafficking** ([justice.gov, humatrafficking hotline.org](https://www.justice.gov/humatrafficking-hotline.org))." This constitutional amendment will accomplish the ACLU's long held, and stated goal to "decriminalize sex work".

The amendment says, "Every individual, " (Notice: **NO AGE RESTRICTION HERE**. This includes adults and children.) The amendment language continues, "Every individual has a right to make and carry out one's own reproductive decisions..." So if a woman claims, "It is my reproductive decision to have sex and get paid for it," the state can not make any law against it. "The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against" this newfound "right." Prostitution legalized.

The ACLU has been even more bold saying they want to, "remove criminal penalties for **youth** who participate in sex work," **WE CALL THAT CHILD SEX TRADE, CHILD PROSTITUTION, AND CHILD SEX TRAFFICKING!**

Adults can exploit youth and children legally:

The Constitutional Amendment actually provides legal protection for, "A person or entity that assists an individual exercising this right." Again, this means an adult can exploit a youth or child legally. This part of the amendment language would protect prostitution ring leaders, child sex traffickers, people who exploit youth with gender confusion, and any person or entity that assists a minor with abortion (without parental consent or notification). Child prostitution legalized, with protections for the adult or brothel that is exploiting the youth, specifically if the youth claims he/she is doing this voluntarily.

### **Evidence that this will legalize Pedophilia:**

The same goes with Pedophilia. If an adult can convince a child it is his or her reproductive decision to have sex with him or her, and can convince the child to say it is his or her, "own reproductive decision," then the state can not make any law against that. Again there is no age restriction to the amendment's requirement. In fact, the phrase "Every individual" legally requires the state to recognize adults **and children** have the legal "right to make and carry out their own reproductive decisions".

This all becomes legal because the Amendment says, "The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against either: An individual's voluntary exercise of this right or A person or entity that assists an individual exercising this right".

Again, this is not hidden. The ACLU who co-wrote the Amendment has published their goals, and this amendment will accomplish their goals.

### **Evidence that this will remove parental rights:**

We know that the ACLU has been active in litigation to remove parental rights for minors seeking abortion. Alaska is one example. The ACLU has also argued in court that parents should not have parental rights when it comes to gender confusion in kids.

This constitutional amendment will remove parental rights because the Amendment language clearly states "Every individual has the right to make and carry out one's own reproductive decisions" this language "Every individual" is the linchpin to removing parents out of the decision making for transgender surgeries, transgender hormones, abortion for minors.

This goes even further than states like New York where the ACLU claims that when a youth has the legal ability to consent to "Abortion" and the "morning after pill", but "There is no New York law that allows you to consent to trans-related health services, like hormone replacement therapy or gender affirming surgery." The State of NY even prohibits a parent from accessing their minor child's medical records. "Unless the law requires it, a health care provider may not release any confidential information without the patient's permission." Found at:

Again this constitutional amendment will go further than that, and remove parents out of the decision making, consent, or notification for issues relating to sex or sex organs.

### **Evidence that this will legalize abortion through all nine months of pregnancy:**

The Amendment states "abortion may be prohibited after fetal viability" this means all Protections for babies in the womb are removed for the first five months of pregnancy. Second, the Amendment proclaims, "But in no case may such an abortion be prohibited if in the professional judgment of the pregnant patient's treating physician it is necessary to protect the pregnant patient's life or health." This means that abortion up to birth will be legalized if the abortion doctor can proclaim it is for the mother's life or health. Here in lies the purposeful trick. We know the word health can legally mean emotional health and mental health. If a woman claims it is for her mental health or emotional health, she can legally kill her son or daughter up to the moment of birth.

### **Evidence this will enshrine incest, and trans, and same-sex anti-discrimination into law:**

The first line in the Constitutional Amendment states, "Every individual has a right to make and carry out one's own reproductive decisions." Because reproductive decisions deals with any decisions dealing with the action of sex or sex organs, this therefore will include the actions of homosexual sex, polygamy, and incest. <-**Shocking right! Incest legalized!**

This will also deal with any decision, dealing with the sex organs, which includes transgender hormones, transgender surgeries, and sterilization of minors without parental consent, involvement, or notification. We've seen many states where parental involvement has been attacked.

Because the Amendment says that the state cannot "discriminate" against these new "right"s therefore trans, incest, and same-sex anti-discrimination would be accomplished by this constitutional amendment.

LASTLY,

This is a part of a nationwide strategy, and you will find many of the constitutional amendments currently being proposed have similar language. But the Ohio Amendment will go further than the Michigan Amendment passed last November because this one WILL create the legal framework to allow pedophilia, child sex trade, prostitution, incest, which the Michigan amendment did not do.
