4. The nominated project should have a total value of not less than Rs. 5 lakhs.
5. Prepare a short write-up '*Company CSR Statement*'; preferably including the following;
 - a. The tangible results obtained by the nominated CSR project as of 31st December 2016.
 - b. Touch upon the procedure adopted for monitoring the nominated CSR project.
 - c. If conducted by an implementing agency, mention manner/modality/ procedure adopted by such agency.
 - d. If an assessment or evaluation conducted by the company itself, indicate the procedure followed.
6. Brochure and other material available on the nominated project.
7. Attach the media write-ups (if any) on the nominated project.
8. For individual category/ CSR leadership awards please provide details, including a vision statement and a profile of the individual CMD/ Chairman/ MD/ Director/CEO/ CSR Head with CSR related contribution details.
