SYNOPSIS

NARRATIVE

On Thursday, May 14, 2020 at approx. 0724 hrs Investigator T.J. Taylor reports answering a call to McBean Elementary School. I talked with School Principal -Janina Dallas and learned the following:

Dallas said between 1700 hrs Wednesday, May 13, 2020 and 0715 hrs this date person(s) unknown entered classrooms 16 and 20 by breaking the classroom window. Dallas said after entrance both classrooms were ransacked.

Dallas said the below listed items stolen.

Classroom -16

1- "Apple" I-Pad valued at \$300.00
 2- "Verizon" Tablets valued at \$400.00 each
 1- small- I-Pad (Unknown Name) valued at \$300.00

Nothing appeared to have been stolen from classroom 20, however, several computer monitors were damaged.

NARRATIVE

On Wednesday, May 13, 2020 at approximately 0820 hours, I, Sgt. A. Burns, was notified via public service of a possible burglary at McBean Elementary School. Upon arrival at McBean Elementary School, I met with the principal, Dr. J. Dallas. Dr. Dallas stated that damage was found on the outside in the rear of the school building upon arrival at the school this morning. After further investigation and viewing of video footage, officer's investigation revealed that four (4) unknown suspects were at the rear of the school building (west end) at approximately 0444 hours on May 12, 2020. Video show the males wearing hoodies and had backpacks on their backs. The subjects used a classroom chair and threw it mulitple times against the windows to school building. Officer found three windows with the glass broken and shattered. A small compact refrigerator with juices inside thrown to the ground, two shelves in the greenhouse were shattered and also a computer monitor thrown to the floor in a classroom. No other details were revealed. Incident was reported to me on 05/13/2020. Pictures and videos attached.
