Is Las Vegas Truly A Gambling House?

When politicians get together and make a gambling authority to oversee and track the casinos in Nevada, they inadvertently create one of the largest misuse of power and greed that exists in the world today. Why do I say this? Well, because the Gambling Commission and the politicians who made the commission, did so to be able to safeguard the gambling industry from competition. Needless to say, the result of this is obvious in the way that the gambling industry operates.

Maybe in retrospect, state and city leaders would also be better off if they'd kept the Convention Center available and instead put on large events and placing all their hardearned money into a gambling facility that pays absolutely no taxation and pays small amounts for the use of their property in the center of the largest city in the state.
