Notice of Removal of Implied Right to Usage and Access to a widow's robbed In Trust "land" and "fixture(s)" YOU are advised to read the following notice thoroughly and carefully. It is a lawful notice. It informs YOU that **My Self: Victoria-Ann: Nevens.** hereby give notice to all persons trespassing and Benjamin HOW and Sandra DENNIS of 1474 Faircliff Lane Victoria BC dba "HOWFAM HOLDINGS INC." that the implied right of usage and access to "the land" and "fixtures" known as **604 Polyanthus Crescent Victoria BC V8Z 2J4** has been removed, along with all associated property including, but not limited to, any

Private and or public conveyance in respect of the following:

- 1) ANY employee, principal, agent, third party, representative or any other person acting on behalf of or under the instruction of persons trespassing, Benjamin HOW and Sandra DENNIS dba "HOWFAM HOLDINGS INC.", "DISTRICT OF SAANICH", "THE CROWN" and or any other criminal CORPORATE BODY (i.e. Company) howsoever named and,
- 2) ANY PERSON performing the role of "POLICE OFFICER" who is acting for THE CORPORATE "district, city or township" POLICE and NOT acting as a Constable for and on behalf of the person acting in the role of His Majesty King Charles and the people as expressed in the Oath of Office to serve "*with fairness, integrity, diligence and impartiality, upholding fundamental Common Law rights and according equal respect to all people; and that I will, to the best of my power, cause the peace to be kept and preserved and prevent all offences against people and property*"

Any and all usage and access to the above-mentioned robbed widow's In Trust security will be by strict invitation only and will be subject to terms and conditions, available by written request. **My Self: Victoria-Ann: Nevens.** do not have, and have never had a contract with persons trespassing or Benjamin HOW and Sandra DENNIS of 1474 Faircliff Lane Victoria BC dba "HOWFAM HOLDINGS INC." the persons knowing they are in possession of property obtained by crime CC Sec. 354 (1)(a). And any permission that you persons believe you many have from **My Self: Victoria-Ann: Nevens.** is hereby withdrawn.

If ANY PERSON believes that YOU have power of attorney to act on **My** behalf YOU are hereby fired, and any consent that YOU believe YOU may have, tacit or otherwise, is hereby withdrawn. If YOU feel so inclined as to enforce statutes as a consequence of this notice **I: Victoria-Ann: Nevens.** will report your conduct to ALL relevant bodies and will pursue Proof of Claim in affidavit form, under YOUR full commercial and personal liability, under the penalty of perjury and YOUR imprisonment for life.

YOU persons, Benjamin HOW and Sandra DENNIS dba "HOWFAM HOLDINGS INC." and persons trespassing guilty beyond reasonable doubt of Mischief CC Sec. 430 (1)(a-d) causing danger to **My Life** are deemed to have been served this notice with immediate effect. All persons having been informed to leave are now under a Common Law responsibility and obligation to withdraw from the "land" and "fixture(s)" forthwith and failure to do so is not thereafter acting in the execution of your good faith duty and proves guilt of indictable trespasses with any subsequent levy claimed being invalid and attracts personal and commercial liability for each person for civil damages, criminal charges and imprisonment for life.
