


LabWorks Parameters and Benefits

LabWorks provides turn-key life science laboratory suites for commercial lease in the Research Park. The space will be constructed with a \$1.1 million investment in tenant improvements, with funding support from the Rebuild Illinois Wet Lab Capital Program (IL DCEO), the University of Illinois Research Park, LLC, and GEM Realty. This provides affordable leasing for laboratory space with no upfront tenant capital contribution required and lease rates at market office rates for the Research Park, which are well below large metro private alternatives. LabWorks provides a location for growth stage life science and agriculture companies.

- Office and conference room furniture provided
- Lab furniture and core equipment provided
- Access to EW lab support services, including ability to transfer and use shared lab equipment from EnterpriseWorks
- Access to procure from UIUC core labs and central lab stores through EW internal purchasing
- Entrepreneurship and business development services from EnterpriseWorks and the Research Park, including use of EIRs, shared services student projects, SBIR grant assistance
- Research Park recruiting services for student employment, job postings, internship program (including assistance with international student employees), and other recruitment assistance
- Employees retain Research Park Allied Agency Status with UIUC
















LabWorks has 3 suites available for lease with a lab and office contiguous suite and access to shared areas of the the suite, including one shared lab, entry vestibule, copy/print/mail area, and a networking closet. The tenants each also have access to shared areas within the building with their pro rata share of the common areas that include a loading dock, restrooms, conference room, corridors, and kitchen with break room.

Landlord responsibilities include major repairs (i.e. roof renovations). However, the tenant is responsible for maintenance and minor repairs, like painting and decorating. Expenses for maintenance of equipment and shared support lab will be charged back to tenants based on actual expenses incurred.

EnterpriseWorks Lab Support includes assistance from DRS (to be approved), lab manager assistance, access to shared labs and equipment at EnterpriseWorks, and ability to transfer equipment between sites, continued entrepreneurship services.



Utilities (Gas, Electric, Water, Sanitary Sewer): Allocated Monthly based on pro rate share of space and paid by each tenant to landlord.
