**AFFIDAVIT FOR ARREST WARRANT**

STATE OF FLORIDA  
COUNTY OF ORANGE

Before me, the undersigned witnessing authority, personally appeared **Officer Ellis Schoen**, who first by me duly sworn says he is a sworn police officer for the Winter Garden Police Department and that he has personal knowledge of an offense that occurred in Orange County, Florida on **01/20/2019**, in which defendant, **ROBERT CURTIS HEAD**, did, in violation of Florida State Statute(s) **784.045(1)(A)(2)-17**, unlawfully commit the offense(s) of **AGGRAVATED BATTERY W/ DEADLY WEAPON (DOMESTIC VIOLENCE)**.

On January 20, 2019, at approximately 0053 hours, I responded to 3627 Turningwind Ln on reference to a battery. Upon my arrival, I was flagged down by Tyler Head (other person) who advised his mother was struck by his father.

I observed Michelle Head (victim) lying on her stomach with paper towel soaked with what appeared to be blood held tightly to her head. Michelle's hair was soaked in blood, as was the back of her shirt. Michelle was awake and speaking to me, but seemed out of it and unable to remember what happened. Next to Michelle was a wooden decorative window frame with rot iron decoration. The decoration had a wooden corner missing from it. The frame looked to be taken from the wall in the kitchen, where there were two empty nails in the wall. The spacing of the nails were consistent with the hooks on the frame.

While Michelle was receiving medical attention, I spoke with Tyler about the incident. He advised he was upstairs when he heard his parents arguing. Among the sounds of a verbal disturbance he heard several loud bangs as if things were being thrown around the home. He stayed upstairs until he heard

his father, Robert Head, leave the residence. Tyler then came downstairs to find his mother lying at the foot of the stairs bleeding from the head, and called police.

I spoke with Michelle who was very hesitant to give information and insisted she did not remember what happened. After separating Michelle from the other responders and family on scene, she advised she did remember and wished to speak with me. She explained that her birthday was a couple of days ago, so she and Robert went to dinner with a few friends to celebrate. While at dinner, there was a short argument that was squashed before they left dinner. Michelle advised when they returned home, the argument continued. There was a physical disturbance both upstairs and downstairs. I observed their bedroom to be torn apart, with a broken bed post and broken vases on both sides of the bed. The sheets from the bed were on the ground, and there was a broken wooden candle stick by the door way. I observed a long hair, consistent with the length and color of the victim's hair, stuck in the broken wood of the candle stick. The candle stick was collected and submitted into evidence.

Both parties exchanged words that hurt Michelle's feelings, so she threw a plastic plate at Robert in the kitchen. Michelle advised after she threw the plate, she began to walk away from Robert when she was struck with an unknown object in the back of the head. She explained that the time between her being hit in the head and my arrival is unclear, and she does not remember any of it. Michelle expressed that she does not want to press charges, and signed a Prosecution Declaration.

Robert fled the scene before my arrival. I spoke with Tyler again who advised Michelle instructed him to call Robert before calling police. Robert answered the phone, and Tyler told him Michelle was bleeding from the head and he needed to return home. Robert apologized, and hung up the phone. No contact was made while I was on scene.

During a canvass of the home, the wooden window frame with rot iron decoration was examined. There was a red stain found on the side facing the ground that was consistent with blood. The window frame included rot iron flowering in the center. The sharp edges of the iron flowering contained the majority of the red stain consistent with blood found on the frame, and the metal was bent inward. The metal was secured to the wooden frame with several small screws. The force of the metal hitting Michelle's head dislodged the screws from the wood. The screws were found on the ground beneath the frame. There was also blood found on the pillar located at the bottom of the stairs, beside the wooden frame.

The window frame was taken from a spot in the kitchen, and was found in the space between the foyer and the living room. Michelle was walking away from Robert when he grabbed the wooden frame with rot iron decoration from the kitchen and utilized it as a deadly weapon. Robert lifted the frame, walked toward Michelle, and struck her in the back of the head as she was walking away and defenseless. It should be noted that the weapon used, the blood, and where Michelle was lying upon my arrival, were all in the same immediate area.


Michelle refused to fill out a sworn written statement, and was provided with a Domestic Violence victim's rights brochure. Photographs were taken of the scene and the victim and submitted into evidence. The wooden frame was also collected and submitted into evidence.

Due to Robert intentionally striking Michelle with a deadly weapon, intentionally and knowingly causing great bodily harm, and the nature of their relationship (being married and having a child in common), probable cause exists to charge Robert with Aggravated Battery Domestic Violence.
