I, Daniel T. Satterberg, Prosecuting Attorney for King County in the name and by the authority of the State of Washington, do accuse PATRICK LEON NICHOLAS of the following crime: **Murder In The First Degree**, committed as follows:

Count 1 Murder In The First Degree

That the defendant PATRICK LEON NICHOLAS in King County, Washington, on or about December 14, 1991, with premeditated intent to cause the death of another person, did cause the death of Sarah Yarborough, a human being, who was not a participant in the crime, and who died on or about December 14, 1991; and/or while committing or attempting to commit the crime of Rape in the Second Degree, and in the course of and in furtherance of said crime and in the immediate flight therefrom, did cause the death of Sarah Yarborough, a human being, who was not a participant in the crime, and who died on or about December 14, 1991;

Contrary to RCW 9A.32.030(1)(a), (c), and against the peace and dignity of the State of Washington.

And further do allege the defendant, Patrick Leon Nicholas of committing this crime with sexual motivation, that is: that one of the purposes for which the defendant committed this crime was for the purpose of his sexual gratification, under the authority of RCW 9.94A.835.

3 PROSECUTING ATTORNEY CASE SUMMARY AND REQUEST FOR BAIL AND/OR
4 CONDITIONS OF RELEASE

5 The State incorporates by reference the Certification for Determination of Probable Cause
6 prepared by Detective Kathleen Decker of the King County Sheriff's Office for case number 91-
7 392815.

8
9 Sarah Yarborough was 16 years old at the time of her death. 27 years have passed since her
10 body was found on her high school campus. She was an Honors student with her entire life
11 ahead of her. She was beaten and strangled to death with her own nylons. Several items of her
12 clothing were found near her body with semen on them. Sarah was left discarded in the brush on
13 a hill, adjacent to the school parking lot where she had just parked her father's car.

14
15 Patrick Leon Nicholas was 27 years old on the day he encountered Sarah at Federal Way High
16 School. He had already been to prison for the crime of Attempted Rape in the First Degree out
17 of Benton County. In 1983, he approached a young woman in her car and threatened her with a
18 knife. He forced her to disrobe in her car and then walked her toward a river. The victim
19 escaped by jumping in the river and swimming away. Law enforcement learned that the
20 defendant withdrew money from his bank and left the area by plane on that same day. He was
21 later found and ultimately plead guilty as charged to Attempted Rape in the First Degree. His
22 DNA has never been entered into CODIS.

1
2 Countless hours have been spent by law enforcement attempting to solve this horrific crime that
3 impacted our community in a way that few people have forgotten. Patrick Leon Nicholas has
4 lived for the last several years in a dilapidated building on a large piece of property with few
5 community ties. If he does not remain in custody, he has every reason to flee and attempt to
6 avoid prosecution as he has done for the last 27 years. His crime was one of opportunity and
7 extreme violence and he will always be considered a danger to our community. While his last
8 conviction was in 1994, his DNA will now be placed into CODIS for comparison to other
9 unsolved cases.

11 The State requests that this court set bail at \$5,000,000 for the protection of our community, the
12 security that Nicholas will not evade the court process, and for Sarah's family who deserve some
13 peace of mind after all this time.

2 CERTIFICATION FOR DETERMINATION OF PROBABLE CAUSE

3 That Kathleen Decker is a (n) Detective with the King County Sheriff's
4 Office and has reviewed the investigation conducted in the King County
5 Sheriff's case number (s) 91-392815;

6 There is probable cause to believe that Patrick Leon Nicholas DOB
7 03/10/1964 committed the crimes (s) of Murder 1st Degree RCW 9A.32.030.
8 This belief is predicated on the following facts and circumstances:
9 I AM A 34 YEAR VETERAN OF THE KING COUNTY SHERIFF'S OFFICE AND HAVE OVER 18
10 YEARS' EXPERIENCE WORKING AS A DETECTIVE IN CRIMINAL INVESTIGATIONS. DURING
11 MY TENURE WITH THE SHERIFF'S OFFICE I HAVE WORKED AS LEAD DETECTIVE ON A
12 MULTITUDE NUMBER OF HOMICIDE, FELONY ASSAULT, ROBBERY AND MISSING PERSON
13 CASES.

14 DETECTIVE JAMES ALLEN OF THE KING COUNTY SHERIFF [KCSO] MAJOR CRIME UNIT
15 RETIRED AND I INHERITED SOME OF HIS CASELOAD. ONE OF THE CASES I INHERITED
16 FROM DETECTIVE ALLEN IS THE UNSOLVED 1991 MURDER OF SARAH YARBOROUGH IN
17 FEDERAL WAY, A CITY SOUTH OF SEATTLE IN KING COUNTY, WASHINGTON.

18 SARAH YARBOROUGH WAS 16 YEARS OLD AT THE TIME OF HER DEATH. SHE LIVED IN
19 FEDERAL WAY AND ATTENDED FEDERAL WAY HIGH SCHOOL (FWHS), WHERE SHE WAS AN
20 HONOR STUDENT AND A DRILL TEAM MEMBER. ON SATURDAY DECEMBER 14, 1991, SARAH
21 WAS JOINING THE FWHS DRILL TEAM FOR A TEAM COMPETITION. ACCORDING TO A FEMALE
22 CLASSMATE WHO SPENT THE PREVIOUS NIGHT AT SARAH'S HOUSE, SARAH WOKE UP ON
23 SATURDAY MORNING AND LEFT HER HOME ALONE, SHORTLY AFTER 0800HRS, IN HER
24 FATHER'S CAR. SARAH WAS IN A HURRY, THE CLASSMATE SAID, BECAUSE SHE THOUGHT
25 THAT SHE AND THE REST OF THE DRILL TEAM MEMBERS WERE SCHEDULED TO MEET AT
FWHS AT 0800HRS AND TRAVEL TOGETHER TO THE DRILL TEAM COMPETITION AT ANOTHER
SCHOOL. HOWEVER, SARAH WAS WRONG ABOUT THE TIME OF THE RENDEZVOUS - IT WAS
0900HRS, NOT 0800HRS.

IT APPEARS THAT SARAH ARRIVED AT FWHS SOME 45 MINUTES EARLY. A FWHS STUDENT
SAW HER FATHER'S CAR, UNOCCUPIED, AT THE STUDENT PARKING LOT AT FWHS, LOCATED
WEST OF THE CLASSROOMS, AT ABOUT 0825HRS. AFTER THE MURDER, INVESTIGATORS
FOUND THE CAR IN THE STUDENT LOT, UNLOCKED, WITH SOME OF SARAH'S PROPERTY
INSIDE THE CAR, UNDISTURBED.

ADJACENT TO THE STUDENT PARKING LOT AT FWHS WAS A LARGE "PRACTICE BALL
FIELD," A RAISED PLOT OF LAND SOME 30 FEET ABOVE THE LEVEL OF THE PARKING
LOT. WEST OF THE PARKING LOT AND THE PRACTICE FIELD WERE TENNIS COURTS. AT
ABOUT 0910HRS THAT MORNING, A MAN WAS JOGGING NEAR THE TENNIS COURTS AT FWHS
WHEN HE NOTICED MOVEMENT IN THE BRUSH ON THE HILL ADJACENT TO THE PRACTICE
FIELD. HE LOOKED OVER, AND SAW A GIRL LYING MOTIONLESS ON THE GROUND. A
WHITE MALE WAS KNEELING OVER HER, MOVING HIS HANDS OVER THE BODY OF THE GIRL
IN THE AREA OF HER BREASTS AND THIGHS. THE JOGGER THOUGHT THEY WERE A COUPLE
"MAKING OUT," AND JOGGED ON. HE LATER DESCRIBED THE MALE AS WHITE, ABOUT
6'0" TALL, WITH STRAIGHT, DIRTY-BLONDE HAIR, WEARING A DARK TRENCH COAT.

AT APPROXIMATELY 0920HRS, TWO TWELVE-YEAR-OLD BOYS WERE WALKING THROUGH THE
SCHOOL GROUNDS NEAR THE TENNIS COURTS WHEN THEY SAW A WHITE MALE, WEARING A
LONG, DARK TRENCH COAT, EMERGE FROM THE BRUSHY HILLSIDE BESIDE THE PRACTICE
FIELD. THE BOYS LATER DESCRIBED THE MALE AS 17 TO 30 YEARS OLD, 6' TO 6'1"

1 TALL, ABOUT 160 POUNDS, WITH BROWN TO BLONDE SHOULDER LENGTH HAIR. THE BOYS
2 SAID THE MALE LOOKED IN THEIR DIRECTION, SAW THEM, LOOKED QUICKLY AWAY, AND
3 BEGAN WALKING RAPIDLY TOWARD THE STUDENT PARKING LOT SOME 100 FEET AWAY.
4 THE BOYS CONTINUED WALKING IN THE DIRECTION FROM WHICH THE MALE HAD COME. AS
5 THEY APPROACHED THE AREA WHERE THEY HAD FIRST SEEN HIM, THEY LOOKED TOWARD
6 THE HILLSIDE AND SAW THE BODY OF A GIRL, WEARING A DRILL TEAM MEMBER UNIFORM,
7 LYING MOTIONLESS ON HER BACK. THEY RAN BACK TO THE HOUSE OF ONE OF THE BOYS
8 AND TOLD HIS PARENTS, WHO CALLED THE KCSO AT 0933HRS.

9 RESPONDING INVESTIGATORS ARRIVED WITHIN MINUTES, AND DISCOVERED THE BODY OF
10 SARAH YARBOROUGH ON THE BRUSHY HILLSIDE ADJACENT TO THE PRACTICE FIELD. SHE
11 WAS WEARING HER DRILL TEAM MEMBER SKIRT AND SWEATER. HER SHOES WERE ON HER
12 FEET, BUT THEY WERE UNLACED. HER NYLON STOCKINGS WERE WRAPPED AROUND HER
13 NECK IN A LIGATURE. ABOUT THREE FEET FROM HER BODY LAY THE REST OF HER
14 CLOTHING: HER UNDERPANTS, BRA, JACKET, AND SOCKS. THEY APPEARED TO HAVE
15 BEEN PLACED, RATHER THAN TOSSED, THERE.

16 AN AUTOPSY FOUND THAT DEATH WAS THE RESULT OF LIGATURE STRANGULATION; THERE
17 WAS ALSO EVIDENCE OF BLUNT FORCE INJURIES TO HER FACE.

18 THERE WAS NO INDICATION OF SEXUAL PENETRATION, AND NO SEMEN OR SPERMATOZOA
19 WAS FOUND ON OR IN HER BODY. HOWEVER, THERE WAS SEMEN ON MULTIPLE ITEMS OF
20 SARAH'S CLOTHING THAT LAY NEAR HER BODY, AND IT APPEARED TO INVESTIGATORS
21 THAT THE SEMEN HAD BEEN DEPOSITED AFTER THE CLOTHES WERE PLACED THERE. A DNA
22 SCIENTIST AT THE WASHINGTON STATE CRIME LAB SUBSEQUENTLY DEVELOPED A SINGLE
23 MALE DNA PROFILE FROM THE SEMEN FOUND ON SARAH'S CLOTHES. THAT DNA PROFILE
24 HAS NEVER BEEN ASSOCIATED WITH ANY IDENTIFIED INDIVIDUAL, DESPITE REGULAR
25 SEARCHES IN WASHINGTON AND NATIONAL FORENSIC DNA DATABASES.

AN ARTIST, WORKING AT THE BOYS' DIRECTION, CREATED A SKETCH OF THE MALE THE
BOYS HAD SEEN LEAVING THE AREA WHERE SARAH YARBOROUGH'S BODY WAS FOUND. THE
SKETCH WAS WIDELY CIRCULATED IN THE SEATTLE-KING COUNTY AREA.

Many Detectives, over the years, have been assigned to conduct follow-up on
this case. Over 4,000 tips have been generated and multiple leads have been
pursued. In 2005 the Washington State Patrol Crime Lab was contacted to
perform additional forensic testing on evidence previously recovered and
submitted to the lab for analysis. Multiple individuals have been identified
as possible suspects in this case, but there has never been a match to the
male DNA profile found at the scene. Detectives have continued to utilize
the most current and state of the art forensic and genetic testing in an
attempt to identify the person responsible for this crime.

ON SEPTEMBER 27TH, 2019 I RECEIVED A PHONE CALL FROM DR. COLLEEN FITZPATRICK
REFERENCE THIS CASE. DR. FITZPATRICK IS THE FOUNDER OF IDENTIFINDER
INTERNATIONAL, INTERNATIONAL FORENSIC GENEALOGISTS BASED OUT OF FOUNTAIN
VALLEY, CA. DR. FITZPATRICK HAS WORKED ON THIS CASE ON MULTIPLE OCCASIONS.
MOST RECENTLY, SHE WAS CONTRACTED BY THE KING COUNTY SHERIFF'S DEPARTMENT IN
2019 TO PERFORM ADDITIONAL GENEALOGY COMPARISONS.

DR. FITZPATRICK STATED THAT SHE AND TWO OTHER GENEALOGISTS HAD IDENTIFIED A
LEAD ON A PERSON OF INTEREST IN THIS CASE. I ALERTED SGT. ANTHONY MCNABB AND
SGT. BLYTHE MINIKEN TO THIS CALL. I PLACED THE CALL ON SPEAKER PHONE AND DR.
FITZPATRICK INTRODUCED TWO ADDITIONAL GENEALOGISTS AS GRETCHEN STACK AND
HOLLY TURK.

1 ALL THREE GENEALOGISTS SHARED THE NAMES OF TWO BROTHERS IDENTIFIED THROUGH A
2 FAMILY TREE ANALYSIS ORIGINATING FROM THE UNKNOWN SUSPECT DNA PROFILE. THE
3 BROTHERS WERE IDENTIFIED AS EDWARD PETER NICHOLAS JR. BORN 12/01/1958 AND
4 PATRICK LEON NICHOLAS BORN 03/10/1964. BOTH OF THESE BROTHERS HAVE BLOND
5 HAIR AND BLUE EYES. I LEARNED THAT THIS INFORMATION WAS DERIVED FROM
6 RESEARCHING FAMILY MEMBERS FROM THREE SETS OF GRANDPARENTS.

7 UPON LEARNING THE NAMES OF THE TWO BROTHERS, I INVESTIGATED THEIR HISTORY
8 WITH THE CRIMINAL JUSTICE SYSTEM. EDWARD P NICHOLAS HAD A PRIOR CONVICTION
9 FOR RAPE 1ST DEGREE AND WAS A REGISTERED SEX OFFENDER. HIS DNA IS IN CODIS
10 AND THEREFORE HE CANNOT BE THE KILLER OF SARAH YARBOROUGH AS THE UNKNOWN
11 SUSPECT DNA PROFILE HAS BEEN IN CODIS WITH REGULAR COMPARISONS TO FELON
12 PROFILES.

13 PATRICK LEON NICHOLAS HAS A 1983 CONVICTION FOR ATTEMPTED RAPE IN THE FIRST
14 DEGREE OUT OF BENTON COUNTY. HE WAS SENTENCED TO PRISON AND RELEASED IN
15 1987. HE ALSO HAS A 1993 ARREST FOR CHILD MOLESTATION IN THE FIRST DEGREE IN
16 KING COUNTY. THAT CASE WAS RESOLVED WITH A GUILTY PLEA TO A GROSS MISDEMEANOR
17 ASSAULT 4TH DEGREE CHARGE. WASHINGTON STATE SEX OFFENDER REGISTRATION AND
18 DNA COLLECTION FOR CODIS ELIGIBLE OFFENSES STARTED IN 1990. PATRICK L
19 NICHOLAS HAS NEVER PROVIDED A DNA SAMPLE FOR ENTRY INTO CODIS.

20 IN RESEARCHING WHERE PATRICK I. NICHOLAS RESIDED, WE NOTED A 1989 CASE IN SKID
21 UNDER 89-278804 SHOWING PATRICK L NICHOLAS ASSOCIATED TO THE ADDRESS OF 153
22 S. 160TH #14 IN BURIEN, WA. SKID RECORDS ALSO SHOW A 1993 CASE (93-428772)
23 WHERE PATRICK L NICHOLAS 03/10/1964 WAS ASSOCIATED TO THE ADDRESS OF 3002 S.
24 208TH STREET V-11 IN THE CITY OF SEATAC, WA. THE SEATAC ADDRESS IS 6.4 MILES
25 FROM THE ADDRESS OF THE FEDERAL WAY HIGH SCHOOL.

PATRICK NICHOLAS WAS LISTED AS BEING 5'10, 150LBS WITH BLOND HAIR AND BLUE
EYES. SGT. MCNABB CHECKED THE NAME OF PATRICK NICHOLAS IN THE YARBOROUGH
TIPS DATABASE AND NOTED THAT HIS NAME NEVER WAS NEVER TIPPED AS A POSSIBLE
SUSPECT TO LAW ENFORCEMENT. HOWEVER, IT WAS DETERMINED THAT PATRICK I.
NICHOLAS AND HIS BROTHER EDWARD NICHOLAS WERE CURRENTLY RESIDING ON PROPERTY
LOCATED IN KING COUNTY.

DURING THE EVENING OF 09/29/2019 KING COUNTY SHERIFF DETECTIVES CONDUCTED
SURVEILLANCE ON PATRICK I. NICHOLAS. DURING THE SURVEILLANCE OPERATION
DETECTIVE T SMITH APPROACHED THE SUBJECT BELIEVED TO BE PATRICK L NICHOLAS
AND ASKED FOR DIRECTIONS. DETECTIVE T SMITH ALSO INTRODUCED HIMSELF AND
THANKED HIM FOR THE DIRECTIONS. THE SUBJECT RESPONDED BY SAYING THAT HIS
NAME WAS "LEON". LEON IS THE MIDDLE NAME FOR PATRICK L NICHOLAS.
ADDITIONALLY, IN THE KING COUNTY PAPERWORK FOR A PETITION FOR DIVORCE IN JULY
1993, BETWEEN WANDA NICHOLAS AND PATRICK L NICHOLAS, THE PETITIONER IS
IDENTIFIED AS "LEON NICHOLAS". DETECTIVE T SMITH ALSO NOTED THE SUBJECT
MATCHED THE PHYSICAL DESCRIPTION OF THE WASHINGTON STATE DRIVER'S LICENSE
PHOTOGRAPH UNDER HIS NAME AND DATE OF BIRTH.

DURING SURVEILLANCE, DETECTIVE SERGEANT CALABRESE ADVISED HE WAS WATCHING
PATRICK L NICHOLAS SMOKE A CIGARETTE WHILE STANDING IN FRONT OF THE LAKE
MERIDIAN CLEANERS. THE LAKE MERIDIAN CLEANERS ARE LOCATED AT THE ADDRESS OF
15220 SE 272ND STREET KENT, WA. THE CIGARETTE WAS RETRIEVED BY DETECTIVE
SPEIGHT. A SHORT TIME LATER, PATRICK L NICHOLAS WALKED BACK OUTSIDE AND
SMOKED AN ADDITIONAL CIGARETTE, WHICH HE TOSSED ONTO THE GROUND. PATRICK L
NICHOLAS ALSO REACHED INTO HIS POCKET AND WHEN HE PULLED HIS HAND OUT OF HIS
POCKET, A NAPKIN FELL TO THE GROUND. DETECTIVE SPEIGHT COLLECTED THE 2ND
CIGARETTE AND THE PAPER NAPKIN. DETECTIVE SPEIGHT REPORTED HE DONNED A CLEAN

1 LATEX GLOVE PRIOR TO COLLECTING EACH PIECE OF EVIDENCE. EACH EVIDENCE ITEM
2 WAS PLACED INTO A PAPER BAG WHICH WAS PROPERLY MARKED AND SEALED.

3 I TOOK POSSESSION OF THOSE THREE ITEMS OF EVIDENCE DURING THE MORNING OF
4 09/30/2019. I TRANSPORTED THOSE ITEMS TO THE WASHINGTON STATE PATROL CRIME
5 LAB FOR DNA PROCESSING.

6 ON 10/02/2019 AT ABOUT 0740HRS, I RECEIVED A PHONE CALL FROM WSPCL DNA
7 SCIENTIST JENNIFER VENDITTO. IT WAS CONFIRMED THAT THE MALE DNA PROFILE
8 OBTAINED FROM THE CIGARETTE BUTTS IS THE SAME PREVIOUSLY UNKNOWN MALE DNA
9 PROFILE OBTAINED FROM THE ITEMS AT THE SCENE OF SARAH YARBOROUGH'S MURDER.

10 ON 10/03/2019, I PLACED PATRICK L NICHOLAS UNDER ARREST. DETECTIVE T SMITH
11 CONFIRMED THAT THE PERSON PLACED UNDER ARREST WAS THE "LEON" THAT HE ASKED
12 FOR DIRECTIONS AND WHO SMOKED THE CIGARETTES OUTSIDE THE LAKE MERIDIAN
13 CLEANERS. AFTER FULL MIRANDA, PATRICK L NICHOLAS CONFIRMED THAT HE WAS AT
14 THE LAKE MERIDIAN CLEANERS ON THE EVENING OF 9/29/2019 AND SMOKED A FEW
15 CIGARETTES OUT FRONT WHILE WAITING FOR HIS LAUNDRY.

16 THE MALE DNA PROFILE AT THE SCENE OF SARAH YARBOROUGH'S DEATH HAS BEEN
17 UNKNOWN FOR 27 YEARS. THAT PREVIOUSLY UNKNOWN MALE DNA WAS LOCATED ON
18 SARAH'S BLUE JACKET, HER UNDERPANTS, GLOVES, SKIRT AND PANTY HOSE. THE PANTY
19 HOSE WERE FOUND AROUND SARAH'S NECK AND WAS THE LIGATURE USED TO STRANGLE HER
20 TO DEATH. THE MALE PROFILE ON EACH OF THESE ITEMS IS THE SAME AS THE MALE
21 PROFILE IDENTIFIED ON THE CIGARETTE BUTT DISCARDED BY PATRICK LEON NICHOLAS
22 ON 9/30/2019. THE UNKNOWN MALE PROFILE AT THE SCENE OF SARAH YARBOROUGH'S
23 DEATH HAS NOW BEEN IDENTIFIED AS THE DNA OF PATRICK LEON NICHOLAS.

24 BASED UPON THE ABOVE FACTS I BELIEVE THERE IS PROBABLE CAUSE TO CHARGE
25 PATRICK L NICHOLAS WITH MURDER 1ST DEGREE UNDER RCW 9A.32.030.

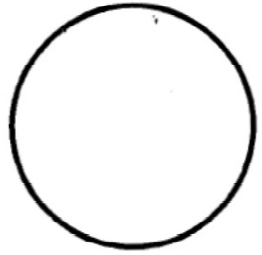
