Narrative:

On December 7, 2005 at approximately 0030 hrs, radio advised of a suspicious person on Trillium St. SE. Radio advised a caller at 2310 Trillium St. stated an unknown female came to her door and seemed very disoriented. The reporting party stated the female left her property and was last seen heading towards Shadylane. Upon arrival I was unable to immediately locate the female in question. However, after leaving the area a second report of an unwanted female came in.

V-1 Larry W. Locklar was stating a female had entered his residence at 2302 Trillium St. and seemed very disoriented. Upon arrival I made contact with A-1 Danielle L. Phelan who was still in the residence. Phelan stated she did not know why she was at the residence and was simply trying to find her way home. I asked Phelan where she lived and she stated she lived on the west side of Olympia. I asked Phelan if she had been drinking and she admitted she had but denied being on any narcotics. While talking with Phelan she was extremely disoriented and could not answer basic questions. I asked her if she knew where she was and she stated "I am where I am." Phelan was asked if she knew the residence she was at was not hers and she stated she was aware of that.

Locklar stated Phelan entered his residence from the back door and he found her in the living room. Locklar stated she entered the premises without his knowledge or permission and scared his mother. Locklar then dialed 911. I have attached a written statement from Locklar.

During our investigation it was discovered there was a house party further north on Trillium St. Officer Sapinoso checked the residence to see if Phelan had come from the party. Several individuals from the party arrived on-scene and stated they in fact did know Phelan and that she was at the party earlier in the evening. Phelan provided us with a breath sample which registered a alcohol level of .160.

I issued Phelan a criminal citation for Trespass in the first degree and she was released on signature.

Narrative:

On 12-7-05 about 0030 hours Lacey units responded to a suspicious person in the area of 2310 Trillium St SE. The calling party at the residence stated that a younger female that appeared to be either intoxicated or "high" rang her doorbell, and was now standing next to her mailbox. The female was last seen walking towards Shady Lane.

Upon arrival I was unable to locate the female, but just north of the calling party's address I observed several cars parked on the side of the roadway. I observed a male and a female talking outside the residence on the driveway. I asked if they had seen a female walking around the neighborhood possibly intoxicated. The female stated that about an hour ago she observed a female walking around the neighborhood, and possibly knew her name to be Danielle.

Radio advised that another calling party c1-Locklar who resided at 2302 Trillium St SE advised radio that an unknown female had entered his residence. He stated that the female appeared to be confused.

Upon arrival I observed c1-Locklar outside of his listed residence standing next to the carport dressed only in boxers. He invited me inside his residence, and pointed out the unknown female. I asked the female to exit the residence and talk to Officer Newcomb while I spoke to Locklar. He stated that while he was asleep an unknown female entered his residence from the unsecured back door. The unknown female startled Locklar's mother who was reading in the living room. Locklar stated that the female looked confused, and might have been "high on something". Locklar stated that the female was very polite, and did not pose a threat, but she had startled his mother. He advised that he was not missing anything and his residence appeared to have not been tampered. I asked Locklar if he wanted to pursue criminal charges against the female and he replied, "No, but shake her down she might have something on her."

I contacted Officer Newcomb outside the residence and he advised that the female was so intoxicated that she did not even know her residing address. I returned to the residence just north of location, and inquired if anyone knew Danielle Phelan. A male name Jason Anderson and a female name Katie Witkowski came forward and stated that they both worked at the Rock with Danielle. Jason stated that Danielle was welcomed back at his residence and he and Katie would take care of Danielle.

Officer Newcomb cited Phelan for trespassing and released her to Katie and Jason.
