REPORT:

On above date (in morning hours between 0900 and 1000), KGB individual by the name Valerio aggressively approaches me and other roommate (also associated to KGB but from Chechnya) with whom we have just exited gym and begun to yell at me on how one is tired of cleaning garbage after me (had trash bin from room in his hands and was about to dispose one in garbage can)

KGB Valerio as well as several other individuals were previously even involved in MKULTRA case against me when held in Poland between 1999 and all the way to 2013. Valerio and others with whom I was station from day A (first day) when I applied for protection in Poland and then compelled with them into stay even in same room at new location in Grotniki, did nothing but harass with psychiatric issues, have used profanities against me, my computer charger was destroyed no less than twice within less than month (other equipment was damaged or stolen as well), have exercised extreme yelling at me, and begun to even physically engage against me (THE NEXT DAY ON 15TH OF SEPTEMBER BOTH BEGUN TO PUSH ME CLAIMING ON HOW THEY WILL NOT CLEAN AFTER ME AND VALERIO WENT AS FAR AS PUSHING PLATE INTO MY MOUTHS - AGAINST

MY TEETH WHAT I SEE AS EXTREMELY AGGRESSIVE ACT) . . .

TRASH CAN WAS EMPTIED WITHINN 9 DAYS TWICE...ONCE BY ME PERSONALLY(THREE DAYS EARLIER) AND ONCE BY VALERIO...ROOM NEVER EVER WAS CLEANED BY NEITHER OF US AND WAS LIKE THAT ALREADY FOR MONTHS WHAT IS ALSO VISIBLE FROM VIDEO RECORDING BELLOW.

FINALLY POLICE WAS CALLED AS I HAD ENOUGH.

WHY CASE WAS FILED IN CITY LODZ AND NOT IN ZGIERZ AS ADVISED TO DO BY POLICE OFFICERS .

BECAUSE THE TWO WERE INVOLVED IN MKULTRA(was gestured in advance on how this will happen and nothing good for me once I complain to local authorities – in fact even on how I would be deported to United Strates of America and so on)....even security officer on duty refused to call for police when I asked for one – he adviced me to walk to Zgierz instead.

Don't bother about two officers...as far as I remember(the opposite from Debak, **Warszaw reception center where police officer was local**), these two work most likely on different location – at least its what I was gesured under MKULTRA. If this is truth, its just another fact that whole thing was orchestrated in a such a way that would make me look as paranoid if I would dare|(as I do to claim right here) on how whole thing described above was orchestrated by local authorities(government) for the sake of KGB. This takes us little further and I am using yet as another proof of MKULTRA in Poland between 1999 and 2013.
